MESSAGE FROM THE PRESIDENT

This edition of *The Order* will reach you in the month of the centenary of the end of WWI. The Great War ended after a successful 100 day campaign, begun on 8 August near Amiens in north-western France.

The campaign by the British Fourth Army, led by General Sir Henry Rawlinson, included four Canadian, ve Australian and ve British divisions. Rawlinson declared, after the successful Amiens battle, "The Canadians have done splendidly and the Aussies even better...". For his part the German commander Ludenhorff wrote "August 8 was the black day for the German army". He told his superiors that Germany's only option was defensive operations en route to seeking terms for the end of the war.

For today's generation, and earlier generations, the nation has largely forgotten Amiens (and the conclusive victories which followed in 1918 at Mont St Quentin and Peronne, culminating in the breaking of the Hindenburg Line). We should remember Amiens, and the battles before and after, as the most momentous actions in Australia's military history. This was a moment of Australia's greatest in uence on world affairs. The battle of Amiens made a national hero of Sir John Monash. Monash was then commander of all Australian forces consolidated into an Australian Army Corps. When Monash died in 1931 over 300,000 lined the streets of Melbourne, re ecting the esteem in which he was held. Shortly before his death the most famous living Australian was asked to lead a coup against the national government. Monash rejected this, declaring "The only hope for Australia is the ballot-box and an educated electorate". These words adorn the new statue of Monash unveiled this year at the Australian War Memorial in Canberra.

The Association is delighted Monash joins Weary Dunlop and Simpson as the preeminent gures featured in statues at the Memorial.

We share too Monash's emphasis on education which is re ected in so many of our activities across Australia.

NATIONAL CHAIRMAN'S REPORT

The message from our President Philip Flood AO on the Centenary of Armistice and the incredible contribution of the ANZAC Corps emphasises the uniqueness of our Australian society. In 1915 volunteers came together from all walks of life and from vastly different

backgrounds and cultures. They endured together more than 4 years of con ict. Their greatest strength was the bond of 'mateship' which we still see today, not just in our servicemen and women, but throughout our society. While the word 'racism' continues to be a source of debate, we enthusiastically accept the individual for her or his contribution to society.

The Order of Australia is a unique honours system, in that a nomination may be made by any Australian in respect of another, without political or other bias. The Order of Australia thus re ects the value placed on community contribution at all levels in our society.

Your Board is mindful of the need for open and transparent management and has for over a year been overhauling policies and procedures throughout the organisation. This work continues.

We began the year with a call to encourage more nominations for awards in the Order, and this has been taken up at all levels in our Association. We have seen a signi cant increase in the number of awards as well as a higher proportion of women being nominated. Association membership is increasing, with more new recipients joining and a higher rate of renewal of annual membership. Receptions for new recipients held in Branches and Regions have contributed to this pleasing result.

Members are encouraged to provide the Association with their email address. Nationally we have achieved over 80% acceptance, but in some areas, take-up remains low. Email allows both your Branch and Region, as well as National, to keep you better informed of issues of importance at a lower cost than by letter. Provision of email address does not result in your copy of The Order magazine coming by this means – to take it electronically requires you to 'opt in'.

We are now approaching the Annual General Meeting 'season' both for Branches and the National organisation. You will have received in this copy of The Order the necessary nomination forms for the appointment of 'non-Branch nominated' directors to the National Board. Soon you will also receive advice and nomination forms for your Branch management committee, and for 'Branch nominated' directors. I ask you to consider whether you have the skills and enthusiasm to contribute to the leadership of our Association. We need continual renewal at all levels, together with the injection of new ideas. If you can contribute, we encourage you to nominate.

Our National Conference in Hobart, from 11th to 14th April 2019, will be a great opportunity to meet up with fellow members and to express your views on the future of the Association. I look forward to meeting as many members as possible in Hobart.

FREMANTLE PRISON VISIT

A guided tour of the historic Fremantle gaol was organised by Bettine Heathcote AM, the Branch events co-ordinator. The members and their guests who attended thoroughly enjoyed the tour and, the anecdotes about the colonial, post-colonial and more recent use of the prison. Even up until its nal days in the 1990s, none of the prison cells had plumbing and the prisoners used a bucket while locked up for the night. Self-control was encouraged (sometimes physically) by those prisoners whose job it was to empty the buckets each day. Along with the ogging post, the very basic infrastructure was a signi cant deterrent to doing anything that might warrant incarceration. No wonder the re-offence rate was so low for those serving time in this gaol.

Prisoners spent all day from 7.00 am until 4.00 pm out in exercise yards with no shelter in either summer or winter. Those who had incurred solitary con nement were locked into cells with double doors made of jarrah with a very small barred window high up in their cell which could be completely blocked making the cell very dark. These prisoners were taken out to a special exercise yard alone for an hour each day. This was to ensure they had no contact with other prisoners and led to many being ending their days in "the madhouse".

CHAIRMAN'S REPORT

The ACT Branch continues to provide a variety of events to suit all interests. In this edition of the The Order, you'll nd reports on our annual Multi-Faith Observance (19 August), our second reception for new recipients for the year (19 September), and the 2018 Order of Australia Associa-

tion – Australian National University Lecture (3 October). We recently hosted a fascinating morning tea with Di Johnstone AM, and still to come this year, the 2018 Student Awards (22 November).

Our sub-committee working on promoting more nominations for women has been working quietly in the background, engaging organisations across the ACT. It's also sometimes been working not so quietly – in this edition of *The Order* you'll nd a report of a terri c interview given by sub-committee Chair, Narelle Hargreaves OAM, to Canberra's *City News*. Narelle pulled no punches in telling it like it is – put simply, we need to nominate more women for honours and awards in the Order of Australia. We hope you'll be inspired by what Narelle said to nominate a woman yourself and to encourage colleagues, family and friends to do the same.

On 26 July, the Branch Committee hosted National Chairman, Barry Nunn AO, for dinner at the Ottoman Restaurant in Barton. We were delighted that National President, Philip Flood AO, was also able to attend. The evening afforded a wonderful opportunity for our Branch Committee to engage with our national leaders to hear their views, and to put an ACT perspective to them.

OAA-ANU LECTURE

On 3 October 2018, members and guests were privileged to hear Professor Ann McGrath AM, Director of the Australian Centre for Indigenous History, deliver the 2018 Order of Australia Association – Australian National University Lecture, entitled Time Immemorial: dates, history and the deep human past. The lecture sketched an outline of the work Professor McGrath is leading as part of the Kathleen Fitzpatrick Australian Laureate Fellowship.

Professor McGrath began by explaining that the methods employed by traditional western historians – literature, anthropology, linguistics and so on – stand in contrast to indigenous ways of recording history, which include stories around the camp re, dance, song and rock art. Western accounts, she said, reduce history to dates, whereas she feels it is important to humanise the story.

She went on to say that there is a particular problem in Australia, where there has long been a sense that prior to 1770 the continent was 'historyless'. British settlers conceived Australia as a new world, free of the problems of the old (European) world, and indigenous history was ignored.

A further issue is differing understandings of time. For western historians, history only becomes history when it is framed by dates and periods. In contrast, Australian aboriginals have a sense of 'everywhen' – the idea that there is a deep past that is also present and future, in which spirits live on.

Professor McGrath then introduced the term 'time immemorial', which is an expression found in western law, poetry, identity and history. In law, it connotes the idea that something has been enjoyed for so long that the owner no longer needs to prove that they own it. This principle has been adapted by indigenous peoples for strategic purposes. In the United States, the Cherokee used it in two cases in 1831 and 1832 against the US Government to show that long occupation established ownership of their land. Indigenous Australians drew on the Cherokee argument in their land rights cases in the 1970s.

Professor McGrath said that her project will analyse Australia's indigenous narratives alongside relevant new scienti c evidence in order to create a big picture history of Australia. Through critiquing the evolution of traditional western disciplines, especially the world history/pre-history divide, the project will develop future-oriented transdisciplinary techniques for researching the deep human past. She said that this work will transform the scale and scope of history, and that fresh 'periodisations' and understandings will reorient this history in its wider global context.

Professor Ann McGrath was awarded the Medal of the Order of Australia in 2007 for service to education, particularly in the elds of indigenous history, as a teacher, researcher and author, and through leadership roles with a range of history-related organisations. She was appointed a Member in the Order in 2017 for signi cant service to the social sciences as an academic and researcher in the eld of indigenous history, and to tertiary education.

The OAA-ANU Lecture was established in 2010 with the aim of further recognising the contribution made by academic members of the Order of Australia to the fabric of Australian society.

The ACT Branch of the Association is grateful to the Vice Chancellor of the University, Professor Brian Schmidt AC, for his continuing support in this important community outreach endeavour.

NATIONAL SECRETARY REPORT CTD A REVIEW OF CURRENT ACTIVITY – OCTOBER 2018

A very substantial number of items have over recent weeks reach the point of decision. The timing of this edition allows an unusual opportunity for a summary of these issues.

INCREASED BRANCH ADMINISTRATIVE GRANTS

Having considered the nancial outcomes for 2018 so far and the forecast for 2019 the Board agreed to calculate the BAG for the 2^{nd} 2018 and for each of the two tranches for 2019 based on:

\$1000 per Branch plus

\$2.00 per member

UK/Europe Group to receiv at BAG of \$750.

The purpose of the BAG as the name suggests is to assist Branches with their necessary administrative costs and to provide some funds to progress activities associated with the Association's goals of increasing awareness and nominations.

The Board has funded additional 'one-off' requests for assistance in relation to speci c administrative circumstances and projects, which are considered on a case by case basis.

Constitution, By-Laws and Model Rules Having received an assurance, supported by legal opinion that the current Governance documents are compliant with all necessary Regulatory requirements, the Board decided not to embark on a 're-write' of these documents at this time. Rather the Constitution Working group has been tasked to report on two questions:

Question 1. What within our current Constitution, By-Laws and Model Rules inhibits the governance and management of the Association?

Question 2. What fundamental principles should be included in a future suite of governing documents?

A report on Question 1 by the April 2019 Board meeting has been requested.

INSURANCE RENEWAL – POLICY RAMIFICATIONS

The Association maintains a comprehensive insurance policy that encompasses in part, Public Liability, Volunteer and Director Insurance. Renewal in November this year involved the imposition of two caveats (common now to this sort of policy) that require to have established:

A Workplace Harassment and Discrimination Policy.

A Volunteer Register and Associated Policy.

These issues are being staffed as a matter of priority. Please note these are mandatory conditions on the insurance coverage.

The Board seeks the cooperation of all Association members in complying with the appropriate outcomes and procedures, when they are developed and promulgated.

MEMBERSHIP ADMINISTRATION

The Board approved several proposals relating to the National Membership database, explanatory brochures, National and Branch newsletters and other communication options.

NOTIFICATION OF SPECIAL RESOLUTIONS

The Constitution of The Order of Australia Association Ltd requires that any business at the Annual General Meeting other than Financial Accounts & Reports be addressed through 'Special Resolutions'.

Such Special Resolutions are, in accordance with the By-Laws, to be approved by the Board no later than 35 days before the Annual General Meeting.

To accord with the requirements of the Of cial Notice of the Annual General Meeting and the intended Board meeting schedule, any Special Resolutions are to be lodged with the National Secretary no later than 10 January 2019.

INTRODUCTION:

OUR ORGANISATION:

The tour has been arranged under the leadership of Dr John Basarin OAM and Mrs Hatice Basarin OAM for the Turkey leg, and Mr Gary Snowden OAM for the Western Front campaign.

TOUR STATUS as at October 3:

This report is written by Tom Harding OAM (Barwon Regional Group member) only after Day 6 of the overall period of 20 days, during which we have covered Istanbul sights and the Gallipoli battle elds and related historic sights

TOUR IMPRESSIONS TO DATE:

There has been instant camaraderie developed amongst the current group of 35 members, re ecting their common interests in gaining on-site exposure to the terrain, timelines and objectives our service personnel encountered.

We have necessarily learnt of the impact of Turkish political history, which contributed signi cantly to the Battle circumstances at Gallipoli.

Also, we have learnt that Gallipoli was only one part of the German/Turkish endeavour to maintain sovereignty over the very large peninsula that commands the Dardanelles Straits - a large European/Asian shipping trade route.

Turkish/German forces were well established in heavily defended positions at strategic points on the Peninsula to protect Turkey's sovereign interests.

ROY WARD LEADERSHIP PRIZE SHOWCASING YOUNG ACHIEVERS

The Roy Ward Leadership Prize is granted to a Student in years 11 or 12 attending a secondary school within the boundaries of the City of Frankston and the Mornington Peninsula Shire who has shown qualities of leadership, character and community service, which exempli es Australian citizenship over an extended time period.

It has been recognised by secondary schools and students, since its inception in 2000, as prestigious, with the process providing an insight for the tertiary interview process and community involvement.

Twenty-one secondary schools within the zone were invited to forward submissions. These were evaluated by a selection panel with six submissions short listed to interview to determine the winner.

The winner of the **2018 Roy Ward Leadership Prize** is Amy Youngman from Woodleigh School, a year 12 student involved in all aspects of school life. She has tutored children of Sudanese refugee families, a program established by Woodleigh School and operated through the Brotherhood of St Laurence in Frankston.

In years 10 and 11 she was selected by her school to work with Ampilawartja and Miwati indigenous communities. At the end of year 11 she was selected to go to Cambodia to teach English at Chumkriel Language School.

2018 saw the introduction of **The Roy Ward Leadership Prize for Courage and Fortitude.** The Award recognises a secondary student who has demonstrated, outstanding qualities of leadership, character and community service, which exempli es Australian citizenship, whilst facing signi cant challenges in their own lives.

This year's winner is Will Hipkin, who has been a student at Mornington Secondary College for 4 ½ Years.

In February 2017 he was diagnosed with Leber's hereditary optic neuropathy (LHON) and is now identi ed as being legally blind. As Will was continuing to study he spoke to a Staff meeting in term 1 of 2017 explaining his condition, so that staff would be aware of the severity of his LHON.

Will is currently in a Year 11 Sport and Recreation VCAL class. When he completes his studies he is intending to establish a tness gym for visually impaired and disabled members of the community. He is an inspiration to all areas of the community having developed the capacity to manage his condition and adapt to everyday life at school. He has remained optimistic and positive, deciding to undertake additional



VCE units in addition to his VCAL studies. He was appointed as a Year 11 Captain in 2018, and has organised and presented assemblies alongside two fellow students.

He is highly regarded by staff and students due to his thoughtful and considerate nature and the resourcefulness and resilience that he has demonstrated in coming to terms with his diminishing eyesight. Will has also devoted his time to assist Mark, a wheel chair athlete, to access and use the Orbit Gym tness suite (Nepean Highway).

WILLIAM (BILL) COREY OAM

William (Bill) Corey was born in Riverton on 7th August 1917 and grew up in the mid north town of Tarlee in South Australia. Both his parents came from SA pioneer families. His mother's family came out from Scotland in 1837 and his father's family in 1838 from Cornwall. His father was born at Robertstown in 1882 and ran a butcher shop.

In June 1940 Bill joined the 2/43rd Infantry Battalion. After six months training at Woodside in the Adelaide Hills he left for overseas service. During the next ve years he served in different locations including: Tobruk (Libya), El Alamein (Egypt), Lae and Finchafen (Papua New Guinea), Labuan Island and on the mainland to Beaufort (Borneo). He returned to Australia in November 1945.

His personal accounts of his war service can be found on the 'RSL Virtual War Memorial' web pages.

As one of the few surviving 'Rats of Tobruk' Bill, who turned 101 in August this year, uses his life experiences to talk to young people in schools and through a program called 'The Ice Factor' a program set up by magistrate Marie Shaw QC. She was concerned at the number of teenagers coming through her court. The program targets at risk, disengaged and disadvantaged teenagers identi-

ed by high schools. It uses the sport of ice hockey and provides these students with a focus through which they can develop vocational and life skills in a team. Bill does not talk much about the war but rather about how they lived during the war, in the desert and in the jungle. How they were all different, but how they all got on together, the importance of his mates and everyone helping each other. He tries to give advice such as "life has its ups and downs and if you are not prepared to do a good turn for others then don't expect to get anything back".

When he returned from the war he was lost as it was all so different and you were expected to go back to normal life. However when he met his wife Iris she changed his life. "It was the best thing that ever happened to me". Bill went on to set up and run a successful business, had two children and now has ve grandchildren, four great grandchildren and two more on the way.

On 9th June 2014 Bill was awarded the Medal of the Order of Australia. For service to veterans and their families, and to the community.

His secret. "Positivity and a smile is my secret to longevity, everyone wants to know a smiling person. I can't say no! Also, you have to learn to accept help. I used to say I'm OK I don't need help, now I realize that when someone is helping you, you are helping them to feel good". "I was a scout – we were taught to do a good turn every day so if you can't do a good turn then at least smile!" Bill pulled out this poem from his wallet; he carries it around with him all the time.

SMILE

The thing that goes the farthest towards making life worthwhile

that costs the least and does the most, is just a pleasant smile.

The smile that bubbles from a heart that loves its fellow men,

will drive away the clouds of gloom and coax the sun again.

Its full of worth and goodness too with genial kindness blent.

it's worth a million dollars and doesn't cost a cent.

Sadly Bill passed away on the 10th October and our condolences are expressed to his family. It was a privilege and an honour to interview Bill Cory at his home earlier this year for this article, he was a humble and inspiring man. Jan Forrest OAM.

NOEL HENDER OAM, CSTJ, BEM



Noel joined the South Australian Branch Committee last year and is now the co-ordinator for the Student Citizenship Award Program.

Volunteering for St. John has been part of Noel Hender's life for the last 60 years. Even as the busy principal of an Adelaide secondary school for 10 years, and with a professional teaching and administrative role extending over 45 years, Noel put much of his personal time into serving St. John Ambulance Australia (SA). Joining in 1957 as a cadet, Noel worked voluntarily and trained over the years to achieve and perform the clinical role of ambulance transport of cer for about 35 years during the period when St. John was responsible for the ambulance service in South Australia. In 1968 he was awarded the British Empire Medal for Gallantry, along with two Metropolitan Fire Service of cers, for rescuing another reman who had been trapped in the basement of the burning News building in the early hours of a Saturday morning in October.

Since 1993 when St. John withdrew from the ambulance service, Noel has continued as an advanced rst aider and advanced responder, attending community and commercial events and providing emergency rst aid support when required at local and interstate bush res, oods and major incidents.

Within St. John, Noel was able to use his knowledge and expertise from education

to support much of the earlier training curriculum and leadership development which is now provided largely by salaried of cers. He has been a volunteer accredited instructor for many years, a divisional superintendent with both adults and cadets, a state training of cer, has had responsibility for emergency preparedness, has been a state duty of cer, a member of the St. John Board of Directors and rose through the ranks to the position of Commissioner, the most senior volunteer position. Although of cially retired, he is still connected with St. John as a Commander in the Venerable Order of St. John and is currently leading a formal review of the Cadet and Youth Engagement Program for St. John SA.

As a school principal and later as an educational administrator, Noel also provided voluntary service to the University of Adelaide for 12 years as a workshop facilitator and member of a steering committee, providing enterprise education and business links to secondary students in the western and northern districts of Adelaide.

Noel was awarded an OAM for service to the community of South Australia in June 2017.







CHAIRMAN'S REPORT

Twenty two Queen's Birthday Honours recipients attended the investiture at Government House in September. The Tasmanian Government House was built in 1857 from sandstone quarried on site, local timbers and roof slate from Wales UK. The magni -

cent ballroom with its chandeliers, high gallery at the rear from which the trumpeters play the fanfare and National Anthem and timber arch beams that support the roof adds atmosphere to the formality of the investiture ceremony. With excellent acoustics, the ballroom has been used by the Tasmanian Symphony Orchestra to record various musical items.

Following the Investiture the Branch hosted a dinner at the University Club's Pickled Pear where members were able to celebrate the recognition of awardees, eight of whom attended with their family and friends. With an attendance of 106 members and guests it was another successful and enjoyable evening.

The Tasmanian Branch nancial membership remains virtually static with18 new members joining from this year's honours lists that had 18 Australia Day and 22 Queen's Birthday recipients; in total a 55% membership take-up. The gender imbalance has lessened with 16 (40%) of the 40 awardees being women and in fact included 50% of the Queen's Birthday awardees.

Members are invited to not only attend the forthcoming 2019 National Conference from 11 to 14 April 2019 but are urged to extend their stay and take time to explore some of Tasmania's wineries, galleries, museums and tourist destinations. DR PATRICIA CAMERON AO

Patricia (Patsy) Cameron was born in 1947. She grew up on Flinders Island that is situated in eastern Bass Strait. Patsy proudly traces her Tasmanian Aboriginal heritage through her mother's line to Tebrakunna Country in the far northeast of Tasmania. Her Italian heritage is connected to her father's birthplace on Ponza - an island in the Mediterranean Sea.

Patsy left Flinders Island Area School at the age of 15 after gaining her Secondary Schools Board Certi cate. In 1964 she began her working life in a small island grocery store and, after moving to Launceston, was employed as a supermarket checkout operator, and later as a clerk for a local medical bene ts association. Patsy has been married to Graham for 51 years; they have four children and nine grandchildren.

For over forty years Patsy has been a passionate champion for Aboriginal education and the promotion of cultural heritage and traditional practice. She was an inaugural member of the Flinders Island Aboriginal Community Association and the National Aboriginal Education Committee, a Tasmanian member on the National Museum of Australia Aboriginal Advisory Committee, a member of the Tasmanian World Heritage Area Advisory Committee, founder of the Tasmanian Aboriginal Education Advisory Committee, and founding director of Melythina Tiakana Warrana Aboriginal Corporation. She is currently co-chair of the Queen Victoria Museum and Art Gallery Aboriginal Reference Group, co-chair of the Tasmanian Regional Aboriginal Communities Alliance, a member of the Tasmanian Aboriginal Education Reference Group and a community member on the Peter Underwood Centre Advisory Committee. Patsy recently joined the Tasmanian Reconciliation Council. Her commitment to reconciliation underpins her engagement with the wider Tasmanian community.

The rst family member to attend university, she has a Bachelor of Arts with major studies in Archaeology and Geography (1991) and a Master of Arts in Aboriginal History (2008). Her MA thesis *Grease and Ochre: The blending of two cultures at the colonial sea frontier* was published by Fuller's in 2011. In 2016 Patsy received an honorary Doctor of Letters from the University of Tasmania.



She was inducted into the Tasmanian Women's Honour Roll in 2006 for service to education and training, and to Aboriginal Affairs. In June 2017 Patsy was awarded an Of cer of the Order of Australia for distinguished service to the Indigenous community of Tasmania through the promotion of educational participation and achievement, and to the preservation of culture, custodianship and traditional knowledge. Patsy considers her AO as the pinnacle of her life's work, and, while acknowledging her humble island origins, is extremely proud to be considered worthy of this recognition by her country.

PROFILE – CHLORIS (CHLO) MARTIN OAM

Chlo Martin was awarded an OAM on the 25th January, 2011 for services to the community of George Town Tasmania, through Historical, Business and Service organisations.

She was born in Brisbane and educated in Queensland. She married in 1959 and moved to Tasmania with her husband Peter. Sadly, Peter passed away 45 years ago.

At that time, much of George Town's early architecture had been lost in the post war years. In 1969 she and her late husband restored the 1835 two story very dilapidated George Town house "The Grove", developing it into a prime tourist attraction – the rst in the George Town area.

Chlo Martin was the inaugural President of the National Trust of Australia George Town group and was a member, past President and Public Of cer of the George Town Chamber of Commerce since 1970. She was a member of the George Town Tourist Committee and its President during the 1980's. She was involved in the welcome committee for the rst fast cat Tasmania to Victoria service when it berthed in George Town in the early 1990's.

Chlo has also been a member of the George Town Police and Citizens liaison group since 1980 and is still a member and current Treasurer of the George Town and District Historical Society. She has been a member of the George Town Rotary Club since 1996 and is a past President. Chlo was actively involved in organising festivities as part of the George Town Bicentennial organising committee in 2004.

Chlo Martin has given a great service to the George Town Community over many years and has been a leader and inspiration in the all-important tourist development area. We are proud to have her as a member of the Northern Tasmanian region Order of Australia Association.

DR PATRICK CORRIGAN AM

Patrick Corrigan has long held a special position in Australia's art community as an avid collector, generous philanthropist and tireless promoter of Australian indigenous and contemporary art and photography.

His collection has underpinned countless exhibitions and he has donated or loaned an enormous number of works to art institutions, universities and organisations around the country. He was made a member of the Order of Australia in 2000 for his dedication as a patron to the arts.

But Corrigan has two other great preoccupations in his life; sport, speci cally sailing and rugby union and jazz! The Australian jazz scene has long bene tted from his support, from hiring bands for big events such as the opening of the National Portrait Gallery (where he is now a Director of the board), sponsoring travelling scholarships for young jazz musicians, and underwriting regular concerts at the Art Gallery of NSW for 20 years.

He has been a compulsive collector since childhood, when he was into toy soldiers. A recent Braithwaite Archibald portrait has a Chinese lacquer-red wall behind him, referring to his beginnings in China, where he was born in 1932 to English parents and raised in comfort until the age of nine.

But then came the war. Attempting to ee, he and his mother were caught in the Repulse Bay Hotel siege in Hong Kong and ended up in a prisoner-of-war camp for four years before being liberated by Australian Navy frigates.

He was introduced to the world of art collecting through his friend Ron Hodgson, who sold second-hand cars in Parramatta when not frequenting art galleries and auctions and at one point set the record price paid for an Australian painting. Corrigan was with him at that auction. "That's where the adrenalin started pumping'.

Like many art collectors, he cannot explain exactly why he buys what he buys, he just responds to it and wants to own it. And then share it. When asked what being part of the Australian art community has given him over the years, apart from fun, he hands over a stack of photos of the medical school that opened at Bond university on the Gold Coast in 2005.

He was at a charity dinner seated next to the new school's deputy head when she said she had a lot of blank walls, "you wouldn't have a spare picture?' she joked. He installed 300 of his indigenous artworks.

He may not be able to paint a stroke or play a note ("too lazy") but it is clear why for so long, Pat Corrigan has been the life of Sydney's arty party!

For life, work, music and sport the ethos is it's got to be fun!

P.S. Who is this handsome Navy Of cer of some 15 years' service? Surely not!

The meeting on 11th April 2000 agreed that funds should be made available for the purchase of image portfolios and Mrs Helen Christian AM accepted the role of archivist, initially as a co-opted Branch member and then as a Committee member.

Helen approached Mr Alan Tasker of the Mitchell (State) Library regarding the conservation of photographs and Mr Ross Warr of Identity Studios for early Investitures and Functions photographs. Image Portfolios were purchased from Zetta Florence Pty Ltd in December 2001 and

ORDER FOR MORE EXTRAORDINARY WOMEN

ORDER of Australia recipient Frances Rose couldn't understand why there was so many extraordinary women in the community, yet the number of men being recognised still far outweighed the women.

So, Frances, with her friends Dr Bill Maiden and Narelle Hargreaves formed a subcommittee of the ACT branch of the Order of Australia Association and together have been encouraging the Canberra community to nominate its community-focused women.

They've written to the heads of organisations, they have been to see the Of ce for Women, and now, they want to get the word out to the community.

"There's some absolutely fantastic women who are working so hard and they should be recognised," says Narelle, 76, of Latham.

It's no secret that men recipients outweigh the women every year, and Narelle says even the governor-general has outwardly said he'd like to see more women nominated.

"I'm not really into quotas because I like to think people got the award on their ability and capability," she says.

"But then again I'm into af rmative action for women, so I want to see really outstanding women nominated, because there's many of them."

Narelle and the committee still want to see men continue to be nominated because, she says, there's some fantastic fellows doing some great stuff, but she wants people to be more aware of the women doing similar amazing things, too.

"I'd like to see younger women and men getting awards as well," she says.

"It's sad that a lot of amazing women [and men] have to wait until they're older to be recognised."

Narelle, who received the Medal of the Order of Australia in 2008, says the award is a real honour and privilege.

"It's provided me with opportunities to speak at different groups," she says.

She even believes it opened many opportunities for her and led her to other achievements such as being named the Canberra Citizen of the Year in 2016 for her commitment to vulnerable children and young people in the ACT through various roles.

"People have this misconception that you have to write all this stuff," she says.

For example, if people don't know four referees connected to the person they're nominating, they can write down organisation or business names and Government House will ferret out the missing information.

"It's not hard, it just takes a little bit of time and a little bit of thought and away you go," she says.

The August edition of the The Order which I read with interest contained two Letters to the Editor under the heading 'Multicultural Australia' and contained some statistics, including a search of 'QB 2018' for 'Non-Anglo' surnames.

May I add to the debate:

As an Australian born in Germany I have noticed that the awards do not seem to re ect our multicultural country. Yet, surnames are not necessarily an indication of background nor is service to ones own ethnic community the only way non Anglo migrants can contribute. My award was for distinguished service to higher education in Australia (with much involvement internationally) and to community and church organisations. My German-born friend, Dr Ortrun Zuber-Skerritt was awarded her AO in the 2018 Queen's Birthday list, and she, too, did not receive it for her work to the German community but for her work in action research and learning Australia wide and internationally. It is one of the wonderful features of Australia that migrants from non-English speaking background have the professional opportunities commensurate to their skills and quali cations, and, in our cases, gaining recognition for services to our adopted country.

I will be nominating two women this year for an award who have been contributing to multicultural Australia for a very long time.

STUART DEVLIN A.O., C.M.G.

Designer, Goldsmith and Silversmith. Born Geelong, Australia, October 1931. Died at his home in England, April 2018 aged 86.

Holders of the Order of Australia may not know the story of the man who devised and designed Australia's Honours System. This was Stuart Devlin. He rst came to public recognition in 1966 when his winning designs for Australia's new decimal coinage were released. He went on to become one of the most important goldsmiths and silversmiths of the 20th century designing for Royal Households, governments, cathedrals, armed forces, sport and universities, as well as for numerous private collectors throughout the world. He also designed coins for at least 30 different countries. The Duke of Edinburgh's forward in a book published this year describes him as ... probably the most original and creative goldsmith and silversmith of his time, and

In 1975 Devlin was awarded the commission for the Order. He based it on the golden wattle which was to become Australia's official floral emblem. Initially and for some years thereafter, the badges were made in his workshops in London, where he had set up his goldsmithing and silversmithing business.

Stuart Devlin was born in Geelong in 1931, one of four brothers, to parents of modest means during the Great Depression. His father, Richard, was a master painter and decorator but work was intermittent. His mother was a housemaid before marrying. Real poverty was always a threat but family life was happy. However, tragedy struck in 1949 when Stuart's father and his older brother, Geoffrey, one of twins, were drowned at sea in a boating accident.

After a meteoric rise through the art education system, with the support of a scholarship to the Geelong Institute of Technology, Devlin was to become a teacher of art and a range of subjects involving creativity and craftsmanship. In his mid-twenties he lectured at Prahran Technical School while studying at the Royal Melbourne Technical College (now RMIT) completing a three year full-time course in one year, with the highest marks ever awarded.

In 1958 further scholarships led him to the Royal College of Art in London where Devlin studied both silversmithing and industrial design (engineering) completing both these three-year courses within two years. He was then awarded a prestigious Harkness Fellowship (also known as a Commonwealth Fund Fellowship) which lead him to study at Columbia University, New York.

It was on his return to complete his teaching contract with the State of Victoria, that Devlin was persuaded, in 1963 by Professor Joe Burke of Melbourne University, to enter the decimal coinage competition.

Stuart Devlin never lost touch with Australia, designing further coins, many Defence Force medals and the gold and silver collectors' coins for the Sydney 2000 Olympic Games as well as the Paralympic winners' medals.

HISTORIC WIRELESS MESSAGE CENTENARY CELEBRATED

At Lucania, a house in Wahroonga in the northern suburbs of Sydney was the venue on 22 September for a public celebration to mark the successful transmission exactly 100 years earlier of the rst direct public wireless message sent from the United Kingdom to Australia. The house was at the time home of wireless radio entrepreneur Ernest Fisk who had set up an experimental wireless station there.

Fisk, later knighted in 1937, was managing director of Amalgamated Wireless (Australasia) Ltd. He logged the historic message, transmitted in Morse code by Italian radio pioneer Guglielmo Marconi from his wireless station at Waunfawr, near Caernarvon in Wales on 22 September 1918.

The message, from Australian Prime Minister Billy Hughes, who was at the time visiting Europe and the UK, said:

I have just returned from a visit to the battleelds where the glorious valour and dash of the Australian troops saved Amiens and forced back the legions of the enemy, lled with greater admiration than ever for these glorious men, and more convinced than ever that it is

the duty of their fellow-citizens to keep these magni cent battalions up to their full strength. W. M. Hughes – Prime Minister

The celebration was organised by the Ku-ring-gai Historical Society supported by representatives of Federal, State and Local Governments and local community groups. The Hon Paul Fletcher MP, federal member for Berowra, acted as master of ceremonies.

In December 1935, a monument marking the event was erected outside the Wahroonga house and unveiled by Billy Hughes. The proceedings included an address by Marconi, speaking from Paris by wireless telephone.
