STUDENT CITIZENSHIP AWARDS

In light of the current circumstances, the closing date for nominations for the 2020 Student Citizenship Awards has been extended to the last day of Term 3 in South Australia, 25 September 2020.

All SA schools have been advised of the change, and our website has also been updated to reflect the new guidance:

The good news though is that this page has been regularly viewed, and the nomination form has been downloaded a number of times, consistent with this time in past years.

The nominees will be selected as worthy of recognition for their voluntary service and contribution to citizenship in South Australia. The panel will be looking for students who exemplify the Association's objective, *"to foster love of and pride in Australian citizenship"*.

After the closing date, the nominations will be considered by an adjudication panel – subject to the circumstances prevailing at that time, the committee may meet 'virtually', using telephone conferencing or online networking apps.

It is likely that the Government House ceremony for the Top 10 recipients from 2020, and the announcement of the 2020 Student Citizen of the Year, will be held early next year.

His Excellency the Governor is Patron of the SA Branch of the Association and his ongoing support for the Association, and our Student Citizenship Awards, is greatly appreciated.

ANZAC DAY DURING SOCIAL DISTANCING Saturday 25 April 2020

At this time, it is important to reflect on the service, achievements and sacrifice of our forebears.

Anzac Day does not require a big crowd to have an impact, nor does it require an elaborate cenotaph or memorial arch. All it needs from each of us is a personal act of reverent reflection – which might be based around a candle, a photograph or a poppy.

While many traditional Anzac Day activities have been cancelled, or substantially reduced in scope, there are still ways for us to pay our respects.

One way is to use a social media platform to pay respect, either to a particular family member or a notable Australian perhaps from your local district. This could be through sharing a photo of them, a photo of a memorial where they are honoured, a poppy tribute, or some other personal message of reflection. Some suitable platforms could be:

THE ORDER OF AUSTRALIA

Did you know...?

The full-size insignia of the Order of Australia in the grades of Knight (AK), Companion (AC) and Officer (AO) are worn as a neck decoration.

A Dame of the Order (AD) may also wear the insignia as a neck decoration or, if preferred, on the left shoulder suspended from the ribbon of the Order 38 mm in width tied in a bow.

The insignia of Knight, Companion and Officer is presented with a full-size neck ribbon in Royal blue silk moiré, 38 mm in width, with fastening clasps at either end. This ribbon is only ever used for the purposes of the investiture – and should not be used again after that time.



This is the presentation ribbon of a Companion of the Order of Australia (AC) in the General Division – a full-size neck ribbon, 38 mm in width, with fastening clasps. This ribbon is only ever used for the investiture ceremony.

Within the presentation case will be a length of ribbon of the Order 16 mm in width, with fastening clasps at either end.

This ribbon should be used to wear the neck badge insignia on all future occasions.

Female recipients of the AC or AO not in uniform may, if they prefer, wear the insignia on the left shoulder suspended from the ribbon of the Order 38 mm in width tied in a bow.

Further information on wearing the insignia may be found in the booklet *Order of Australia* published by the Office of the Official Secretary to the Governor-General, Canberra.

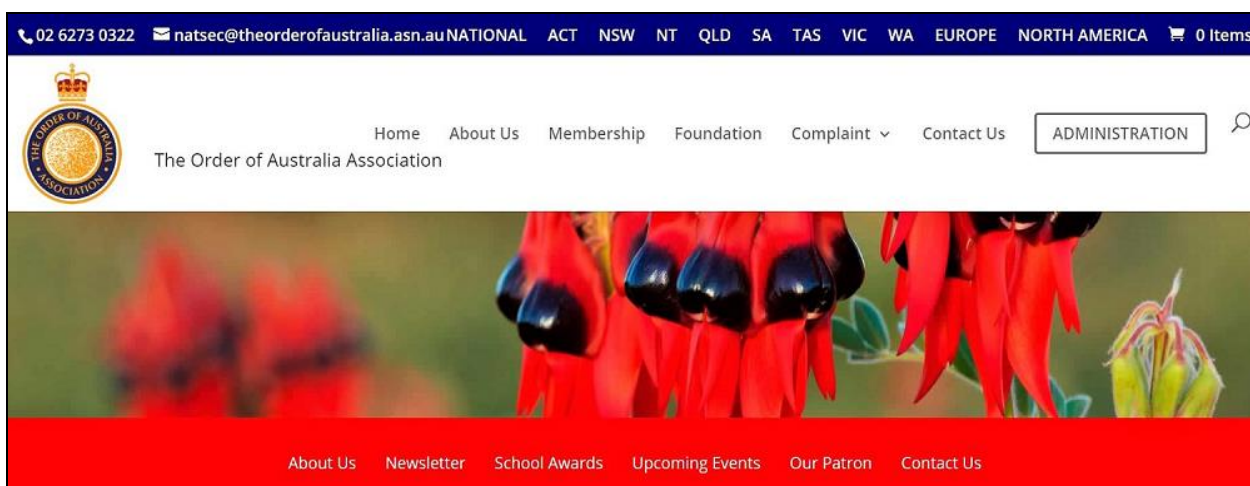
A copy of the most recent booklet is included with the presentation folder and Warrant at the time of the investiture.



This is the full-size neck badge insignia of a Knight of the Order of Australia (AK) worn by the Right Honourable Sir Zelman Cowen AK GCMG GCVO QC DCL (1919–2011), a former Governor-General of the Commonwealth of Australia, who was appointed on 8 December 1977.

The insignia is worn using a neck ribbon in Royal blue silk moiré, 16 mm in width.

Message from His Excellency the Honourable Hieu Van Le AC, Governor of South Australia

The COVID-19 pandemic is proving to be one of the greatest challenges of our generation.

We are facing a health emergency that poses a significant threat to our physical wellbeing and that of our families and our loved ones.

The widespread ramifications of this emergency, and the steps that must be taken to combat it, mean that our way of life is changing.

As a result, many people are also suffering socially and economically.

In these unprecedented times, it is understandable that people are feeling anxious, distressed and vulnerable.

There is much uncertainty in the face of this crisis, but there are also things that are certain.

First, we are not alone.

Every one of us is potentially affected by this pandemic – no one is exempt.

At the same time, as we are physically distancing ourselves from one another, we need to remain connected in spirit.

More than ever, it is important to extend kindness to one another, to look out and care for each other, and to ensure that our actions and words reflect the society that we are – a society that is harmonious, resilient, respectful, and decent; a society that believes in the common good.

History judges a society not only on the outcome of a crisis; it will also look to how society grappled with that crisis.
