ANZAC DAY DURING SOCIAL DISTANCING Saturday 25 April 2020

It is important to reflect on the achievements, service and sacrifice of our forebears. Unfortunately with the unique social distancing requirements that have been imposed upon us this year, Anzac Day activities throughout the state were cancelled.

This was the first time the Adelaide Anzac March has been cancelled since 1971, when it was called off at very short notice due to a terrible storm.

A week prior to Anzac Day, the RSL (SA) Anzac Day Committee advised that the Adelaide Dawn Service would go ahead but only with key invited guests. Representatives of ex-service organisations were not able to attend. Even Service chiefs did not attend: the flag orderly (RAN), commander of the catafalque party (Army) and padre (RAAF) placed tributes on behalf of the three Services.

Our members will be pleased to know however, that His Excellency the Governor, as Patron of the OAA SA Branch, placed his tribute on our behalf as well as on his own behalf.

Many people marked Anzac Day at home through some form of reverent reflection. Many used a social media platform to pay their respects, either to a particular family member or a notable Australian from their local district.

People shared photos of an ancestor or their war medals. Others shared images of war memorials, left a poppy tribute, or gave some other message of reflection.

A PERSONAL REFLECTION

Alana, aged 14, reflected on why commemorating Anzac Day is important, drawing the connection from 1915 to events six decades later:

"To me, Anzac Day is Australia's most important national occasion. It marks the anniversary of the first campaign that led to major casualties for Australian and New Zealand forces during World War One and commemorates all the conflicts that followed".

"My grandparents and great-grandparents took part in the Vietnam War between 1955 and 1975, to then coming over here to start a new life in Australia".

"Anzac Day for me and my family is a time to honour and pay respects to all who served and died in all wars across the Nation".

Jan Forrest OAM is an Honorary Associate at the South Australian Museum, author of two books, and an inaugural member of Butterfly Conservation SA Inc.

JAN FORREST OAM Thursday 30 April 2020

The first 'virtual meeting' of the Fellowship Group was held online on 30 April. The inaugural speaker was Jan Forrest OAM, who spoke via Zoom on her topic, "Attracting Butterflies to your garden".

Jan gained her OAM in the 1991 Queen's Birthday Honours for service to young people through the Girl Guide Association, Duke of Edinburgh Award Scheme and Youth Hostels Association. Jan is the Newsletter Editor and Public Talks convener for Butterfly Conservation SA Inc. She is an Honorary Associate at the South Australian Museum, and is co-author of two books:

"Attracting butterflies to your garden, what to grow and conserve in the Adelaide region" (reprinted in 2016), and

"Caterpillars moths and their plants of southern Australia" (printed in September 2019)

From 2014 to 2018, Jan was a committee member of the South Australian Branch of the Order of Australia Association, serving as Membership Secretary for most of that time.

Using Zoom for the first time was a learning curve for both speakers and members. Nevertheless, this trial proved to be quite successful – Jan was joined by a total of 21 online participants.

Feedback received told us that it was a great success, very interesting and enjoyable. Members stayed to the end, and it was great to see members engaging. It truly was an opportunity to see members informally communicating and sharing knowledge and inquiry.

HOW TO PARTICIPATE

These are short guidelines on how to be connected to our Fellowship sessions by Zoom (please refer to the attached guidelines for additional detail).

You will need an electronic device: a computer, laptop, smart phone or tablet.

Provide your email address to Flavia De Pasquale, who will provide the list of contacts to the guest speaker, who is the host of the Zoom meeting.

The host will email you a link to connect to the Zoom session. You can use that link to automatically access and download the Zoom app. The app is also available for manual download here:

Conferencing will start promptly at 1 pm, but you should plan to be in front of your screen by 12.45.

On the day and time the presentation is scheduled, click on the link. Make sure your sound is turned on.

You will see the faces of your host and others as they join up together on the screen.

The host (guest speaker) will talk first to introduce themselves. Be careful not to talk over each other.

Bryce Saint OAM will give the official welcome. Then Professor John McKellar AM ED will introduce the speaker. The speaker will talk for about 20 minutes.

Members can then talk, one at a time, in a Q&A session for ten minutes.

The session should finish at about 1.45 pm. Bryce Saint OAM will thank the speaker, conclude the session and announce that you can disconnect.

RIVERLAND REGIONAL GROUP FORMATION

On 15 March, eighteen people gathered in the Renmark Club Function Room with the purpose of discussing the value of forming a Riverland Regional Group. Many of those present were members of the Order of Australia Association.

Among those who attended were the SA Branch Chairman Tony Metcalf OAM and his wife Cheryl, and Regional Groups Coordinator Ken Coventry OAM JP and his wife Di.

Tim Grieger OAM JP acted as Convenor, and was supported by the Regional Groups Coordinator.

Ken emphasised that it was up to those present to decide on whether they wanted to form a Riverland Group. He outlined the two options if a group was to be formed. There was a robust general discussion, with sharing of thoughts and ideas.

It was agreed by the gathering that a Riverland Regional Group would be formed on an informal basis, meeting twice a year.

The Riverland Group area includes the Mallee areas of Lameroo, Pinnaroo and Karoonda and down river to Swan Reach.

It was proposed to meet in March/April and September/October. These gatherings will include representatives from the SA Branch committee to provide information on both Branch and National activities.

The format will include a guest speaker, who may be a member of the group or an external person with a topic of interest to the group.

It is believed that occasional informal gatherings of award recipients and partners in such a way would provide a good opportunity for social connectivity.

It was agreed that Tim Grieger OAM JP would be the group Convenor – the group's primary contact and liaison person. His contact details are given in the Regional Groups section of this newsletter.

Other members including David Ward and John Rix will assist with coordinating the group meetings.

The gathering concluded with afternoon tea and social interaction.

The Riverland Regional Group will hold its first meeting on Sunday 27 September 2020.

THE ORDER OF AUSTRALIA Did you know...?

Not only does the Military Division of the Order of Australia have a distinctive ribbon, but members of the Australian Defence Force have a unique method for wearing the ribbon.

When the Order of Australia was established in 1975, it was created with a Civil Division and a Military Division. The former was retitled 'General Division' under Letters Patent dated 24 May 1976.

The riband of the Order of Australia is defined as moire Royal blue silk, 38 mm in width, with a central band 12 mm wide of scattered golden mimosa blossoms of various sizes. Each of these golden discs represents a single flower of mimosa ('Golden Wattle'), which is the emblem of the Order.

The ribbon of the Military Division is identical to that of the General Division with the addition of gold edge stripes, 1.5 mm in width.

Due to the irregularity of the mimosa blossoms, Defence dress regulations mandate that a particular portion of the ribbon is to be used when mounting it on a ribbon bar for wear in uniform.

In the early years of the Order's existence, military service ribbons were constructed using any portion of ribbon, in either manner of vertical orientation.

Once dress regulations specified a particular pattern to be displayed, cutting that specific pattern from a length of ribbon left considerable wastage.

To avoid such wastage, special ribbon was produced with the required pattern repeating with gaps and marker thread, to ensure that exactly the correct pattern was used to prepare the service ribbon bar.





These lengths of ribbon of the Military Division of the Order of Australia are designed for making military service ribbon bars, to ensure that exactly the correct pattern is used, in the correct vertical orientation. Displaying the specified pattern ensures uniformity in the appearance of military ribbon bars.

The ribbon on the left is 38 mm in width, to denote an appointment to the Order – in the grade of AK/AD, AC, AO or AM.

The ribbon on the right is 32 mm in width, to denote the award of the Medal of the Order of Australia (OAM).



The Order of Australia in the Military Division

This is a set of ribbons worn by a senior Royal Australian Navy officer in the mid-1980s, demonstrating the approved Defence format for wearing the 38 mm wide ribbon of the Order of Australia in the Military Division. He was a veteran of service off the Malay Peninsula during Confrontation and with the US 7th Fleet in the waters off South Vietnam. He was appointed an Officer of the Order of the British Empire (OBE) in the Military Division in 1970, and a Member of the Order of Australia (AM) in the Military Division in 1975.
