MESSAGE FROM THE PRESIDENT

Dear All,

When I penned my last message we were at the start of the year and our thoughts were dominated by the bushfires and the tragedies and hardships that were pervasive in their wake.

To this anxiety has now been added Covid-19 and the enormous disruption and cost it is imposing here and around the world. Unfortunately, it forced us to cancel our National Conference in Darwin. This was hard for many as so much effort had gone into its planning. However, we plan to regroup in Darwin next year and this will hopefully be an occasion for reflection and celebration.

It's interesting to observe that neither of these calamities is economic in nature but both have huge economic consequences, consequences which are placing pressure on Governments, businesses and households. It is also interesting that both go to the fundamental resilience of our nation: can we manage our natural environment better to meet the destructive impacts of bushfires, are our emergency services able to respond to sustained pressure; and in the case of the virus, is our national, state and regional health infrastructure able to control and defeat this disease, is our science able to contribute to the global effort to deliver an effective treatment and vaccine.

Yet, in my view, the most important parallel is that both, at their essence, rely on community action, on action by us acting together in our shared interest, if they were to be controlled and overcome.

In the case of the fires, volunteers and emergency service workers risking their lives to fight the fires, people caring for each other, many behaving with extraordinary generosity to support those in need, and others assisting with the recovery; and in relation to the virus, first line workers consistently putting themselves at risk to help others, and the community, despite a few recalcitrants, being willing to profoundly change their way of life to defeat the disease. So, two gut wrenching challenges and both times our communities have shown they're capable of rising to the challenge. Powerful stuff! It is clear that Covid-19 will continue to put enormous pressure on us for many months to come. However, we can take heart from the demonstrated strength and resilience of our community.

There has been a long historic debate about whether there is such a thing as a society and that we're all about individualism. The events of this year have well and truly put the strength of our society, and the idea that our fortunes are linked, to the fore. Our Association, which is all about community building, is well placed to contribute over the difficult months that lie ahead.

"Building a Security Community in the Indo-Pacific" A PRECIS OF AN ARTICLE IN THE NOVEMBER 2019 EDITION REPEATED HERE IN THE CONTEXT OF COVID-19 AND OUR PACIFIC FAMILY

Good evening ladies and gentlemen.

• • • •

Tonight, I want to take this opportunity to acknowledge the breadth of security challenges facing our region, and discuss how Australia, with a focus on the Southwest Pacific, is responding.

• • • •

A century ago, the world was at the tail-end of an influenza pandemic that was on the same terrible scale as the loss of life in the First World War.

Tens-of-millions died between April 1918 and May 1919: the strong, the healthy, the young. The 'Spanish flu' was relentless. It would leap from ship to shore, and from shore to ship. Island communities, especially those of the South Pacific, experienced

some of the most severe outbreaks. Local authorities were unable to cope. Health workers soon started falling ill, and drugs were in short supply.

Back in Sydney, in November 1918, HMAS *Encounter* was ordered to embark as soon as possible to Samoa. It was to be the Royal Australian Navy's first post-war overseas humanitarian and disaster relief operation. *Encounter* moved at remarkable speed. Within ten days, it had docked at Suva in Fiji with 150 tonnes of cargo. Hours later, it was on its way to Apia in Samoa.

It was during that trip to Samoa that the commanding officer, Captain Hugh Thring, asked for volunteers to go ashore if the need proved greater than anticipated. The work promised to be dangerous and unpleasant. It meant being left behind and missing the first peacetime Christmas. But almost everyone aboard put their hand up.

••••

Today, the Indo-Pacific is a stage upon which many of the uncertainties — and challenges — that define our age are playing out.

• • • •

Australia is stepping up our contribution to regional stability: that's one of our highest defence and security priorities. We recognise we must do more to preserve and strengthen the institutions that promote regional peace and security. We must double-down on our relationships with our friends and neighbours and deepen our engagement and partnerships.

• • • • •

But what should be stressed is the *manner* of the engagement. *That matters*. That matters just as much as the outcome. Australia sees itself as a *partner* in these efforts. Not an owner ...not a director ...not a superior. We have and we will continue to listen to the wants and the needs of our neighbours; to their aspirations

• • • • •

Being present. Working *with* our neighbours. Building *their* and *our* security resilience. Australia is playing its part. And we are, I emphasise, stepping up — *not starting up* – right across the Indo-Pacific region.

After reaching Samoa, HMAS *Encounter*'s mission was supposed to end. But Captain Thring had received a message during the ship's brief stop in Fiji. The conditions in Tonga, he was told, were at least as bad as in Samoa. The facilities were worse.

So Thring made a decision: he would extend the mission. Two days after visiting Samoa — where She dropped off personnel and supplies —*Encounter* reached Nuku'alofa in Tonga. Thring sent his last surgeon ashore, accompanied by five orderlies. They took with them the remaining drugs. It was a small contribution — but one that made a big difference to the Tongan community. Captain Thring made the right decision.

We have the understanding. We have the mindset. And we know what must be done.

Above all, it's the manner of our engagement, the trust we create, the patterns of cooperation we display. These are as important as, and essential to, the common outcome we seek to achieve: a stable and prosperous Indo-Pacific.

Our 2400 members all have amazing stories to tell, and we hope to stay in touch with as many as possible while we are all looking forward to life as it was, or a version of it, later in the year.

One such story is from Patricia Johnson OAM in Port Macquarie. Patricia received her Award in 2004, for her commitment to the local community while also teaching science, music and Japanese at the local High School. (see article)

We are also looking at ways to enhance Membership Value and will report on this later in the year.

We held our AGM on February 25, welcoming 45 Members and guests, and confirmed our Committee going forward. (see list)

The Hunter Region managed to hold a welcome lunch for Australia Day recipients in the region, on 22 February, before restrictions were in place. (see article)

On March 7 we welcomed >70 Members and guests at a very interesting Forum, with Guest Speaker Gemma Sisia, who shared stories about her work in Tanzania with the School of St Jude which she founded 18 years ago. Gemma comes from Armidale where her family, including her 7 brothers farmed >40,000 hectares, supporting around 80,000 sheep during the height of wool production; along with cattle, chickens, and horses. We have been implementing The Youth Community Service Awards for 27 years; in recent years capably managed by Committee Member Dr Frank Kelleher AM, however sadly following advice from the NSW Department of Education, the Awards program for NSW High School and Community College students will be put on hold until 2021.

"Until we meet again", as they say, I and our Committee wish everyone good health and wellbeing during this testing period for all on Planet Earth.

Mrs Patricia Johnson OAM

Mrs Patricia Johnson OAM, who received her Australian Honours Award in 2004, was recognized for her commitment to the local community of Port Macquarie while also teaching science, music, and Japanese at the local Primary School. Patricia was also a Teacher Librarian.

In 1988 Patricia, together with a number of very dedicated local musicians established The Hastings Koala Orchestra.

The Orchestra includes people from all age groups and was invited to play at the Sydney Entertainment Centre and participate in the Closing Ceremony of the Pan Pacific Games during the Bi-Centennial celebrations in 1988. The RTA (NSW Government) donated a train to take the orchestra and their instruments from Wauchope to Newcastle as 283 members of the Bi-Centennial Orchestra were from the Hastings Valley area. They took part in 1000 musicians playing together for a world record

As a result of a young Japanese student at the Port Macquarie High School talking about an Art and Cultural Festival in Hokkaido Japan, Patricia formed an orchestra which travelled to Hokkaido in 1989. They took part in the signing of the "Sister City' agreement between Port Macquarie and Handa City.

Since then, the Orchestra, with Patricia as its Musical Director and Conductor, has travelled to Japan more than 16 times, performing in Sapporo, Tokyo Disneyland, Handa City, Kyoto, Sakura and Mikasa. They also perform at local NSW venues including Dreamworld, Seaworld, Marina Mirage on the Gold Coast, Pacific Fair shopping Centre, Darling Harbour and Martin Plaza.

The orchestra was scheduled to be in Japan this year, but due to the current travel restrictions, this trip will be postponed into 2021. In April 2019 we toured Japan. It was 30 years since we had first performed there.

The Orchestra receives a small grant from the Hastings Council each year to cover its overheads, and raises money through local fundraising at eg Bunnings, and through Raffles, and doing car washes, and delivering phone books to support local charities including providing assistance for affordable housing for cancer patients undergoing treatment in local hospitals.

Patricia will be like many of us, practicing what some call "SOCDIS" Social Distancing, until travel is possible again. Two more concerts are in planning at The Panthers in Port Macquarie, to support Rotary Lodge.

We appreciate Patricia sharing her story, which is no doubt one of many which hopefully we will hear about from other NSW Order of Australia Association NSW Branch in the coming months.

Every one of our >2400 members has made a significant contribution to communities in NSW and other places, and we are keen to learn more about that huge investment in time and loving

NSW BRANCH FIRST NETWORKING FORUM

The first Order of Australia Association NSW Networking Forum for 2020, held on 7th March at Sydney Hospital, was a great success with over 70 members and guests attending.

Events manager, A/Prof John Gullotta AM, welcomed guests and introduced the guest speakers:

Gemma Sisia AM, in 1993 as a 22 year old newly qualified teacher from Armidale in regional NSW, travelled to Uganda to teach in an under-resourced girls' school. She grew up on a sheep and wool property, the only daughter among 8 children.

Gemma spoke about Fighting Poverty through Education - Making dreams reality !

On a safari trip to Tanzania Gemma could see an opportunity to really make a difference in the community of Arusha, and so she put her dream into reality. She worked with local community leaders and together they built a free public school which expanded to 3 schools with two boarding campuses, with close to 2,000 students, including 1400 boarders. They named it The School of St Jude, opening the gates on January 29, 2002. With the support of generous volunteers, donors and Rotarians, united by a shared goal, they have provided some of the brightest, poorest students in Tanzania with access to a free, high quality education.

The School of St Jude also now owns and maintains 25 buses which transport students and staff safely to and from school, provides 29,000 hot meals each week and employs over 290 people – more than 95% of whom are Tanzanian.

In 2007 Gemma's achievements were honoured by being made a Member of the Order of Australia (AM) "for service to the international community through the establishment and development of The School of St Jude in Arusha, Tanzania."

Her story has been featured twice in the ABC TV documentary program Australian Story, in 2005 with a follow-up in 2009.

In 2012 Gemma was named one of The Australian Financial Review and Westpac's 100 Women of Influence, nominated in the Global category and was also a finalist in New South Wales for the Australian of the Year Awards.

Our second speaker was **Judith Makange**, who studied at St Jude's for 13 years and, thanks to her 100% free, quality education, life for Judith and her family is becoming easier.

We also welcomed Maddie Kelly, Alumni Coordinator at the School of St Jude's.

From the early days of just three students, St Jude's are now able to support 1,800 students and over 350 graduates as part of their Beyond St Jude's Program. Between them, they have taught over 60,000 government school students as part of a Community Service Year before going on to tertiary education. In January 2020, a girls' secondary school was opened. Girls from a poor, rural background are the least likely to complete their schooling and yet having educated girls is one of the surest ways to break the cycle of poverty. It's an important next step which we will look forward to hearing more about in the future.

Judith, an aspiring Agribusiness mogul who joined Gemma in Australia during The School of St Jude's 2020 promotional tour studied at St Jude's for 13 years and, thanks to her 100% free, quality education, life for Judith and her family is becoming easier. Judith is the youngest child in her family and has three siblings. Judith's mother, Esther, did not finish her schooling. She worked as a maid, but did not earn enough money to provide

basic necessities for her children. The house was ill equipped and Judith often went hungry.

In 2006, equipped with little more than hope for a brighter tomorrow, Esther brought Judith to St Jude's Student Selection Day. Judith was one of several thousand promising students who sat our academic tests that year, earning high enough results to progress to the poverty assessment stage of Student Selection.

When St Jude's staff visited Judith's one-room, cement block home, they immediately knew she was deserving of an academic scholarship.

Judith started at St Jude's in 2007, as a brand new Standard 1 student, eager to put pen to paper and write the future of her dreams. Being selected to attend St Jude's was a golden chance for Judith to help her family. Thanks to her education they were able to move into a two-room house and also purchase some electrical appliances, including a small refrigerator. Judith has now started her Beyond St Jude's Tertiary Scholarship, studying Agribusiness. Agriculture is the largest industry in Tanzania. Judith is already well on her way to success. Since graduating from St Jude's in May 2019, she's participated in the Beyond St Jude's Community Service Year, teaching biology in an under-resourced government school near Arusha. The school has approximately 900 students and only two biology teachers.

After these amazing and powerful insights into life in Tanzania, our guest speakers were thanked by our

Hon Secretary, Martha Jabour OAM who gave a moving speech and announced that the proceeds of the Forum would be donated to the School of St Jude to provide teaching equipment and books to assist future students.

The last function I was able to attend prior to the closure of life as we knew it was an excellent luncheon organised by our North-West Regional Group held at the Emu Bay Rhododendron Gardens at Burnie. My wife Jenny and I travelled from Hobart there and back on a truly glorious fine day made all the more enjoyable by the new green growth showing though in the countryside after months of drought and the sight of four wedge-tailed eagles soaring on the thermals and a sparkling Bass Strait all added to the pleasure. The inaugural meeting of the Tasmanian Branch was held in the Town Hall in Hobart and was attended by 23 recipients of the Order of Australia where the convenor Mr Douglas A

Cashion AO welcomed the attendees and stated that the meeting was called to consider the formation of a Tasmanian Branch of the Order of Australia Association.

It is worth quoting directly from the minutes of that meeting that in part note: "The Chairman called on Mr T [Tom] D Room [AM] to give a brief resumé of the activities of the Association to date and setting out the present position of the National Association and of the State Branches that have already been formed. He stated that all other States and Territories had already had their meetings to form their respective branches as early as possible. He stated that there were 46 members present in Tasmania who had already joined the National Association and it was most desirous that the Tasmanian Branch should be formed immediately. He stated that a cheque for \$250 had been received from the National Association to cover expenses of the branch. He stated that the next meeting of the National Association would be held in Canberra on the 24th January 1981 and the branch would be formed in Tasmania and 6 representatives from the branch to be nominated as members of the National Executive Committee."

The meeting agreed to having a committee of eight persons, four from the South and two each from the North and North-West. Those elected were Mr Douglas A Cashion AO, Mrs Phyllis Benjamin AO MBE, Mr Max A Jillett AO and Mr E Linlay Harris OAM from the South. The election of representatives from the North and North-West was left in the hands of the Provisional Committee.

An annual dinner was organised and it was suggested that a small function be arranged to welcome new awardees.

To celebrate 40 years of existence of the Tasmanian Branch members are invited to suggest an appropriate way in which to mark this point in our history, assuming of course that the current COVID-19 restrictions are well past us.

GOVERNOR PRESENTS MERITORIOUS SERVICE AWARD AT N.W. TASMANIA GROUP LUNCH.

Her Excellency Professor, the Honourable Kate Warner AC, Governor of Tasmania together with her husband Mr Richard Warner AM were the Guests of Honour at a Lunch hosted by the NW Region of the Tasmania Branch of the Order at the Emu Valley Rhododendron Gardens, near Burnie, Tasmania in mid-March. The luncheon was attended by approx. 70 members and guests.

The Governor and Mr Warner were met by NW Region Chairman, Dr Peter Holm OAM and the Members of the NW Group Committee, together with the Tasmania Branch Chairman, Mr Alastair Douglas OAM and his wife Jenny; and the Northern Region Chairman, Dr Nicholas Chantler AM and his wife Tanya.

After the Official Welcome and introductions, Toasts to the Queen and to the Order, lunch was served. The reception room was beautifully prepared and decorated with flowers and

foliage from the Garden and everyone was clearly in a mood to enjoy themselves, including our Distinguished Guests. Indeed, it was to be almost the last official engagement the Governor will be attending, due to the current health situation.

After main course, the Governor was invited to give a brief address which focused on one of the great contributors to both the Order and the local community, Mrs Betty Hite OAM.

Betty received her OAM on 11th June 2001 for services to the communities of Burnie and Wynyard, which focused on helping the elderly and less fortunate by engaging the local population to engage in money raising activities for many years, which continued until very recently. She has held many positions on both the Tasmania Branch Executive and to the NW Region Committee and given enormous service over very many years. Betty was also one of the founders of the Wynyard Foreshore Market, and played a major part in the organisation of the Umina Park Home for the Aged Annual -Village Green Fair for over twenty years. In this latter role she would gather up all the soft toys that had been donated for sale and take them home for a "dip" in her washing machine (You never know where they have been!). From there they were hung on her washing line to dry, by their tails, legs or whatever appendage may be long enough and convenient! In time this became quite a feature of the area.

At the end of her address the Governor presented Betty with a Wooden Plaque featuring The Order of Australia Association emblem and an inscription recognising her Meritorious Service to the Association and the Community. She was totally surprised by the whole proceedings and clearly very proud. Well done Betty.

On behalf of the NW Region, the Governor then presented Betty with a soft stuffed pink rabbit as a memento of the occasion, with the observations that it may need the occasional wash, but would cost nothing to feed and incur no veterinary fees!!

NATIONAL NEWS

NATIONAL ANNUAL GENERAL MEETING

The necessary restrictions imposed by the advent of COVID-19 have been wide-ranging and have affected us all in many ways. Our inability to meet for Branch activities has also meant that in most Branches we have been unable to welcome new recipients of an award in the normal way. To the great credit of Branches alternative means of maintaining contact have been developed

The regrettable cancellation of the planned National Conference in Darwin from 7th to 10th May meant that we were unable to hold our Annual General Meeting on Saturday 9th May. The same spirit of innovation that has maintained Branch activity was extended to holding our AGM by internet-based videoconference. Inviting all 8,000 members to attend was clearly impractical and another form of participation was required. This was achieved by encouraging all members to 'have their say' by appointing a proxy with the option of directing the way in which their vote should be directed.

The AGM videoconference was chaired by our National President, Heather Ridout AO and was attended by directors and Branch chairmen as well as our auditor. The pleasing financial results of 2019 were presented, and some forecasts made of the way ahead. The meeting noted the appointment of the following to the Executive Committee:

It was noted that there had been no nomination for the position of National Secretary following the decision of the incumbent, Phil Morrall AM CSC not to continue in the role. Phil has provided three years of dedicated effort to the role and will be missed.

NATIONAL BOARD MEETING 6TH TO 8TH MAY

The challenge of holding a national Board meeting from widely dispersed locations was considerable but was successfully managed. This was achieved by the wonders of videoconferencing and by holding the meeting in stages over 3 days. Significant matters discussed included:

- The appointment of John Archer OAM as Interim National Secretary in addition to his role as National Deputy Chairman
- The adoption of a revised budget for 2020 taking account of the impact of COVID-19 on all aspects of Association activity
- Proposals for enhanced communication with members
- Support for plans to hold the 2021 National Conference in Darwin if restrictions are sufficiently eased

- The continued development of the new Association Constitution and associated Bylaws
- Review of Policy management and development
- Plans for future Board meeting

THE WAY AHEAD

The impact of COVID-19 on all aspects of the Australian way of life has been something not experienced sine the Great Depression of the 1930s. Our Association has been affected, but our difficulties have been minor compared with those of many of our countrymen and business operators.

Our Association Branches have taken up the challenge of maintaining cohesion within our membership by extensive use of email newsletters, phone calls, videoconferencing, and other means. Our next task will be to emerge from the restrictions on our activities with enthusiasm tinged with caution.

We need keep in mind that many of us are in the more senior age bracket and thus may have heightened vulnerability to COVID-19. The Audit & Risk Committee of your National Board have taken on the urgent task of providing guidance to Branches and members in their reestablishment of personal contact. This guidance will of course be in accord with Federal and State requirements.

COVID-19 has severely restricted our ability to welcome new recipients announced in the 2020 Australia Day Honours, and may also carry over to the 2020 Queen's Birthday Honours. As restriction are lifted it will be important to reach out, offer fellowship and encourage them to join our Association. It will be important to remember that the virus is likely to be with us for some time and caution will be required to achieve a balanced approach to Association activity.

Draft OAA Constitution

The new draft Constitution represents a key first stage in an overall 'governance' project to be accompanied by the completion of a revised set of bylaws and continued policy development. The draft Constitution has been developed with guidance from the Australian Charities and Not-for-Profit Commission (ACNC), our corporate regulator, and with input from Branch Committees and those with constitutional expertise. The template for not-forprofit (NFP) organisations has been adopted as the model for our Constitution. It is intended that members be asked to adopt the new Constitution, after a period of consultation, at the National AGM in May 2021. A favourable vote by 75% of the members is required to adopt the new Constitution.

Some proposed changes

Purpose of our Association

The 'statement of purpose' in our Constitution has been reworded to provide a clear and simple expression of why we exist and what we do. This is an essential part of ensuring that we are focussed on the appropriate goals and that we attract and retain members

Election to the Board

The ACNC favours, but does not mandate, the election of board members by the membership of the organisation. Since our formation, nomination of Branch Directors to the Association National Board has been by Branch Committees, and the appointment of the Executive (Chairman, Deputy Chairman, Treasurer, Secretary and Membership Director) by the Board itself.

Our new Constitution will provide for the election of Branch Directors by the members of that Branch and the election of the Executive Directors by the eight Branch Directors.

Tenure of Directors

At present directors are appointed to the National Board for one year and may stand for reappointment. The ACNC is aware of the potential loss of experience in short board tenure. It recommends that board members should be appointed for a longer period, typically 3 years, with the opportunity to stand for re-appointment for a total of 9 years' service. Our Constitution is to adopt this recommendation.

FOUNDATION NEWS - NEW SCHOLARSHIP WINNERS

Order of Australia Association Foundation Scholarships

The Board of Directors of the Order of Australia Association Foundation endorsed the recommendations of the National Selection Panel to award Scholarships to Charles Darwin University student Shanae Kuo and The University of Adelaide student Nicholas Simm.

This generous Scholarship provides for financial support of \$40,000 and an introduction to a eminent volunteer mentor, who is a recipient of an Order of Australia award in the field of interest of the student. Selection is made from:

*young Australian citizens undertaking a full-time undergraduate Degree *high academic results

*involvement in community affairs who exhibit potential as future leaders and *demonstration of financial need.

With the current lock-down situation in Australia, due to the coronavirus, the prestigious award ceremony which occurs at the Order of Australia Association Annual Conference Dinner cannot be held this year. Alternative arrangements are being planned.

The Scholarship Awards rely entirely on donations from members of the Association and the public. Donations of \$45,000 include naming rights. Smaller amounts are aggregated to fund an Award. All donations are tax-free. To date, forty-three Scholarships have been awarded to University students from all States and Territories – twenty-two to men and twenty-one to women.

Mentors play a very important role by volunteering their expertise, advice and understanding of the fields of study and career paths.

Hearty Greetings are forwarded to all members.

At the recent February AGM there was a significant transfer of batons within the Queensland Committee. We said goodbye to several stalwarts who collectively have given over 35 years of meritorious service to the Queensland Branch, namely Associate Professor John Harden AM, Emeritus Professor Mary Mahoney AO, Geoff Cowles OAM, Pat Galligan OAM, Royce Voss OAM and Ray Young OAM. Due acknowledgement was made of the substantial array of Branch organised events for the prior year, successfully completed and reported upon. It was my privilege to welcome onto the 2020 team two new members, Ross Patching OAM as Secretary and Kathy Wooldridge OAM as a Committee member.

At our initial March meeting other changes in office positions were affected and these are listed adjacent. Position Descriptions for all positions have been compiled together with a short bio for all Branch Committee members. A communique was broad cast to all State members introducing the Branch Committee and Regional Co-ordinators and recognising a Duty of Care, enclosing a health message to deal with the COVID-19 crisis.

Sadly, with the closure of Government House and introduction of necessary Governmental restrictions on personal interfacing, all our planned Branch activities for 2020 have been cancelled for the indeterminate future.

I would like to include some of the highlights from the Queensland Branch 2019 Annual Report. It was another busy year with a great variety of events organized by a hard-working Branch committee as well as many worthy functions organized by our regional groups throughout the State.

An annual highlight of the Queensland Branch calendar is its two outstanding celebratory lunch events to welcome new award recipients. These were held in May for new Australia Day awardees in and October for Queen's Birthday awardees. Another important event in the 2019 calendar was the Black-Tie Queen's Birthday Dinner cohosted by the Association and the Victoria League Brisbane for Commonwealth Friendship (VLB) at the Tattersall's Club in Brisbane on Saturday 11 June 2019. Added to the calendar was a novel Christmas event, also co-hosted with the VLB, in November, being the premiere of "Bring them Home" the Musical about the State of Origin, preceded by a cocktail reception, in the iconic, historic Princess Theatre at Woolloongabba.

Each Regional Group Convener organises at least one event during the year. This year there were fourteen events across the State. As most people are aware, Queensland is a large decentralised State and it is a credit to our Regional Conveners that they can organise well patronised events for members bearing in mind that for some members it is a whole day out due to distances travelled.

He was the winner of the "Environmental Contributor of the Year" award in Caloundra in 2016 and a finalist in the Sunshine Coast Australia Day Senior Citizen of the Year in 2017 and 2019.

Ken is certainly a worthy recipient of a 2019 Senior Volunteer Award for his significant service as a volunteer in the community.

Joyce Ridgeway- Harristown, Toowoomba

Joyce has been an enthusiastic and committed musician volunteer for most of her life, contributing to the entertainment and enjoyment of many people.

Her work includes her involvement with the U3A group where Joyce conducts a "Sing-along" group. In all her activities she researches and prints sheet music for her participants at her own costs and helps those to read music where this skill is absent.

Of special note is Joyce's diligent work as Secretary of the National Seniors Garden City Branch. During her life she has served on many committees including one notable one for a woman in the "Vauxhall Owners' Club of Australia".

Joyce's nominator tells us that Joyce's impact on others through her joy of music has been invaluable. Many have commented that it has given them confidence in later life and a sense of purpose and community.

Joyce's contribution to the social welfare and enjoyment of the community has been extensive, valued and widespread.

She is a worthy recipient of a 2019 Senior Volunteer Award.

How rare is an Order of Australia? - By Dr Tom Lewis OAM, Chairman NT Branch

The question came from the mouth of babes, and floored us. The talk was on an unrelated matter, but a recipient of the Order of Australia, Austin Asche, AC, QC, was presenting on his life: a rich tapestry of war service; legal work, and a stint as the Administrator of the Northern Territory.

"How rare is an Order of Australia?" was the question from a young member of the audience. Neither Austin, nor I, the organiser of the talk, knew the answer. But it's a question that may well be asked, or has already been asked, of others. So here are some findings.

The database kept at *It's an Honour* contains 40,219 recipients. Of those, 421 honorary recipients are listed. This therefore means there are 39,798 people definitively honoured.

The Order has been presented approximately 36,700 times since its inception in 1975. Of that, approximately 23,000 recipients are still alive. These approximates are for a number of reasons.

The first total is approximate because:

- The records are a little uncertain in pre-database days
- Some Australians have been awarded more than once
- Honorary recipients are not counted
- For reasons unknown, recipients in the military division were not counted.

The second "approximate" total – how many are still alive? – is not known, simply because deaths of recipients of the Order are not formally recorded. However Government House in Canberra does record the deaths of recipients in their database – but this is only if they are advised, or pick it up through the media or newspaper announcements.

The frequency of the bestowing of the Order has varied somewhat over the years. In the early years, prevalence of OA members honoured each year was between 0.001% and 0.003% (one in 100,000 to three in 100,000). Since about 1987 it has hovered around the 0.004% to 0.005% mark (one in 25,000 to one in 20,000), with a peak in the early 21st century around 0.006% (a bit more than 1 in 17,000). It is significant that the Bali Bombings, of 12 October 2002, saw many notable acts carried out by Australians both during and after the attack.¹ These were echoed later in awards both within and outside the Order of Australia.

So what to tell people who want brief immediate answers? Simply put, every year about one person in 20,000 receives an Order of Australia.

How many people in the population at present have an Order?

¹ The Bali Bombings saw 202 people killed, including 88 Australians.

At the time of writing, at the end of 2019, with a population of just over 25.5 million, $1/10^{\text{th}}$ of one percent of the population have an Order of Australia, or expressed another way, "point 1 of 1 percent".²

Expressed another way, one living person in 1,110 has an Order of Australia.

Yes we acknowledge Kevin as a VFL/AFL player, coach and ambassador has had one of the most successful careers in Australian sporting history. Martin FitzPatrick OAM

Martin says he endured 'months of questioning' by a certain member of the SA Police Road Patrol who was a fellow Scout Leader at the 1st Reynella Scout Troop. He was awarded the OAM in the 2003 Australia Day Honours List – Martin says he then understood the reason for all the questions.

He received the insignia at Government House Adelaide on 8 April 2003. Martin had previously been made a Life Member of the Scouting Association in 1984, and was awarded the Silver Emu in 1998. In 2019 he celebrated 60 years as a Scout Leader: he received a Long Service Award with other Leaders on Sunday 13 October 2019 at Titanium Security Arena.

Martin came from a large family of five girls and three boys, living at Marino and later Seacliff. He trained with the Army Cadet and then the Sea Scouts (1st Brighton Sea Scouts, then 1st Holdfast Bay), which became a life-long involvement. His two older brothers were Sea Scouts Leaders at Brighton, and all school holidays became camping expeditions. Martin started by gaining his Wood Badge, then Rowing, Sailing & Power Charge Certificates, and he gained

First Aid certificates through St John Ambulance. His older brothers ran Brighton and Marino Sea Scout Troops for 17 years.

Martin went on to assist with rowing regattas and sailing races, as a starter, then judge and patrol boat examiner. He was promoted in 2016 to Assistant Branch Commissioner of Boating: as the trainer of all Scout and Cub Leaders, he has had the satisfaction of testing in the boat some 92 adults in rowing drills.

They attended jamborees and other events interstate, hosted international Scout members, took Scouts in wheelchairs camping. Martin ran the 1st Holdfast Bay Sea Scouts for 20 years, and the 1st Reynella Scout Troop for 22 years. He ran groups in Gladstone, Hamley Bridge and Flaxmill with his own two sons as members.

Outside of his volunteer activities, Martin worked in the clothing industry. He spent 10 years at the Scout Shop, and then in the optical industry for 34 years, retiring at the age of 70. Retirement saw him breeding disease-free pork: he is especially proud of the act that he and his partner never lost a piglet. This is especially impressive considering one Sunday morning, no less than five large white sows all gave birth at the same time, to 17 each: this equalled 85 piglets. They all lived, although many required mouth-to-mouth. As martin says, "*There was no-one else around, so you need to step up, pronto*".

He has spent 15 years active with his local Neighbourhood Watch program. He notes that, at 80, he's the youngest in the group: "*the others are tiring and need youth to step up, sooner rather than later would be nice*". He is also active with his local parish at Morphett Vale, but notes that they have a similar need – with age overtaking the members who are no longer able to fulfil the traditional roles, from Catechists and Eucharist Ministers to car-parking attendants.

Martin remains active as a boating trainer and assessor. He said, "No doubt the powers that be feel I still have the skill and the knowledge to carry on; the next regatta may signal another story. Be Prepared said Baden-Powell".

VIRTUAL FELLOWSHIP

While the SA Branch Fellowship lunch meetings are unable to proceed in the current circumstances, the group has begun meeting 'virtually' using an online tool as their new 'venue' to keep members and guests involved and communicating.

Dr Alan Morrison AM is the new ACT Branch Nominated Director for the OAA National Board. Alan was previously a member of the ACT Branch committee and has a wealth of experience in Corporate Governance, Business Planning, Government, and Business Development. On Australia Day 2018 Alan was appointed a Member in the Order of Australia for significant service to the community through development and support for International Standards, to the Energy Supply Sector, and to Engineering.

OAA-ANU LECTURE – ADMIRAL CHRIS BARRIE AC (RETD) - WEDNESDAY 4 MARCH

Members ventured out on a rainy night to attend our annual ANU lecture **delivered by** Admiral Chris Barrie AC (Retd) on the subject **"It's an Honour - Reflections"**.

Admiral Barrie challenged the audience to think critically about the design and execution of our honours and awards system to ensure that it is inclusive and free of the perception of bias. He pointed to the role that the Association has in this important task. As a former Chief of Defence Force, Admiral Barrie had the opportunity to recommend many people for an

He was appointed an Officer in the Order in 1998 *for distinguished service to the Australian Defence Force as Deputy Chief of Naval Staff and Vice Chief of the Defence Force* and appointed a Companion in the Order in 2001 *for eminent service to the Australian Defence Force as Chief of the Defence Force*.
