AUSTRALIAN OF THE YEAR 2021 AWARDS

Congratulations to SA Branch member Russell Ebert OAM, a Respectful Relationships Advocate, who has been named as the 2021 SA Local Hero.

The Australia Day Council of SA has said: "Each year our nation celebrates the achievement and contribution of eminent Australians through the Australian of the Year Awards by profiling leading citizens who are role models for us all".

"They inspire us through their achievements and challenge us to make our own contribution to creating a better Australia".

Russell Ebert's award was announced in the Australian of the Year 2021 Awards presentation ceremony on Monday 12 October hosted by the Australia Day Council of SA.

Russell is the only player to have won four Magarey Medals, awarded to the best and fairest player in the South Australian National Football League.

Russell was awarded the OAM in the 1984 Australia Day Honours List, "In recognition of service to the sport of Australian football". He also received the Australian Sports Medal on 24 October 2000.

He is considered to be one of Port Adelaide Football Club's greatest players of all time.

The Australia Day Council of SA noted: "Today, Russell continues to give back to the club and the South Australian community through his leadership of the club's Power Community Ltd (PCL) youth programs. He is particularly passionate about PCL's Power to End Violence Against Women (PTEVAW) program, which he delivers to Year 10 students around the state".



THE ORDER OF AUSTRALIA Did you know...?

Members of the Order of Australia are entitled to use post-nominal letters after their name.

The handbook of the Order advises: "Upon publication of their award, recipients are entitled to have the appropriate post-nominals placed after their name on all occasions when the use of such letters is customary".

The 'Designations and Insignia Ordinance' (as amended) made under section 30 of the Constitution of the Order specifies that the postnominals applicable to the Order of Australia are:

AK (Knight)

AD (Dame)

AC (Companion)

AO (Officer)

AM (Member)

OAM (Medal of the Order of Australia)

These post-nominals apply to appointments made in the General Division and the Military Division, and also to Honorary awards.

'Promotions'

When a Member or Officer of the Order of Australia in either division is subsequently appointed to a higher grade in the same division, they are entitled to use the post-nominals of the *higher award* only.

For example: if an Officer in the General Division (AO) is subsequently appointed a Companion, also in the General Division, they may only use the postnominals 'AC'.

Similarly, when a holder of the Medal of the Order of Australia (OAM) in either Division is subsequently appointed to the Order of Australia at any grade in the same Division, they may use the post-nominals of the *higher award* only.

For example: if the holder of an OAM in the Military Division is subsequently appointed a Member of the Order, also in the Military Division, they may only use the post-nominals 'AM'.

Different rules apply to the use of post-nominals relating to appointments and promotions in *both* divisions of the Order of Australia, where both awards may be retained and worn (this situation will be described in the next newsletter)

DESIGNATIONS AND INSIGNIA

26. (1) A Companion or honorary Companion of the Order is entitled—

- (a) to have the letters 'A.C.' placed after his name on all occasions when the use of such letters is customary; and
- (b) to wear as a decoration the prescribed insignia for Companions of the Order.
- (2) An Officer or honorary Officer of the Order is entitled—
 - (a) to have the letters 'A.O.' placed after his name on all occasions when the use of such letters is customary; and
 - (b) to wear as a decoration the prescribed insignia for Officers of the Order.
- (3) A Member or honorary Member of the Order is entitled—
 - (a) to have the letters 'A.M.' placed after his name on all occasions when the use of such letters is customary; and
 - (b) to wear as a decoration the prescribed insignia for Members of the Order.

Post-nominals

<u>Left</u>: The use of post-nominal letters by members of the Order of Australia was first prescribed in the Constitution of the Order of Australia, published in the *Australian Government Gazette* No S28 dated 17 February 1975.

Note that in the original Letters Patent establishing the Order, given under the Great Seal of Australia at St James's on 14 February 1975, the Order of Australia was created in just three grades.

These appointments could be made in either the Civil Division or the Military Division (the former was retitled 'General Division' in 1976) or as Honorary appointments.

The levels of Knight (AK) and Dame (AD), and the Medal of the Order of Australia (OAM), were created on 24 May 1976.


