### **BRANCH NOMINATED DIRECTOR'S REPORT**



I attended the OAA Board meeting, held using Teams, on Friday 18 February 2021.

The Board discussed issues raised by the SA Branch, including a concern that not enough is done to attract new members. It agreed that attraction and retention of members is primarily the responsibility of branches but would welcome suggestions on how it could provide support.

The Board confirmed three circular resolutions regarding further payment of \$1000 to each Branch from the Government's Stimulus Package, approval of By-Laws and an amendment to By-Law 2.3.4(c).

The Board noted that the 2022 National Conference & AGM had been discussed by the Executive Committee and was satisfied that planning is on track.

The National Treasurer reported a healthy balance sheet and that the current year surplus stands at \$166,020.

The Deputy National Chairman reported on Audit and Risk Committee activity, including consideration of a revised G5 Risk Management Policy and drafting of a social media policy.

The Board considered the results of the Board Skills Matrix recently completed by Board members and where appropriate would share requirements with Branch Chairs to inform election of branch nominated directors.

The Board approved expenditure required to upgrade the Association's website.

The National Membership Director noted that there were 565 recipients in the 2021 Australia Day list compared with 838 in 2020.

The Board discussed the leakage of news of Margaret Court's honour and the Victorian Premier's public commentary. The Chair has taken the matter up with the Chair of the Council.

The next Board meeting is scheduled for 16 April 2021.
