## NATIONAL PRESIDENT'S REPORT

#### Heather Ridout AO National President

Fellow Members,

After a prolonged period of business isolation, like a number of us I suspect, I have now started to return to the office and to face to face meetings. I do so with alacrity but also with a slight sense of unease. It's hard to shake off the nervy covid habits; the board room set up is different to cope with the covid rules; people behave differently too.

Business has worked hard to support employees working virtually and has drawn down heavily on the cultural capital of their organisations in that endeavour. And there are a number of good things that have come of it. Digital technologies have well and truly proven their value and companies that don't have deep digital capability are now working hard to acquire it. And Working From Home now has its own acronym, WFH, and, more importantly, is established as a business norm with its own particular protocols and idiosyncrasies. Many have thrived on this change. Yet WFH hasn't been without cost, and the toll on some employees has been considerable. There has been a rise in mental illness; working hours have expanded; global business has to be transacted 24 hours a day in different time zones putting sustained pressure on affected workers. Productivity, which has held up well, is now coming under pressure.

Unfortunately we are still early in the recovery and we remain in transit to a new normal which I suspect we hope will be somewhat like the old one! Our 2021 AGM held this week still had to be conducted by Zoom. I know the Association has worked hard to maintain the engagement with members and to support communities during this tough period. Let's hope it wont be too long before we can get back together again.

The recent passing of HRH the Prince Philip, Duke of Edinburgh, was a sad and important event. As I noted in the message I posted on the national condolence register on behalf of OAA, Prince Philip was a great friend of Australia and committed his life to duty and public service. This didn't, however, prevent him from pursuing his interests and, infact, he was able to make a huge impact on these interests through his role in public life. He was deeply interested in people, their attitudes and cultures. He was passionate about technology and innovation, a lover of the natural environment and relentlessly intellectually curious. I saw this first hand early in my career when I was invited to be a Member of the Duke of Edinburgh Study Conference in Canada. The Conference brought together some 300 young emerging leaders from Commonwealth countries to explore the interaction between people and industry and the relationship between industry and the community around it. He addressed the Plenary session of the Conference stressing that our three weeks exploring Canada was not just about coming out with some good ideas about how to improve our world and having a good time, although I must say Montreal had a lot to teach me in all those respects, but to challenge our assumptions and prejudices and to appreciate diversity. The Duke founded this Conference in 1956 and it continues today. He was well ahead of his time.

Can I wish you well in the weeks ahead.

## NATIONAL CHAIRMAN'S REPORT CONTINUED

Branches and Regional Groups have done much through the recent difficult period to maintain contact with members and offer activities within local rules. It is hoped that we will now be able to cautiously extend our activities and continue with both meeting our members' needs and promoting the Order of Australia within the community. It is gratifying that, through the efforts of all, we

have not seen a reduction in membership numbers though the recent difficult period.

Our ACT Branch, through its Conference Committee, is now well advanced with plans for a most interesting and informative Annual Conference in Canberra in May 2022.

The Association National Project was agreed by your National Board in 2017 as focussing on the provision of member-funded scholarships in the name of the Association. This project has now been extended to encourage Branch members to donate to scholarships in the name of the Branch, where possible to be awarded to a scholar in a tertiary institute in the Branch during the appropriate National Conference.

I look forward to being able to meet with some members soon and to be able to renew many friendships at our National Conference in Canberra in May 2022.

#### HIGHLIGHTS OF THE ANNUAL GENERAL MEETING HELD ON SATURDAY 8 MAY 2021

For the second time in a year the Annual General Meeting was conducted as a virtual meeting via Zoom. Forty-six members attended and sixty-seven members submitted proxies.

Heather Ridout AO, National President opened the AGM and provided an overview of the Association in the national context.

Barry Nunn AO, National Chairman and Muriel Barasso OAM, National Treasurer gave a brief overview of the 2020 year which was one of considerable challenge for the Association against a background of national response to the Covid-19 Pandemic.

Some of the highlights of the year were:

- Membership Fees were held at level of the previous year.
- Income decreased by 30% in part because of the impact of Covid-19 on the ability to hold functions.
- We had a surplus of \$94,366 net of investment value changes.
- National Investments increased by \$169,989 over the previous year.
- Branch Administrative Grants were increased to \$51,028 plus a Government stimulus of \$16,000.
- The Darwin Conference did not proceed because of Covid-19. It is planned to hold a Conference in Canberra in 2022.
- Members Equity (assets-less-liabilities) increased by \$150,180 to \$1,036,527.
- The Order Magazine costs were reduced by \$16,411 with members choosing electronic distribution and editorial efficiencies.
- We welcomed 620 new members but regrettably lost 611. At year end the Association strength was 8211 members.
- Despite lockdowns and considerable ongoing restrictions on members' events, innovative ways were developed to maintain contacts and continue with the activities of the Association.
- Branches and Regional Groups embraced the capacity to communicate electronically with members both by email and video conferencing and consequently contact and involvement were maintained.
- A new Constitution, By-laws and a series of Policies were developed with substantial input from Branches
- The National Board, thorough its Board Committees and Working Groups, updated the Strategic Plan and continued to review Association governance arrangements.
- A survey of reader views on the content of The Order Magazine was completed during the year, with valuable feedback provided on the future structure and content of the magazine,

There were some changes in directors during the year. Michael Crane AM, Dr Frank Madill AM, and the National Secretary Phillip Morrall AM retired and were replaced by Dr Alan Morrison AM, Alastair Douglas OAM and Graham Hyde OAM. Paul Wheelton AM retired as Deputy National Chairman and was replaced by John Archer OAM and Jim Mein AM replaced John Archer as the NSW Branch Nominated Director. Elsewhere in the magazine you will see the 2021-2022 Board members listed.

We all hope that 2021 will be a year where we can return to normal and at last meet with fellow members and our communities. Graham Hyde

He came here prior to self-government as a young single reporter on the nowdefunct Darwin Star newspaper. Uranium mining, land rights, the excitement of the end of "colonial rule" for the Territory made it a great place to be.

After working in newspapers in Darwin, Tasmania, and Brisbane and a producer at Channel Nine Brisbane, he and his family returned to Darwin to head up the news service - and a few years later, to take over as the long-term CEO of the broadcast company that became Darwin's Channel Nine. In the meantime, he took up community roles across a plethora of areas including Employment and Vocational training, Rugby League, Cricket and St John Ambulance.

"I look forward to working with the Order of Australia NT Branch to bring more Territorians the recognition they deserve for the contributions they make daily to this wonderful part of Australia".



#### CONGRATULATIONS TO THREE VICTORIAN WOMEN AWARDED OFFICE OF THE ORDER OF **AUSTRALIA ON AUSTRALIA DAY 2021**

Professor Susan Davis AO, for distinguished service to medicine, to women's health as a clinical endocrinologist and researcher, and to medical education.



Professor Susan Davis is a leading international researcher in the field of women's health and menopausal medicine. She is a National Health and Medical Research Council (NHMRC) Principal Research Fellow and, since 2005, has been the Professor of Women's Health in the School of Public Health and Preventive Medicine at Monash University.

Susan was a founder of the Jean Hailes Foundation and was Director of Research of the Foundation from 1997 until 2005. She also held the Monash-Jean Hailes Chair

of Women's Health from 2003 to 2005, and between 2003 and 2007 was the lead Investigator for the NHMRC Centre of Clinical Research Excellence for the Study of Women's Health. She is a past president of the Australasian Menopause Society and a board member of the International Menopause Society since 2011.

Professor Helen O'Connell AO was recognised for distinguished service to medical education and to medicine in the field of urology, as an academic and clinician, and to professional groups.

Professor O'Connell is an academic Urologist based in Melbourne. She is the Head of Urology at Western Health. Completing her Urological training in 1994, she became Australia's first female Urologist. She was Fellowship trained after that in Houston and became a leader in the field of clin-



ical urology, urodynamics and lower urinary tract reconstruction, particularly in women.

Her Doctorate, (Melbourne University 2005) was in the study of female urogenital anatomy, studies for which she has international renown. She has been Principal investigator on a large number of clinical trials for drugs and devices for overactive bladder, stress incontinence in men and women and benign prostatic hyperplasia. Her current research interests are female urethral science, minimally invasive surgical approaches to problematic transvaginal mesh, stimulated transplanted smooth muscle neo-sphincters and shared care models of treatment for men with prostate cancer, and big data on



incontinence in men and women.

Ms Brenda Shanahan AO was recognised for distinguished service to medical health research, to the business and finance sectors, to corporate governance, and to philanthropy.

A pioneer in the financial industry, Brenda was the first female member of the Australian Stock Exchange. She has been a Non-Executive Director of DMP Asset Management since 2000 and of SG Hiscock & Co since 2019 and during this time has shown great dedication to the direction of the businesses. Brenda is and has also been a director of many

listed companies, including Clinuvel Pharmaceuticals, Challenger Group and Bell Financial Group. Her contribution to philanthropy has been both generous and impactful. Brenda is currently the Chair of Aitkenhead Centre for Medical Discovery and was the founder of the SVI Foundation and the Chair of St Vincent's Health. She is also a director of Rock Art

Australia (formerly Kimberly Foundation Australia), a not for profit organisation dedicated to researching and protecting Kimberley rock art by bringing science and Aboriginal cultural knowledge together. Brenda established the Brenda Shanahan Charitable Foundation, through which she supports various not for profit organisations.

#### FRANK COSTA AO

Frank Aloysius Costa, a legend of Geelong's business, sport and social scene, died peacefully on Sunday 2 May 2021, aged 83.

Although he never played a game of AFL football it was as the transformative Geelong Cats President that Frank Costa came to national prominence, helping the club break a premiership drought of 44 years when they won the 2007 flag under Coach Mark Thompson and Captain Tom Harley.

Frank and his brother Adrian, the sons of Italian immigrants bought the Geelong Convent Garden fruit shop on Geelong's Moorabool Street from their parents in 1959 before expanding it into a national wholesale fruit and vegetable empire. From humble beginnings, Costa Group became Australia's largest horticultural company and a major supplier of berries, mushrooms, tomatoes, bananas, avocados and citrus fruits.

He was a generous philanthropist and fierce advocate for the Geelong community and the State of Victoria. He was Patron and Ambassador of numerous organisations Australia wide.

Our thoughts are with Frank's wife of 61 years Shirley, their eight daughters and extended family.

In June 1997 Frank was a Medal of the Order of Australia recipient for service to Youth and the Community of Geelong. He was appointed an Officer within The Order of Australia in January 2015, for distinguished service to the community of Geelong through ongoing roles and contributions to a range of sports, business, religious, medical, educational and social welfare organisations. He was a Life Member of our Association.

#### THE HON GEORGE P SHULTZ AO (HON)

George Shultz, a pillar of the Republican foreign-policy establishment whose diplomacy helped seal the end of the Cold War, died in February 2021. He was 100 years old.

Mr Shultz held four different cabinet posts in the Nixon and Reagan administrations and served for six years as President Ronald Reagan's secretary of state, one of the longest such tenures since World War II. He remained an active voice on national security, economic and environmental issues after

leaving government, sometimes taking positions challenging the Trump administration.

A man of strong convictions who nevertheless rarely lost control of his emotions, Mr Shultz played a pivotal role in encouraging Mr Reagan to pursue a dialogue with the Soviet Union's leaders despite strong opposition from the Pentagon and, at times, the president's own national-security adviser.

He was appointed as an Honorary Officer within The Order of Australia in September 2011 in recognition of his services to Australia. He was a Life Member of our Association.

## AUSTRALIAN CARDINAL EDWARD CASSIDY AC

Cardinal Edward Cassidy, passed away in Newcastle on Saturday 10 April 2021 at 96, after more than 70 years of service that saw him become one of the nation's most senior Vatican officials of all time.

Born in 1924 in Sydney from humble beginnings, Cardinal Cassidy served in parish ministry in the Wagga Wagga diocese before relocating to Rome to further his studies.

He spent more than 30 years as a Vatican diplomat in Asia, Europe, Latin America and Africa, before going onto work for the Secretariat of State, where he served for almost two years in a role equivalent to the Pope's chief of staff.



He served as president of the Pontifical Council for Promoting Christian Unity in 1989 and was elevated to the rank of cardinal in 1991.

Cardinal Cassidy was appointed a Companion of The Order of Australia in 1990 in recognition of his service. He was a Life Member of our Association.

#### THE HON ANDREW PEACOCK AC



Andrew Peacock, ex-Liberal leader, debonair diplomat, and influential defence and foreign policy specialist, passed away in Austin Texas on 16 April 2021 at age 82.

Born in Melbourne on 13 February 1939, Mr Peacock was elected to Parliament at the age of 27. Dubbed the "colt from Kooyong", Mr Peacock succeeded Sir Robert Menzies in the blue-ribbon Liberal seat of Kooyong in 1966.

He held a number of cabinet portfolios during his time in politics, including as foreign minister between 1975 and 1980, then led the Liberals at elections in 1984 and 1990.

After leaving politics in 1994, Mr Peacock served as Australia's ambassador to the United States from 1997 to 1999. He spent much of the rest of his life in the US and died at his Texas home.

Mr Peacock was appointed a Companion within The Order of Australia in June 1997; for service to the Australian parliament, to politics and for the formulation and implementation of defence and foreign policy. He was a Life Member of our Association.

#### OUR ASSOCIATION PURPOSE: TO CELEBRATE AND PROMOTE OUTSTANDING AUSTRALIAN CITIZENSHIP.

#### 2022 NATIONAL CONFERENCE THEME: TO CELEBRATE SERVICE.

Do you find a resonance between our purpose and our intended conference theme and this extract from the Prime Minister's speech? I do! – Phil Morrall AM, CSC Editor.

#### You are more, we are more, individually, than the things others try to identify us by .

This is an edited extract of Prime Minister Scott Morrison's address to the United Israel Appeal NSW Donor Dinner in Sydney 29 April 2021.

Tonight, I want to talk about a topic that I know is very dear to you. My father was a big believer in community. He was Mayor of Waverley, he was on the Waverley Council for some 16, 17 years and he taught me a lot about the importance of community. And he learnt it all from you because my father would tell me, if you want to understand community, understand the Jewish community, which he loved passionately and dearly. A community of individuals, a nation of individuals.

Now, as some of you may know, I have been deeply influenced in recent years by the writings of the late Rabbi Lord Jonathan Sacks. His books Lessons in Leadership, Covenant and Conversation, and Morality, his last work, have given me a more textured understanding of Judaism, my own Christian faith and what unites us all as human beings. In his works, Rabbi Sacks wrestles, a bit like Jacob, wrestles with the practical complexities of our modern pluralistic world and finds, through the tenets of his faith, as he did, a pathway to the common good.

At the heart of our Judeo-Christian heritage are two words. Human dignity. Appreciating human dignity also fosters our sense of shared humanity. This means that because we are conscious of our own failings and vulnerabilities, we can be more accepting and understanding of the failings and vulnerabilities of others. True faith and religion is about confronting your own frailties. It's about understanding your own and our humanity.

Human dignity is foundational to our freedom. It restrains government, it restrains our own actions and our own behaviour because we act for others and not ourselves, as you indeed do here this evening. That is the essence of morality.

Acting to morally enhance the freedom of others ultimately serves to enhance our own freedom. So it is no surprise then that Rabbi Sacks concluded in his final work, Morality, "If you lose your own morality, you are in danger of losing your freedom."

The implication here is very important. Liberty is not borne of the state but rests with the individual, for whom morality must be a personal responsibility. Freedom therefore rests on us taking personal responsibility for how we treat each other, based on our respect for, and appreciation of, human dignity. This is not about state power. This is not about market power. This is about morality and personal responsibility.

Now, morality is also then the foundation of true community. The place where we are valued; where we are unique; where we respect one another and contribute to and share one another's lives. Where we pledge faithfulness to do together what we cannot achieve alone. Sacks describes this as the covenant of community.

Now together and individually we are each responsible for building and sustaining community, and we each have something unique to bring. Because community begins with the individual, not the state, not the marketplace. It begins with an appreciation of the unique dignity of each human being. It recognises that each individual has something to offer and that failure to appreciate and realise this, as a community, means our community is poorer and it is weaker.

When we reduce ourselves to a collection of attributes, or divide ourselves, even worse, on this basis, we can lose sight of who we actually are as individual human beings - in all our complexity, in all our wholeness and in all our wonder.

#### So, my message is simple: you matter, you make the difference, you make community.

I've been so incredibly heartened to see people from across the country show the best of us as a nation this past year. Drought, bushfires, floods, cyclones, pandemic — Australians have found ways to support each other and stand with each other. Checking in on each other, keeping jobs there for your employees, volunteering, helping neighbours with their shopping.

## Professor Shirley Randell AO, PhD, Hon.DLitt, FAICD, FACE, FIML, FIPAA

is a highly experienced board director and committee member of government and nongovernment-organisations in Australia and Rwanda. She is internationally renowned for her work advancing the status and rights of women, with many years of distinguished service to international relations through public sector and institutional reform.

Professor Randell was educated at Perth Modern School and the Universities of Papua New Guinea, Canberra, New England



and London. She has provided specialist technical assistance to governments in the Asia Pacific Region and in Africa over the last 20 years. From 2006-2013 she worked in Rwanda as a gender and education specialist and was the founder director of the Centre for Gender Studies at the University of Rwanda's School of Arts and Humanities.

She is the author of numerous journal articles and books. In 1988 as Director of the Disadvantaged Schools and Country Areas with the Commonwealth Schools Commission, Professor Randell was awarded an AM for 'public service especially in education', followed by an AO in 2010 for 'distinguished service to international relations, particularly through the promotion of human rights of women and through public sector reform in developing countries'.

In 2018 she was awarded the Institute of Managers and Leaders ANZ Inaugural Sir John Storey Lifetime Achievement in Leadership Award.Professor Randell was one of Australia's 100 Inaugural Women of Influence in 2012 and one of The International Alliance for Women's 100 World of Difference Awardees in 2013.

Professor Randell was awarded Life Fellow of the Australian Institute of Company Directors at the Australian Governance Summit in March 2021.

Professor Randell is now living in Australia, is a public speaker and has several ambassador, patron and board and committee roles. She had special interests in women's sport, physical fitness, theatre, music and her four children, 13 grandchildren, and four great grandchildren living in Sydney, Canberra, Melbourne and Townsville.

#### Maria Venuti AM - 80th Birthday Celebrations The Star Centre Sydney

Maria Venuti AM has been a household name in the Australian entertainment industry for over 60 years. I have had the pleasure to have known and worked with Maria for over 30 years especially in the Variety Club of Australia and in Ovarian Cancer fundraising at the Royal Hospital for Women.

In her 60 year career she has helped raise over 20 million dollars for various charities.

She suffered a stroke in 2016, after a confrontation with a stalker at home, which makes it hard for her to walk or speak and she can now sing only a few words but she still continues to fund raise and give back to the community. She actually sang a song on the day which brought tears to the eyes of those present!

Maria's daughter Bianca Venuti (left in the photo) said her mother's stroke has had a big impact on her mother's life, but singing is a driving force in her recovery journey.

At her 80th birthday celebrations at the Star Event Centre Sydney in March 2021, funds were donated to the Stroke Foundation. The great majority of the 300 attendees were

Nicolette (Niki) Norris AM

Niki is the Chair of the National Child Protection Alliance Australia and in 2017 was invested as a Member of the Order of Australia for significant service to the community and particularly to the rights of children to care and protection and to voice their views and opinions. She is currently focusing on social policy, youth resilience and leadership (NSW) and the ongoing and damaging effects of trauma caused to children and the protective parent when they become involved in Family Court proceedings.

Niki has been an advocate for children and young people and their families for over a decade. She was a founding member of the NCPA, held the role of Vice Chair since inauguration and took on the role of Chair in 2017.

Under the umbrella of the NCPA a new group was formed called, 'Young People Against Child Abuse' and Niki is now mentoring young survivors and other keen young people and taking them to speak with State and Federal leaders to explain the damaging aftermath and ongoing trauma which has been forced upon them by systemic failures.





#### NSW "ONCE-IN-A-100-YEAR FLOODS, MARCH 2021

During the unprecedented rainfall in NSW in March, 20 of the 40 river catchments which flow east to the coast, were in flood. The entire NSW coast was impacted by more than 200 millimeters, and in some places, more than 400 millimeters. Flood warnings were issued on 33 rivers over 600 kilometres along the coast, including main catchments, the Hawkesbury-Nepean, Clarence-Hunter. Tens of thousands of people were ordered to evactuate.

Roger Butler, OAM, regional convenor for the geographical area of the New England and North West Region of the Order of Australia Association reported that only the town of Moree was flooded.

He said "If on Sunday the 21st March any one had asked me whether I thought Moree was likely to be flooded I would have laughed. The 8 to 10 inches of rain that fell in 36 hours on the Monday and Tuesday (22nd and 23rd) produced a flood which certainly proved me wrong. Just as that started to subside the rain that had fallen upstream and filled the river systems arrived creating a major flood. The second wave peaked around 7:00 am on Thursday the 25th at which time the town was totally isolated and had been "cut" in three . By Friday morning although there was still plenty of water around (the famed Moree Golf Course being still inundated) the roads were no longer cut and travel was freely restored.

The support from SES, Fire & Rescue and Moree Council staff was phenomenal – highly organised, substantial in number and very efficient. As a consequence, damage and inconvenience was minimised and a clean-up of public areas and public buildings quickly completed. This flood produced more mud and debris than any that I have previously seen and that presumably is a consequence of the three-year drought which preceded it and the fact that many farmers had prepared their country for the 2021 winter crop and there was thus a lot of nice cultivated top soil to be washed away by the flood waters.

Moree was very fortunate compared to our coastal cousins. Furthermore, the floods will have replenished the water table and provided magnificent subsoil moisture for the next crop. As farmers are known to say "there is money in mud".

This area did not experience flooding in the same way as the coastal regions. We were pleased to have some good rain and fill the tanks and dams. Yes, it was very wet and several sports and other events had to be cancelled.

The Macquarie River certainly brought plenty of water past the city and the tributary rivers likewise brought plenty. The flooded creeks and roads created difficulties for many people living on properties in the district. Often transport would be limited to a high vehicle.



I am sure that many of the volunteers from services in the district have been working to assist the less fortunate people in other places.

In general terms life is getting back to normal, but normal will not exist for a long time for those worst off, especially having had homes totally inundated plus loss of livestock. Most people believe they live in the best place on earth, and we certainly do here in the Hastings/Macleay, but when nature wants our attention we certainly have to take notice! Thus our community will continue to work side by side with those in need"

#### VALE: VILMOS MILISITS OAM (1948-2021)

SA Branch member and legendary Adelaide baker Vilmos 'Vili' Milisits OAM died on 26 March following a lung transplant, aged 72. Vili came to Adelaide as a refugee from Hungary in 1956. and ultimately He and his wife Rosemary came to run ran a business that has become a South Australian icon. Vili and Rosemary were both awarded the OAM in the 2005 Queen's Birthday Honours List, "For service to the food industry, and to the community through support for a range of charitable organisations".

Vili joined the SA Branch in August 2005 as a Life Member. Has and has been involved in the operations of the Branch since then, and has provided providing assistance through generous donations of produce for various branch functions and, until recent changes to health regulations, tours of the bakery for members, followed by a morning tea at the 'Cafe de Vilis'.

SA Branch Chairman, Tony Metcalf OAM, gave offered this message of condolence: "Vili has supported the SA Branch with enthusiasm and contributions since 2005 when he and Rosemary were awarded their individual Medals of the Order of Australia. Vili will be remembered with deep affection".

At the end of last year, several members of the Order of Australia were among a group of volunteers recognised in a special award ceremony held by St John Ambulance SA. Firstly, Dr Franklin Bridgewater OAM KStJ was recognised for his many years of voluntary service, receiving the Sixth Service Bar to the Service Medal of the Order of St John, representing 40 years of service.

#### DR JOHN MILTON WETTENHALL OAM RFD FRACP



John Wettenhall was born on the 16th of April 1945 in Melbourne. He was educated at Caulfield Grammar and obtained his medical degree at the University of Melbourne in 1969. He also studied at the University of Singapore and the Charles Sturt University, and obtained his MRACP in 1974 then his FRACP in 1978. One of his other proud achievements is achieving an Associate Diploma in Applied Science in Wine Growing, which he did in 1999.

John spent three years with the Royal Australian Medical Corps as a General Duties MO in 1971 at Puckapunyal, then at ANZUK Mil Hosp Singapore from 1972-1974, then Specialist in Medicine UK Mil Hosp Singapore in 1975. After returning to Australia, he was Consultant Physician to the 3rd Military District, and Consultant Physician at the RAN Hospital Cerberus, and briefly at RAAF Base Butterworth in Malaysia. From progressive command positions he rose to Honorary Colonel of the RAAMC for Tasmania 2004-2008. He worked as a Specialist Gastroenterological at the Royal Melbourne Hospital, Frankston Hospital, and the Mt Eliza Geriatric Centre; and was the Area Medical Co-Ordinator for the Victoria State Disaster Plan from 1982-1989. He was Clinical Senior Lecturer in Medicine at the University of Tasmania from 1996-2011. He has been a Director of the Clifford Craig Foundation from 2018 to the present; and Chairman and Director of the Peter Hewitt Care for Africa Foundation since 2017. He received the AMA Leadership Award in April 1975. In addition to his Medal of The Order of Australia he has the Reserve Force Decoration.

John is an Honorary Life Fellow of the Royal Australian College of Physicians and a Life Member of the Gastroenterological Society of Australia. He is an active member of the Rotary Club of Launceston, particularly involved in the campaign against Malaria and in the Water Sanitation and Hygiene Rotary Action Group. He is a member of the Launceston Philatelic Society, the Melbourne University Rifles Association, the RACV Club and the RACT. As a volunteer he has been a visiting Gastroenterologist to Nauru, helped a rehabili-

tation centre in Java, is currently a Trustee of the Christopher Strong Education Trust, and a committee member of Longford Blooms Inc. John has had a past interest and activity in viticulture and at present his hobbies include the collection and study of disinfected mail from the 15th – 21st centuries and growing Australian native plants.

John Wettenhall's medical career has taken him across the world with a great range of military, civilian and volunteer activities. He is a most worthy recipient of an Order of Australia Award from a grateful nation.

#### MEET OUR MEMBERS – BRIAN O'KEEFFE AO

The involvement of Branch member Brian O'Keeffe AO in air traffic management over five decades has resulted in his becoming one of the most influential Australians in world aviation safety. Brian first applied his electronics engineering knowledge to radio installations, setting the groundwork for the design of the Instrument Landing System (ILS) which became the standard in Australia for many years. This allowed pilots to conduct an instrument approach to landing if they were unable to establish visual contact with the runway.

Brian was the co-developer of a high accuracy optical electrical tracking system which became part of the Microwave Landing System (MLS). In 1967 he presented a paper to the International Civil Aviation Organisation (ICAO) to replace ILS with MLS. He led the Department of Transport MLS program to produce and test an MLS system (later known as INTERSCAN). This more accurate landing system was adopted in 1978 by ICAO as the world standard technology for assisted landing.

Brian was elected chairman of the ICAO committee that worked to have an integrated system of communication, navigation, surveillance and air traffic management accepted at a world-wide ICAO meeting in 1991. He was subsequently elected First Vice-President of the ICAO General assembly in 1992.

He held a number of key strategic and operational roles in the Department of Transport including First Assistant Secretary Airways Operation Division and in 1988 was appointed General Manager Advanced Systems Development for the Civil Aviation Authority, a position he held until retirement in 1997.

In recognition of his international contribution, Brian received many awards including being inducted into the Hall of Fame at the Smithsonian Air and Space Museum in Washington DC in 1997 and in 2004, receiving the Edward Warner Award, ICAO's highest honour.

In 1992 Brian was appointed an Officer in the Order of Australia for service to civil aviation, particularly international civil aviation.



An interview with Hannah...

#### What area of your course excites you the most?

I have loved a lot of different subjects throughout my law degree. The subject I did the best in was equity and trusts, the subject I found the hardest was remedies, the most rewarding so far has been company law and my favourites to study have been education law, health law, death law and sports law which I am currently completing. It's hard to pinpoint an exact area of law, as each is so unique. My favourite part of my politics study is where I get to look at the legal and political systems of other countries and think about how they compare with Australia.

## How has the pandemic affected your year, and has the scholarship aided this crisis at all?

The pandemic has been challenging but it has given me more time for myself and pushed me to grow my sports coaching company. I studied throughout the entire year and continued to train my skating every day throughout the pandemic at my local netball courts. I usually coach and train inside, but due to the pandemic I took

everything outdoors. The outdoor classes became pretty popular with rollerblading booming again. I didn't mind studying online, but I found it difficult to separate work and study time from relaxation time. I did find the very long lockdowns in Victoria challenging, as no one really knew what would happen. I'm happy the restrictions are easing now. I also moved to a new house this year. I did have a reduced income as a result of the lockdowns and the scholarship allowed me to be financially stable enough to move and make sure I had all of the essentials. The scholarship meant that I was able to buy a new desktop computer, because I was having trouble studying so much at home on my laptop.

#### What has been something positive to come out of University in a global pandemic?

I am grateful that this year I had a lot of time to focus on completing all my law subjects, and on top of them to complete an international certification for my coaching. Now, all that is left to complete is some arts subjects. Some of the final law subjects were challenging and required a lot of time for me to feel like I was ready for exams. I also found at home exams to be a lot better, as I felt they still assessed student knowledge very well but they didn't have the exam room feeling. I also enjoyed being able to type my exams. I was lucky this year to have great law tutors which I had already had throughout my degree, and I felt like I had some form of social connection with people when attending ZOOM classes in a tough lockdown. I don't think I would have video called anyone if it wasn't for my studies!

#### What message would you like to pass on to your donor?

I would just like to say thank you so much for the incredible support that I have received from The Order of Australia Association Foundation Scholarship. This year has been difficult due to the pandemic and lockdowns in Victoria, but despite that I was still able to continue my study, achieve great results and not have added worry about not being able to support myself financially. I feel proud of my results this year and the scholarship has continued to give me confidence in my academic, professional and personal life. I can't wait to see what happens next for me.
