
#### Thursday July 15

## **Melbourne Central Regional Group**

The Melbourne Central Regional Group has commenced its program of events, COVID 19 having stalled everything from last year and early this year. Our first two events were for those present very informative.

**Tuesday May 11** lunch at The Kooyong Lawn Tennis Club with speaker Professor Jayashri Kulkarni AM a specialist and well recognised researcher in Women's Mental Health

A fierce advocate of women's health who is also a migrant, mother and former marathon runner, Professor Jayashri Kulkarni AM was recognised in the 2019 Queen's Birthday honours for significant service to medicine in the field of psychiatry.

Professor Kulkarni is a world-leading mental health researcher and director of the Monash Alfred Psychiatry research centre (MAPrc). Professor Kulkarni's world-first research on the relationship between women's hormones and mental illness has led to new and improved treatments for conditions such as schizophrenia and depression.

#### Melbourne Central Regional Group continued

Working as a young Registrar at the former Royal Park Psychiatric Hospital, Professor Kulkarni was drawn to the plight of mothers who had developed mental illness after giving birth.

"I got to meet women who had been institutionalised for a long time and they told me about the fact that they had children," she says. "The psychosis had happened post-partum and it hadn't improved."

This led to a distinguished career investigating the relationship between hormones at varying life stages and women's mental illness. World-first estrogen treatments for psychosis and other mental health conditions have been developed from this research, which began in the late 1980s.



Professor Kulkarni's late parents, Rangnath and Shashikala, arrived from Bijapur, south-west of Mumbai, in 1961 with three-year-old Jayashri and her baby brother Anand.

The White Australia Policy was still in force when they became only the second Indian family to migrate to Melbourne. Rangnath set up the CSIRO's ozone research program and Shashikala taught at a local high school.

"At this stage there were probably some people with Italian background and Greek background but not very many Asian migrants at all," Professor Kulkarni recalls.

"I was called Jane for a few months by this teacher, who said, 'I can't say your name it's too complicated'. My mum came to pick me up

and she spoke with the teacher, but in a very gentle way, taught her how to pronounce my name. and I was then called Jayashri."

Professor Kulkarni studied medicine at Monash University in the 1970s, when less than one in three students was female, which helped instill the strong sense of empathy and social justice that inspired her work.

Wednesday May 12 networking evening at RMIT with speaker Professor Calum Drummond AO appointed an Officer of the Order of Australia (AO) in the Queen's Birthday 2019 Honours List for his outstanding service to science and innovation.

The Deputy Vice-Chancellor for Research and Innovation and Vice-President received the appointment in recognition of distinguished service to chemistry and materials science research, commercialisation initiatives, and his exceptional contribution as a scientific leader and mentor.

Professor Drummond's research achievements include advancing the fundamental understanding of materials at the nanoscale that have enabled high-performing products to be developed and commercialised.



## Virtual Agricultural opportunities and challenges

Our Wednesday May 12 virtual event MC'd by David Mann AM focused on agriculture with two speakers Alana Johnson AM and Dr Joanna (Jo) Newtown OAM.



Alana Johnson AM is a rural development specialist and principal of Lurg Cattle Co. She is Acting Chair of the Victorian Catchment Management Council, Chair of the Victorian Women's Trust, past President of Voices for Indi and founding member of Australian Women in Agriculture.

Alana has served on a range of Ministerial advisory committees and statutory and not-for-profit Boards. She was named in the inaugural 100 Women of Influence in Australia by the Australian Financial Review and the inaugural 100 Women in Australian Agribusiness by Rural Press and was the Rural Women's Award Victorian winner and Australian runner up in 2010. Alana was inducted onto the Victorian Honour Roll of Women in 2018.



Alana is a graduate of the Australian Rural Leadership Program and the Australian Institute of Company Directors and holds a BA and BSW.

In recognition of her service to women through leadership and advisory roles, Alana was a Member of the Order of Australia (AM) recipient Australia Day in 2020.

Dr Joanna (Jo) Newton OAM works as a research scientist in genetics for the dairy industry with Agriculture Victoria. In 2017 she won the Dairy Research Foundation's Emerging Scientists Award and in 2018 won the Leadership category in the Victorian Young Achiever Awards, received the University of New England's Young Distinguished Alumni Award and was included in the Australian Financial Review's "100 Women of Influence" List

Her active involvement in the agricultural sector has included serving as inaugural Chair of the



Youth Voices Leadership team and previous roles with the NSW Young Farmers Council. She dedicates a considerable portion of her spare time to speaking at schools and events, mentoring students and junior scientists and volunteering at agricultural shows.

Jo's contributions to agriculture have been recognised through numerous awards including at the age of 31 for service to agriculture through her advocacy and support of young people, volunteering and contribution to dairy research she was a Medal of the Order of Australia (OAM) recipient Queen's

Birthday 2020.

## Virtual Agricultural opportunities and challenges continued

Discussion included the contribution of agriculture to our economy which is often underestimated. Half our land is used directly or indirectly for agriculture, the challenges of and opportunities of our weather Australia wide have a huge impact on outcomes and employment.

There are many players who come to the table when decisions need to be made, there has been rapidly changing approaches to all the challenges, and on a positive note the impact of women in agriculture is now being recognised.

Members heard about the history of agriculture, the structure today, issues, and innovation including greenhouse emissions, appropriate use of the land, better farm management, research, data collection use and future opportunities from the data.

We thank Reg Smith OAM and the Rotary Club of Melbourne for the Zoom link, National Anthem both verses and a collation of picturesque rural scenery.

#### Elevated member Anne Mackenzie AM

We congratulate Anne Macarthur a Member of the Order of Australia (AM) in the 2021 Australia Day Honours for service to the Red Cross and East Gippsland community. This is an elevation from her Medal of the Order of Australia (OAM) in 2007.

Anne acknowledged she accepted the honour on behalf of all those who helped her over the years because no one does things on their own.

She first became involved with Red Cross at the age of 10 when boarding at St. Catherine's School in Melbourne. Anne moved to East Gippsland in 1961with her husband and has been a member of the Lindenow branch since its formation 50 years ago.

She recalls the 1965 bushfires in the area and baking fruitcakes and delivering them to families affected. A similar situation ensued following the Black Summer bushfires in 2019, but this time Anne was delivering Red Cross teddies made by branch members.

"It wasn't just kids hugging the teddies (also known as trauma teddies) but adults too," she said "They gave comfort to people of all ages."

For as long as she can remember, Anne has been one who door knocks in the Lindenow area during the Red Cross annual fundraising drive in March.

Anne became the first female chair of Red Cross, after 100 years of male dominance, and chaired the Victorian Red Cross Board for six years.

When she's not chairing Red Cross meetings, baking cakes and rattling tins or swimming laps at the BARC in Bairnsdale Anne is the Order of Australia Association VIC Branch Gippsland Regional Group Secretary.

## Vale Frank Costa AO February 1938 to May 2021

Frank Costa AO will be remembered as a family man, a philanthropist, a community advocate, a "natural leader" and one of Australia's most successful businessmen and one of the most influential figures in the history of the Geelong Football Club

An iconic figure in the Geelong region, he has long been a community leader. He joined the Geelong Football Club board in 1996 and was elected as President two years later - appointing Brian Cook as CEO and Mark Thompson as Coach. He remained as president until the end of 2010 when he retired from the board and then became the club's Patron.



2,000 people attended the State Memorial Service at Kardinia Park to celebrate Frank's life and his contributions to our state, the Geelong region and his beloved Geelong Football Club. The service MC'd by Ian Cover opened with a Welcome to Country by Wadawurrung traditional owner Corrina Eccles, accompanied by a Didgeridoo tribute performed by Norm Stanley.

Frank's memory was honoured by the Acting Premier, the Honourable James Merlino MP,

followed by tributes from family, friends and former colleagues including Robert Costa, Lindsay Fox AC, Brian Cook and Father Kevin Dillon AM. Tim McCallum sung the Australian National Anthem.

The service also commemorated Frank's official induction as the Geelong Football Club's 26th Legend. Frank became the first non-player to receive this honour and the medal was presented to his wife Shirley. Frank was made aware of his induction in April.

The Memorial Service concluded with a guard of honour formed by the Geelong Football Club, accompanied by a minute of silence which started and ended with the game siren followed by the Geelong Football Club song.

There was a private service at St Mary's Church Geelong for family and friends prior to the State Memorial Service.

"Frank was a legend as a person, and a legend of the club. He forged so many strong and lasting relationships through his warmth and authenticity. He will be missed by all that have been fortunate enough to know and love him," Geelong Football Club CEO Brian Cook said.

Awards received recognising the contribution made by Frank Costa:-Centenary Medal (2001) for service to the Barwon community Australian Sports Medal (2001) for services to Australian Football Medal of the Order of Australia (OAM 1997) for service to youth and the community of Geelong Officer of the Order of Australia (AO 2015) for distinguished service to the community of Geelong through ongoing roles and contributions to a range of sports, business, religious, medical, educational and social welfare organisations

The widely admired Frank Costa AO is survived by his eight daughters and wife Shirley.
