His Excellency told us that his staff had collated some statistics on his term as Governor – notably, in seven years he has attended over 8,000 events, and he has invested 1,003 recipients of the Order of Australia.

His Excellency had earlier written to us: *"It has been a privilege to have served as your patron, and I wish your organisation continued success in its important work in the community"*.

We welcome Ms Frances Adamson AC, who will be sworn-in as Governor of South Australia this month.

And we have been advised by Government House that the investiture ceremonies for the Queen's Birthday recipients will be held in the first week of November, over seven separate ceremonies to accommodate COVID restrictions.

Our Student Citizenship Award Assessment and Selection Panel has determined the top 10 nominees. The 2021 Student Citizen of the Year will be announced at the award ceremony.

I remind you of our Strategic Planning Day to be held on 30 October. A light lunch will be provided. Please come along and have some input into the future direction of your Branch.

Please also note in your diary that our 2021 Annual General Meeting (36th AGM) will be held at the Arkaba Hotel on Saturday 26 February 2022.

### FELLOWSHIP LUNCHEON MEETING

Thursday 26 August 2021

For the August Fellowship meeting, Ms Kathryn House AM spoke on "Collective Giving and the changing face of Philanthropy in Australia". Kathryn was appointed a Member of the Order of Australia in the 2020 Queen's Birthday Honours List, "*For significant service to the community through charitable initiatives*".

Kathryn began her career as an educator, and has taught over the last 35 years in a wide range of educational settings. Most notably, she was a pioneer in Chinese language teaching in SA, and was a founding board member and Secretary of the Chinese Language Teachers' Association SA (1986-89).

For the past 25 years, she has worked with her husband Nick in the House Group of Companies, in administration and support roles (the Group has a portfolio of interests and companies, ranging from

aged care, building, development and property management to community engagement).

Kathryn's appointment to the Order of Australia recognised her role as a "committed philanthropist", as she was described by *SA Life* magazine. She devotes most of her time to supporting various not-for-profit organisations, and sits on several boards including the Adelaide Festival Centre Foundation and Grandparents for Grandchildren SA. Kathryn is one of the newest members of the Order of Australia SA Branch Committee.

She has been a volunteer for Catherine House Inc for the past 17 years, supporting women who are experiencing homelessness, serving as chair of their Trust and Community Ambassador and working in fundraising and events during that time. She was a founding Board Member of the Roger Rasheed Sports Foundation (2011-19) and is a supporter of a range of other charities and clubs, including the South Australian Health and Medical Research Institute, Cambodian Children's Trust and Yalari. In addition, she chairs many community groups including a collective giving circle Impact100 South Australia, Young Impact for school-aged children and Powerful Women, as well as her own streets' residents' association in St Georges.

Kathryn says that she has "*a commitment to create kinder, more connected communities*", and her aim is to raise the profile of philanthropy and the culture of giving in our community.

### HIGH FLYER

This year the RAAF has celebrated the centenary of its formation. To mark this milestone, Air Force has produced a Commemorative Program for the year's events. One of the features is "Our Air Force, Our People".

Among those featured is Flight-Lieutenant Matt 'Checkers' Holecek, one of our few F-35A Lightning pilots. Matt is the son of SA Branch member and former committee member Brian Holecek OAM.

Matt learned to fly through the Murray Bridge Gliding Club, and within just a few years was flying F/A-18 Hornet fighter jets from RAAF Williamtown near Newcastle, NSW and RAAF Tindal near Katherine in the Northern Territory. With the Hornets reaching their end of life, Matt underwent training at Luke Air Force Base in Phoenix, Arizona to convert to the newest aircraft in the RAAF inventory, the single-seater F-35A Lightning II.

Updating the story published in the RAAF Commemorative Program – Matt finished his conversion training in July last year. He is instructing the new F-35 pilots at No 2 Operational Conversion Unit at RAAF Williamtown, before he returns to an operational squadron. ## Jubilee Medals

### A Brief History, Part 2

On 6 February 2022, the 70<sup>th</sup> anniversary of Queen Elizabeth II's accession to the throne will be celebrated.

Following long-established precedent, this milestone will be marked in Great Britain and parts of the Commonwealth through the awarding of a Jubilee Medal.



### Queen Victoria Diamond Jubilee Medal, 1897

On 23 September 1896, Queen Victoria surpassed King George III as Britain's longest-reigning monarch, however the Queen requested that celebrations be delayed to coincide with her Diamond Jubilee. Following the precedent set in 1887, a Diamond Jubilee Medal was created to mark the 60<sup>th</sup> anniversary of Queen Victoria's accession to the throne on 20 June 1837, for award to those who attended the celebrations in England.

This medal was identical in design to the 1887 Golden Jubilee Medal other than the inscription on the reverse: "IN COMMEMORATION OF THE 60<sup>TH</sup> YEAR OF THE REIGN OF QUEEN VICTORIA 20 JUNE 1897" (the date of the actual anniversary of the Queen's accession).



This is a Queen Victoria Jubilee Medal 1897 in bronze in its original presentation case, with the suspension ribbon formed into a bow as worn by ladies. This medal was presented as a personal gift from the Sovereign to one of Queen Victoria's Drawing Room maids, who served at Buckingham Palace from 1894 to 1905.


The suspension ribbon is also identical to the 1887 medal: in garter blue (drawn from the ribbon of the Order of the Garter) with wide white stripes towards each edge.

Anyone who had received the earlier 1887 Golden Jubilee Medal wore a silver or bronze clasp '1897' on the ribbon (to match the metal of the original medal). For this reason, the 1897 medal was issued in relatively small numbers, making it quite rare.

The medal was awarded in gold to members of the Royal Family and the Royal guests (73), silver to officers and those of similar status including Envoys, Foreign Ambassadors and Colonial Prime Ministers and certain senior members of the Royal Household (3,040) and in bronze to selected Other Ranks and those of similar status who took part in the jubilee parade, and ladies and gentlemen of the Royal Household (890 awarded).

Military recipients included selected officers, sailors and soldiers of the Royal Navy and Army, and the Indian and colonial contingents, that participated in jubilee activities, including the London parade and the Royal Naval Review at Spithead, where the commander of each ship received the medal in silver. Members of the Australian contingent to the UK received 25 silver medals (officers) and 251 bronze medals (other ranks).
