## COVID-19; TIME TO LOOK AT SOME GOOD NEWS

Here and globally, Covid-19 has been devastating. Not only because of high hospitalization and death rates in those infected, especially in the elderly, but frequently on overwhelmed health systems. Restrictions on what we can do, have been necessary at times to restrict the spread of the virus. But restrictions also have detrimental effects on people's livelihoods, the economy, our ability to interact with friends and families. So, they have had major effects on us all psychologically and socially, and on our sense of wellbeing.

But we have also had remarkable achievements since late 2019, when this infection first started to spread in China. In Australia, with our prompt action in early 2020 in closing our international borders, and by people cooperating and decreasing their interactions and travel, we have not only kept large numbers of infections out of Australia but also prevented their spread. We not only flattened our epidemic curve, and did so very early on, but we reversed the curve. In all States and Territories, the virus was eliminated, often for long periods of time. Even when reintroduced into our larger cities, elimination was again achieved , albeit not before devasting effects in Melbourne in winter 2020. But with those efforts and despite setbacks, we have still one of the lower per capita mortality rates in the world from Covid-19 (here 57 per 1 million people, compared to 2026, 1224, and 2145 per million in the UK, Germany, and the USA respectively by October 11th).

The recent introduction of the delta variant has however changed our ability to stop spread. The virus is now endemic in the largest states in Australia as well as in New Zealand and will continue to be present and spread. But we now have very effective vaccines, and they are being taken up in very high numbers of Australians. Already by early October, in NSW and the ACT we exceeded over 90% first dose vaccine uptake. So, by mid-November, both will have reached 90% or more of those eligible, who will then be fully vaccinated.

Science and innovations have allowed very effective and safe vaccines to be produced, approved and distributed in less than a year after the virus was first identified. We also have developed new drugs and better support for those with serious illness that have decreased hospitalisation and mortality rates.

We developed PCR tests to detect the virus, very early in Australia in our Public Health network. This allowed us to do early and effective contact tracing and quarantine, which helped keep the virus from circulating widely. Globally there are now large numbers of commercially available diagnostics tests, including rapid antigen test, widely available. These were manufactured, approved, and distributed at remarkable speed.

We should be optimistic for the immediate future. By December we will have a very large percentage of the population fully vaccinated. We will, also have much warmer weather with us over the next 6 month and this is when all respiratory virus (including Covid-19) spread less readily than in winter. This all means any restrictions when present, will be much less severe and this will open-up opportunities for us to all have much more interactions and travel, including to some overseas destinations.

# MESSAGE FROM PATRON- His Excellency General the Honourable David Hurley AC DSC (Retd)

Like so many Australians, I have spent the last two months in lockdown – working remotely and via video conference.

It could be easy to focus on the challenges and the things we have missed – we still eagerly await meeting our second grandchild for the first time – but I am an

optimist and I prefer to focus on the positive.

There is much to celebrate in our community and we should never lose sight of that fact.

Linda and I particularly enjoyed the opportunity to meet via video conference with representatives from state and territory branches of the Order of Australia Association. These meetings reaffirmed my long-held appreciation for the work of the Association in the community and its support of the Order of Australia.

From people who have started cooking and delivering meals to those in need, to volunteers in organisations who provide help and comfort, to the men and women on the frontline of the response to COVID-19 – our community has responded to the challenge.

Readers of *The Order* will, I'm sure, be able to instantly recall recent and inspirational examples of Australians putting the interests of others before themselves. It is both apt and timely that the theme of the Association's 2022 National Conference is 'Celebrating service'.

There is much to celebrate in our community. It is important that we take the time to celebrate and to recognise outstanding service and achievement.

I thank all members of The Order of Australia Association for their important work in our community. As we head towards Christmas, Linda and I hope that pandemic restrictions continue to ease and that you are able to re-connect with families in the same room.

# MESSAGE FROM THE PRESIDENT

I heartily endorse the comments of our guest columnist, Professor Peter Collignon, on the great progress we have made in managing Covid 19 and the role modern science has played in it. Science has certainly served us well in the pandemic.

I'm off to my first in person Board dinner for months and it feels good, albeit a bit strange. China is asserting its power in our region. It has enormous economic and strengthening military power.

So, while we should be happy to break free of the shackles of covid, armed with our vaccinations and better therapeutics, there's a lot going on. Hopefully our policy makers can move to focus on these equally existential issues.

In the meantime, I'm set to enjoy my dinner!

## "Let's Talk About" 21.7.21

In the large Meeting Room on the St Louis Estate Claremont on 21.7.21 a number of OAAWA members and Residents of the Estate awaited the guest speaker who failed to arrive. Our Treasurer, Peter Snow OAM stepped into the breach and gave us an entertaining and informative talk on Albany's Discovery Bay Tourism Precinct.

In early 1979 Peter had been on an assignment in the Gold Coast. On his last evening, he met up with former client, Colin Green, from EG Green and Sons (Harvey Beef). They had successfully taken over the Cheynes Beach Whaling Company that operated Australia's last whaling station at Albany and closed it a few months previously as unviable. Along with plant and equipment rusting away and 3 rusty whaling ships, 106 people were put out of work when it closed on November 21, 1978. The final upshot was that Peter, then as Chairman of The Jaycees Community Foundation Inc, was offered the 50 acre site with 6 whaler's cottages and 2 rusting ships. On 12 December 1980 the paperwork for a museum and youth camp was finalised and on 15 December 1980 the Greens gifted the site to the Jaycees Community Foundation.

On 26 December 1980 it was opened as Whale World. Since then, there has been ongoing development with help by many donors, volunteers and Lottery West.

It now comprises Albany's Historic Whaling Station, Australian Wildlife Park, Regional Flora Garden and a 2,000 seat grassed Amphitheatre. Planning for a marine science Eco-village and a pilot site for renewable energy are well advanced.

The project has contributed more than \$40 million to the local economy and won a number of awards. The project is not subsidised and a portion of its operating surplus is applied to the benefit of the wider community.

We learnt subsequently that our advertised speaker had had a bad fall and ended up in Royal Perth Hospital while we were waiting for him.

## Reception for the new awardees in the Queen's Birthday Honours 17.8.21

The RAAFA Club Centre was once again an excellent venue for our Reception honouring the new recipients of the Order of Australia Awards.

At the beginning of the evening a friendly, relaxed atmosphere was created when guests could mingle, enjoy a drink and choose a table in which to sit before the formal proceedings began.

Our Chairman, Bettine Heathcote AM welcomed the new recipients, recognising their achievements and congratulating them.

As Senator Dean Smith, who had hosted the Reception, was unable to leave Canberra as he was in quarantine because of COVID-19 restrictions, the Hon Steve Irons MP was pleased to be able to represent Senator Smith and read his message in which he said he was proud to sponsor the event, recognising that those who received the Order ranged in age from 29 to 100 years old.

Bettine Heathcote AM read out the achievements of the new recipients : six AOs, 13 AMs, and 26 OAMs. The OAAWA Branch was delighted that 45 recipients and their guests were able to join us for the evening.

Our Patron, Hon Kerry Sanderson AC CVO congratulated the new recipients and raised a toast to them.

Thanks, on behalf of the Recipients was given by Ian Trust AO, who had flown from Kununurra to be with us on the night. He was proud to be the son whose Mother was from the Gidja People of Turkey Creek and his Father from the Walmatjari People from Gogo Station. He noted empowering Aboriginal people was a work in progress, it was important to do your best for other people and know your people are right behind you. Your Character is how your family know you and Reputation is what other people think of you.

His speech was succinct and to the point.

Our National Chairman, Barry Nunn AO, who lives in WA congratulated the new awardees. He honoured the 69 recipients in WA, many whom were with us and noted the team work behind them. He said, as did Senator Smith that this award is not a Government but is a Citizen's award. He said the Association is a Federation with eight unique branches. There are 8,000 members, Australia wide, in the Order of Australia Association. He ended his speech with a recommendation that all at the Reception be vaccinated!

A delicious supper was served after the formal proceedings.

During the evening Joy Sinclair OAM did well selling most of the merchandise she had brought and also encouraging donations, all going towards the Scholarship Fund.

#### OAAWA Annual Dinner 2021

Despite a forecast of cold, wet weather 145 braved the elements to attend the Annual Dinner at Royal Perth Golf Club, a record number. It was a very enjoyable occasion meeting up with old friends, meeting new acquaintances with wonderful stories and achievements and good food.

We were welcomed by the Branch Chairman, Bettine Heathcote AM. Grace was given by Frank Crawley OAM. We were delighted to have our Honorary Vice Patron, the Honourable Kerry Sanderson AC, who before raising the toast to the Order encouraged members to make nominations to the Order, especially as WA is under represented in nominations relative to our population numbers. In 2024 WA will host the OAA National Convention in Perth. Bill Hassall AM spoke about the Order of Australian Association Foundation Scholarships. Only two have been awarded to Western Australians Rahul Khubchandani and Ash Hunt. We are planning to raise \$45,000 to fund a scholarship at a WA University to be presented at the 2024 National Conference. Members and those present were encouraged to donate.

The Guest Speaker, Commissioner Chris Dawson APM, spoke mainly about his present role as COVID-19 Vaccine Commander and State Emergency Coordinator.

After 18 months of long hours, he has just come back from a short holiday in the South West of WA where his ancestors came to in 1830. Elijah Dawson, a veteran of Waterloo, was the first policeman in the South West. Chris Dawson is a very true West Australian.

His present role is ever being challenged and he says he is being handed "a curved ball" so it is difficult to plan – there are a "lot of spinning plates" he is presented with. He pointed out how difficult it is with polarised people in our country and beyond our shores.

He pointed out that COVID-19 is not the first pandemic we have faced. Many occur after fighting wars. Smallpox was brought to the State and devastated the First Nation Peoples. He pointed out the story of Jenner who started the first vaccination in England and was soundly denounced by many. The Smallpox vaccination saved countless lives and finally the disease was eliminated.

After WW1 the Spanish Flu was a terrible pandemic, killing more than the war!

He is pleased that we are not calling the delta variant the Indian variant as the Spanish Flu did not originate in Spain! It is wrong to demonise a certain country.

He claimed we are now all epidemiologists and acknowledged the work of the Public Health Physician, Dr Andy Robertson, who is even tempered and consistently gives good advice.

He pointed out the need to protect the vulnerable and his concern that insular communities, with distrust of the police and military, may not want vaccination.

The problems we face are with social media and disinformation.

We do not ask for the efficacy and the side effects of the flu vaccine and all the other vaccines we have!

We live in one of the most privileged areas in the world.

We need to look at what is common and what brings us together and not follow the human trait to look for differences.

The vote of thanks was given by the National Chairman, Major General Barry Nunn AO.

#### Adjunct Professor the Hon Dr Andrew Lu AM

Andrew Lu was appointed AM in the 2021 Queen's Birthday Honours for significant service to the visual and performing Arts, the Law and Legal Education.

Born in Britain of Chinese heritage and to a family hailing from southern China via the British Colonies of Sarawak and Hong Kong, he first visited Perth in the 1980s and fell in love with the blue sky, sunshine and freedom from some of the hierarchy of the British Class System. "It was a good place to run away to!" He returned in the 1990s and enrolled at the Law School of the University of Western Australia where he obtained an LLB before taking a doctorate in Law at The Australian National University. This was where he first began lecturing in law.

He was the first lawyer of Chinese heritage appointed to the WA State Administrative Tribunal. He is also the first Asian-Australian person ever recognised in the Order of Australia for services to Law in Western Australia.

# GIVING BACK TO THE COMMUNITY OF MILDURA AND BEYOND - SHANTELLE THOMPSON OAM

Shantelle's amazing story was shared by the Governor-General's office to showcase the level of achievement recognised by the Order of Australia.

Shantelle Thompson is a proud Barkindji and Ngyampaa women, three time Jiu-Jitsu world champion and mother of five.



She is also now Shantelle Thompson OAM, having being awarded a Medal in the Order of Australia for services to the Indigenous community of Victoria Queen's Birthday 2021. For as long as Shantelle can remember she was determined to break through the cycles of intergeneration trauma and the low expectations and aspiration that have surrounded her community.

"First and foremost I have tried to do this with myself, leading by example, so that my children and family didn't become victims of my trauma and so the cycle didn't continue.

"With the determination to empower others through my own journey, I became the first person in my family to finish school, go to University and start my own business."

Following the birth of her twins in 2009, Shantelle developed serve postnatal depression and began Brazilian Jiu-Jitsu as a form therapy. "I went from trying to harm myself to becoming a world champion, a member of the 2018 shadow Commonwealth Games wrestling team and a member of the National Wresting team."

Throughout her achievements Shantelle has strived to share her story and be an advocate for self-determination, mental health and connection to culture.

"When I was competing at a national level, I was trying to encourage more women to get involved in sport. I was trying to break through and make a change, because when you have a foot in the door, you're responsible for making sure that door stays open. You create a pathway for others to come through."

Shantelle's commitment, drive and passion, not just in the indigenous space but for women and youth has been recognised with Medal of the Order of Australia.

"To know that someone has seen the work I have done and to nominate me for such a prestigious honour – it was really humbling. I also found it really empowering to know that the work I am doing is valued and I can continue to do that work."Giving back to community: Shantelle set up 'Kiilalaana' — a Barkindji word meaning 'growth', a volunteer youth program in Mildura. As a gifted storyteller and skilled motivational speaker, Shantelle runs empowerment and leadership programs in schools and community groups, with a strong focus on women's and girl's empowerment.

But Shantelle says that her work is only effective if she is taking her own advice. "I don't believe you can tell someone they can be or do something, unless I've done that myself," she says.

"We have an inherited responsibility to overcome the trauma and everything that has happened because our ancestors fought really hard so that I could have these opportunities.

She was also a founding member of Community Mental Health Australia (CMHA) working to establish this organisation



nationally.

Kim has many years of leadership and management experience in health and community services including over 25 years' on numerous Boards. In 2017 she was inducted into the Victorian Honour Roll of Women in recognition of her contribution to Mental Health within Victoria and in 2019 appointed a Member of the Order of Australia (AM) for her work nationally. Kim is one of only 5 people in Australia certified to teach Compassion Cultivation Training, an evidence based course created at Stanford University and now delivered worldwide

**The Hon Robert (Rob) Knowles AO** holds commercial directorships at Global Health, Drinkwise Australia, Silver Chain Group and IPG. He was a member of the Victorian Parliament and had responsibility for a number of portfolios, including Minster for Health and Minister for Aged Care.

Rob is also Chair of the Royal Children's Hospital, Commissioner of the National Mental



Health Commission, Chair of the Victorian Health Reform and Innovation Council and Director of beyondblue since September last year.

In 2007, Rob was appointed an Officer of the Order of Australia for service to the community through a range of aged car, mental health, research and cultural activities and his work in the Victorian government.

Notably, she has been a volunteer for Catherine House Inc for the past 17 years, supporting women who are experiencing homelessness, serving as chair of their Trust and as a Community Ambassador, and was a founding Board member for the Roger Rasheed Sports Foundation, working in fundraising and events during that time. Kathryn says that she has "*a commitment to create kinder, more connected communities*", and her aim is to raise the profile of philanthropy and the culture of giving in our community.

For the luncheon held on 28 October, John Phillips OAM gave an address titled: 'SA Waste Strategy 2022-25 – Engaging the Population'. John is Secretary of the SA Branch Committee, a member of the events Sub-Committee and a member of the Student Citizenship Awards Assessment and Selection Panel. He is also a Life Governor of Apex Australia, and former CEO of KESAB Environmental Solutions (1988-2019).

#### STUDENT CITIZENSHIP AWARDS

As a result of a state-wide lockdown, the closing date for this year's Student Citizenship Award nominations was extended to 30 July to allow schools extra time to compensate for the disruption. Each will receive an inscribed plaque and certificate ('With Distinction') at an award ceremony to be held at Government House Adelaide on Monday 29 November hosted by Her Excellency the Honourable Frances Adamson AC and Mr Rod Bunten. The Student Citizen of the Year will be announced at this time.

The Student Citizenship Awards program is the flagship endeavour of the SA Branch. Branch Chairman Tony Metcalf OAM joins with all SA Branch members in congratulating these worthy award recipients, and thanks schools for their strong support of this Branch initiative.

# TASMANIAN DIRECTOR OF THE OAA BOARD – DR ROSEMARY CALLINGHAM AM

Rosemary is enjoying her role as the Tasmanian Director on the OAA Board. To enable you to find out more about Rosemary she was invited to share more about her activities.

I am a retired academic having worked at two universities in mathematics education – educating preservice teachers about teaching mathematics. This career has taken me to some surprising places. I worked with UNICEF in North Korea, helping the Korean educators develop a new primary mathematics curriculum using evidence-based processes. I was privileged to visit the country seven times over the three-year life of that project. More recently I spent a month in Kazakhstan as a visiting scholar at a developing university, working with teacher educators – all of whom were very young by Australian standards! I have also had extended stays in Hong Kong. I have come to realise that the challenges for educators may seem diverse in different places, but that everywhere I have been, teachers at all levels want the best outcomes for their students. The varied encounters that I have been privileged to experience have made me realise the importance of social equity. As a result, I worked with Anglicare Tasmania as a board member for nine years, the last three as chair. The variety of needs and the extent of poverty in Tasmania is confronting at times. Those working directly in the field, regardless of which organisation they work for, go way beyond expectations to support people needing help. I have found that Tasmanians genuinely care about each other and want to support the most vulnerable members of our community, both formally through funded programs, and informally through their own neighbourhood networks.

Since being awarded my AM for services to mathematics education, teacher development and the community, I have taken on the role of the Tasmanian director on the Order of Australia Association national board. The amazing people I am meeting, and the wide range of interests and achievements is genuinely awe-inspiring. I am convinced that the system of Australian honours is unique, and I encourage everyone to consider nominating an unsung hero.

### DR FRANK MADILL AM

Dr Frank Madill AM is the past Tasmanian Branch Nominated Director for the Order of Australia Association from 2018 - 2020. Frank was awarded an AM at the Australia Day Awards in 2014 for his services to Tasmanian Parliament, the community and for his work as a general practitioner. He has given distinguished service to the organisation since receiving that honour. He has actively canvassed members to join the committee and supported the nomination of numerous of recipients. His own long term contribution to so many different organisations is a shining example of selfless service to the community.

A century before the onset of COVID -19 the Australian population was subjected to mask mandates, closures of public services and events, the emergence of quarantine camps, inter-State squabbles and border travel restrictions. Some 12,000 Australians died from the 1918-19 pandemic.

'Hullo! How are you?' is as apt and welcoming a greeting today as it was a hundred years back.

On 6 October an HISTORIC meeting, the first of a kind by the Chancellor the Order of Australia (OA), His Excellency the Honourable General David John Hurley, AC, DSC, FTSE and Her Excellency Mrs Linda Hurley with Queensland Branch Committee members and Regional Convenors was progressed via ZOOM protocol. ## PROFESSOR CAROL POLLOCK AO

Royal North Shore Hospital clinician and Kolling Institute researcher Professor Carol Pollock AO was recognised for her extraordinary contribution to healthcare in this year's Queen's birthday honour roll.

Carol was appointed an Officer of the Order of Australia (AO) for her distinguished service to medical research, education and science, nephrology, and clinical practice and governance.

As a renal medicine specialist and internationally respected academic, Prof Pollock has had a remarkable career as a clinician, researcher, lecturer, mentor and advocate.

Professor Pollock authored over 400 publications relevant to kidney disease and its treatment. She is an inaugural Fellow of the Australian Academy of Health and Medical Sciences (2015) and recognised as a 'Distinguished Professor' by the University of Sydney (2012). In 2014 she was the recipient of the Ministerial Award for Excellence in Cardiovascular Research. She was Scientific Chairman of the 2013 World Congress of Nephrology and is the current Chair of the NSW Bureau of Health Information. She is also a Director of the Photobionics Research Institute, Deputy Chair of the Australian

Organ Tissue and Transplant Authority, Director of Certa Therapeutics, a member of Council of NHMRC and Chair of Kidney Health Australia.

## MEET OUR MEMBERS - MR THUAT VAN NGUYEN AM

NSW Member of The Order of Australia Association NSW Branch, Thuat Van Nguyen was awarded an AM in the Queen's Birthday 2021 Honours List in recognition to his service to the community.

Following the fall of the South Vietnamese Government in 1975, Thuat and his family were able to escape six years later. They ended up in a refugee camp in the Philippines and amazingly, there was a Vietnamese Scout Group in the camp. He had first joined the Scouts when he was 12 years old and went on to form a Rover Crew in his local area in Vietnam. In 1982 Thuat and his family were taken to Germany with other refugees, staying there for the next eight years. He formed a Scout Group where they lived. Through scouting, Thuat learned about multicultural life in Australia, and decided to migrate from Germany with his family to Australia in 1989.

He set up the 2<sup>nd</sup> Bankstown Scout Group soon after arriving in Australia, and the First Canley Heights group in 1992. The growth of the Vietnamese scouting movement in Sydney is one of Thuat's proudest accomplishments, but his biggest life achievement has been the very successful creation of the Children's Festival which has in the past 22 years been successfully staged 35 times in Western Sydney, in Bankstown, Canterbury, Marrickville, Campbelltown and Sydney, attracting a quarter of a million participants and inspiring thousands of volunteers, particularly young people. #### 2005 Scholarship Awardee Dr NICK CLEMENTS

On Christmas Eve 2003, I discovered I'd won an OAAF Scholarship. I was elated, but I had no idea just how much it would help me. In 1997, I'd left school at 15 with poor results and plenty of teenage angst. After an apprenticeship, I travelled for a year before returning at 21 to work as a fitter machinist. Five months in, I broke my back in a diving accident and had to say goodbye to manual labour. In 2004, I enrolled in an arts degree at Utas, waddling into my first lecture in a full body brace. I fell instantly in love with learning, specifically with history, philosophy, and Aboriginal studies. It's hard to explain, because I was so often disengaged from high school, but to this day passion for learning is my strongest personality trait.

It didn't hurt that I was doing well. By the end of my first year, I was receiving top marks in all subjects and then, to my amazement, I was considered worthy of the country's most reputable Scholarship. It felt utterly surreal – I'd always considered myself dumb but now I felt capable of anything. And because I now had the financial means, I could throw myself at my studies in earnest.

My volunteer work was something the OAAF considered when awarding me the Scholarship in 2005, and I continue to volunteer on Aboriginal initiatives and most recently a school board. My luck in life has been extraordinary, and like those who support the Foundation, I believe in spreading that around.

In 2006, I graduated with majors in Philosophy, History and Aboriginal Studies. The next year was Honours. Working under Prof/ Henry Reynolds, I examined Aboriginal representation in the press during Tasmania's Black War (1823-31). After a year abroad in 2008, I started a PhD, looking at experiences and motivations on both sides of the Black War. It became <u>The Black War: Fear, Sex and Resistance in Tasmania</u> (2014), which has sold 8000 copies and been shortlisted for several awards.

I was married in 2013 and, desiring a more settled life, I became a high-school teacher and had two children. I love my work and my family and consider myself very fortunate on both counts. I swore I'd never write again.

That was until 2018. Enter Henry Reynolds and the idea for a co-authored book about an unknown but remarkable resistance leader. I couldn't say 'no' to working with the guru once more. I went part time and pulled my historian boots back on. In August this year, we published <u>Tongerlongeter: First Nations Leader and Tasmanian War</u> <u>Hero</u>. The first print run sold out in four days, and the response from all corners has been incredibly gratifying.

We wanted to give Tongerlongeter the recognition he deserves and to advance the movement to commemorate frontier wars and memorialise their heroes and victims. This book will go a long way towards achieving that. This makes me feel like I've made a difference. I hope it makes those who work so hard to raise money for

Scholarships like mine feel they too have helped in a small way to better the world, and in a big way to better the lives and opportunities of the growing number of young people they support.
