Over the past few years, she has been a prime mover in our efforts to encourage more nominations for women, and we thank her for her time and energy.

## 2021 ACT STUDENT CITIZENSHIP AWARDS

The Student Awards are an important community outreach for the Association to acknowledge and reward good citizenship in the ACT student body. Following last year's COVID-19 hiatus for the ACT Branch Student Awards, the Branch has awarded the following students with commendation certificates after consideration by the judging panel of the 2021 nominations from schools and colleges.

- Jake Johnson (Year 5) and the school's 'Children's Parliament', from the new Margaret Hendry Primary School in the suburb of Taylor, were awarded Certificates of Commendation for sustained community service at their school. Jake has demonstrated leadership skills in helping younger children and working in the school's grounds presentation. The seven children elected to the 'Children's Parliament' volunteer their time to positively effect change through community service, which improves conditions for all at Margaret Hendry School.
- **Carl Thygesen (Year 5)** is a student at St John Vianney's Primary School, Waramanga. Carl is regarded as a valued and reliable helper who strives to help and serve others in the local community and through dedication, Carl demonstrates excellent service to his church community. His outstanding efforts have been recognised with a Highly Commended Certificate.
- Sophie Thorp (Year 12) and Sam Harding (Year 12) are students from Canberra College and have demonstrated outstanding and sustained student leadership throughout their high school years and especially in college during the COVID-19 outbreak. They made significant contributions to building a vibrant and cohesive student community at a time when students were facing the challenges of learning in isolation. Both have been awarded Highly Commended Certificates.

The Branch appreciates the work by Student Awards coordinator Dr Bill Maiden PSM, OAM and fellow judging panel members, Elizabeth Grant AM, Narelle Hargreaves AM, and Trish Keller OAM, to make the awards program a success.

## **BRANCH NOMINATED DIRECTOR'S REPORT**

The Board met online on 20 August and ongoing COVID-19 concerns will force the December meeting online as well. Some 18 months after taking up my position, I still have not met most of my Board colleagues in person!

There was good financial news for members as COVID does not seem to have harmed the Association's financial position. We have a consolidated profit for FY20/21 of \$78,935 which enabled the Board to increase our funds invested by a further \$50,000 in July and to move \$200,000 of our cash holdings into higher earning accounts on the advice of our financial advisor.

The news was not so good on membership. A review of the data on conversion of OA recipients to OAA members shows a downward trend from 2018 to 2021. There was a general discussion on how to address this issue.

There was some discussion on risk management. Following consultation with the branches, a more comprehensive plan had been drawn up, which with some minor modifications, was agreed by the Board. Charters for the Constitution and Scholarship Committees were received and adopted.

The Board considered a report on planning for the 2022 National Conference by the ACT Branch and noted that this is progressing well.

The Board discussed the selection and handover procedure for a new President to replace Heather Ridout AO at the end of her tenure next year. It was agreed that Heather would Chair the 2022 AGM with the incoming President taking up the role at the conclusion of the meeting.

The Board decided that the National Futures Day planned for December would now be held in conjunction with the 2022 Conference, and that branches may apply for up to \$1,000 to support planning for this event.

### Mrs NERIDA CULLEN OAM

New member Nerida Cullen was recognised in the 2021 Queen's Birthday honours with a Medal of the Order of Australia *for service to the community of Goulburn* and followed earlier recognition in 2013 as Goulburn Woman of the Year.

Nerida said she is motivated by the enthusiasm, generosity and resilience of those she interacts with. "Country towns by their nature encourage people to contribute to the vitality and viability of their communities, otherwise these communities stagnate. It has been my privilege to contribute to the ongoing success of Goulburn and rural and regional NSW."

Nerida has been active in many aspects of community work including

fundraising for Goulburn Hospital. She is President of the BDCU Goulburn Hospital Fundraising Inc which has raised over \$400,000 for needed equipment and has been a member of the Community Consultative Committee for Goulburn Health since 2015. In the Education field she has been a Board Member of the Country Education Foundation of Goulburn and District, former President of the Board of Southern Tablelands Community College, and former President of Goulburn Rostrum Club.

Nerida has also served as a member of the Community Advisory Group, South-East Local Land Services and is a former Director and Deputy Chair of the Goulburn Rural Lands Protection Board and its successor, the Tablelands Livestock Health and Pest Authority. She is on the NSW Farmers Goulburn Branch executive committee and has also been a board member of TALGA (The Australian Lavender Grower's Association) promoting this emerging industry. Nerida has been a member of the Goulburn Agricultural, Pastoral and Horticultural Society since 2003 and is now Patron.

She is a former Director for the ACT/New South Wales branch of *Australian Women in Agriculture* which is committed to ensuring that women influence the agricultural agenda.

Her support for rural women was shown with her positions as former Co-Chair and Member of the State Advisory Committee, Rural Women's Network and Co-Chair and Member of the New South Wales Rural Women's Council from 2011-2012. She has also been active in the local Country Women's Association branch and was President of Soroptimist International Goulburn.
