Our future is in good hands

With inspiring young speakers at our virtual lunch on Wednesday November 24 we agree our future is in good hands. Thank you to Trevor Clark OAM Deputy Chair VIC Branch who was the MC.



The first two speakers Jade Hameister OAM and Paul Hameister OAM, father and daughter talked about their polar explorations including the Polar Hat Trick

In April 2016 at the age of 14, Jade Hameister became the youngest person in history to ski to the North Pole from anywhere outside the last degree.

That year she was recognised by the Australian Geographic Society as Young Adventurer of the Year and

her journey was captured in a National Geographic Channel documentary that aired in 170 countries in late 2016.

In August 2016 she delivered a TEDx Talk on why we need to shift the focus for young women from how they appear to the possibilities of what they can do.

In June 2017, aged 15, she became the youngest woman to complete the 550 km crossing of Greenland, the second largest ice cap on the planet unsupported and unassisted.

In January 2018, aged 16, Jade skied 600km from the coast of Antarctica to the South Pole unsupported and unassisted via a new route.

In finishing this incredible journey, Jade set a number of world records including:

- The youngest person to ski from the coast of Antarctica to South Pole unsupported and unassisted
- The first Australian woman in history to ski coast to South Pole unsupported and unassisted
- The youngest to ski to both Poles; and
- The youngest to complete the Polar Hat-Trick.

In 2018, she delivered a speech on climate change at the Vatican as the Oceania Youth Representative and met the Pope.

In late 2018, National Geographic Channel released a featurelength movie of Jade's polar journeys focussing on global warming.

Also in 2018 Pan Macmillan released a book that Jade authored seeking to also educate young people on climate change (also published in the USA).

At the end of 2018 Jade won the Australian Geographic Society Award for Young Adventurer of the Year for a second time and her award was presented to her by Prince Harry.



November 24 virtual lunch continued:

In the 2019 Queens Birthday Honours, Jade was awarded an Order of Australia Medal for service to Polar Exploration

Jade is currently 20, has finished her second year of a combined Bachelor of Commerce and Global Studies at Monash University.

Paul Hameister OAM is best known as "Jade's dad".

As well as accompanying Jade on her polar expeditions, Paul has climbed the Seven Summits



(including Everest in 2011) and completed a 1,000km expedition through unexplored Amazon jungle sponsored by the Australian Geographic Society with his then 14-year old son in 2018.

Paul is an ex-lawyer and investment banker.

He is Executive Chairman of property development group, Hamton, which he founded in

2005. Hamton has completed or current projects approaching \$4billion in Melbourne's inner and middle ring suburbs.

Hamton is currently the development partner for Moonee Valley Racing Club and North Melbourne Football Club.

Paul has a range of other business and charitable interests.

In 2021, he received the Melbourne University Faculty of Business & Economics Alumni of Distinction Leadership Award.

In the 2019 Queens Birthday Honours, Paul was awarded an Order of Australia Medal for service to Exploration and Business.



November 24 virtual lunch continued:

Our third speaker was the Order of Australia Association Foundation 2018 Scholarship recipient Hannah Gandy.

This year Hannah completed a Bachelor of Laws/ Bachelor of Arts (Politics) with a high distinction in both degrees at La Trobe University and will be admitted as a lawyer early next year.

She was awarded the Order of Australia Association Foundation Scholarship in recognition of her work with youth, and was mentored by former Prime Minister The Honourable Julia Gillard AC.

Hannah is still doing community work. COVID really presented challenges in working with young people face to face; she was proactive in her approach. Working as a youth worker for Banyule, she created resources about how young persons can keep positive during lockdown and how to access mental health services.



She continued to run community events when the restrictions allowed, and has worked online to help keep people and kids active with skating through lockdowns by posting tutorials and challenges online for them to stay connected.

In addition she has been volunteering for Legal Action for Afghanistan doing offshore visa applications.

Hannah recently started assisting a Barrister in discrimination law research, and is still working at the Fair Work Commission.

September next year Hannah is off to London to continue her studies.

The General Sir John Monash Foundation last month announced the 18 recipients of its 2022 scholarships, Australia's most prestigious postgraduate overseas study program.

Among the recipients is Hannah Gandy. She plans to study a Master of Laws specialising in Law and Social Justice at University College London.

She is passionate about improving the lives of disadvantaged young persons through law and understanding how law impacts youth in areas like education, employment, health, and through family and criminal law.

The General Sir John Monash Foundation received 245 applicants and conducted 115 first round interviews and then 40 national interviews to determine the final 18 recipients.

The scholarship selection criteria include demonstrated excellence in their field, leadership ability and a vision to deliver a positive impact for the benefit of Australia.

Hannah has spoken at various Order of Australia Association VIC Branch events as an OAA Foundation scholarship recipients, I known many of our members will follow the next chapter in her life as she heads to London. We wish her success and welcome the opportunity to hear from her again after she returns.

Vivienne Ritchie AM


Vivienne received her AM for significant service to the Anglican Church of Australia, and to the community. Vivienne has been actively involved serving in many roles some listed below:

- Victorian Probation Officer, 25 years. Member and Supporter, since circa 1970s.
- Melbourne Recital Centre, since 2013. · Supporter, Melbourne International Chamber Music Competition, current. · Bequestor and Supporter, Australian National Academy of Music, current. · Former Supporter, Musica Viva, Melbourne.
- Delatite Winery · Co-Founder, 1968

Vivienne, from Mansfield says that most local people were surprised by her honour; being unaware of the confidential voluntary work she was undertaking along with her other volunteer roles.

Not only was she doing welfare work for Red Cross 3 days per week but she was also taking on a confidential role of Probation and Parole for 2 days a week.

Having studied psychology and criminology for several years, Vivienne was approached by the Victorian Government to take on this role.



After counselling the probationers and their families, only one young man, on probation with Vivienne, ended up in gaol. A great testament to the probationer's determination and Vivienne's contribution.

She now insists that when she meets them, lately, they are delighted to introduce her to their own families, which has been immensely rewarding.

The local Shire Council were advised about this confidential role only after the award was announced.

Clive Walker OAM

As per all of us, the award came out of the blue, for services to the Myrtleford Community.

Over time I have been involved with the service Club, Apex, both in Healesville then Myrtleford and later, Rotary International. I was on hospital Boards of Management at Healesville, Myrtleford and Alpine Health. Rostered to deliver meals on wheels, and lately, Myrtleford Men's shed where I



have been secretary Treasurer for 10 years. I am treasurer of the Myrtleford Uniting Church and have been most useful to many groups in Myrtleford, writing submissions for grants.

I am sure this service culture was instilled in me from a young age, as my father and mother were great supporters of their local community.

My profession was Local Government Engineer, and in a small municipality it could also be considered as a Service club in some aspects of its' community role.

The question "of what it meant for me" – It's hard to answer – still hasn't really sunk in yet. When people talk to me about the award, I answer by saying "I yelled the loudest" to get things done. But we all know that it's the support of people around you that make things happen.

Now to replace our generation - young people of today, I believe, are

interested in project-based programs. They will give their all for a cause they believe in, rather than "being on a committee" or in a "club". The 2009 bushfires are an example where young people developed ideas and projects to help recovery.

So, thank you to the people of Myrtleford who thought I was worthy of being nominated for the OAM.

A moment with 'the father of Australian diamonds'

Geologist Ewen Tyler AM discovered all three of Australia's diamond mines – Argyle and Ellendale in Western Australia, and Merlin in the Northern Territory.

Acting against conventional wisdom, Tyler spent the better part of a decade searching Australia's vast interior for diamond-bearing kimberlites (ancient volcano 'pipelines' filled with diamonds) where none had looked before.

On the verge of having his funding withdrawn, Tyler's team finally found a diamond in a rock sample – but the journey was only beginning. Here, he reflects on the miraculous Argyle story and predicts the future of diamonds in Australia.

How does it feel to look back on the life cycle Argyle project? It's been a life's journey. I started the search in 1969 and we found Argyle in 1979. We constructed the mine and brought it to production. At one stage it was producing 40 per cent of the world's natural diamonds.

They might not have been top quality, but nevertheless, we had 10 times more diamonds in a tonne of rock than the average, so we were laughing really!



I retired from Ashton Mining in 1990, though I kept an involvement with Argyle until 2002. It was a very, very exciting time – a once-in-a- lifetime affair. And really, from my 45th birthday when we found the first diamond, my life has never been quite the same.

I've become known as the 'father of The Australian diamond industry', which is nonsense in one sense – but its right in another sense. Without me starting it, it wouldn't have gone anywhere

What is your fondest memory from the project?

I think the fondest memory is the discovery of the first diamond, on the evening of my 45th birthday in 1973. It was nowhere near Argyle but it represented a milestone in exploration. We had not had any confirmation that there were any diamonds in the Kimberley.

There had been rumours – one story was that there was a chap in the 19th Century who had taken some diamonds to show an abbott at a monastery – but there was nothing on paper that told me that diamonds had ever been found in the Kimberley before.

We'd found a few pieces of chrome diopside a few months before, but to actually find a sample not only with indicator minerals, but a diamond in it, showed we were on the right track. It took us a long time though – it was six years before we stood on the Argyle site.

The other great day was when we crushed the first tonne of ore. I sent a case of Champagne to the engineering team!

Did you ever have any doubts, or any moments when it seemed like it might have all ended?

If we hadn't found the diamond on my birthday, I was expecting to be chucked out of Tanganyika Holdings the following Christmas. I'd more or less got my marching orders.

The money was going to dry up; they were more interested in doing something in the North Sea than continuing to back me. That was the first major hurdle – and there were a lot of hurdles.

There was another when people said, "It's no good buying Australian diamonds – they will all explode if you put them on the polishing wheel." The press were very unkind to us. If you can't sell your product and everyone is against you, it's hard to keep up enthusiasm.

There were lots of government problems too; when we first established the project and were showing alluvial diamonds, the West Australian government was of the opinion they were worth twice as much as they were, so we paid a very substantial royalty.

The government also tried to tell us we couldn't do fly-in-fly-out, saying it would cost us \$50 million to avoid building a town at the mine.

We could have walked then.

When was the first pink stone found at Argyle?

It was something that came out of the alluvial production, before we began mining. Bill Leslie [legal representative in the early years of the project] claims to have one of the first pink diamonds from Argyle but it was not something that we recorded because pinks were a very, very small percentage of the diamonds.

Talking about the pinks made people aware that we had a mine, and we only showed them once per year. While it wasn't part of the equation at the start, the pink diamonds have created the market and awareness of the Argyle Mine itself.

What do you think about the future of diamond mining in Australia?

I am absolutely convinced there are more diamonds. In fact, I'm a participant in the continuing diamond discovery about 600km south of Argyle. The first diamond mine we discovered was Ellendale; though we didn't mine it, others found there was a market for Ellendale yellow diamonds.

It's the same at Merlin in the Northern Territory – another mine we discovered, and mined for a period. It has been shut down but I think there is some stirring to see if it can be brought back.

Is there any chance more pink diamonds will be found in Australia?

I think there are, and I'm looking for more! We've got signs of them occurring all around Merlin, some signs around Ellendale, but not much around Argyle.

As a nation, I believe that we've got to keep exploring. It's the nature of this continent we started off with gold – Melbourne wouldn't exist without the 1850 Gold Rush. It's more about finding people who are willing to join this lunatic search! As they say, people who look for diamonds have rocks in their heads – but it's a lot of fun.

The Honourable Sir James Gobbo AC CVO QC 1931-2021

Sir James Gobbo's parents migrated to Australia in 1938 when he was seven.

After graduating from the University of Melbourne, Sir James received a Rhodes scholarship and left Oxford with a BA and MA.

He was appointed to the Supreme Court of Victoria in 1978 and was knighted in 1982 for his services to the community.

He was again honoured for service to the law, multicultural affairs and hospitals by the award of Companion of the Order of Australia in 1993.

After retiring from the bench, he was appointed Lieutenant Governor of Victoria and Governor of Victoria in 1997; the first person of non-English speaking background to be appointed to that office in Australia.

Sir James served as the chair of the Council of the National Library of Australia, the Australian Multicultural Foundation, the National Advisory Commission on Ageing and served on the Council for the Order of Australia. He was generous with his time and knowledge. His legacy will live on. Our thoughts are with Lady Shirley Gobbo and family.

A state funeral to pay tribute to The Honourable Sir James Gobbo AC CVO QC legacy and contribution to the Victorian community was held Tuesday November 16 at St Patrick's Cathedral.
