STUDENT CITIZENSHIP AWARDS 2021 'With Distinction'

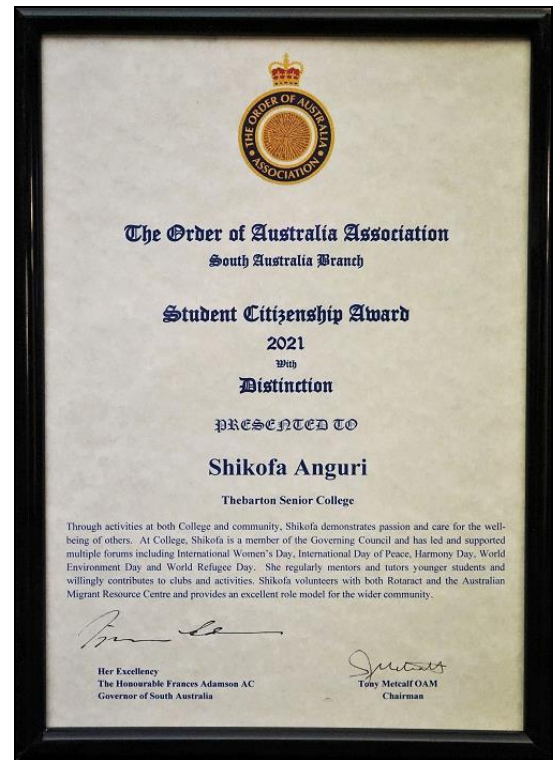

IMPORTANT NOTICE – VACCINATION REQUIREMENTS Severe Acute Respiratory Syndrome Coronavirus 2 (SARS-CoV-2)

The National Board of the Order of Australia Association decided on 10 December 2021 that only *fully vaccinated* Association members and guests, visitors and volunteers should attend Association meetings, events and activities. This decision was made in recognition of the Board's duty of care to all attendees to ensure that they are not exposed to preventable risk.

This decision forms part of the Association 'Health, Safety and Welfare Policy' and 'Health Safety and Welfare Procedure'.

It will now be a requirement when attending an event to acknowledge your status as fully vaccinated.

On arrival at the event, the SA Branch or the venue may require you to provide documentary evidence. It is recommended that you carry the necessary document or electronic certificate to meet any venue inspection requirements – any specific safeguards imposed by SA Health or the venue must be observed.

Partially vaccinated attendees will be permitted to attend SA Branch meetings, events and activities only until 31 March 2022, subject to any venue or other State government restriction.

This requirement does not apply to those with a valid medical exemption, nor currently to children under 12. Evidence of exemption may need to be provided.

Dr Aileen Connon AM MD

Aileen Connon graduated in medicine at The Queen's University of Belfast, Northern Ireland in 1954, and in 1963 became a Doctor of Medicine (University of Liverpool). After her retirement, she returned to study and gained a Master of Arts (Anthropology) from the University of Adelaide in 1995.

She was invited to apply to the University of Adelaide as a Lecturer in Obstetrics and Gynaecology, and she moved through the academic ranks including the position of Associate Dean of the Faculty of Medicine.

Aileen was appointed a Member of the Order of Australia in the 2005 Australia Day Honours List:

"For service to public health and medicine, particularly through organisations to improve available health care for women and children, and to medical education".

To honour her mother Lottie, who died before the award was made, Aileen approached the University of Adelaide and in 2007 established the "Lottie & Aileen Connon Scholarship". This scholarship is awarded annually to two second-year students, one in Medicine and one in Dentistry, to provide financial assistance to assist in meeting educational and living costs for one year.

Aileen will be speaking on the topic of "The Life and Times of Robert Burns (1759-1796)" – who was known variously as Rabbie Burns, the Bard of Ayrshire, the Ploughman Poet and the national poet of Scotland.

After his death, Burns became a cultural icon in Scotland and among the Scottish diaspora around the world.

On this occasion, the Lieutenant-Governor of SA Mr Bruno Krumins AM was officiating, on behalf of Her Excellency Marjorie Jackson-Nelson AC CVO MBE who was ill with mumps. Mr Krumins served as Lieutenant-Governor on sixty separate occasions between 2000 and 2007.

He had been appointed a Member of the Order of Australia in the 1986 Australia Day Honours List, *"For service to Ethnic Affairs and to the Latvian Community in Australia"*, and in 2001 received the Centenary Medal, *"For service to the state as Lieutenant-Governor of South Australia"*.

Jubilee Medals

A Brief History, Part 6

This month on 6 February, the 70th anniversary of Queen Elizabeth II's accession to the throne is being celebrated throughout the Commonwealth.

Following long-established precedent, this milestone will be marked in Great Britain and parts of the Commonwealth through the awarding of a Jubilee Medal.

Queen Elizabeth II Golden Jubilee Medal (2002)

A Golden Jubilee Medal was issued in 2002 as a personal souvenir to mark the 50th anniversary of Queen Elizabeth's accession to the throne on 6 February 1952, as the fourth monarch of the House of Windsor, following the death of her father King George VI. There were some 400,000 medals awarded.

The medal was struck at the Royal Mint, in gold-plated cupronickel, 32 mm in diameter and with a ring suspension. The medal was issued unnamed, in a white cardboard box. The obverse bears a crowned effigy of Queen Elizabeth II wearing the St Edward's Crown facing right. The reverse of the British and Commonwealth pattern medal bears the Royal coat of arms flanked by the years '1952' and '2002'. There was also a uniquely Canadian version of the medal struck, using the same suspension ribbon.

The offer of this medal was not accepted by Australia or New Zealand, so the only Australian recipients were three senior military officers and a small number of dignitaries. In addition, two living Australian Victoria Cross recipients received the medal as a personal gift from the Queen.

Queen Elizabeth II Diamond Jubilee Medal (2012)

On 6 February 2012, Queen Elizabeth II became only the second British Monarch to celebrate a Diamond Jubilee. A British and Commonwealth jubilee medal was struck in silver, 32 mm in diameter, with a ring suspension. The obverse bears the effigy of the Queen, crowned with a tiara and facing right. The reverse bears a faceted hexagon with a crowned Royal Cipher. The medal was issued unnamed, and was despatched in a red cardboard box.



The Queen Elizabeth II Golden Jubilee Medal (2002) was despatched to recipients in a Royal Mint white cardboard box. The lid bears the Royal Cipher of Queen Elizabeth II surmounted by the St Edward's Crown; the inside of the lid bears the crest of the Royal Mint.

The same medal was awarded in the eight Commonwealth realms in the Caribbean – Antigua and Barbuda, The Bahamas, Barbados, Grenada, Jamaica, Saint Kitts and Nevis, Saint Lucia, and Saint Vincent and the Grenadines – but with a central black stripe on the ribbon.

There were 523,000 medals awarded in the UK and its overseas territories. There were an additional 60,000 awards of the distinctive Canadian medal.

Again, the offer was declined by Australia and New Zealand. The only Australian recipients were one living Victoria Cross recipient, three living Victoria Cross for Australia recipients and five Cross of Valour recipients, accepted in each case as a personal gift from the Queen.

Jubilee Medals

A Brief History, Part 7

In 1952, Queen Elizabeth became head of the Commonwealth and Queen Regnant of seven independent Commonwealth countries – the United Kingdom, Canada, Australia, New Zealand, South Africa, Pakistan and Ceylon.

Between 1956 and 1992, the number of realms varied as territories gained independence, and as various realms, including South Africa, Pakistan and Ceylon (Sri Lanka) became republics. Today, Elizabeth II is Queen of the United Kingdom and fifteen other Commonwealth realms.

Queen Elizabeth also holds the title of Duke of Lancaster. In the Channel Islands and Isle of Man, which are Crown dependencies rather than separate realms, she is known as Duke of Normandy and Lord of Mann, respectively.

Queen Elizabeth II Platinum Jubilee Medal (2022)

Significant events during the Queen's reign have included the celebrations of her Silver, Golden and Diamond Jubilees in 1977, 2002 and 2012 respectively, while in 2017 Queen Elizabeth became the first British monarch to celebrate a Sapphire Jubilee.

Following precedent, the 70th anniversary of Queen Elizabeth II's accession to the throne is being marked in Great Britain and parts of the Commonwealth through the awarding of a Platinum Jubilee Medal.

The medal was designed by Timothy Noad of the UK College of Arms, and will be struck in nickel-silver.

This Medal will be awarded to serving frontline members of the police, fire, emergency services, prison services and Armed Forces who have completed five years' service on 6 February 2022, as a token of the nation's thanks to those who diligently serve the public.

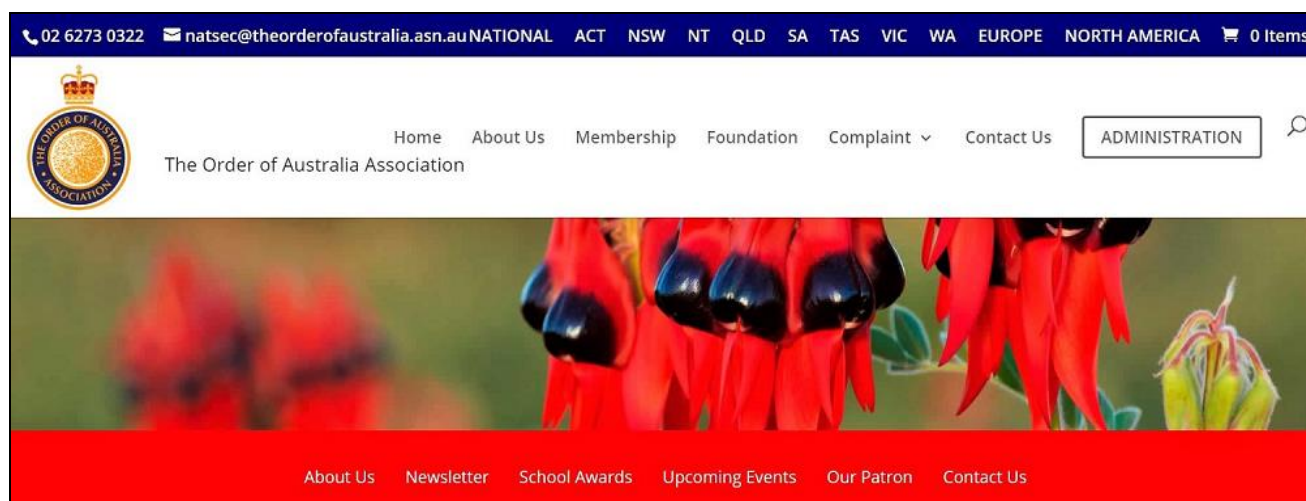
It will also be awarded to individual Victoria Cross and George Cross recipients, and members of the Royal Household with one year of qualifying service.

The Australian honours and awards system falls under the responsibility of the Department of Prime Minister and Cabinet. As early as April 2021, the Honourable Ben Morton MP, Minister Assisting the Prime Minister and Cabinet and Special Minister of State advised that, based on the precedent set on Her Majesty's 50th and 60th Jubilees, the Australian Government was making no plans to issue a commemorative Platinum Jubilee Medal.

The Minister has however confirmed that the government will be celebrating the Jubilee in a manner that is a worthy tribute to The Queen, including the release of commemorative stamps and coins, lighting the Queen's Platinum Jubilee Beacon in Canberra and illuminating monuments around the nation. Lake Burley Griffin's Aspen Island will be renamed "Queen Elizabeth II Island" for a special event in June.
