At a function at Government House the top ten students receive an inscribed plaque and certificate and the student-citizen of the year is named.

AN HISTORICAL PERSPECTIVE

Inaugural Scholarship Recipient 2004

I have recently had time to reflect on my career development since being the inaugural scholarship recipient in 2004. Some 18 years later, I am able to more fully appreciate the impact the scholarship has had on my life. Growing up in the bush I was limited to the impact of medical services had on rural communities. The financial support of the scholarship allowed me to drop my part time jobs that were filled in around the onerous hours of medical training. This then enabled me to participate in honours and research projects, following my CV in papers and referees which aided in the competitive process of applying for surgical training. As a medical student I had decided, naively, that I wanted to be a rural ENT Surgeon. I can say with certainty that this would have been extremely difficult without the support of the Foundation which not only encourages potential leadership and community involvement but provides the financial means to assist young people in achieving their dreams. The OAA Foundation scholarship was unique at the time in allowing the recipient to direct the financial support. Although there were other scholarships that specifically targeted medical students wanting to work rurally, the bonded nature of these would not have supported the constant movement required throughout my specialty training, therefore making me ineligible. My mentor, Dr John Yu, understood that the vocational nature of medicine was best supported by the scholarship being able to reduce other stresses such as rent and cost of living, allowing me to focus on my studies.

I am very fortunate to now be doing a job that I love which allows me to contribute to my community. I am involved in outreach programs for indigenous and rural health and also am an investigator for an NH&MRC application to develop a Flexible Automated Hearing Test that can be utilised in rural and remote communities. I am still involved with Stirling University's School of Rural Health as the Surgical Coordinator for our medical students. I am constantly learning from our trainees and am overwhelmed by the calibre of the applicants' CVs for our training positions. The flexibility of a rural lifestyle and the satisfaction of working with my hands is something that I hope I can foster in future trainees.

My career as a regional ENT surgeon is extremely satisfying but not without its challenges, including onerous hours, excessive on-call and the tedium of distance synchronous with rural healthcare. The culture of the surgical profession is slowly evolving to meet the expectations of both its trainees and modern society. The intensive demands on trainees entering the profession will hopefully be met with an increased focus on the mental and physical health of our junior doctors. The work we perform is hard but the job satisfaction is high and I feel privileged to be able to contribute to the health and well-being of my community.



### LIEUTENANT-GOVERNOR

**Dr James Muecke AM**

The Department of the Premier and Cabinet recently announced that Dr James Muecke AM would be the next Lieutenant-Governor of South Australia. He was sworn-in on Thursday 27 January 2022.

Dr Muecke is an accomplished Adelaide-based eye surgeon. He was appointed a Member of the Order of Australia in the 2012 Queen's Birthday Honours List, *"For service to ophthalmic medicine, to the provision of eye health services and rehabilitation programs for Indigenous and South East Asian communities, and to professional organisations"*.

Dr Muecke was the Australian of the Year for 2020, in recognition of his 32 years of humanitarian work. He used this platform to raise awareness of poor diet laden with sugary drinks and ultra-processed foods, which is devastating the health of Australians.

The role of the Lieutenant-Governor is to support the Governor of South Australia and is appointed as the Governor's Deputy when the Governor is absent or on leave. See more here:

### MR NOEL HENDER OAM CSTJ BEM National Emergency Medal with clasp, "BUSHFIRES 19-20"

Congratulations to SA Branch Deputy Chairman Noel Hender who has received the National Emergency Medal with clasp "BUSHFIRES 19-20" for having rendered eligible service with St John Ambulance SA during the Black Summer Bushfires on Kangaroo Island.

The medal was presented by Her Excellency the Honourable Frances Adamson AC, Governor of South Australia in a ceremony held at Unley Town Hall on 20 December 2021.

In Her Excellency's address, she noted that 141 St John Ambulance SA staff and volunteers provided service during the 2019-20 Black Summer Bushfires at multiple sites throughout SA, with 45 members meeting the criteria to receive the Medal.

The **National Emergency Medal** was created by Her Majesty The Queen of Australia through Letters Patent dated 23 October 2011.

This medal provides recognition within the Australian Honours System for the committed and courageous efforts of frontline responders, volunteers and community supporters during nationally-significant emergencies within Australia.

It complements the Humanitarian Overseas Service Medal, awarded for humanitarian service overseas in hazardous circumstances.

To be considered for the award of the National Emergency Medal with a specific Clasp, applicants must have rendered eligible service during the 'Response' phase – this refers to action, assistance and intervention during a declared emergency. The focus of direct response is on saving lives and protecting community assets (properties and infrastructure). Applicants must meet specific criteria relating to dates of service, type of service, location of service and length of service. Service during the 'Recovery' phase is not considered as eligible.

The Black Summer Bushfires emergency of 2019-20 was declared on 2 December 2020 for the purpose of the National Emergency Medal, and the Declaration included information on areas, dates and eligible service.

The National Emergency Medal is worn in precedence after such awards as the OAM, the Order of St John (all grades), decorations, and war, campaign, active service and service medals. It is worn ahead of coronation, jubilee, remembrance and commemorative medals (such as the Australian Sports Medal and Centenary Medal) and all long service medals (including the National Medal).

### NATIONAL EMERGENCY MEDAL Award Ceremony, 20 December 2021

These are some excerpts from the address by Noel Hender (right) who spoke on behalf of the St John Ambulance volunteers about their Bushfire response experience.

St John SA has a functional agency role within the State Emergency Management Plan and through this, St John volunteers provide a 24/7 service to respond in times of major bushfire or significant emergency incident.

When the State Emergency Centre was activated 2 years ago to the day, on December 20, 2019, in response to the Cudlee Creek fire, St John appointed a liaison officer to the State Control Centre at SAAS who provided a communications link with the St John Operations and Communications Centre.



It was through this emergency management structure that our Incident Management Team ensured the ongoing planning, rostering, and management of our first aid teams, who were the volunteers deployed from Divisions across the State. Forward commanders were deployed to provide local leadership at the Zone Emergency Support Centre at Mt Barker, for our respective teams in the field. By collaborating with the Incident Management Team, the Forward Commander was able to integrate our services with other local resources and deploy them as required across the fire region.

For the Adelaide Hills fires, multiple Mobile First Aid teams were deployed to provide continuous first aid, minor medical and health care support at the active CFS staging posts.

Fortunately, the Adelaide Hills fires were contained and controlled when fires which had been burning for a few days on Kangaroo Island, escalated in early January after multiple lightning strikes across the Island.

As the weather dynamics changed and the emergency continued, St John was called upon to provide personnel to assist at the Emergency Relief Centres which had been established at Modbury and Gumeracha to accommodate the families displaced from their homes in the fire zone.

Concurrently, first aid teams were required in KI, firstly flying, and later travelling by ferry, to assist with the catastrophic fires that were steadily spreading across 50% of the Island.

On their arrival, our first attending members found things over there to be fairly chaotic, with many locals on the Island feeling overwhelmed by it all. Slowly the emergency services were able to establish themselves and began to contain the fires with the main staging post operating firstly at Parndana, and later from the safer site at the Kingscote airport.

With the arrival of the Defence Force, a field hospital was established at Parndana whilst St John continued to provide a 24-hour treatment centre at Kingscote airport until the fires were declared to be out after heavy rains flooded parts of the Kingscote staging point on 30 January.

Importantly, we should appreciate that throughout this total response phase, our responders in the field had been regularly and reliably resourced and supported by our hardworking logistics team and Event Health Services staff.

The clear focus for our members was to facilitate or to be in the field to care for and support individuals whose health and general well-being were impacted by the bushfires.

However in so doing many of our members found themselves confronted not only by a variety of trauma and medical issues, but also with stressful situations involving individuals experiencing significant mental health issues triggered by the misery, grief and devastation surrounding them.

Fortunately, the St John team leaders were invited to attend the daily Zone briefings with the Incident Management Team and other services, and thus were able to highlight any operational issues that were concerning us.

These meetings enabled us to connect directly with the local hospital and thus refer any service personnel or the public who presented to us, for further and ongoing support.

The presence of our members, although only temporary, was greatly appreciated by the locals.

Our members gained great personal satisfaction from being able to make a positive difference for those many local and emergency service personnel who benefitted from our service and told us how much they valued our presence.

Any minor discomforts we may have encountered during our placement paled into insignificance when we looked around and saw the resilience of the local people amongst the devastation and loss they had experienced.

The many positives and the satisfaction from helping those affected by this Black Summer made the experience very satisfying and a valuable learning experience for us all.

The recipients tonight are those St John members who willingly contributed their time and expertise over a sustained period in one or more of these operational roles I have mentioned.

However, we should not forget and should acknowledge the significant number of St John volunteers who also willingly gave their time and expertise to assist the overall response but who we are not congratulating tonight as they did not meet fully the specified criteria for the Medal.

St John SA and the wider community can feel justly proud that all of the responding St John members, including the recipients here tonight, demonstrated through their response and by their selfless actions, the key values reflected in the St John motto:

*Pro Fide : Pro Utilitate Hominum*  
For the Faith : For the Service of Humanity

# The Order of Australia Association, South Australia Branch



## THE ORDER OF AUSTRALIA

- The Order of Australia is the most important and meaningful awards system in Australia.
- Each year, the Governor-General approves and announces awards to people for their outstanding service and achievement.
- People from all sorts of backgrounds, of all ages and who have done just about everything you can think of have been recognised through the Order of Australia.
- The system relies on nominations. People don't put their hand up to be recognised and they're not selected. They are nominated by peers and considered and recommended to the Governor-General by an independent Council.
- Anyone can nominate someone for an award, and anyone – if they've worked hard and made a significant contribution to their community – can be recognised.
- Awards are announced on Australia Day and in June (the Queen's Birthday long weekend).

### Who receives the awards?

- While some recipients are well known, others are not. In fact, most awards go to members of the community who volunteer or work to help others.
- Recipients are recognised for their impact – whether at the local level, nationally or internationally. The types of service vary greatly and could include volunteer work in a community, acts of charity and compassion and/or professional achievement.
- The Governor-General wants to increase awareness and understanding of the Order of Australia – particularly amongst groups that have historically been under-represented.
- Australians born overseas represent, on average, only 18% of awardees. To increase this percentage, and ensure outstanding Australians are celebrated through the Order of Australia regardless of their background, we need to increase awareness of the Order and encourage more nominations.

### How the system works

- Nominations can be made at any time. A nomination needs to include:
  - Examples of the individual's service or achievements
  - Names and contact details of referees who can validate the individual's service.
- Upon receipt, additional research is undertaken on each nomination. This includes verifying facts and claims and checking with independent referees.
- Nominations are then assessed by the independent Council for the Order of Australia – which includes members from each state and territory and community representatives.
- This assessment includes what level of award an individual should receive. There are four levels: Companion of the Order (AC), Officer of the Order (AO), Member of the Order (AM) and the Medal of the Order (OAM).
- The Governor-General acts on the Council's recommendations and approves awards.
