#### AN HISTORICAL PERSPECTIVE

**Inaugural Scholarship Recipient 2004**

I have recently had time to reflect on my career development since being the inaugural scholarship recipient in 2004. Some 18 years later, I am able to more fully appreciate the impact the scholarship has had on my life. Growing up in the bush I saw firsthand the impact dwindling medical services had on rural communities. The financial support of the scholarship allowed me to drop my part time jobs that were fitted in around the unforgiving hours of medical training. This then enabled me to participate in honours and research projects, bolstering my CV via papers and referees which aided in the competitive process of applying for surgical training. As a medical student I had decided, naively, that I wanted to be a rural ENT Surgeon. I can say with certainty that this would have been extremely difficult without the support of the Foundation which not only encourages potential leadership and community involvement but provides the financial means to assist young people in achieving their dreams. The OAA Foundation scholarship was unique at the time in allowing the recipient to direct the financial support. Although there were other scholarships that specifically targeted medical students wanting to work rurally, the bonded nature of these would not have supported the constant movement required throughout my speciality training, therefore making me ineligible. My mentor, Dr John Yu, understood that the vocational nature of medicine was best supported by the scholarship being able to reduce other stressors such as rent and cost of living, allowing me to focus on my studies.

I am very fortunate to now be doing a job that I love which allows me to contribute to my community. I am involved in outreach programs for indigenous and rural health and also am an investigator for an NHMRC application to develop a Portable Automated Hearing Test that can be utilised in rural and remote communities. I am still involved with Sydney University's School of Rural Health as the Surgical Coordinator for our medical students. I am constantly learning from our trainees and am overwhelmed by the calibre of the applicants' CVs for our training positions. The flexibility of a rural lifestyle and the satisfaction of working with my hands is something that I hope I can foster in future trainees.

My career as a regional ENT surgeon is extremely satisfying but not without its challenges, including unforgiving hours, onerous on-call and the tyranny of distance synonymous with rural healthcare. The culture of the surgical profession is slowly evolving to meet the expectations of both its trainees and modern society. The immense demands on trainees entering the profession will hopefully be met with an increased focus on the mental and physical health of our junior doctors. The work we perform is hard but the job satisfaction is high and I feel privileged to be able to contribute to the health and well-being of my community.

As we begin a new year it is rewarding to look back at the achievements of our Association in 2021. Although much of the year was greatly influenced by the pandemic, Branches maintained contact with members. Some events were cancelled, sometimes at late notice, but effective work by many ensured that we made the most of activities under differing and changing regulation within States and Territories.

Branches will now be arranging annual general meetings at which the election of directors to the National Board and membership of Branch committees will be carried out. ## DAVID BRILL AM, ACS



David Brill was born in Devonport on the northern coast of Tasmania in 1944. Having graduated from Scotch College in Launceston he studied photography and cinematography at a commercial studio in Hobart from 1964-66 before getting a job as a trainee cameraman with the ABC.

As a 22-year-old, his stunning footage of the Hobart bushfires in 1967 earned him the £10-prize as February 1967's Cameraman of the Month by a British photo agency. This set him on the path for world recognition as he went on to cover countless conflicts and national disasters in Asia, Africa and North and South America for nearly 50 years. He has worked for a host of current affairs programs, including Four Corners and Dateline, and has won numerous awards including six United Nations Peace Awards. Working as a video journalist for Dateline for 10 years he roamed the world telling the stories of unsung heroes and highlighting the good things happening in the world, which often go unreported.

It was the human element of those conflicts that David was able to capture that made him one of Australia's best cinematographers. In 2008 he was inducted into the Australian Cinematographers Society Hall of Fame and in 2017 was inducted into the Australian Media Hall of Fame.

When accepting the Honour he said,

"My main focus was the people, the suffering of the people. It's easy to film guns going off; it's the suffering after the battles, the refugees. What happens to all these people we just leave? That's what I have always tried to care about." He was

first and foremost a storyteller, combining journalism, pictures and sound to help viewers understand what was really going on.

Mike Willesee said, "He was the best cameraman of his era. He has the great ability to capture what has happened in one take. A take that held longer and told you more. He was a strange combination of artist and action man."

What set him apart was his empathy with the people and his ability to tell a story. He respected the dignity of the people and through the lens of a camera was able to show what was going on in the world. Over the years he has directed and filmed many documentaries. The most recent one was on the great Australian cinematographer Dean Semler who won the Oscar for dances with Wolves. In 2017 David was recognised with an AM Award on Australia Day for significant service to the broadcast media as a cinematographer and journalist, and to the community of Tasmania.

He said while it was an honour to be recognised in the Order of Australia for his work, he felt that it shone a light on the work that his colleagues did in unglamorous, dangerous and demanding places. "Providing good journalism is more important than it's ever been," he said.

"They are the real heroes."

Brill's ambition is to see his work (preferably in documentary form), made available somewhere where young cinematographers, history students and Australians from all walks of life could learn something of how the world worked during his half century behind the lens.

That ambition may just have been realised in December 2021 when the ABC aired: 'A life through the lens - the story of Legendary ABC cinematographer David Brill looks back at his incredible career on the frontlines of history from the 1960s and Vietnam to Four Corners and beyond.'

This can be accessed now on ABC iview. It is the first of what is hoped will be a three-part series. The second part will feature his 10 years in America for the ABC covering Presidents Carter, Ford and Reagan and the conflicts in central America. The final episode will feature the Middle East, Afghanistan, Iraq, the breakup of Yugoslavia and Somalia. This will certainly be a fitting legacy which will serve as a source of information and inspiration for future generations.

## GRAEME DODD OAM



Born in Melbourne in 1945, Graeme Dodd's childhood was spent on the family plantation in far North Queensland. He describes this as a wonderful place to grow up in, studying by correspondence and joining his family in working hard on the land.

The family then slowly, over a number of years, worked their way down the East Coast to Numurkah, Vic, where Graeme completed his schooling.

To obtain training and qualifications in electronics, software and logistics, Graeme then joined the Royal Australian Air Force in 1963.

The following 23 years were spent travelling throughout Australia, South East Asia and the USA, visiting and working on most Air Force bases. This included three years in Malaysia and war service in Vietnam in 1967–1968.

During his time in Vietnam he formed long lasting associations and friendships with many local Vietnamese. This made him very aware of how lucky we are in Australia. As Graeme says "it also made me far less tolerant of some of the current society's recalcitrants".

He specialised in electronics and logistics, managing electronic installations at many Air Force bases. This he found enjoyable and rewarding.

He became a team leader in the major projects division. This led to being selected to join the F/A-18 Aircraft procurement team based in St Louis, Missouri, USA, where he spent four years.

During his time in the USA, he was awarded an OAM in the Order of Australia Military Division Australia Day 1983 Honours in recognition of service as a radio technician (ground) in the RAAF. His OAM was presented at the Australian Embassy in Washington by Sir Robert Cotton KCMG AO.

Graeme modestly says he was, and is, very honoured to receive the medal - in military service it really is a team effort that achieves the best results and unfortunately not all can be recognised.

Graeme married late in his military career and left the Air Force, as he says to "put down roots" He became the Technical manager for Marconi Instruments, then for NEC Australia for a number of years.

He then contracted to the Government-sponsored Broadband for Seniors project as Software and Hardware Support Manager. It was a most rewarding experience interfacing with Australian seniors and he made lots of friends. Graeme believes many Australian Seniors benefited greatly from this initiative.

He has been semi-retired since 2015, but still has an active role in various service associations, including acting as Treasurer for the OAA Eastern Suburbs Regional Group in Victoria and contracts to local electronic companies. He also supports his wife in her positions with U3A (Strength Training), Rotary-Sponsored LAARF Singers and the Manningham Interfaith Network.

Graeme says his life has been, and is, filled with wonderful experiences that he would never trade.

It is with much sadness that we report the passing of Emeritus Professor Dr Mary Mahoney AO (pronounced marney).

Mary is well known to many Brisbane based Members of the Association having served with distinction on the Queensland Branch Committee from 2009 to 2019 including two years as the Queensland Branch Deputy Chair. Mary and her devoted husband Dr Patrick Mahoney were regulars at many of the Queensland Branch functions during that time, always brightening up our lives by their presence.

Mary has had a lifetime in medicine. Her long-term involvement with the Queensland Board of the Royal Australian College of General Practitioners (RACGP), the University of Queensland (UQ) and the Australian Medical Association (AMA) has earned her well-deserved accolades.

Mary's contributions to advancing the status of women in medicine and advocating for children are well recognised.

Mary graduated from UQ with a Bachelor of Medicine and Bachelor of Surgery and subsequently developed a great interest in education particularly in the field of General Practice.

Her work as a medical practitioner and teacher has influenced hundreds of students and medical graduates in the art of General Practice. Her work has also included research appointments with the Department of Child Health at UQ and involvement in research projects for the RACGP with whom she also held the role of State Director of the Training Program for 25 years.

Throughout her career Mary has been widely recognised for her contributions to medicine. In 1985 Mary was made a Fellow of the Australian Medical Association (AMA) and in 1994 when as part of a team she received a Research Award for Medical Education from the Australasian and New Zealand Association for Medical Education.

Her significant recognition occurred in June 2006 when she was made an Officer of the Order of Australia (AO) for service to medicine in the field of general practice, to tertiary education and university administration, and to the community through activities promoting the status of women and contributions to the early childhood education sector.

Mary has given a lifetime of service to The University of Queensland, including service on the UQ Senate and election to two terms of the Deputy Chancellorship, being the first woman to hold this office. In recognition of this service, UQ conferred on her an Honorary Doctorate of Medicine in 2005 followed by an Emeritus Professorship in 2014.

However, for all her wonderful medical achievements throughout her life it is Mary, the person that is so fondly remembered. Mary was a most gracious lady of great charm who took a keen interest in everything around her and everyone she met. It was a pleasure to have her on the Queensland Branch Committee where she took on the role of a listener of wisdom, only entering a Committee robust debate after everyone had their say and then come up with a solution that nobody else had previously thought of. Committee members like Mary possessing these qualities are "liquid gold".

We offer our sincere condolences to Mary's husband Patrick, their children and the wider Mahoney family over Mary's passing.

Mary will be sorely missed but she will also be remembered with much fondness.

Grace Truman was the 2021 Head Girl at International Grammar School and Student Leader in charge of her school's inaugural Science, Technology, Engineering and Mathematics portfolio. In these roles Grace sought to promote gender equality and to encourage the student body to engage with social justice issues by launching a Year 9 community service program and the "cohort" video platform, starting a whole high school discussion about morals and moral courage. She is also an experienced actor, with a string of professional credits, and a film-maker with her own internationally award-winning series.

Grace lost her father at the age of 10 and wanting to keep his memory alive she created her initial film series Amazing Grace, which explores wellbeing issues confronting many teenagers and particularly families suffering the loss of a loved one. Her second video series Graceful continued and broadened these themes and was acknowledged and awarded at the 2021 New York Web Fest as "Best International Web Series" and the 2021 London International Web Festival as "Best Series". Grace was also awarded "Best Female Performance" at the London Festival. Grace is also an ambassador for the charity flyhighbillie (<http://flyhighbillie.org>) and its annual B Kinder Day, which is celebrated internationally. In 2021 she spoke at the UNESCO and Mahatma Gandhi Institute's World Conference on Kindness, sharing the difference that kindness has made in her life and encouraging everyone to strive for a kinder world. His academic and sporting achievements are at the highest level and he gives freely of his time to tutor his peers when needed. His 'outside' achievements include a successful internship with DLA Piper, a global law firm; employment as a Food Service manager for KFC; and completion of the Duke of Edinburgh Award Bronze Medallion. He is aiming to complete the Silver and Gold Medallions in the future. During the DLA Piper internship, he explored the legal framework of child protection laws and law reform, with in depth analysis of the current level of Australian privacy laws designed to protect children, especially regarding their personal information and advertising protocols to prevent their exploitation. His employment at KFC as a Food Service Manager included staff induction, mentoring and training programs to enhance service delivery and staff satisfaction. ## HONOURS AND AWARDS

In one of her first official duties, Her Excellency the Honourable Frances Adamson AC hosted the St John Ambulance-SA Awards Day at Government House Adelaide on Saturday 16 October, in her capacity as Deputy Prior of the Order of St John in South Australia.

Mrs Raelene Denham OAM DStJ received the Third Service Bar to her Ultra-Long Service Medal of the Order of St John, representing a total of 65 years of service to St John Ambulance. Noel Hender OAM CStJ BEM was awarded the Second Service Bar for 60 years' service. Noel is the SA Branch Deputy Chairman, and Convenor of the SA Branch Student Citizenship Awards program.

In a separate ceremony on 20 December, Her Excellency presented Noel with the National Emergency Medal with clasp "BUSHFIRES 19-20" for having rendered eligible service with St John Ambulance SA during the Black Summer Bushfires.

The National Emergency Medal is awarded in recognition of eligible service during the 'Response' phase – action, assistance and intervention during a declared emergency, where the focus is on saving lives and protecting community assets. A total of 141 St John Ambulance SA staff and volunteers provided service in the Adelaide Hills and on Kangaroo Island in response to the 2019-20 Bushfires, with 45 members meeting the criteria to receive the Medal.

At the award ceremony, Noel provided a quick overview of the St John Ambulance involvement, concluding with the observation: "St John SA and the wider community can feel justly proud that all of the responding St John members, including the recipients here tonight, demonstrated through their response and by their selfless actions, the key values reflected in the St John motto: Pro Fide, Pro Utilitate Hominum : For the Faith, For the Service of Humanity".

Meanwhile SA Branch Committee member Paul Rosenzweig OAM JP has been awarded the Long Service Medal of The Duke of Edinburgh's International Award – Australia. This medal was created by the National Board in 2015 to acknowledge significant service to the Award in Australia. The medal provides formal recognition for those individuals who have provided ten years' or more service to the Award in a voluntary and/or paid capacity. At various times since 1984, Paul has been a School Award Coordinator, a Squadron Coordinator in the Air Force Cadets, an Award Leader and an Advocate, and he is also a Friend of the Award. The medal is not part of the Australian Honours System, and therefore is worn by the recipient on the right breast.

## AWARD FOR NARELLE HARGREAVES AM



On 3 November the Government of Japan announced the 2021 Autumn Conferment of Decorations on Foreign Nationals for their outstanding contribution to their respective areas.

Two Australians were recognised in this announcement, Dame Olivia Newton-John AC DBE and ACT Branch Committee member Ms Narelle Hargreaves AM, who was awarded "The Order of the Rising Sun, Gold and Silver Rays" for her contribution to enhancing interregional exchanges between Japan and Australia through promoting sister-city exchanges. Narelle is Chair of Canberra Nara Sister City Committee and has supported the Sister City relationship since its beginnings in 1994.

Narelle was awarded an OAM in 2008 and was upgraded to a Member in the Order of Australia on Australia Day 2019 for significant service to children and young people in the Australian Capital Territory and to education. She was announced as 2016 Canberra Citizen of the Year for her deep commitment to vulnerable children and young people in the ACT in her roles as an Official Visitor for Children and Young People in the ACT with Bimberi Youth Justice Centre, President of the ACT Children's Week Committee and as Chair of the Non-Government Schools Education Council.

Narelle spent 14 years as a principal in ACT schools and a further 10 as Director of Schools and International Education, which demonstrated her strong leadership and passion for the welfare of young people.

## MEET OUR MEMBERS

### DIANE KARGAS BRAY AM

Diane has been a tireless contributor to the Canberra community and mentor for people in the charitable and not for profit sector. In her former role as Public Trustee for the ACT, Diane founded the Capital Region Community Foundation known as GreaterGood, for the perpetual benefit of Canberra and the region.

She helped to establish Common Ground, which provides quality tenancies to people who have experienced homelessness, and to low-income earners who are unable to access other affordable housing options and Diane advocates for people with disability, encouraging the growth of new social businesses that employ people with intellectual disabilities. As the chair of Hands Across Canberra she has been instrumental in bringing together businesses, government, and individuals to channel donations to local charities.

Diane's work has extended to roles with the Canberra Bushfire Recovery Appeal, the ACT Committee for the Fundraising Institute of Australia, the Juvenile Diabetes Research Foundation and as Chair of the Social Enterprise Taskforce at the Canberra Business Chamber. She is currently a director of Australian Community Philanthropy, is the Chair of the Chief Ministers Charitable Fund and a member of the ACT Reconciliation Council.



Diane was the ACT Local Hero in 2004, and in 2007 was recognised by the International Women's Day Award for services to the ACT Community. In 2010 she was appointed a Member of the Order of Australia for service to the community of the Australian Capital Territory, particularly through the establishment of the Capital Region Community Foundation, to aged persons, and to diabetes research organisations. In 2011 Diane was listed on the Honour Roll of 100 inspiring women in the ACT, and in 2018 was named as the ACT Citizen of the Year.

## 2021 OAA-ANU LECTURE BY PROFESSOR PETER YU AM 4 NOVEMBER 2021

Members and guests enjoyed the online 2021 OAA-ANU Lecture by Professor Peter Yu AM, whose theme was Looking forward, Looking Back. 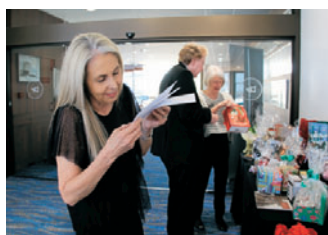

## JANET SAVAGE OAM JP



Janet Savage has organised the Albany Church Service and lunch for several years.

Janet received her OAM in June 2005 for service to the Shire of Gnowangerup, representing the Ongerup Ward, in 1987. At that time she was the only female on Council. It was otherwise an all male council that elected her as Deputy president and then as the first female Shire President in 1995.

In total she served 26 years on the council and was shire president for 12 years.

In 1991 she was appointed as a Justice of the Peace, serving in Ongerup, often officiating in the local court.

Other local service was several years as treasurer of the Ongerup Bowling Club, treasurer of the Ongerup Museum, officiating as the Ongerup representative on the Ongerup Football Association disputes tribunal and a member of Ongerup Red Cross Unit, receiving a medal and bar for 20 years of service.

She has been on the Board of the Yongergnow Malleefowl Centre in Ongerup for many years, stepping down as Chairman at the last AGM where she was awarded Life Membership of Yongergnow.

Since retiring to Albany 4 years ago, she has continued as a JP, usually volunteering once a fortnight in the signing room at the Courthouse. She volunteers 2 afternoons per week in the Living Water Anglican Op shop, where she is secretary/ treasurer. She and her husband, Barry, are involved with their local parkrun event and volunteer on average, once a month, allowing other runners to participate.

Mr. Alan James OAM has succeeded Mr. Andy Bruyn AM as Chairman of the NT branch of the OAA. Alan brings a wealth of managerial experience and administrative expertise to the committee. Alan has also been appointed NT Director to the National Board of the Order of Australia Association.

Alan was born in Katherine, NT, then a town of only a couple of thousand people, and his family later moved to Darwin. When he was 17, Cyclone Tracy struck the city, and Alan found work soon afterwards sorting through the rubble with government clean-up gangs.

In the 1980's while organising Territory tours for elite groups like the Australian Chamber Orchestra he saw an opportunity to take the touring artists into Aboriginal communities as part of his itinerary planning. It was on one of these visits – to Yirrkala in Arnhemland – that Alan met Dr. M Yunupingu AC, who wanted to form a band and was in search of a manager. The band became a reality, of course, as Yothu Yindi. They went on to record six albums with Mushroom Records and toured the world many times. In 1993 Alan won AIM Northern Territory Manager of the Year. In 2001, their hit song "Treaty" was named as one of ARIA's 30 top Australian songs of all time and in 2012 the band (along with Alan) was inducted into the ARIA Hall of Fame. In 2005 Alan was awarded the Order of Australia Medal for his contribution to the arts, in particular, Indigenous arts.

Alan established and was CEO of the not for profit Yothu Yindi Foundation from 1990 to 2010. As part of this work he established and ran the annual Garma Festival for twelve years turning it into the nations most respected indigenous cultural festival.

In 2013 Alan became General Manager of Darwin Entertainment Centre which was struggling financially. He engaged with a business-minded management board, adopted a more creative artistic programme, and revitalised the Centre, over 6 years.

The NT Chapter looks forward to Alan's leadership in the Order of Australia Association.
