The National Board Meeting was again held on TEAMS on Friday 25 February 2022 .

Once again, the financial position of the Association was reported to be in good shape despite COVID.

The report by the ACT Branch Planning Committee for the Conference was considered and it noted the good progress made by the Planning Committee in the planning of the Conference.

The Board Audit and Risk Committee had now decided to include the COVID Vaccination Policy as part of the Health, Safety and Welfare Policy and to make the combined Policy available on-line.

The Board Committee, formerly named the Marketing and Strategy Committee, was broken down into two committees to give better focus on each of the elements. The strategy Committee would now be chaired by Robin Watts AM, The Director WA, and the Marketing Committee by Dr Alan Morrison AM, Director ACT.

The agenda for the Futures Day, to be held in the Realm Hotel on Thursday 19 May 2022, and attended by the Members of the Board, the Branch Chairmen, and the Secretary of the OAA Foundation, was considered by the Board and approved in draft form.

Dr Pedersen opined that Sir John Monash could be considered the greatest Australian.
