

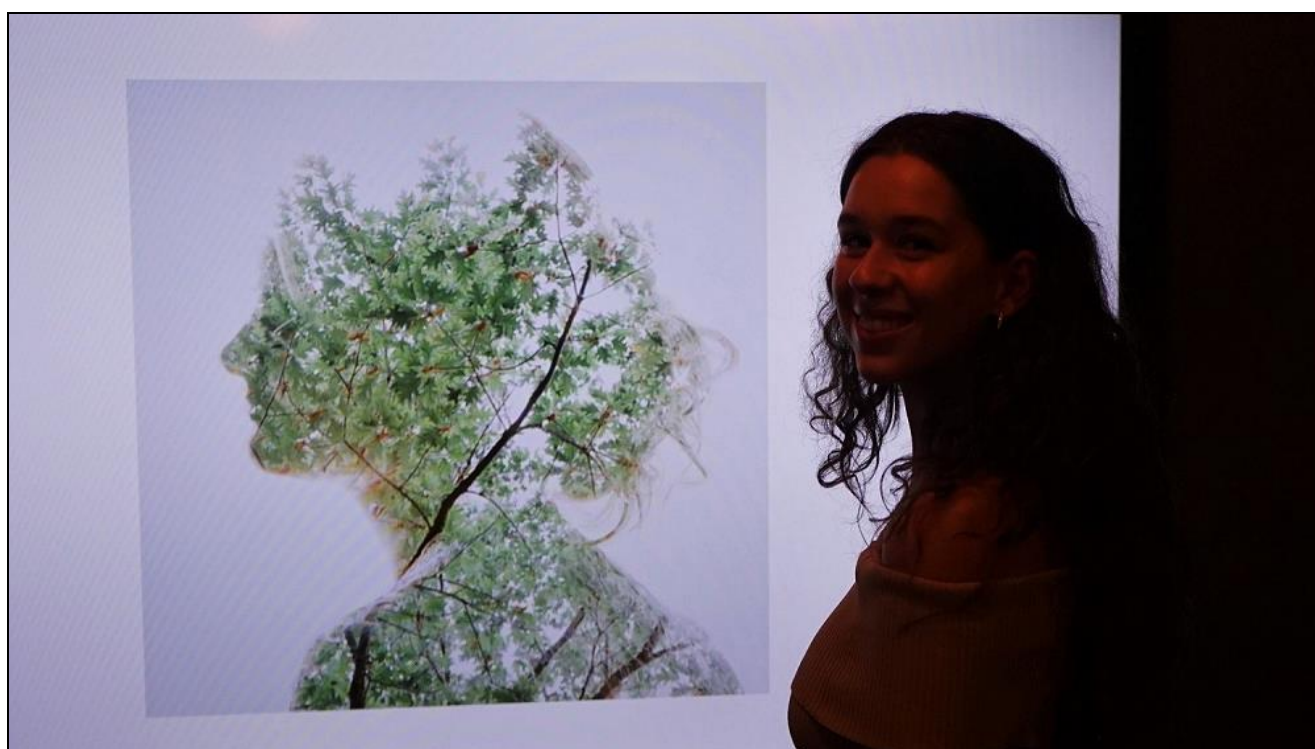

GEORGIA KEHAGIAS

SA Student Citizen of the Year 2021

My name is Georgia Kehagias, and I am incredibly honoured and grateful to have been invited to speak and connect with you all today.

In late November of last year, I was named South Australia's Student Citizen of the Year for 2021. This was an incredibly humbling recognition and for those who were there, could tell by my reaction of shock, was not one I was expecting.

To be named the Student Citizen of the Year among a group of 9 other deeply inspiring and service-driven peers was and is still something I am grasping. While such recognition has been difficult to comprehend, my gratitude continues to deepen, and I am truly honoured to now have such a platform with which I can voice and action change.

When planning my speech for today, I viewed it in two halves. The first of which will connect to my journey to today and hence, my background, and the second connecting to how I wish to use my platform for greater, positive change and my future endeavours and passions.

Background

I was born and raised in Adelaide, growing up along the beach at Tennyson in a family of three, being my Mum, Dad and I.

In 2016 I started my high school journey at Immanuel College, where I graduated from last year. When people ask me what Immanuel means to me, I always come back to the word and notion of service. This crucial notion has encouraged me to lead a life led by service and strengthen my passions for the environment and a holistic approach to sustainability.

I am forever grateful for the community I have at Immanuel and their choice to nominate me for this award. It was a most pleasant and humbling surprise as my contributions to school and community are just an innate part of who I am and to me did not seem like anymore and less than I felt called to do.

In reference to my citation, my school highlighted my contributions to supporting international students during early COVID times, ongoing involvement in Relay For Life, Pink and Blue swim and St Vinnies Sleepout as well as close working relationships with the current Future of the Coastline Project.

I would like to expand on some of these as well as other areas of my service that I see most influential in my future endeavours and passions for service.



Sustainable Fashion

An early example of the positive impact of such an opportunity was Genuis Project in Year 8 when we were given the opportunity to work on and present a personal project. My project allowed me to realise a passion of mine surrounding sustainable fashion through the establishment of an online platform called The Clothing Revival Store.

The platform allowed me to grow in my knowledge and activism for this issue. I posted alarming statistics about the devastating effects of fast fashion on a social, environmental and economic level, converted second-hand clothing into new pieces to illustrate the importance of upcycling and giving clothes a new life and used the platform to sell my own second hand and vintage pieces.

My aim was to create a space where my peers could begin to understand the deep, worldwide and systemic impacts of simply the clothes they wear. What was meant to be a term-long project, has turned into something that I have been running on and off since 2017. This has allowed me to grow my knowledge and passion for sustainable fashion immensely while also publicly advocating.

Dune and Coast Involvement

A major aspect of my service to community which has left a lasting and ongoing impact for me is my involvement in local coastal and dune management and connection to the Future of the Coastline project.

I have grown up around the coast, specifically in the Tennyson Dunes. Over time, my family and I have seen the dunes' height and diversity change due to human impact. We have often wondered and almost jokingly said how long it will be till our home, a street away from the beach, will be beachfront. These queries and observations inspired me to study the state and future of Adelaide's metropolitan coastline closer.

I initially sought to study the sustainability of current sand erosion mitigation strategies, and this led me to connecting with local community groups. Through beach clean-up days and dune management activities, I was able to connect with community groups and leading members to gain a firsthand perspective on the current state of the dunes and mitigation activities. The deeper I delved into this issue, the more dynamic it became. And the clearer the most pressing and divisive issue became.

From connecting with both community and government representatives, it was revealed that consultation regarding a sand recycling pipeline was a major issue.

Through attending community forums and further research, I realised the severe impact that transparency, voice and platform was having on not only the community but also the environment. My research into the question of "To what extent has the government considered the range of perspectives which exist in relation to the sand recycling pipeline" taught me far more than what I was originally expecting, and far more than any book or website could directly teach. This research journey opened my eyes to the power of community voice and the effects of politics on the environment, both for its benefit and detriment. This project has deeply inspired me to continue with my awareness of the issues facing our coastline and importantly ensuring community voice is empowered and has its place in the big decisions for our future.

I noticed a lack of youth representation and awareness of this pressing and local issue. This was really highlighted by both the community and government's appreciation of my interest and passion for this issue and a request from community to have me join the Community Reference Group for the pipeline as a Youth Representative.

With her passion for the coast and desire for youth representation, Georgia applied and has been accepted to be a Coastal Ambassador through Green Adelaide for 2022. She said:

I hope to broaden and deepen my knowledge of the coast and use this knowledge to create a platform and space for my peers to learn about the human and natural issues affecting our coast, importantly how they can get involved and how we can all enjoy the beach for many generations to come.

University

Georgia has now begun her university journey at the University of Adelaide studying a Bachelor of Environmental Engineering and Climate Solutions. She hopes to use her learnings and qualifications from this degree to solve many environmental concerns facing our planet and communities. She said:

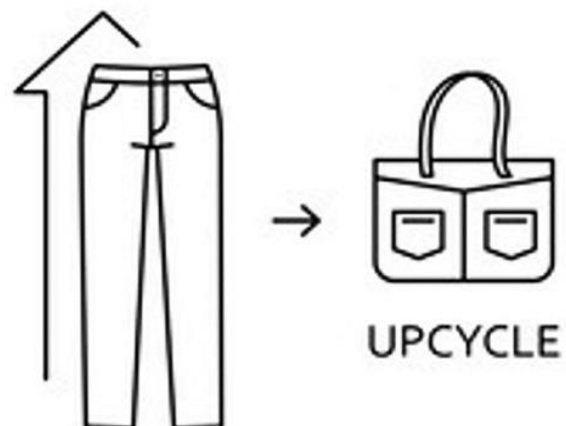
Specifically, I wish to work in sustainable fashion and architecture, food security and water treatment.

My dad recently asked me what I am passionate about and when he asked, I answered with almost no hesitation, and that is to hold brands accountable for their wrong doings and ensure they are transparent in their environmental, social and wider impacts and processes.

To solve any of the environmental issues facing the planet, it really comes down to the notion and movement of conscious consumerism.

We live in a world where we can buy anything we want, whenever and from wherever we want. Therefore, I feel called to use my knowledge and platform of any size to educate others on the importance of conscious consumerism.

It is important to encourage consumers to do their research and truly consider the need, rather than the sheer want, for an item.

Teaching Skills

In a video I recently watched, I was reminded that we vote with our money and that each time we purchase an item, we are performing an exchange of power. Where we put our money, feeds that industry and their wrongdoings.

Therefore, it is my sincere desire to ensure brands are held accountable for their transparency so that consumers can make more informed decisions about who and where they are putting power.

I have always enjoyed helping others and teaching people new skills. From this love and being creative, I would love to travel to schools and educate students on the impacts of a disposable fashion mindset, this current fear of re-wearing outfits.

I would instead empower students to restyle old clothes, upcycle second-hand garments and to simply mend holes or rips in existing clothes that are otherwise preventing them from being worn or encouraging them to be thrown out.

I see that my generation are losing the connection to hand skills, and they feel almost incapable of these tactile tasks.

Therefore, by working with and empowering youth to learn these simple skills, I believe it can go a long way in establishing sustainable habits and preventing the continuation of the wasteful culture we are currently living in.

We are Nature

We ourselves are not separate to the environment; humans and nature are intertwined and we ourselves are nature.

As we all begin to understand this more, we will all become more aware of our actions. When we return to nature, return to ourselves, will we understand the synergy of the Earth.

Protecting and connecting to ourselves and community is connecting and conserving nature.

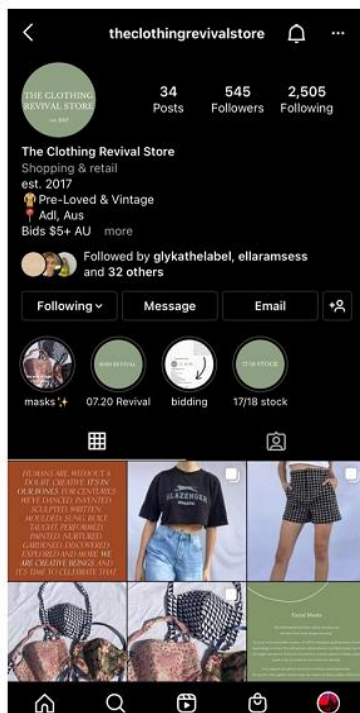
Connecting and preserving cultural practices and indigenous land knowledge for example is crucial in returning to the deep and innate relationship we all have to and with Earth.

Mr Greg Gordon OAM JP

For the honours recipients fellowship luncheon on Thursday 28 April, Greg Gordon will speak on the topic: "My Journey into Gordon Ancestry".

Hanging in Greg's office at home is a print of 'The Scots Greys and The Gordons at Waterloo'. Beside it is a chart he produced on canvas, the result of his research into his family history, showing his Gordon heritage across 30 generations.

After completing teacher training in Mathematics and Science, Greg joined Renmark High School in 1962, and he joined the Murray Highlanders Pipe Band.

On returning to Adelaide in 1965, he established a piping programme and class for young learners within the band of the Caledonian Society, and was a volunteer tutor. He represented the band at the SA Pipe Band Association (SAPBA) and led the pipe corps at the Australian Pipe Band Championships in 1968.

In 1966 he was a founding staff member at Christies Beach High School. Greg was commissioned as a Justice of the Peace for South Australia in 1970, and qualified as a member of the Quorum of Justices.

Greg was selected to participate in a teacher exchange program as a Senior Master (Mathematics) in 1974, and he and his family lived in Singapore for that year.

On returning to Adelaide, Greg was appointed Senior Master at Seaton and then Morphett Vale for an extended period, and at times was called upon to act as Deputy Principal and as Principal.

Greg continued his involvement with the SA Pipe Band Association, and was their elected President from 1976 until 1997.

Greg represented SA at the Australian Federation of Pipe Band Associations (AFPBA), and led the organising committee for the Australian Pipe Band Championships in Adelaide in 1986.

He was granted Honorary Life Membership of the Royal Caledonian Society SA (1987), and Life Membership of SA Pipe Band Association (1994).

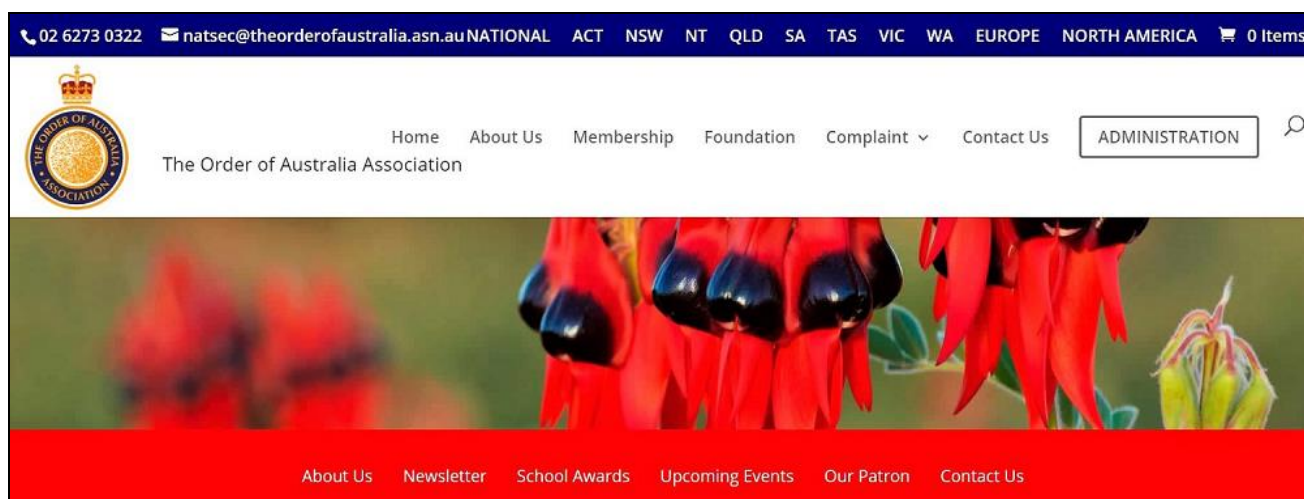
Greg retired from teaching on Australia Day 2000, coincident with his award of the OAM. He was presented with the insignia at Government House on 4 April 2000.

Greg took on a part-time position at Woodcroft College teaching Information Technology Studies, from which he retired in 2011.

When the AFPBA was superseded by the incorporation of the Australian Pipe Band Association (APBA) in 1997 with Branches in each State, Greg was elected inaugural President of the APBA.

The APBA was rebranded as 'Pipe Bands Australia Inc' in 2013. Greg retired in 2015, having contributed 39 consecutive years in the role of a president.
