## **GOVERNOR GENERAL'S REPORT**

#### HIS EXCELLENCY GENERAL THE HONOURABLE DAVID JOHN HURLEY, AC, DSC (RETD)

I want to begin my contribution to this edition of The Order by acknowledging the passing of Queen Elizabeth The Second.

In my address at the National Memorial Service I observed that throughout her reign The Queen had consistently demonstrated tireless and selfless service, devotion to duty and a compassion for others. History will remember few like her and while we mourn her passing, we are grateful that we have witnessed — and benefited from — her remarkable life. She epitomised servant leadership and set an example of living and serving for something greater than herself.

The Queen was, of course, the Sovereign of the Order of Australia. His Majesty The King assumed that role on his ascension to the throne. Ours is, however, very much an Australian system. Notwithstanding that the Sovereign does not have an active role in the Order, we can, however, take note of and inspiration from the legacy that The Queen has left us.

Part of her legacy is to be found in her values, values to which we can ascribe and aspire to. They are as relevant today as they were 70 years



ago. They will be as relevant in 70 years' time as they are today. They are also values that we see writ large in members of the Order and across the best of our community. As I review honours lists or welcome people to investiture ceremonies, I'm constantly amazed by the breadth of endeavours and the diversity of backgrounds represented. The same values, however, are consistent: overwhelmingly recipients are selfless, devoted to duty and compassionate. Like The Queen, they are an example and inspiration for our community.

In our system, and I say 'our' very deliberately, we all have a role to play in identifying people who exhibit those characteristics. Those who go above and beyond, who inspire and who have an impact at the local, national and international level. Critically, we need them to be both identified and nominated.

There is much work in progress to increase awareness of and encourage greater engagement with the Order. My office is producing new promotional material, guidance and working with parts of the community to encourage more nominations. I know that there is close collaboration with the Association – a partnership that I'm delighted to support and, I believe, will be of great benefit. While social media isn't for everyone, you can follow updates on Facebook. In addition, I know that new material will be shared with the Association regularly. # You are invited to join the 10 day tour of Gallipoli/Turkey, 25 May 2023, followed immediately by a 9 day tour of the battlefields of Western Front.



This fully escorted tour is reserved for OAA members and their guests. All Covid related rules and regulations at the time will be strictly adhered to ensure safety.

Highlights of the Turkey tour lead by author and historian Dr John Basarin OAM will be visits to Gallipoli Battlefields [Anzac Cove, Lone Pine, Chunuk Bair, Shrapnel Gully, The Nek, Ari Burnu, Quinn's Post, Krithia and Helles], Troy, Pergamum, Ephesus and Istanbul.

Western Front tour highlights, lead by researcher Garry Snowden OAM, will include cities of Paris, leper, Amiens and Arras and the battlefields of Menin Gate, Polygon Wood, Passchendaele, Fromelles, Bullecourt, Pozieres, Compiegne and Villers-Bretonneux.

You can choose to tour Turkey on its own, the Western Front on its own, or combine the two. A small part of the funds go towards OAA and FOGI. Approximate costs are:-

a. Turkey \$3999.00 twin/double per person. Single supplement \$899.00.

b. Western Front \$4950.00 twin/double per person. Single supplement \$990.00.

c. Combined \$9799.00 twin/double per person. Single supplement \$1899.00 (this includes the flight from Turkey to Paris).

All 3-4 star accommodation, breakfasts, several meals, site entrance fees, luxury coach travel, sightseeing, and services of professional tour guides are included.

Not included are international airfares from Australia, insurance, some meals and expenses of personal nature.

# AWARD FOR WORK WITH THE AUSTRALIAN ANTARCTIC PROGRAM

On Friday 26 August, a luncheon to mark the celebration of the 75th anniversary of the post-war Australian Antarctic Program was held in Hobart.

As part of the formalities, Sir Guy Green AC KBE CVO, who was Governor of Tasmania from 1995 to 2003, was awarded Honorary Membership of the Australian National Antarctic Research Expeditions (ANARE) Club in recognition of his support to the Antarctic Program both as Governor (he visited Macquarie Island which is part of Tasmania) and as "Ambassador for Antarctica", a position he was appointed to by the Tasmanian Government in recognition of his significant involvement in Antarctic affairs in the State.

ACT Branch Committee member Dr Joe Johnson CSC OAM AAM was awarded the Phillip Law Medal for outstanding contributions to Antarctic affairs and the Antarctic community. In his case this was "In recognition of his outstanding contribution to Antarctic affairs and the wider Antarctic Community particularly for his Station and Voyage leadership, as Antarctic Names and Medal Committee Chairman, work in relation to the Antarctic Air Link and service to the ANARE Club

Dr Johnson served in Antarctica as Officer in Charge of Casey Station in 1981, having been transferred to the Army's Reserve of Officers list for the duration of that appointment. He joined ANARE Club on his return and has been active member ever since, including as National Council President on four occasions – 2013, 2014, 2017 and 2018. Joe also returned to Davis Station as leader in 1998 and was voyage leader in two summer trips in 2001 and 2002 in the ships Polar Bird and Kapitan Khlebnikov respectively. He was the author of a review of the Australian Antarctic Division (AAD) Operations Branch in 2001, including a feasibility study into the air link between Australia and Antarctica. Joe was awarded the Australian Antarctic Medal in 2001 for outstanding service in support of Australian Antarctic expeditions and a Medal of the Order of Australia on Australia Day 2020 for service to veterans, and to the community.

## 2022 STUDENT AWARD RECIPIENTS



Recipients of ACT Branch Student Awards - Lize van der Walt, Anneliese Smolonogov, Anna Charlton, Forrest Primary School's 'Earlyact' Club

At an event held on 25 August at the Royal Canberra Golf Club, The ACT Branch presented Student Awards to the following local students who were judged to have shown good citizenship and community service by a Branch panel led by Dr Bill Maiden PSM OAM. The student awards are the primary outreach program of the ACT Branch.

#### Anna Charlton – Year 9 – Radford College

Since she was in Year 7, Anna has worked for two afternoons a week as a volunteer at a kitten and cat refuge/rescue centre. As a member of a dedicated team, her responsibilities have included helping homeless and often unwell cats restore to good health. Just as importantly, she works to support the cats' social skills without which they will not be able to find new homes. Anna is valued for her contribution and commitment in this work, displaying maturity and reliability. She has provided community service over and above her regular school activities in a valued community project, often foregoing social and enjoyable activities to undertake this role. She was awarded the Association's Medallion Award for Outstanding and Sustained Community Service.

#### Anneliese Smolonogov – Year 12 – Canberra Girls Grammar School

Anneliese has a strong record in volunteering. She has assisted children with disabilities at a nearby school on a weekly basis. Also, she has contributed annually to Anglicare's Crafts and Carols Christmas Service by making, wrapping and delivering toys to enable children in the broader community to enjoy these resources. A further community service is her engagement in a four-day program each year in another educational setting which offers targeted care to young people who meet the ACT Disability Criteria. Her nomination summarised the strong commitment she gives to her community and described Anneliese's humility in her service to others. She is a role model to peers. Anneliese was awarded the Association's Medallion Award for Outstanding Community Service.

#### Lize van der Walt - Year 12 - Canberra Girls Grammar School

Lize has earned widespread respect through her many activities as a citizenship leader and the contributions she has made to her community. Her nomination cited many leadership roles both in and outside her school. Examples are that, within her school, she is captain of her school's Duke of Edinburgh program and has demonstrated that she is a role model in demonstrating that program's values, the school's values, and Australian values. As a House Vice-Captain she exhibited exceptional community spirit, leadership skills and the ability to serve others. Away from the school she has organised donations for St Vincent de Paul each weekend for several years. Lize was awarded the Association's Medallion Award for Outstanding Citizenship.

#### Forrest Primary School's 'Earlyact' Club

Since 2017, Forrest Primary School has established a club that aims to capture the children's enthusiasm in increasing awareness of the importance of taking action and working together to make change. This club is comprised of approximately 30 Year 6 students who lead and coordinate activities across the school to raise awareness of community support programs and through fundraising, achieved through a 'Big Action Week' held each term. Examples of supported organisations and programs include RSPCA, 'OzHarvest', Queensland schools affected by floods and a university research program for endangered Australian wildlife. The 'Earlyact' Club has had a close relationship with Rotary for several years and since 2017 the school community has been collecting and donating stationery to support schools in Papua New Guinea. The Club was awarded the Association's Group Award for Outstanding Community Service

The investiture at Government House for the Queen's Birthday honours recipients was held on 8th September 2022. The investiture was conducted as a single ceremony

Sixteen Tasmanian were invested with their honours and many with family and friends accepted the Branch's invitation to attend the celebratory lunch following the ceremony. This was another successful event with 88 guests enjoying lunch at the Royal Yacht Club of Tasmania.

On Saturday 10th September I was privileged to receive an invitation with my wife Jenny to attend Government House on the next day for the wreath laying in memory and respect for Her Majesty Queen Elizabeth II by Her Excellency Barbara Baker AC, the Tasmanian Premier the Hon. ## BRIAN WINSPEAR AM

Brian Winspear AM recently celebrated his 102nd birthday in September, 2022.

Brian received his Order of Australia Award in January 1993 for his service to the tourism and hospitality industry. He was a pioneer in the motel and fishing industries in Bicheno, Tasmania, and become a well-known business owner, tourism developer and community figure. He was instrumental in the establishment of the golf club at Bicheno and as a foundation member he coordinated teams of volunteers to implement the course design.

In February this year he attended the Commemoration Service of the bombing of Darwin that occurred 80 years ago. Brian joined the Royal Australian Air Force (RAAF) on 6th December 1940 and was discharged on 26th November 1945. During that time, he earned a number of medals including: The 1939–45 Star, The Pacific Star, British War Medal 1939–45, Australian Service Medal 1939–45 and Australian Service Medal 1939–45 PNG. A survivor of the bombing of Darwin, Brian remembers returning from a mission flying a Hudson bomber to find himself sheltering in a trench as 188 Japanese aircraft mounted their deadly air raid. Brian is one of the few living survivors of the first air raid on Australia.

His contributions to our country did not stop at the end of the war – his life has been a life of service to the community.

The dinner, hosted by Australia's Ambassador to the US, HE the Hon. Arthur Sinodinos, AO, and Mrs Sinodinos at "White Oaks", the Ambassadorial Residence in Washington, DC, was a milestone, glittering event in many ways, apart from its memorable toast to HM Queen Elizabeth II. Gathering the North American Group members is always difficult, given that they are scattered across such a vast area of the US, Mexico, and Canada, but the event saw 20 people at the White Oaks dinner.

As well, the evening was used as the opportunity for the Ambassador to undertake the formal investiture of one new Officer of the Order, Prof. Warren J. Ewens, AO, who traveled to Washington with his wife, Kathryn. Prof. Ewens,

an Australian mathematician, has been Professor of Biology at the University of Pennsylvania since 1997. [He also held that position 1972–1977.] He concentrates his research on the mathematical, statistical, and theoretical aspects of population genetics. Prof. Ewens, now 85, has worked in mathematical population genetics, computational biology, and evolutionary population genetics. He introduced Ewens's sampling formula. His AO citation said that his award was for "distinguished service to biology and data science, to research, and to tertiary education".

The August 31 event was, because of the COVID hiatus, the first dinner for the OAA-NAG hosted by Amb. Sinodinos, and he made sure it was all the more memorable after the long gap between formal reunions. Amb. Sinodinos assumed the Honorary Vice-Patronage of the OAA-NAG on arrival in Washington, DC, and has remained active in the affairs of the Group since then. This was evidenced by his spirited leadership of discussion over the Dinner table, where he suggested how best members of the Order in North America could act as "special ambassadors" for the nation.

The OAA-NAG has very much become a networking organization, where Order holders help showcase Australian capabilities.

Former US Director of Central Intelligence, Gen. David Petraeus, AO (hon.), also participated strongly in this discussion at dinner. He has been an active supporter of the OAA-NAG following his extensive service with Australian forces in Afghanistan and Iraq.

Amb. Sinodinos and OAA-NAG Chair Gregory Copley, AM, led the toasts to HM the Queen of Australia and the Order of Australia Association.

Copley also added: "We cannot thank the Ambassador and Mrs Sinodinos sufficiently for their support of the Order. They recognize its importance, and particularly the value of having a number of Order holders in North America to show the Australian flag. As a result, the effort put into the special dinner at White Oaks resulted in perhaps the most special event the North American Group has seen."

## DR ALISON THOMPSON OAM, D.LITT.

#### Founder of Third Wave Volunteers

#### Ukraine War update late September 2022:

Australian humanitarian Dr. Alison Thompson OAM, and her team of Third Wave Volunteer first responders, have been working on the front lines of the Ukraine war for the past seven months. They have been training thousands of Ukraine soldiers in combat



medics on how to save lives, extracting orphans and women and children from the red zones and delivering food aid to recaptured front line villages. They are based around the Kherson oblast regions.

The Third Wave team have been escorted to the recaptured villages by a young Ukraine mayor, who had been captured and tortured by the Russians for 3 months and was recently released in a prisoner swap. The Russians are located only a half mile down the road and as the artillery begins to drop around Thompson's team, they seek shelter in WW2 underground bomb shelters.

Dr. Thompson speaks about their work.

"When we enter newly recaptured villages, the locals slowly gather around us, scared and cautious at first, and

then cry for joy in our arms as they realize they are now safe, and that the terror of the Russian occupation is over--- at least for now.

It is in those remote wheat fields, where a volunteer and a refugee meet and embrace - no walls, no discrimination, one country, one human race. Sometimes a hug would last more than 5 minutes and other hugs 30 seconds, and it is in those minutes where we have felt the greatest moments of unconditional love.

This is a civilian war, where the Ukraine soldiers are made up of fishermen, farmers, PHD philosophy students and baby food salesmen. They are given a uniform and a gun and trained for five days, before being sent to the front lines. Many won't return.

It's easy to be in the wrong place at the wrong time but it is Leadership to be in the wrong place at the right time. "





Note: Dr. Alison Thompson was a Sept. 11th 2001, first responder in NYC and since has run large refugee camps, field hospitals, and resilience hubs around the world in natural and man-made disasters for the past 22 years, including the Syrian, Afghan and Venezuela refugee crisis. More recently she has raced into the Puerto Rico hurricane Fiona disaster with her rescue teams - as half of the country is under water. She will be back in Ukraine.

In 2010 she received the Medal of The Order of Australia for her service to humanitarian aid, particularly in Sri Lanka during the Boxing Day 2004 tsunami.



# STOP PRESS: UNITED STATES PRESIDENTIAL AWARD

Ahead of her ninth trip to Ukraine in 2022, the humanitarian charity worker and paramedic Dr Alison Thompson OAM, has received a US Presidential Lifetime Service Award, usually reserved for American Citizens. The award, which honours "outstanding volunteers and recognises the impact they make", was one of five presented on Friday 4 November.

In late September, while between visits to Ukraine, Dr Thompson helped in the aftermath of Hurricane Fiona in Puerto Rico and Hurricane Ian in Florida.

STEFAN ROMANIW OAM LEADING THE CHARGE IN UKRAINIANS CARING FOR COMMUNITY

For Australian Ukrainians, their focus has been on the war in the Ukraine: their fears for their families and friends, and their dismay at seeing Ukraine in the grip of a war.

Stefan Romaniw OAM presented an insightful account of how the war has impacted the community, both locally and overseas when he spoke at the Victoria Branch Melbourne Central Regional Group lunch. Stefan was joined by key members of the Australian-Ukrainian community.

Members of the Order of Australia Association listened intently to how the local Ukrainian community and their friends have been frantically collecting clothing, blankets, and important supplies to send to the Ukraine to ease the conditions of those effected there. Also, how the local Ukrainians, joined by the broader community, have mobilised to ensure that those fleeing the war, are supported as best possible.

Stefan Romaniw, has held, and continues to hold many distinguished community positions. As Co-Chair of the Australian Federation of Ukrainian Organisations he is normally overseeing community social, educational and other programs. However, recently found himself in the warzone seeing for himself the devastation and trauma that war brings. Suffice to say, that each person present found Stefan's presentation very moving and informative, and the Ukrainian community, equally moved and grateful for the support provided by the OAA.

One of the issues raised was the need for winter clothes as for many they belongs are all gone. The Australian Ukrainian community is seeking to send clothes as their winter approaches.

I was challenged by a comment from popular ABC Presenter Stan Grant who opined at a recent Oration event he moderated: "DON'T ACCEPT THE STATUS QUO."

That could easily be a fundamental criterion to a successful nomination which can be measured by the Governor-General's comment to our Branch Committee during a zoom meeting he instigated last year with us. The results are extremely motivating for their inspiration, "rippling impact" and humility, as well as being encouraging for not just our local communities, but for the nation and internationally. The same can be said for the high school recipients of our Branch Youth Community Service awards.

I am also quick to respond to many recipients who make comments such as "I do not know why I got my award as there are many people who have done more for the community than I have." In fact, one NSW State Governor chastised a recipient to never say anything like that. "A group of citizens have nominated you because they have seen and highly value your service. I know you did not serve to be recognised and they recognise your impact and want to publicly thank you."

Not one of them has accepted the status quo and there is more each of us has yet to do.

I enjoy my regional and branch gatherings and I continue to be inspired. These have included our Branch attendance at the 2022 Queen's Birthday Honours investiture ceremonies and NSW Branch Community Service awards presentation at Government House, our Opera luncheon, regional visits to Dapto, Port Macquarie, Coffs Harbour, Sydney's Northern Beaches and Mittagong.

# HELPING YOUNG AUSTRALIANS FULFIL THEIR POTENTIAL

On November 28, 2003, as Chairman of the Order of Australia Association Foundation, Mr Hugh Morgan AC spoke eloquently and persuasively at the Victorian Branch annual dinner about the difference the Foundation's work could make in the lives of young Australians. In the following February the first bursaries were awarded to "three young Australians with the potential to go on to great things in their subsequent careers, but whose financial position, for whatever reason is precarious".

Since then, Hugh has led the Foundation with great distinction. During that time, 45 scholarships have been awarded with a value close to \$2 million. # OAA WA BRANCH ANNUAL DINNER 2022

On Wednesday 21 September a number of members of the OAA WA Branch and their guests were once again able to meet and enjoy fellowship and good food at the Royal Perth Golf Club. The flower decorations had been arranged by ladies of the Golf Club and were stunning in yellow and blue. Our National Chairman, Major General Retd. Barry Nunn AO raised the loyal toast to the King, our Vice Patron, Kerry Sanderson AO, toasted the Order of Australia Association.

The speaker was Sue Murphy AO, an amazing lady, who is profiled in the November The Order magazine. She spoke about "Water forever for WA". She discussed the problems that C Y O'Connor experienced with the water supply to the Gold Fields and pointed out the lesson learnt. When in 2001 our water supply was reaching a crisis, we needed to be climate independent. The water issue extends beyond one political term. The solutions were desalination and wastewater recycling. The Water Corporation engaged with the community and Groups were welcomed with innovative ideas. With regard to the wastewater treatment there was a trial plant and visitors centre, numerous workshops and by December 2012 the trial was at an end with 2.5 billion litres of clean water added to the aquifer. There is an 80% agreement in Australia that treating wastewater and pouring it into the sea is not the answer in Australia. We are the envy of utilities across the world. The Water Corporation learnt that technical expertise is not enough. One needs community hearts and minds, both sides of politics must agree, one needs to educate the media and keep them on side.

## SUE MURPHY AO

Sue was made an Officer of the Order of Australia (AO) in the 2019 Queens Birthday Honours List. She has been a trail blazer for women in engineering and management.

We were privileged to hear her speak at the OAAWA Annual Dinner on her work re the wastewater recycling.

Sue was born in Western Australia and educated in Perth, winning a scholarship to high school at MLC. She graduated as a Civil Engineer at the

University of Western Australia in 1979. Women at that time were not encouraged to study Engineering.

After winning a Clough Scholarship as an undergraduate, she joined Clough Engineering in 1980 commencing what would be a 25year career in that organisation. Twelve years in the field as a site engineer and project manager led to corporate roles with a focus on engineering design management, human resources and safety and her appointment in 1998 as the first woman on the board of Clough Engineering Ltd.

In 2004 Sue joined the Water Corporation of WA and was appointed Chief Executive Officer in 2008. Sue is recognized internationally for her leadership of the Corporation's adaptation of water supply in the face of climate change. This includes the delivery of two large scale desalination plants, Australia's first large scale indirect potable recycling scheme and award winning programmes of customer engagement to reduce per capita water demand while maintaining Perth's enviable liveability.

In each year from 2009 – 2016, Sue was listed in the top 100 most influential engineers in Australia by Engineers Australia. In 2013 Sue was honoured with the prestigious Sir John Holland Civil Engineer of the Year Award by the Board of the College of Civil Engineers of Engineers Australia. Sue was also elected as an Honorary Fellow of the Institution of Engineers Australia.

In 2014 Sue was presented with the IWA's "International" Women in Water Award and in 2018 Sue was ranked number 8 in the prestigious Water and Wastewater International magazine for the top 25 Water Leaders and was named as the 2018/19 WA Business Leader of the Year at the AIM WA Pinnacle Awards.

Sue is now a nonexecutive director on a number of listed and not for profit Boards including Monadelphous Ltd, UWA Senate, WA Treasury Corporation and MMA Offshore Ltd.

## A MEMORY OF MEETING QUEEN ELIZABETH II

Greg Gordon OAM JP has observed that Queen Elizabeth II passed on his birthday on 8 September. He was moved to write down his memory of meeting Her Majesty in 1977.

During the Royal Visit of Queen Elizabeth II and Phillip Duke of Edinburgh to Australia in 1977, it was programmed for the Queen to open the Southern Plaza of the Adelaide Festival Centre on Tuesday 22 March.

The arrangement was that Queen Elizabeth and the Duke of Edinburgh would walk from Government House and proceed down King William Road to the Festival Centre, a nominal distance of 250 metres, and spectators would line the route.

For the occasion, pipers of the Royal Caledonian Society of South Australia, Pipe Master Vern Raymond and Pipe Sergeant Greg Gordon were engaged to provide musical accompaniment. Amongst the assembling spectators, behind the barrier rope opposite the Festival Centre, was Christine Gordon with our daughters Catherine (aged 5) and

Ailsa (2).

In order to see more up the street than the surrounding legs, Ailsa broke free and ducked out under the barrier rope, and came face to face with a big policeman, who said "Boo!". She returned quickly to the safety of Mum.

Precisely at 4 pm, the walk commenced, and the sound of bagpipes heralded the progress of the short walk. The destination was reached 5 minutes later, and the pipers ceased playing and acknowledged the Royal Party. Queen Elizabeth, always conscious of protocol, thanked the pipers.

In response, Pipe Master Raymond said words to the effect that it was a pleasure just as it had been to play as duty piper for her at the Palace in years gone by, as a Sergeant Piper in the Scots Guards. There were smiles all round as the pipers took their leave.

A recent addition to the SA Branch Committee is retired Magistrate Ted Iuliano OAM. Ted was awarded the Medal of the Order of Australia in the 2011 Queen's Birthday Honours List, "For service to football in South Australia, and to the Italian community".

Ted came to SA from the Province of Benevento in Italy in August 1958. Graduating from the University of Adelaide in 1972 with a Bachelor of Law degree, he was admitted as a Practitioner of the Supreme Court of SA. From 1980 to 1987 he ran his own law firm, and from 1987 to 2015 was a South Australian Magistrate.

Ted has been heavily involved with Eastern Districts Azzurri Sports Club Inc, notably as Secretary (1975-87) and President from 1999 to 2005, and again since 2015. He was granted Life Membership in 1992.

In 1993, Ted was Acting Chairman of the SA group participating in the FIFA VII World Youth Championship of Soccer. The following year Ted was tour leader for the Australia Today-Indonesia 1994 Soccer Tournament – a Federal Government initiative designed to promote trade, cultural and sporting relationships.

His many other sporting involvements have included Chairman of the SA Soccer Federation First Division Management Committee (1981-83), Vice-Chairman of the SA Soccer Federation (1992-97), and Board Member and Vice-Chair of the Football Federation of SA. In 2001 he was made a Life Member of the SA Soccer Association.

He was Foundation Secretary of Italian Village Inc (1974-79), President of the Coordinating Italian Committee Inc and Chairman of the Organising Committee of the Annual Italian Festival 'Carnevale' (1982-87). He served as Vice-President of Radio Italiana Inc (1986-88), and more recently has been President of Radio Italia Uno Adelaide Inc (2013-21).

He has been the Italian Community Representative on the board of the Migrant Resource Centre of SA (1983-86) and on the board of the Ethnic Communities Council of SA (1983-86). Ted has also served terms as a Board member of the SA College of Advanced Education (1983-87), and on the committee of the Magistrates Association of SA (Secretary/Treasurer 1999-04, and President 2004-07).

In 2008 Ted was awarded a Premier's Award for outstanding achievement in the area of Community Service. In 2010, he was awarded the honour of Cavaliere Ordine al Merito della Repubblica Italiana (Order of Merit of the Italian Republic, 5th Class) by the Italian Government in recognition of his services to the Italo-Australian Community. Also in 2010, he was inducted into the Football Federation of SA Hall of Fame for his 'distinguished contribution' to the game of football as an Administrator and Life Member.

- b. In consultation with the National Chairman, as required.

#### 2. Manage the collection and collation of magazine content, including:

- a. the development of a publication schedule and associated deadlines.
- b. the development of a 'generic page plan' and a specific plan for each edition.
- c. the development of a 'theme' for each edition including the front-page image and Editor's comment.

d. liaison with National contributors, including the Governor-General (through his staff) and nominated Branch magazine coordinators.

e. the transfer of intended articles from email to the designated 'Dropbox' account.

#### 3. Liaise with the magazine printers and publishers including:

- a. providing access to the Dropbox account, and
- b. the clearance of progressive and final drafts.

#### 4. Produce necessary mailing lists for 'Hard Copy' recipients from the National membership database providing:

- a. an Excel spreadsheet restricted to simple 'name / address' data.
- b. the numbers of 'Hard Copy' to be printed.
- 5. Distribute E-copies through email using the National membership database bulk email facility.
- 6. Produce the 'accessible' version of the magazine in Word and then pdf format.

  - a. Specific program methodologies are not complex.
