## GOVERNOR GENERAL'S REPORT

HIS EXCELLENCY GENERAL THE HONOURABLE DAVID JOHN HURLEY, AC, DSC (RETD)

In my National Address on Australia Day, I reflected on what it means to be Australian.

Of course, there isn't a single, simple answer. My experience is different from yours and yours will be different from your neighbour's.

Mine is informed by the people Linda and I have had the privilege of meeting. They and their experiences are as diverse as our country is big. Our conversations tell me that Australia is not a finished product, but that we are a good people. Yes, there are many challenges and, yes, we don't agree on everything.

We do however work hard, look out for each other and are not afraid to take on the big challenges.

We are a country to be proud of and that is worth celebrating.

As members of the Association well know, the Order of Australia provides the means to recognise and celebrate the individuals who help make us proud.

The Australia 2023 Honours List included 736 recipients in the General Division and 30 in the Military Division. The range of service amongst recipients is, as is always the case, remarkable. Amidst that diversity, the characteristics I spoke of in my National Address are writ large – hard work, compassion for others and the drive to take on big tasks and change our community for the better.

I congratulate all recipients. Each has had an impact at the local, national and international level. Each is, in their own way, inspiring.

Long may We Reflect, Respect, and Celebrate our National Day.

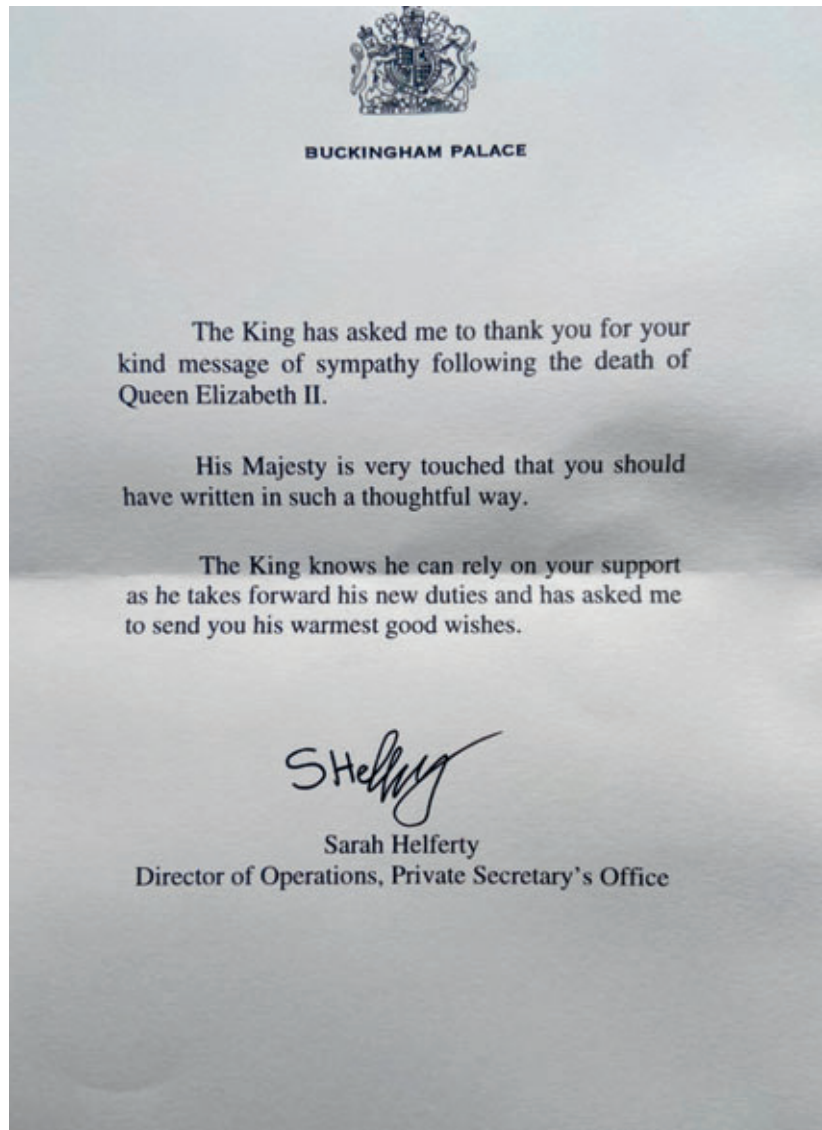

## OBJECTIVES OF OUR FOUNDATION

The Order of Australia Association Foundation is supporting the next generation of leaders by helping promising young Australians to achieve their potential for the benefit of future generations of Australians.

Every year the Foundation provides scholarships with Australian universities for young students in their early years of tertiary study. The Foundation seeks donors for funding individual scholarships. The Scholarships have two significant features. Recipients receive: A scholarship of \$40,000 which is tailored to the Awardee's individual needs to include tuition fees, living allowance, text-books, equipment; etc. and An introduction to a personal mentoring relationship with a volunteer mentor who has received an appointment or award in the Order of Australia and is eminent in the chosen field of study of the Awardee.

Selection of Awardees is undertaken by a partnership between The Foundation and an Australian University. The University and Faculty are nominated by the Donor. A National Selection Panel (NSP) comprising three Foundation Board members and a University Professor from the Faculty, deliberate over short-listed candidates. The successful candidate is referred to the Foundation Board for ratification. The Foundation appoints a mentor for the new Awardee. The Awardee receives their Award at The Order of Australia Association National Conference Dinner.

## LET'S ENSURE THE ORDER OF AUSTRALIA REPRESENTS US ALL



The Australia Day honours list includes hundreds of recipients in the Order of Australia. Most aren't famous, but their stories are inspiring. They are the people in our community who go above and beyond and have an impact at a local, national and international level.

Yet, as I celebrate those Australia has recognised, I also don't believe there aren't more outstanding Australian women, First Nations people and people from culturally diverse backgrounds who inspire and make a significant contribution to our community.

As chair, I am not seeing enough of them in the pool of nominations.

Each of the 40,000 Australians from all walks of life that have been recognised since 1975 has something in common – they were nominated by their fellow Australians.

I am not advocating for lowering the bar. The Order of Australia will always recognise and celebrate achievement but it must represent the diversity of the Australian community and represent the colourful spectrum of who we are.

We all have a role to play.

First to gender: there has already been some work in this space within the honours system, with good progress in recent years; women received 46 per cent of honours in 2022. While this increase is welcome, it's still not enough. We need to ensure gains are not lost and that the pipeline of nominations of women continues to flow to reach and sustain gender parity.

Interestingly, our data shows that the gender of the nominator plays a significant role in the under-representation of women. More men nominate (56 per cent of all nominations) and 70 per cent of the nominations made by men are for (other) men. Women nominate less often (44 per cent) but nominate men and women equally – so encouraging both men AND women to nominate women will make a difference.

And much more needs to be done to encourage nominations for outstanding First Nations people and people from culturally and linguistically diverse backgrounds. According to the most recent census, almost 27.6 per cent of Australians were born overseas, yet nominations for the Order do not reflect this.

Similarly, far fewer First Nations Australians are nominated than is represented as a percentage of our population.

The perception that honours are designed to recognise only the elite contributes to these outcomes. This simply isn't the case.

In the list for every well-known name there will be many, many more that are known only to those they serve. In fact, last year 43 per cent of awards were for outstanding service or achievement in local communities.

These people are often volunteers who give their time, passion and energy to make the world around them a better place.

The same qualities exist in those who, while not well-known, are recognised for their professional achievement – scientists, local leaders, people in industry, teachers and so on. If you read their stories you'll see they're not simply doing their jobs well but also expanding their contribution in many different ways, often by volunteering, mentoring, or through charitable work.

I would love to see more of these stories told on our front pages and in our news bulletins. These Australians are inspiring and learning about them is important.

The Council I lead is a diverse group, with different backgrounds and areas of expertise. Every year we volunteer our time to the considerable task of reviewing together the thousands of nominations that are received, along with each independent research report, to ensure that great Australians are recognised and celebrated.

But the decision on who the Council considers for an Order of Australia honour belongs to all of us.

To be very clear, the only barrier to outstanding people being recognised in the Order of Australia is the absence of a nomination.

By nominating, we can all have a say in what sort of service and achievement should be celebrated.

If we as a nation want to see "more people like us" reflected back to us through our honours system, we all need to be proactive by nominating those Australians who deserve our recognition.

As you scan the list of recipients, I urge you to think about who you would like to be considered in the Order of Australia. And then to act and nominate.

## WEBINAR INVITATION TO OAA MEMBERS AUSTRALIAWIDE

When the newly-elected Eastern Suburbs Regional Group (ESRG) Chairperson and committee took office in early 2021 they were faced with the dilemma of needing to arrange an activity program which did not involve bringing people together during COVID lockdowns. A tentative start with one online webinar has now developed into a solid program with speakers from a wide range of areas. Speakers at intervals of about two months share their passion and the ways they have been able to make a difference in the community, and engage in the lively discussion.

The last speaker for 2022 was Robyn Guymer AM, Professor of Ophthalmology at Melbourne University, who spoke about her life-changing research into the treatment of macular degeneration. Other speakers in 2022 addressed the world's rich diversity of edible plants, the role of Chaplain in the Victorian Police and the role of communication in a time of pandemic.

The schedule for 2023 is now complete, with the first webinar to be held in conjunction with the ESRG AGM on Thursday March 16 when the speaker will be Iain Edwards, CEO of Guide Dogs Victoria. All ESRG webinars are open to all Order of Australia Association members Australiawide.

Other speakers planned for 2023 include Hazel Edwards OAM; Author of *There's a hippopotamus on our roof eating cake*, who will speak about the physical and intellectual risks of being a long-term author with a family and a life. Janet McCalman AC, of the Melbourne School of Population and Global Health and author of *Vandemonians*, will examine the issue of how penal servitude in Van Diemen's Land and service in World War 1 may have affected the lives of those who went through those ordeals. Later speakers will include Dr Neil Roy AM, consultant paediatrician at the Women's Hospital from 1975 to 2007 and Jenny Graves AC, Australian geneticist, Distinguished Professor within the La Trobe Institute for Molecular Science and a winner of the Prime Minister's Science Prize.

Most webinars are recorded, and the Regional Group has established a public repository to allow members unable to join at the scheduled time to share in the event at a later date. These recordings, which are post-processed to ensure they meet quality guidelines, have proved to be very popular, both within the Group's own membership and, increasingly, to a wider audience. 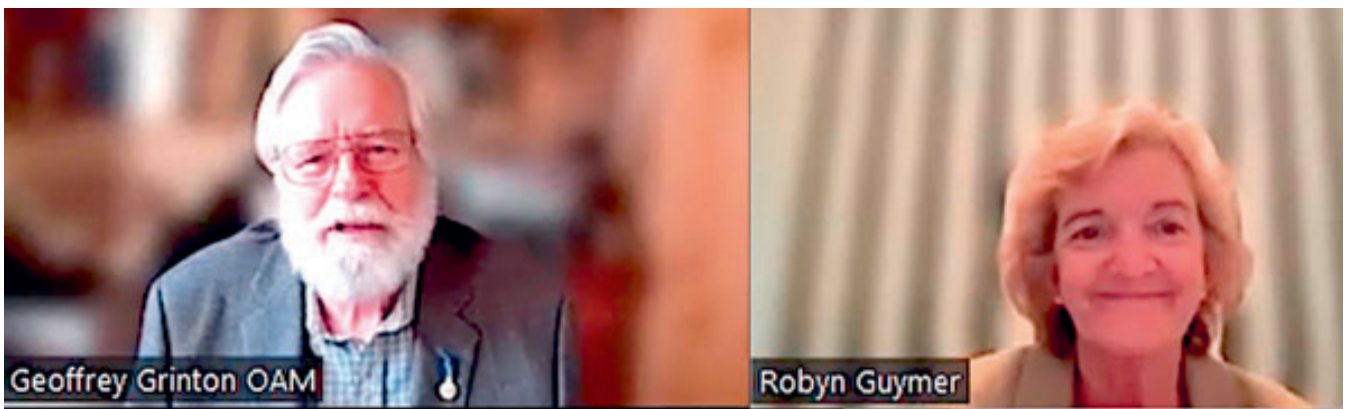

## THE HON NEVILLE OWEN AO



The Hon. Justice Neville Owen OA

The Honourable Justice Neville Owen AO is a committed Roman Catholic, born in Western Australia, educated at St Ildelphonus College New Norcia and then the University of Western Australia, where he lived at St Thomas More College and enjoyed College life. He was undecided on a career and initially was studying science but once involved in Law Studies he realised corporate law, equity and commercial law were of greatest interest. He graduated in 1968 with Bachelor of Laws (honours)

Justice Owen was a barrister and solicitor from 1972 – 1991. In 1991, he was appointed to the Supreme Court of Western Australia from 1991 - 2010.

From 2001 through to 2003 after being appointed by John Howard, Prime Minister, he headed the HIH Insurance Royal Commission in Sydney. In July 2003 he started the five-year hearing into Alan Bond's group of companies.

In 2005 he was appointed as an inaugural member of the Court of Appeals Division.

He has been associated with the University of Notre Dame Australia almost from its inception from 1989. He has been Governor, Director and Trustee of the University and served a term as Chancellor.

In 2014 he was appointed by the Roman Catholic Bishops to chair The Truth, Justice, and Healing Council as the Church's official coordinating agency with the Royal Commission into Institutional Responses to Child Sexual Abuse.

In 2018 Pope Francis appointed Hon Neville Owen AO as one of seventeen members to the Pontifical Commission for the Protection of minors.

Justice Owen is a humble man who despite the accolades he has received, questions whether he is worthy of it! In relation to his role as a judge he commented that his education and upbringing impressed on him 'the need to treat everyone who comes into court and on whom I must pass judgement (civil or criminal) as another human being, no matter how flawed her or his character or how despicable his or her actions may appear to be.'

He is married with five children and eleven grandchildren.

His relaxation is walking, following the Dockers, playing tennis, and reading biographies and history.

In 2019, Justice Owen was awarded an Officer of the Order of Australia for distinguished service to the law, to the judiciary, to legal education and to the community of Western Australia.

## OAA NSW CHRISTMAS FUNDRAISING LUNCHEON TO SUPPORT NSW FLOOD VICTIMS

The OAA NSW 2022 Annual Christmas Fundraising Luncheon was held at The Kirribilli Club on Sunday 11th December 2022.

The Charity we supported was GIVIT to help people impacted by the floods in New South Wales. GIVIT was founded by Queenslander Juliet Wright OAM.

GIVIT will be working with these communities for as long as this recovery takes. 100% of publicly donated money received by GIVIT for the Storms and Flooding Appeal is used to buy essential items - exactly what's needed, when it's needed.

GIVIT buys locally where possible to support the local economy of impacted communities during these difficult times especially over the Christmas period.

As is always the case in natural disasters, Australians have shown incredible generosity. It's this generosity that enables GIVIT to provide short, medium and long-term support to people who've lost everything.

Communities have been devastated, lives have been lost, and thousands of people have been displaced and left with nothing. Recovery is going to take a very long time.

Our Branch raised \$7800 for GIVIT's Storms and Flooding Appeal and funds will be used to purchase essential items and services for those affected.

GIVIT is working with the New South Wales Government, as well as support organisations, charities, outreach teams and community groups to identify exactly what's needed to help people recover.

Unfortunately our Guest Speaker Ms Denim Rose - NSW State Manager GIVIT was unable to attend as she was working on the ground in flood affected areas so we showed a video message from CEO Sarah Tennant as well as two short videos on the great work the GIVIT does for our community.

She is a Fellow of the Australian Academy of Science (AAS), The Australian Academy of Technology and engineering (ATSE), the Optical Society of America (OSA), the Australian Institute of Physics (AIP) and is a member of the Board of the Commonwealth Scientific and Industrial Research Organisation (CSIRO).

A Branch member, Professor Monro was appointed a Companion of the Order of Australia in June 2022 for eminent service to scientific and technological development, to research and innovation, to tertiary education, particularly in the field of photonics, and to professional organisations.

## COLIN BERRYMAN OAM – A KOREAN WAR VETERAN

Colin Berryman OAM, an 89-year-old Korean War veteran and Branch member, recently visited the Republic of Korea (ROK), by invitation of the government for a reunion of UN War Veterans. While there, he was awarded the ROK Presidential Citation which was presented to him by the ROK Prime Minister at one of the formal functions. Colin has been performing extensive liaison and co-ordinating with the ROK Embassy now for the last half century, mostly as part of the function of performing duties as ACT Delegate of the Korean Veterans Association of Australia. Sadly, there are few from the Association still alive, although it still exists, as next of kin of surviving and deceased veterans still carry on the main functions. Colin will be returning to the Republic again this year, with the Department of Defence Korean Missing-in Action (MIA) Committee, on which he still participates. He was also invited back there again by the ROK Department of Patriots and Veterans Affairs. The MIA Committee is still working in close liaison with the Army Unrecovered War Casualties Section. Colin is an original member of this Committee which has been functioning now for many years. He was awarded a Medal of the Order of Australia in June 2004 for service to veterans and their families in the Australian Capital Territory.

Alison Andrews AM has been a journalist and writer since she started her cadetship at The Examiner Newspaper, Launceston, Tasmania in March 1970.

She has worked for a number of media organisations both locally and interstate, is a published author and has run her own media and public relations company.

Alison worked for many years as The Examiner's chief of staff and as its chief reporter and owned and operated Northern Tasmanian country newspaper, THE Northern Midlands COURIER, for seven years until she retired as editor in September 2022 after selling the paper earlier in the year.

While at The Examiner, a book of 100 Tasmanian people stories called Ali's People was published, selected from a weekly series by the same name which she wrote for six years. Proceeds from book sales were donated to the Friends of the Launceston Library to help support publication of local history books.

Alison has also served on community boards and organisations including TasDance, as director and chairman and director for Tasmanian Arts Advisory Board and Eskleigh Foundation. She was recently elected as a Councillor on the Northern Midlands Council.

Her AM was awarded for services to the media, particularly print media and to the community.

## LOU JOHNSON AM

Lou Johnson received an AM at the 2022 Queens Birthday Honours and after joining the Association will serve on the Northern Tasmanian Region Committee.

He has been associated with many organisations including schools, agricultural societies and the accounting profession but it is Rotary International where he travelled the world and has learnt the importance of real compassion.

His Rotary journey started in Launceston at the club level (Launceston West), then onto district level (Tasmania) followed by national appointments (Australia) and then international roles. At the international level his first challenge was learning to speak through interpreters and to speak slowly using simple words and pausing at the end of each sentence. This does not come naturally to Australians when they are enthusiastic about their topic.

The one constant over his nearly 40 years in Rotary has been the project to eradicate polio. This project appears constantly on the agenda at all levels. Rotary and its partners have reduced the number of wild virus cases by 99.9% but the remaining 0.01% has remained frustratingly beyond reach. The wild virus still circulates in Pakistan and Afghanistan, two countries where volunteers are not always welcome following incorrect publicity as to Rotary's intent. He is confident that Rotary will complete this project as history may be very unkind on this generation of Rotarians if they stopped now with the finishing line in sight. Lou continues to actively promote the work of Rotary and shares his passion for the eradication of polio as a gift to the children of the world.
