## GOVERNOR GENERAL'S REPORT

HIS EXCELLENCY GENERAL THE HONOURABLE DAVID JOHN HURLEY, AC, DSC (RETD)

It was a delight for Linda and me to be with so many members of the Association in Geelong for the National Conference.

Indeed, as I said in my speech at the conference, it was a delight because the opportunity to spend time with people who have been recognised in the Order of Australia is never to be missed and because I value the work of the Order of Australia Association.

I greatly appreciate the work you do in our communities and your custodianship of the Order.

Your membership of the Association tells me a lot about you. Most importantly, it's that you haven't stopped. You're still giving back, you're still looking out for other people, and you're still making a difference in our community.

It reinforces in me that recognition in the Order of Australia isn't an end point. People don't spend their careers or adult lives working to win a medal. They work to make an impact and to help those around them.

The theme of the National Conference, 'Working together – building the future', encapsulates that spirit perfectly.

The great strength of our system is that anyone, no matter who they are, where they are from or what field they have contributed to can be recognised. That egalitarian design principle is the Order's defining characteristic. Ours is a bottom-up system that relies on nominations. For everyone recognised, someone has taken the time to put them forward.

That means that the equality of design can only be reflected in outcome if there is equal awareness, understanding and ability to access.

Regarding awareness, more people than ever before are seeing, hearing and reading about the sorts of people recognised in the Order. We're also telling more and different stories, including talking to people who have nominated others in order to share their motivation and experience. We're working with diverse organisations, including FECCA, multicultural councils and many more, to reach new audiences.

To increase understanding, we've begun a regular series of live webinars — taking people's questions and making our team available to provide guidance. We're making more information public about how the process works.

To improve access, we've built a new nomination system. This new back end will make the nomination and sounding processes easier for the user and give us access to contemporaneous, detailed data to inform outreach efforts.

I value the partnership between my Office and the Association. You are the boots on the ground and people of influence in your communities. My Office stands ready to support your work in any way we can.

The work is ongoing, but I'm confident and pleased that, consistent with the theme of the National Conference, we are working together and building the future for the Order.

## THE HONOURABLE VICKI O'HALLORAN AO CVO



The Honourable Vicki O'Halloran AO CVO was sworn in as the 22nd Administrator of the Northern Territory on 31 October 2017 and remained in office until 30 January 2023.

As Administrator, Her Honour represented the Crown in right of the Northern Territory. Her Honour performs the constitutional role aligned to that of a State Governor.

Her Honour was born in Tasmania and moved to Darwin in 1989, where she has resided for the past 34 years.

As Administrator of the Northern Territory, Her Honour valued the importance of supporting and promoting the Territory and Territorians. She was Patron to 60 organisations, and actively supported the development of emerging Territory leaders. Her Honour was very passionate about sharing Government House Northern Territory with the wider community, and pursued innovative opportunities to enable access to thousands of Territorians and visitors each year.

Prior to her appointment as Administrator of the Northern Territory, Her Honour was Chief Executive Officer of Somerville Community Services. She has been a member of a range of boards and committees locally and nationally. Her Honour was Chair of National Disability Services Northern Territory, serving as National President of National Disability Services from 2012-2015, and Chair of the Northern Territory Government Ministerial Advisory Council on Disability Reform.

Her Honour was a Committee Member of the Northern Territory Government Community Benefit Fund, National Disability Insurance Scheme Pricing

Committee, National Disability Insurance Scheme Operations Committee, National Disability Insurance Agency, Independent Advisory Council's Housing Innovations Working Group and the Australian Institute of Company Directors (AICD) Northern Territory. She was also a member of the AICD Not for Profit Chairs Forum and the Territory Economic Summit External Reference Group.

Her Honour was also the Chair of the Northern Territory Housing Appeals Board for eight years and a member of the Children Australia Journal's Editorial Board. She has been a juror on numerous Award panels, most recently the Australian Institute of Architects Northern Territory Architecture Awards.

In 2015 Her Honour was a Territory (State) Finalist in the Australian of the Year Awards. In 2013 she was appointed to the Northern Territory Government Events Ambassador Program, a position she held for two years. Her Honour was named Telstra Northern Territory Business Woman of the Year in 1998.

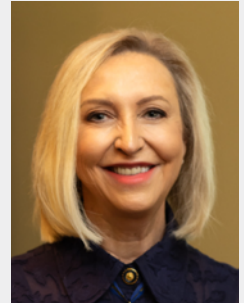
Her Honour has represented the Northern Territory on the national and international stage promoting the importance of good governance and social inclusion. During her tenure as Chief Executive Officer of Somerville the organisation was nationally recognised as an employer of choice and champion of cultural diversity.

Her Honour was invested as an Officer of the Order of Australia (AO) in 2019 for her distinguished service to the people of the Northern Territory. In 2014 she was invested as a Member of the Order of Australia (AM) for her significant service to people with a disability. In December 2022, Her Honour was appointed a Commander of the Royal Victorian Order (CVO) by His Majesty The King in recognition of her eminent service as Administrator of the Northern Territory during her lengthy term. Her Honour holds a Bachelor of Children's Services and a Diploma of Business.

Her Honour and Mr O'Halloran married in 1993. They have one daughter, Coco, who works and resides in Melbourne.

## NATIONAL CHAIRMAN'S REPORT

Our National Conference was held, for the first time, in a regional location rather than a capital city. Our meeting in Geelong, Victoria, was a great success with good attendance and the enthusiastic support of the Victorian Government, Geelong regional authorities, local business, and the community. A highlight was the awarding at the Annual Dinner, in the presence of our Governor General, Chancellor of the Order and our Patron, of four scholarships to tertiary students from the Royal Melbourne Institute of Technology, South Australia University and Adelaide University.

I congratulate the Victoria Branch Conference Committee, led by Helene Bender AM, for their success in staging the Association's first conference in a region rather than a capital city. I thank all who attended the conference and contributed to discussion, and those who expressed their views by proxy voting at our AGM.

The National Conference was, as always, a great opportunity for members to meet, renew and make new friendships and to appreciate the unique environment of each of our great States and Territories. A report on the National Conference is included later in this edition of the magazine.

Your National Board met face-to-face for the first time in 12 months during the Geelong conference. This was followed by productive discussion of Association affairs between directors and Branch chairmen. During the National Board meeting, I was re-elected as National Chairman, John Archer OAM was re-elected as National Deputy Chairman and Muriel Barasso OAM as National Treasurer.

We were pleased to welcome The Honourable Vicki O'Halloran AO CVO as our National President at the conclusion of our AGM on 20 May 2023. We look forward to her involvement with the Association.

The Conference saw vigorous debate of the Association position on the issue of the coming 'Voice' referendum. Decision on this is a matter for individual members, based on careful consideration of the facts of the matter and informed and objective debate. It would be inappropriate for your Association to take a position on this personal decision that is to be taken by every Australian.

A slight decline in Association membership is of note. Nominations in 2022 for an award in the Order were down 34% on the 'peak' year of 2019. Once nominated, 75% of nominations result in an award. I encourage members to be active in encouraging friends, colleagues, and organisations to nominate worthy Australians. To assist you, the OAA brochure 'Introducing the Order of Australia' is available from Branch secretaries, and further guidance is available on both the OAA and the Governor General's websites

We begin another year of active engagement throughout our Association, and continue planning for the next National Conference, In Perth WA, 16th to 19th May 2024. I look forward to another year of Association activity and the chance to meet many of you face-to-face in Perth in May 2024

**Mrs. Faye Miller AM** was Member for Katherine in the NT Parliament from 2003-2008 and the town's Mayor from 2012 – 2020. She will be honoured in a state funeral in Darwin on May 26.

**The Hon Brian Frank Martin AO MBE KC** served as the second Solicitor-general of the Northern Territory from 1981-1987 and was subsequently appointed a Justice of the Supreme Court, and then Chief Justice of the NT. In excess of eighteen multi-cultural communities dressed in their national costume to welcome delegates and Their Excellencies to the Vice-Regal reception in the Geelong Library & Heritage Centre on Thursday May 18. The Official opening of the national conference at the Geelong Events Centre on Friday was ably MCed by Diane James AM with Welcome to Country by Nikki McKenzie with Didgeridoo player Norm Stanley and the National Anthem sung by Geelong Lutheran College's Newtown campus students. The students stayed to hear the 2023 National Conference Address by His Excellency the Governor-General

Australia is facing innumerable challenges including but not limited to maintaining geopolitical stability in our region, managing our response to climate change, and ensuring that we remain a galvanised nation in the face of social divisions that seem to be emerging.

My thinking on these (and other) matters is that we should always continue to work to find solutions. However we should also take the time to consider our great fortune to call Australia home.

I am an optimist. Even with the many challenges that lie ahead I am confident that Australia will remain a great place to live and work and raise a family in the 2020s and beyond.

According to the IMF in calendar 2022 Australia ranked as the 14th largest economy on earth in terms of GDP and as measured in USD. No higher ranked country has a lesser population.

We are really rich per capita.

And while there are issues around the distribution of our wealth this challenge also applies to other nations.

In 1980 Australia ranked 20th out of 195 countries in terms of GDP per capita. Today, or last calendar year to be correct, we ranked 9th by this measure.

Our relative wealth per capita has risen over 40 years largely because we are very much a trading nation. Globalisation has delivered prosperity to the Australian nation and people.

But it's more than this. We Australians command the resources of an entire continent. Not even the Americans make such a claim. This makes us especially rich in terms of resources. The biggest mining company on earth (BHP) is based in Australia. We have rightly built corporate assets around our competitive advantage.

We have built a modern Australia largely founded on the basis of immigration. Around 30 per cent of the Australian population was born overseas. That proportion for the US is 16 per cent. For the UK it is 15 per cent. For Germany it is 14 per cent.

In the 2023 financial year we will bring in 400,000 net additional immigrants, the most ever added in any single year. A large part (around 100,000) of this number comprises foreign students returning to universities in and near our city centres.

Thereafter the immigration rate slows down.

With very roughly one-third of the Australian nation now comprised of overseas born residents we have shifted our culture.

We are now an Anglo-Mediterranean-Asian-Indian-Arabic fusion culture and especially our cities. In Melbourne and Sydney roughly 38 per cent of the population was born overseas.

As long as we offer new residents the opportunity to work, to contribute and to build a version of their dream—a job, a home, a family—then skilled immigrants will continue to seek out Australia.

Immigration plus resources as well as education, agribusiness, tourism, healthcare and so much more are the foundations upon which we have built our nation.

There are challenges that lie ahead and that must be confronted and managed. But we have overcome world war in the past, and the great depression and now two global pandemics.

And on the other side of these challenges we have come out maybe a bit battered and bruised but we have always been optimistic about the future.

We are a young, capable, confident people, with resources, with skills, admired by others and envied by others again.

There is every reason to think that beyond any current crisis, beyond any emerging division, beyond the myriad future challenges presented by climate change, we can and we will prevail.

As indeed we have prevailed over the most recent pandemic. We have emerged from that experience more determined to rebuild a better version of the nation we left behind (in 2019).

And if I haven't yet convinced you as to why Australia is still the lucky country then consider this question: where else is better?

What nation other than Australia offers the freedoms, the quality of life, the prospects for growth, the geopolitical alliances, the resources that we offer?

And if by some remarkable chance you are able to find a fictional place, a notional country, that delivers on all these and other measures, then ask yourself whether that 'other country' offers anything that can compare with Australia's weather, beaches, bush and, frankly, authentic, can-do call-a-spade-a-spade people.

And so it is for this reason that I say Australia was, is, and is likely to remain the lucky country.

# HIGHLIGHTS OF THE ANNUAL GENERAL MEETING AND THE MEMBERS FORUM HELD ON SATURDAY 21 MAY 2023

## ANNUAL GENERAL MEETING

One hundred and one members attended the meeting and there were one hundred and forty-five valid registered Proxies lodged by COB 12 May 2023. Forty-nine apologies were received (including National Treasurer). It was noted that about 33% of the attendees were attending their first Association AGM.

Barry Nunn, the National Chairman advised the Association was without a National President during 2022 thus he would be chairing the meeting. Vickie O'Halloran AO.CVO has been appointed as National President for three years commencing 21 May 2023 and will chair future general meetings.

In presenting his 2022 National Chairman's Report he noted that:

- The year will be remembered with great sadness at the passing of Her Majesty Queen Elizabeth II and the accession of His Majesty King Charles III, who is now Sovereign of the Order of Australia.
- 2022 was very much a transition year as our Association moved from a period of meeting and movement restriction under COVID to the ability to again work face-to-face. Member participation in activities, event and meetings resumed quickly as a result of the great work done by all to retain contacts and enthusiasm throughout the organisation in the earlier restricted period.
- A very successful National Conference, originally planned for 2021, was held in Canberra in May 2022.
- The National Board met face-to-face only once during the year, at the National Conference. The remainder of its 7 meetings were held on-line, a much higher frequency than that limited by time and cost constraints in prior years. The Board completed work on a suite of governance documents that should provide a framework for future operations and continued the development of strategy and growth through Board committees.
- Helene Bender AM, John McKellar AM and Robin Watts AM left the Board during 2022. We welcomed as incoming directors Kathy Wooldridge OAM, Joe Ienco OAM and Clive Robartson AM.
- While international events resulted in considerable movement in Association investments, business activity was healthy with an underlying surplus generated.
- Branches were active throughout the year in promoting the Order, maintaining member interest and in arranging successful activities. Member donations to Association Scholarships were promoted and as a result scholarships sourced from member donations are to be presented at National Conferences in Geelong in 2023 and Perth in 2024.
- The strength of any voluntary organisation is in the willingness of its members to cooperate, communicate and participate. In 2022 this has been well demonstrated and on behalf of the National Board I thank all members for their great contribution to another successful year.

The Annual Financial Report was presented by the National Secretary in the absence of the Treasurer.

Highlights of the 2022 year included in the Annual Report included:

- Membership Fees were held at level of previous years;
- Trading Income increased by 12% ;
- We had a surplus of \$77,466 excluding investment value decrease;
- The average income per member was \$47.00 and the average expense per member was \$39.72 The details of this income and expenditure were illustrated by 'pie charts';
- The National Investment Income increased by 10 % but investment value reduced by \$133,074 to \$1,702,162;
- Administrative Grants to Branches totalled \$49,500;
- Members Equity (assets-less-liabilities) decreased by 15% primarily due to changes in investment value;
- The Order Magazine costs were held at \$58,667 despite increases on cost of printing and postage.
- We welcomed 547 new members and 61 members re-joining but regrettably lost 785.;
- At year end the Association strength was 8045 members- a net loss of 177 members;
- The Conversion rate of Award recipients to Association membership increased;
- The Board had set aside \$45,000 from the 2022 surplus for a Foundation Scholarship to be awarded at a time decided by the Board.

All business requiring member approval was passed unanimously.

### Member's Forum

The National Chairman welcomed members to the Annual Members Forum and reminded members that this was their meeting and a time to raise any issues of concern or suggestions for improvements.

Matters raised included.

- The Voice Referendum.
- The future of the Conference-agreed to continue holding an Annual Conference.
- Give consideration of providing electronic copies of presentations.
- Survey Conference attenders and non-attenders.
- Newer members not always made to feel welcome at Branch Functions.
- The current and future Strategic Plan.
- The Board has agreed to include paid advertising in The Order Magazine.
- Diversity increase is required.
- Suggestion that new awardees be given a one-year complimentary membership as a way of increasing membership.
- Review the OAA Values.
- Need to increase the awareness of The Foundation.

All matters were discussed in depth and, where appropriate, noted for further study by national and branch office-bearers.

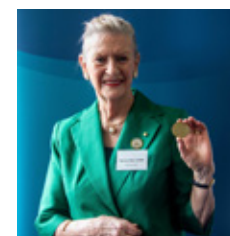

## LIFETIME SERVICE AWARDS 2022

On 24 November 2022 Norma Beer OAM was one of five extraordinary Western Australians awarded one of the inaugural Lifetime Volunteer Service Awards for over 60 years of voluntary service in a single organisation. Norma's 60 years of service has been with Rebound WA (formerly WA Wheelchair Sports Association) an organization dedicated to helping people with physical disabilities rebound from adversity. She is a life member and served in many positions on the Board as well as the Paralympic Medical Commission for Drugs in Sport along with being WA team nurse for 9 National Games, six International Games, and four Paralympics.

Norma Beer was a trainee nurse when she started working with the spinal-cord injured athletes at the first Paraplegic Commonwealth Games held in Perth in 1962. She has been involved in encouraging the public to change their attitude to those with a disability, especially the value of sports for those with a disability. In 2000 she was awarded a Sports Medal and in 2005 was awarded the Order of Australia Medal for services to the Spinal Cord injured community in nursing, research, and sport. She has an ongoing commitment to helping



others and is a very active member of OAAWA.

## KEITH RICKMAN OAM

Keith was awarded an OAM in the 2023 Australia Day Honours List for: Service to the Community of Stirling.

Keith is a West Australian, born in Midland, in a family of 4 boys. Keith has been in Waste industry for nearly 50 years and retired in 2021 but has been called back at times for occasional shifts within the City of Stirling.

At the age of 14 Keith left school and started working for Stirling Council as a “Garbo,” being part of a team of 4 in a truck who in those days picked up rubbish from the backs of houses. He worked his way up through the ranks and on his journey, he initiated many improvements in Waste management. He was a strong supporter of disability services and along with the city helped those with a disability in house training including hands on experience finding work in waste management. This was important to Keith who has a son with a disability. He has played a major part in Community Recycling, helping charities with their clothing bins, and introducing best practice guidelines leading to thousands of tons being diverted from landfill. He worked closely in assisting and establishing one of Australia’s leading electronic waste recyclers with Total Green Recycling. The City has received many awards in the waste industry.

From 1988 he was initially involved in the Waste management with the State Life Saving Championships and became more involved from 2006 when the City sent him and a team of officers to the Gold Coast to help with waste management and logistics when the all State and Australian Life Saving Championships with about 3,000 plus competitors, was held in Scarborough and has continued his support, mostly in WA and some interstate.

Keith is an active volunteer in the community. He drives the City of Stirling Community Bus and is part time manager of the Stirling Community Men’s Shed.

Keith is well deserving of his latest honour.

Elaine was a joint awardee of the 2020 International Standards Organisation Simon Holland Award – the first consumer advocate to have been awarded that honour. She has recently been awarded Life Membership of the National Council of Women of South Australia.

The guest speaker for our second honours recipients fellowship luncheon on Thursday 27 April was Lieutenant-Colonel David Brook AM (ret'd), who spoke on the topic: "Why the Naval, Military and Air Force Club was formed in 1879". David received the Medal of the Order of Australia in the 2016 Queen's Birthday Honours List, "For services to Military History and the Recreational Boating Industry".

David is a retired Regular Army artillery officer, who was born in Adelaide and was educated at Prince Alfred College. Called up under the National Service Training Scheme in January



1957, he was later commissioned and transferred to the Regular Army, and saw active service with the 12th Field Regiment, RAA in South Vietnam in 1968-69. David has written and lectured on military history topics. Notably, David has been a member of the Naval, Military and Air Force Club since 1966, and he compiled the book, *The Club: Martial and Mufti – the history of the Naval, Military and Air Force Club of SA (Inc)*.

## LYNN MASON AM



Lynn enjoying the beauty of Flinders Island

Lynn grew up in Queensland and met her husband Jamie in Greece, where they both worked on a charter yacht in the Aegean. On their return to Australia, they married and began their farming life on Flinders Island. Lynn rapidly became involved in island life, at first in pre-school and primary school activities. There was no pre-school at that time, so Lynn set up

informal play group sessions for parents with young children like their own. When school age came along a group was formed to try to get a gymnasium built for the school.

It wasn't long before Lynn thought that she could achieve more in the meeting room, instead of lobbying from outside. She served on Flinders Council for 33 years, 4 years as Deputy Mayor, six years as Mayor, and simultaneously six years as the President of the Local Government Association of Tasmania.

Lynn started a Tree Group to encourage growing seedlings that could be used as windbreaks or shelter belts, and to assist in beautification of the townships. She also made the mistake of attending a meeting of the little group that produced the Island News once a fortnight and came home as Editor. The entire paper was typed up by a wonderful group of volunteers and then printed off on a gestetner machine and then collated and stapled by another group of volunteers. (No computers then!)

On Council Lynn was immediately charged with organising for the Bicentenary Celebrations – another five years of fundraising and balls and sporting events, culminating in a wonderful day on 26 January 1988 where the greatly enhanced Museum was officially opened.

As Mayor, Lynn was privileged to work with the Flinders Island Aboriginal Association to try to resolve ownership and management issues at the Wybalenna site. The Council was awarded the community award for that work at the first National Reconciliation Conference. Council also agreed unanimously that Lynn, as Mayor, could apologise to the Stolen Generation children, many of whom lived on Flinders and Cape Barren.

After moving residence to Carrick, Lynn increased her board work, becoming Chairperson of the Tasmanian Community Fund, Chairperson of Tasmanian Affordable Housing Ltd, Chairperson of Metro Tasmania, Senior Vice-President of the Australian Local Government Association, Deputy Chairperson of Crime Stoppers Tasmania, Deputy Chairperson of the Primary Industries Education Foundation Australia, Deputy Chairperson of the Tasmanian Abalone Council, and a member of the Board of Rural Alive and Well. Lynn is a Life Member of the Local Government Association.

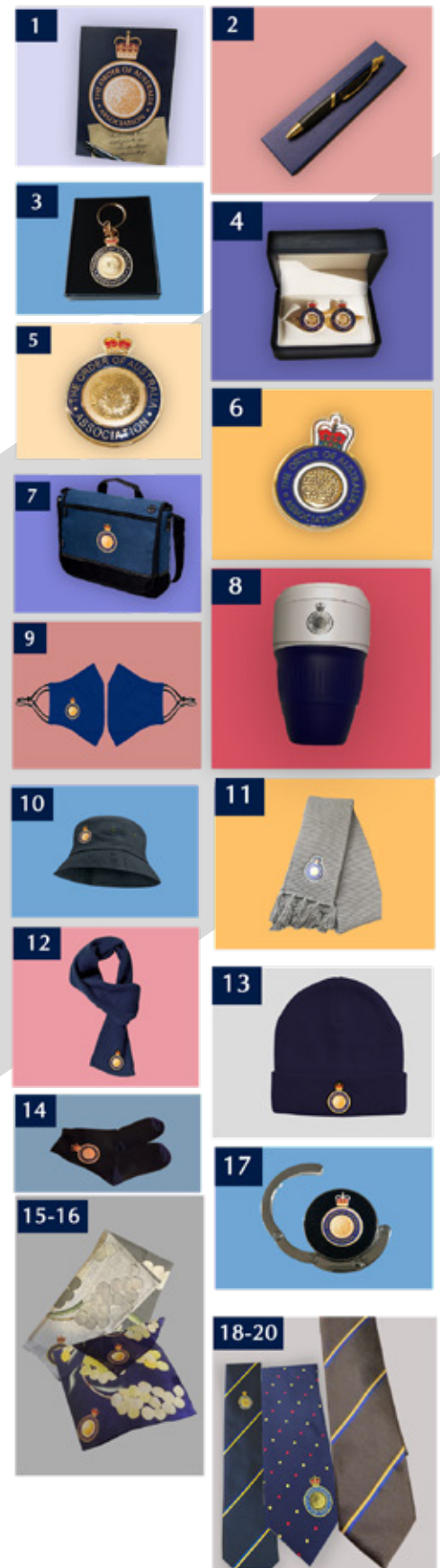
