Hope, Investment, and a Sliding Door





Have you ever experienced a 'sliding door' moment in your life, and then later stopped to think, what might have been? For many, that sliding door moment is all too familiar, and depending on which side of the door we walked through, the course of our future lives was altered forever. When we look back in time, with the clarity of hindsight, these moments always seem incredibly clear. However in the moment, they are innocuous events - part of our everyday lives. Although this might be the case, if we act with intent, we have the ability to create our own sliding doors moments whenever we wish.

Whether it be an innocuous moment, or a moment created with intent - we often see that a sliding doors moment has the power to change your life. When you couple this with considered advice, and a slightly adjusted perspective of money, the path to a purpose driven life is clearer.

And that is something we should 'hope' for all of us.

2023 ANNUAL SIR FRANK MACFARLANE BURNET GALA EVENT

Eighty members and guests met at Dal Mondo restaurant and function centre in Traralgon to participate in the 2023 Gippsland Regional Group Annual Sir Frank Macfarlane Burnet Gala Event on Wednesday evening 18th October.

Given the current cost of living difficulties faced by the community the event was considered a significant success despite the attendance number being down on last year where over 100 guests participated.

The speaker for this year's event was Professor H. Miles Price AM a world renowned haematologist who enthralled the audience as he explained how research was working towards eliminating chemotherapy as a treatment for cancer. He detailed the theory behind converting a person's own t' cells to be able to be injected back into the host (after specific treatment) to go about tracking down and destroying the cancer cells causing the deterioration of the patient's health. In other words, empowering the person's own immune system to fight the cancer cells through manipulation of the host's blood.



Included at the dinner were 10 students from Federation University, Churchill Campus whose attendance was wholly sponsored by Walter and Eliza Hall Institute. There were two other students who accompanied their parents to the dinner and, the Regional Group Committee was also very proud to be able to sponsor the Victoria Branch Order of Australia Association Foundation scholarship recipient (Alex Nair) who resides within the Gippsland Region.

Another special guest on the night was Jenny Dexter, who is Sir Frank's granddaughter. Jenny has made the trip down from Melbourne on several occasions now to join in the celebration of arguably Australia's most famous scientist on a date that is very close to the anniversary (20th of October) on which Sir Frank was awarded his joint Nobel prize for medicine.


Luncheon Report from Sunday October 8 at The Woolshed @ Emerald Bank, Shepparton

Guest Speaker Dr Pieter Mourik AM, gave a most entertaining presentation on "Then and Now; Changes in Medicine in My 50 Years". How much has changed in those 50 years!

More recently Pieter was the Indigenous Culture Town winner in the Keep Australia Beautiful 2023 awards for his work on Aboriginal Ring Trees.



In Northeast Victoria, with "manipulated" red gum trees known as Aboriginal Ring Trees hold significant historical value.

These trees, over 200 years old, were marked by Aboriginal groups to define boundaries and signify important sites. Scar Trees are protected, but Ring Trees are not yet safeguarded. Collaborating with Dhudhuroa Waywurra Nations, efforts to formally register and preserve identified Ring Trees are underway. Raising awareness is crucial, as many are unaware of their

existence, risking the loss of these historically important sites.

New member Milly Parker OAM

Walking to my seat after her Excellency the Governor presented me with an Order of Australia Medal September of this year, I wanted to remember everything about that moment. How on earth had I, Milly Parker from Bendigo and with a brain injury, wind up being honoured here in Government



House?

I owe my life to the volunteers of the Rochester SES who, in 1992, got out of their warm beds at 5am to attend to strangers in a terrible car accident. At just 21, I was one of those strangers.

That day I became a person with a disability, someone with a 'moderate' acquired brain injury, and told was told repeatedly not to expect much from myself career -wise. That was like a red flag to a bull.

For more than 25 years I've voluntarily fought alongside my beloved disability community for basic human rights and dignity in all manner of causes: including at the TAC, the Young People in Nursing Homes Campaign, and employment for people with disabilities and against discrimination of people with disabilities.

For nearly 15 of those years, I also ran Happy Yappers, a business I created ne world, including to Harrods.

around my disability. I made and sold dog biscuits around the world, including to Harrods. Of all this, I am most proud of being part of bringing the NDIS to disabled Australians. As my car accident happened in Victoria, the TAC was there to give me the resources to reach my potential as a person with a disability. It was unfathomable to me that this wasn't the case for most Australians with a disability.

I was there when the NDIS was just an idea and campaigned relentlessly for years with the disability community.

I told my story as a TAC client to show why a scheme like that needed to be expanded nationally.

And I sat in Federal Parliament when Prime Minister Julia Gillard made the NDIS a reality.

I am also proud of being part of the 2014 Four Corners program *In our care*, which exposed horrendous sexual abuse at Yooralla and contributed to the creation of many investigations, including the recent Disability Royal Commission. I hope now that this has concluded real change occurs.

New member profile Milly Parker OAM

I was awarded my OAM in 2018 for services to Disability through advocacy roles, but due to health issues, including PTSD, I was only well enough to receive it in person this year. I sincerely thank Wendy Heintz, Investiture co-ordinator at Government House for her kindness and encouragement over those five years.

Now my medal is finally where it belongs, at home with me. I smile every time I look at it and feel such pride at what the medal represents and at what I did to achieve it.

At the Investiture Ceremony, I fought back tears of joy, knowing I owed that moment to my disability my brain injury. My beautiful brain, which struggles daily but I've learned to live with and love – and I've achieved more than I ever could have imagined because of it.

Milly attended the Thank You Reception in October, her citation read by David Mann AM was:

For service to people with a disability through advocacy roles. The Victorian Multicultural Commission (VMC) was established 40 years ago and since then has provided Victoria with the support and guidance needed to create an inclusive and cohesive community for all.

The VMC was set up following the passage of the inaugural Ethnic Affairs Commission Act in 1982. It's primary role is one of advocacy between community and government, ensuring that the many communities who have made Victoria their home are represented and able to engage on aspects of policy debate as well as take part in all aspects of civic life in Victoria.

Our current appreciation of multiculturalism has not always been present in society. The White Australia policy was particularly damaging and was finally abolished in 1966. It was followed briefly by integration policy before Australia began to understand the social, economic, and cultural benefits that migrants brought to Australia and embrace multiculturalism.

Current Chair of the Commission Vivienne Nguyen is very proud of how far the Commission has come, since its inception, the VMC has played a vital role in promoting and celebrating cultural diversity within Victoria. It provides the

giving voice and visibility to communities that might be otherwise marginalised in policy debates and developments.

Recently, the VMC gathered with many former commissioners, community representatives, and agency stakeholders to mark the 40th birthday. Christina Despoteris OAM was a key public servant at Ethnic Affairs at the time and has fond memories of the landmark moment multiculturalism found its voice in Victoria.

At this event, Minister for Multicultural Affairs, Ingrid Stitt MP recognised the VMC's contribution to social cohesion, striving to ensure that when one community is uplifted, we are all uplifted.

Recently the impactful work of the VMC under the leadership of Vivienne Nguyen AM has included responses to natural disasters on multicultural communities, such as bushfires and floods for farmers and other victims.

Interestingly, the appointments of VMC Commissioners and Chairpersons over the 40 years reflect the patterns of migration to Australia. Vivienne Nguyen AM herself and her family settled here as refugees fleeing the Vietnam War.

Amongst all that work there are moments of celebration brings many together to enjoy the richness of diversity and the oneness of Victoria's community. These events include Cultural Diversity Week events each year in March, and the much-loved Multicultural Gala.

The Commission also supports a range of festivals and arts initiatives, the Italian Festa, Hispanic Festival, Lunar New Year, African Music and Cultural Festival, amongst others. Look out for the logo and you will see it everywhere.

Thankfully, we have moved on from the relics of the White Australia Policy with the VMC ensuring Victoria's multiculturalism continues to be a defining characteristic of our community.
