The Board met face-to-face for the first time in 2023 at Rydges Hotel in Geelong on 18 May prior to the 2023 National Conference. The Board meeting was followed by a meeting with the State and Territory Chairmen.

This meeting held an in-camera session to elect three members of the Executive Committee who had nominated again for office. Barry Nunn OA RFD ED was reelected as National Chairman, John Archer OAM was re-elected as National Deputy Chairman and Muriel Barasso OAM was re-elected as National Treasurer. As these were the only candidates for the positions, there was a debate about the need for more active succession planning.

A resolution recommending to the Board that the Honourable Vicki O'Halloran AO CVO (Former Administrator of the Northern Territory) be offered the position of

National President of the Association had been circulated to Board Members. This was unanimously agreed for the three years commencing on the 20 May 2023.

The Board agreed to proceed with an advertising trial in an issue of The Order. Suitable guidance on the type of advert acceptable will be developed by the Audit &Risk (A&R) Committee.

Financially, the OAA is trading with an acceptable surplus in 2023 to date, and slowly recovering the investment losses incurred over the previous years. It was agreed that a further \$30,000 be transferred from the cash account to the investment account.

The Board were pleased to note that the conversion rate of awardees to members in 2022 was the highest for some years at 38%. To date in 2023 it is at 27%.

It was agreed that a more coordinated effort was required in communicating the benefits of joining the OAA.

The means of adopting a Social Media Policy was once more considered. The Policy is being developed by the A&R Committee. This would be a trial of a single platform in one Branch as a first stage of implementation.

The Board reviewed the progress of the WA Branch in developing the 2024 National Conference to be held in Perth.

There was good news about the OAA foundation. Its 'corpus" now stands at \$2.7 million, providing support for two scholarships per year. The Foundation Directors are to be encouraged to meet with branch committees and to assist in attracting scholarship winners to speak at functions.

The next Board Meeting is scheduled on 16 June 2023 via TEAMS.

THE OAA-ADF ORATION



Members and guests gathered at Russell Offices Ngunnawal theatrette on 18 April for the 2023 Oration with Chief of Navy, Vice Admiral Mark Hammond AO RAN.

Vice Admiral Hammond sketched his views on the strategic situation, contemporary issues for his command and the critical role which the Royal Australian Navy will continue to play in the defence of the Nation. His emphasis on submarines drew a wide range of questions.

Vice Admiral Hammond was appointed a Member of the Order of Australia in 2018 and in the 2023 King's Birthday honours was appointed an Officer of the Order of Australia for distinguished service to the Royal Australian Navy in senior command roles.

MEET OUR MEMBERS

Reverend Joe Mullins MC, OAM is closing in on his 103rd birthday on 16 July. He grew up in the UK and served in the British Army in the Burma Campaign under Field Marshall Sir William Slim and was awarded the Military Cross for courage in battle. After the war he studied at Oxford University and gained an Honours BA and an MA and was ordained in the Diocese of London. Joe served for many years in India, including ten years as a Scripture Union missionary and it was there that he met his wife Edith.

Joe and his family arrived in Canberra in 1974 and he was appointed Associate Priest and then Rector of Weston Creek for eight years. His strong evangelistic ministry helped to lay the foundations for the building of the present St Peter's Church. After further service in North Goulburn, Pambula and Wanniassa, Joe retired in 1987. Reverend Mullins was awarded the Medal of the Order of Australia on Australia Day 1998 for service to the community, particularly through the Anglican Church and as the rector of St Peter's Church, Weston.
