# Mid-Year Lunch with Alaa Elzokm OAM

Imam Alaa Elzokm OAM believes the greatest impact of his work is in establishing and participating in peaceful and cohesive relationships between the Australian Muslim community and the wider Australian community.

"Particularly the youth," he says. "My message to all young people is to focus on respect and compassion towards all people, regardless of their culture or religion."



Recognised for his service to the Islamic faith, and to multiculturalism, Imam Alaa says he is motivated to overcome misconceptions spread among members of the community about both Muslims and non-Muslims and observes that often these misconceptions are held by youth, or by elders.

He says the award of the Medal of the Order of Australia is particularly special for him as a young Muslim Imam (religious leader) and also as a migrant.

"It shows that being from overseas, young and Muslim does not make it impossible to excel and make positive contributions to the Australian community. I hope my work sets an example for others to do their best and never be deterred by any challenge. Those who seek success will find it if they strive. I pray that it inspires others, particularly the youth from the Muslim community."

This Valentine's Day, SBS will re-write the book of love with *The Matchmakers*, a heart-warming yet confronting documentary series that dives into the unique and private world of three of Australia's most successful cultural matchmakers. All three episodes of the series will be available to stream free on SBS on Demand from Wednesday 14 February, with episodes airing weekly at 8.40pm.

# Mann about town: 50 years at 3AW for David Mann AM

December 17 2023 marked 50 years at **3AW** for **David Mann AM**. David is potentially the longest serving person at a single radio station, and perhaps also for the multiple roles he has held there either full time, part time, or now as Mann About Town.



David started as an office boy just before Christmas in 1973, before being promoted to panel operator, then given a journalism cadetship. The cadetship led to an on air role for two decades. He also was production manager, creative director and the promotions and marketing manager for 23 years, holding other positions such as Chairman of the Victorian Radio Time Club.

During the Ash Wednesday fires in 1983 3AW dropped all regular programming and used their immediacy to offer

on the spot assistance. A fundraiser that followed, which David was heavily involved in, raised more than \$1 million to distribute to people who had been left with nothing.

David also supports people during and after disasters in an operational capacity with more than three decades of service to the Melbourne Metropolitan Fire Brigade, Ambulance Victoria and the Victorian Police Force. He was awarded an Order of Australia Medal (OAM) in 2006 for

service to the community through a range of police, nursing, heritage and emergency services organisations and in June 2018 he was made a Member of the Order of Australia (AM) for significant service to the community of Victoria, particularly through charitable organisations, to business, and to the promotions and marketing sector.

Christmas Day last year marked the 35th that David has been a volunteer part of the Pensioners Christmas Party looking after senior citizens and single parents.

David has generously given of his time to MC numerous Order of Australia Assiciation VIC Branch events including the Inspiring Australians



On Wednesday 9 October David will MC the VIC Branch Thank You Reception for Order of Australia recipients who join the Association in 2024.

David Mann AM said: "When the world is bad, radio is good. The 3AW team, listeners and sponsors make a difference to those in need. It's still one of the most powerful mediums around and I'm very proud to be a part of the number one station in Melbourne."

#### Making a contribution in Tasmania and Victoria Heather Butler AM and Geoff Butler AM

A combination of community interests in the beautiful East Coast of Tasmania kept Heather **Butler AM** busy, leading to her Member of the Order of Australia in June 2012 for service to the community of the east coast of Tasmania, particularly through the tourism and hospitality sectors, to youth, and to the Parliament of Tasmania.

In addition to managing their tourism businesses, she developed the East Coast Counselling



Service, was a qualified company director for TT Line, RSPCA Tasmania, Uniting Aged Care, Break O' Day Tourism Association and the Friends of Appin Society. Following the sale of their businesses, Heather's strong interests in education, and community development, saw her Chairing the St Helens District High School Association, Community Bank Steering Committee, School Op Shop, initiating the Georges Bay Dragon Boat Club, and involvement with Naval Cadets and St Helens Hospital Auxilliaries.

In 2005 Heather was inducted to the Tasmanian Honour Roll of Women. The same year she was elected to the Tasmanian Parliament as a Member for Lyons, Heather undertook wide responsibilities including Government Whip and Parliamentary Secretary, Deputy Speaker, and membership of Joint Committees.

Since moving back to Gippsland, where her family settled in 1852, Heather has maintained an interest in community, family history and art. She is the Social Issues Officer for Bundalaguah branch of CWA and has fun in the choir. Membership of the Friends of the Gippsland Gallery gives cultural benefits and opportunities for budding artists, again featuring a strong commitment to community.

**Geoff Butler AM** initially became involved with community issues in Victoria when in 1979 until 1982 he was elected as a local government Councillor, chairing both finance and administrative committees.

During the next decade he became State and Regional Manager for a pharmaceutical company in Victoria, Tasmania and Queensland. A change of career saw Geoff and Heather move to Tasmania where they purchased tourism businesses on the East Coast.

Geoff became a member of the Tourism Council of Australia, Chairman of the local tourism group, East Coast Regional Tourism Association and established a co-operative chain of tourism businesses throughout the state.

For many years he served as President and Secretary of the Business Enterprise Centre, President of the St Helens Chamber of Commerce and St Helens Athletics Club, while running tourism businesses. Geoff also served as a Board Member of Medea Park Nursing Home and Residential Care and was a Volunteer Tasmanian Ambulance officer on the east coast.


From 2002 to 2012, Geoff was a member of the Tasmanian Pharmacy Board and Tasmanian Pharmacy Authority.

On 26 January 2015, Geoff was awarded Member of the Order of Australia for significant service to the community of Tasmania through health and aged care, sporting, business, local government and tourism bodies.

After 27 years in Tasmania, Heather and Geoff returned to family and friends in Gippsland. Geoff has joined the Friends of the Gippsland Gallery, Sale and Districts Aeromodellers Association and the Gippsland Vehicle collection Inc. With 11 grandchildren, there are many visitors and life is full.

A couple who have made an excellent contribution to their communities in Tasmania and Victoria – thank you.



# Making a difference to the experiences of our Veterans' Terry Black OAM and Regula (Reg) Black OAM

I **Terry Black OAM** was a young man who had no idea of what the future would bring when I joined AMP in 1965 as a callow youth aged 16. After a few years I was required to register for National Service and "won" the ballot. After Army recruit training I was allocated to the Royal Corps of Australian Electrical and Mechanical Engineers (RAEME). Conscription was a life-changing event, ultimately involving 12-months active service in Vietnam.

On discharge, I returned to AMP and spent 40 years in various roles, mainly involved with the superannuation and financial planning sector. I am a Life Member of the AMP Advisers Association, having been involved as Secretary and President and a 15-year sub-committee role involving regular meetings in Sydney negotiating with AMP management.

I met Reg shortly after my discharge and we married in 1972, two years after my return from Vietnam and two weeks after **Reg Black OAM** graduated from Teachers' College. Reg's passion for education led to further studies at Melbourne University where she obtained her Bachelor of Education degree then a Post-Graduate Diploma in Special Education whilst working full time in mainstream education.

Reg's Special Education career continued until 2006 when she retired due to work-related injuries. Subsequent spinal surgeries caused nerve damage in her legs and a dropped foot. I too retired early due to health issues, since resolved.

During our working careers we were both active volunteers on various committees and with other organisations, and achieved great satisfaction in those roles.

I had been asked by one of my superannuation clients whether she had enough capital to retire. During my fact finding, it emerged that she had been married to an older WW2 veteran who had since died. His history suggested that we should apply for a War Widow's pension from DVA, which was granted 8 days after lodgement. This single event made me realise the power of advocacy. As a direct result of this experience, I joined Legacy and remain active.

Our involvement in the RSL (since 1970) became our social network and soon became much more. I was coerced into a committee role as Secretary and spent 10 years negotiating with State branch to ensure the viability of our Sub-Branch.



I was also on an RSL State Sub-Committee for many years and mentored other RSL's experiencing trading or committee difficulties.

Prior to each ANZAC Day and Remembrance Day, schools in our area were invited to the RSL to meet Veterans, to learn about the veterans' experiences and life during and after their service and also learning about Australia's commitment to world peace and lessons learned. I and a few others represented Vietnam during these sessions.

Reg was also asked to sell raffle tickets on a Friday night – the ubiquitous meat raffle. On one of these evenings, she was asked to assist with the taking of minutes at a Women's' Auxiliary meeting - her first introduction to the work of the Auxiliary and she was very quickly voted in as Secretary.

Reg organises many fundraising events, from Opera on the Hill and other RSL days, raising much needed funds for veterans. She also organises an annual Christmas lunch and a mid-year lunch for the local community, raising further funds for Veterans and their families. Through this work she was named RSL Club Person of the Year in 2010. She was awarded Life membership of the National RSL Women's Auxiliary in 2019.

I undertake the organisation of the annual Long Tan dinners, sourcing guest speakers and am MC on the evening. Funds from these evenings are donated to various organisations including ward 17 at Austin Health, where many veterans are in great need of medical and psychological support

I remain active with Legacy (supported by Reg) and ultimately had 60 legacy widows under my care – although their numbers are diminishing - providing them with support to claim pensions and assistance through DVA, to enable them to live independently. I became a JP in 1999, as this

helped facilitate the paperwork necessary for their claims and was available to other Legatees for this purpose. Together, we delivered Christmas gifts to these widows each year ensuring that they were aware of services Legacy provides. As we've gotten older, I now send a Christmas letter to each.

We are also involved in the Anzac Day badge appeal and the Poppy appeal and with the



community Commemorations conducted locally on ANZAC and Remembrance days. Reg and her sister-in law, Donna, have made all the wreaths laid by local organisations for the past 18 years and coordinated the afternoon teas for attendees after the services.

Reg is also committed to the Family Life charity and works as a volunteer in their Op Shop distribution warehouse two days a week and assists with their monthly Saturday sale.


We have worked side by side complimenting each other and we feel we have a mutual purpose in contributing towards and making a difference in our community through awareness and care. We often reflect on how a society like ours would function without the many millions of volunteer hours contributed across the country.

On Australia Day 2018, I was awarded an OAM for my contribution to Veterans and their families. In 2021 Reg was awarded an OAM in the Queen's Birthday list for her contribution to the Veteran community. # Which medal to wear when?



#### **Day Functions**

The full-size insignia (Main Piece) is generally worn at day functions where decorations have been prescribed by the event, for example Anzac Day, Remembrance Day ceremonies or special services such as a State Funeral, Memorial or Thanksgiving Service.

#### **Evening Functions**

At events such as evening receptions and dinners where decorations have been prescribed, the miniature insignia is generally worn. The main exception to this is Neck Decorations (AC and AO), which are worn in full-size.

#### Every day Wear

A lapel pin may be worn on civilian clothes at any time. Only one badge should be worn at a given time and not when other insignia pieces are worn.
