### BRANCH NOMINATED DIRECTOR'S REPORT



The national Board Meeting was held via TEAMS on Friday 15 December 2023 with all Directors present. In addition, Frank Crawley OAM, the incoming National Treasurer (From 1 Jan 24) sat in as an observer.

The Finance Report was once more positive with a surplus still to be reduced by end of year payments, and the market value of OAA investments has increased by \$88,000 due to the recovery of the share market.

The financial Review Framework project was discussed, with an examination conducted of the budgets and business plans of those Branches that had submitted them. There would be a face-to-face review at the meeting of Directors and Branch Chairs at the National Conference in Perth in May.

The National Membership Director presented a table of the conversion rates of honours awardees for branch's membership and indicated that she would be further refining the results.

The Perth Conference preparations are on track and the National Chairman Indicated that it was the intention of the Governor General to attend the conference. The Sydney conference has contracted a conference organiser and plans were proceeding well, but it was noted that the costs of the conference in Sydney were likely to be high.

The Chairman of the Marketing Committee noted that there had not been a rush of applicants to advertise in '*The Order*' but the Committee was working on encouraging selective advertising. He also noted that one of the factors which could be slowing awards for honours was the long gap between the nomination and the award. Despite this there was still a need for a greater diversity in applicants.

The proposed changes in the membership fees were agreed.

The Chairman reported on the OAA Foundation's financial performance with six scholarships confirmed and announced for 2024.

The National President reported that she recently had a productive meeting with the Governor General, highlighting with him the increasing lag in award decisions, the possible use of emails to contact recipients, Branch involvement in investiture ceremonies, school curriculum and conference planning.

The Board also considered a plan for further social media development by a sub-committee of the Board's Marketing Committee to be chaired by the National Membership Director.

The next meeting of the Board to be held by TEAMS on Friday 16 February 2024.

### OAA-ANU LECTURE – MONDAY 6 NOVEMBER 2023

**Professor Kiaran Kirk AM,** Dean ANU College of Science, delivered the 2023 OAA-ANU lecture on *Humanity's ongoing battle with infectious disease* at the ANU Kambri Cultural Centre following an introduction by ANU Vice-Chancellor Professor Brian Schmidt AC.

In his address Professor Kirk dealt with a complex subject in a form for the audience to easily understand the issues regarding the development of vaccines, and how vaccine-resistant and drug-resistant pathogens are continually emerging, necessitating the ongoing development of new vaccines. He also reflected on the significant contribution that the ANU has made, and continues to make, to the development of measures to prevent and treat infectious diseases, including bacterial infection, viral diseases such as smallpox, and the parasitic disease, malaria.


Professor Kirk was appointed a Member of the Order of Australia in January 2023 for significant service to science education and research, and to professional organisations.

#### 2024 AUSTRALIA DAY BREAKFAST

We were privileged to have Gary Humphries AO as the guest speaker for the annual Branch Australia Day Breakfast held at the Hyatt Hotel, Yarralumla. Gary was a senator for the ACT from 2003 to 2013, Chief Minister of the ACT from 2000 to 2001, and a member of the ACT Legislative Assembly from its inception in 1989 until 2003.

In his presentation, Gary explored some of the research he has undertaken as part of his PhD thesis at the ANU. He is writing a history of ACT self-government, describing events in which he was sometimes a participant. He explained that it took 166 years for self-government to come to every community on this continent – the last being the national capital. He discussed the reasons for this, and the fears of local residents that self-government would mean the end of generous Commonwealth spending in Canberra. This was evident in the referendum for ACT self-government held in 1978 and rejected by 63.75% of the voting residents.

Gary described the fractious result from the first ACT election, where anti-self-government MLAs made up almost a quarter of the parliament! A highlight was to see and remember the voting sheet that included 117 candidate names and was about a metre long, which took election staff hours to unfold and weeks to count, with party names which included *Party! Party! Party!* and *Sun-Ripened Warm Tomato*. He outlined the machinations that led to the formation of the first ACT government in May 1989; a group of new MLAs gathered on the morning the government was to be elected in an attempt to elect Liberal leader Trevor Kaine as the first chief minister, but when Kaine stormed out of the meeting in a huff, the plan broke down. Instead, ALP leader Rosemary Follett was elected Chief Minister later that day – the first woman to lead an Australian government.

Gary said that he considered the real purpose of studying history was to understand human nature better and guide us in making better decisions by understanding how well our predecessors made similar decisions. He said that one question his thesis (also soon to be a book) would try to answer was: considering all the original anxiety about self-government, has it been a success or have people's fears of 1989 been realised?

Gary's presentation was well received by the 82 attendees, most of whom have been keen observers of the ACT self-government process over the years, and they appreciated the detailed insights that Gary was able to relay to them.

A branch member, Gary was appointed an Officer of The Order of Australia in January 2019 for distinguished service to the Parliament of Australia, and to the Legislative Assembly of the Australian Capital Territory.
