Nominations were received from 35 senior schools and colleges across the State, and included 11 Catholic colleges, 12 state secondary schools/colleges, one Islamic college, three Lutheran and eight independent schools/colleges.

## NEW RECIPIENTS' RECEPTION

In our second New Recipients' reception for the year, held on Monday 16 September, we acknowledged nine new recipients announced in the King's Birthday Honours List, and two who had been announced in the 2024 Australia Day Honours List.

We thank the City of Norwood, Payneham and St Peters for their generous support and assistance, and Mayor Robert Bria who gave the welcome address.

The guest speaker was Mr David Seaton OAM, on the topic: "63 years a Chartered Accountant and other things". David was awarded the Medal of the Order of Australia, "For service to the community through roles with medical education, health administration and charitable organisations, and as Honorary Consul for Sweden in South Australia" (AD09). David also holds the Australian Defence Medal and the Anniversary of National Service 1951-1972 Medal,

acknowledging his service with the 1956 intake, with the 16th National Service Training Battalion at Woodside Barracks in the Adelaide Hills.

David has been a Fellow of the Institute of Chartered Accountants (Australia and New Zealand) for more than 60 years. Besides his professional career, he has held board positions and has been chairman and committee member for many professional bodies. David served as the Honorary Consul for Sweden in South Australia from 1986 until 2009, for which he was appointed Commander First Class in the *Kungliga Nordstjärneorden* – the Royal Order of the Polar Star (KNO). This is a Swedish order of chivalry created by King Frederick I on 23 February 1748, to reward Swedish and foreign merit and devotion to duty. Between 1975 and 2023, the order was only awarded to members of the royal family and foreigners, notably foreign office holders. The order is also known as the 'Royal Order of the North Star'. Its motto is *Nescit Occasum*, a Latin phrase meaning 'It knows no decline'. This identifies that Sweden is as constant as a never-setting star.

## COMMEMORATIVE EVENTS

Korean War veteran John Jarrett AM was a very special guest at a Korean War Commemorative Service held on Saturday 27 July which acknowledged the 71st anniversary of the signing of the 'Korean Armistice Agreement' on 27 July 1953, which brought fighting to an end in the Korean War. John served in Korea from 30 May 1953 and beyond the Armistice through to 29 August 1953, and for two further periods of duty in November-June 1954 and July-August 1954. He was recently appointed a Member of the Order, *For significant service to community health, and to veterans and their families* (AD23).

Several members and Order recipients attended a Vietnam Veterans Commemorative Service on Sunday 18 August, which honoured the service of all Australian, New Zealand and Republic of Vietnam service personnel who fought in the Vietnam War, and particularly the 523 Australians, 37 New Zealanders and as many as 300,000 service personnel from the Republic of Vietnam who lost their lives during the Vietnam War.

On Friday 30 August, a Malaya and Borneo Veterans Day Service of Commemoration was held in the West Torrens War Memorial Gardens, hosted by Major Paul Rosenzweig OAM (Retd), who is President of the SA & NT Branch of the National Malaya & Borneo Veterans Association Australia Inc. In this ceremony, the focus was kept on a select group of family members honouring specific named personnel who served or lost their lives in the Malayan wars.

For the Dardanelles Cenotaph Commemoration on Sunday 8 September, hosted by the Legacy Club of South Australia & Broken Hill together with the Australian War Widows (SA) Inc, the Master of Ceremonies was Legatee Mark Bouchier OAM, who received the OAM, *For service to the community of South Australia* (AD20).

Ms Tanya Kaplan OAM, Honorary President of the Turkish Association of SA, recited the Atatürk Statement. She had received the OAM *For service to Turkey-Australia relations, and to the veteran community* (QB17).

On Friday 20 September, members attended an East Timor Veterans Commemorative Service to mark the 25th anniversary of the first Australian Defence Force deployments to East Timor. This was the largest ADF deployment since the Vietnam War. More than 5,500 Australians deployed in the Australian-led operation to restore peace and security in East Timor – facilitating ongoing UN humanitarian assistance operations and subsequent nation-building operations.

**Mrs Jenny Macintosh OAM.** A number of SA Branch members attended a 90th birthday celebration for Jenny Macintosh OAM. During the event, a special announcement was made by Jan Forrest OAM, who is State Advisor to the South Australian Trefoil Guild (ATG) of Girl Guides Australia. Jan had received the OAM in 1991, *In recognition of service to youth through the Girl Guides Association* (QB91). Jan presented Jenny with a very special certificate and badge, *For a lifetime of service to Girl Guides in South Australia, interstate and overseas, and lately to Trefoil Guild South Australia.*

The ATG looks to connect women who are either actively involved in Girl Guiding or have a history with Girl Guiding. Each Trefoil Guild is a self-governing body and is financially self-supporting. Each State has a Trefoil Guild Adviser who keeps Guilds informed of activities and events through their state newsletter. Jenny received the OAM in 2011: *For service to the community, particularly through the Embroiderers' Guild of South Australia, and to the Guiding movement.* Congratulations Jenny!

**Fellowship Luncheons.** For the Fellowship Luncheon held on 29 August, the guest speaker was Ann Ferguson OAM JP, who was awarded the OAM, *For service to local government and to the community* (AD14). Branch Treasurer John Ziesing OAM provided this report on the meeting:

“While 26 members enjoyed an excellent meal at the Naval, Military & Air Force Club, guest speaker Ann Ferguson OAM JP spoke about life on Kangaroo Island and local government. Ann was born and raised on Kangaroo Island – her parents were in local government, and she just assumed that’s what you do.

Ann moved to Mt Barker in 1964 and began training at the Mt Barker and District Soldiers’ Memorial Hospital. She married Malcolm, and they have four children and four grandchildren.

Ann thought her natural progression through the influences of her parents was to be involved in local government – several years later, she was Councillor (1991-03) and then Mayor of Mount Barker District Council (2006-10), and delegate to the Southern & Hills Local Government Association. She worked with the State Government to improve the infrastructure of one of the fastest growing towns in SA. Ann had a major involvement with the Mount Barker Agricultural Society, with recognition as Life Member.”

In May this year the Australian Ambassador to France, Her Excellency Gillian Bird, kindly hosted a lunch at the Australian Embassy in Paris for OAA members and Order of Australia recipients resident in Europe. Eight OAA members travelled from Britain to the event, joining members and guests based in France and

elsewhere in Europe.

During the event the Australian Ambassador honoured General Elrick Irastorza (Retd) by appointing him a Member of the Order of Australia (AM) *For significant service to the relationship between Australia and France during the ANZAC Centenary Commemorative period in France (2014-2018)*. General Irastorza was former Chief of Staff of the French Army. Also present were 10 mayors from towns in Northern France whose annual commemorative events honour the Australian troops who served in their locality, especially during the First World War. Other participants included Stéphane Jacob-Langevin AM, who runs the Galerie Arts d'Australie in Paris, featuring Australian artists, especially Aboriginal and Torres Strait Islanders.

On Thursday 17 October members of the UK/Europe Branch of the Association and their guests were privileged to attend a private showing of the newly opened *Nala Ngura* exhibition of Australian art in Paris by leading Indigenous artist Konstantina, presented by the artist herself together with gallery owner Stéphane Jacob AM. The art series is on show at Arts d'Australie Stéphane Jacob in the Marais district of Paris until 25 January 2025. It reimagines the traditions of Aboriginal artists and offers a modern narrative illustrating Konstantina's passion for language, culture and history of First Nations people in Australia. Guests enjoyed an excellent dinner afterwards in the adjoining Bistro Parcelles.

And sometimes more serious views, briefly expressed. They also reflected his large range of friends from all over the world, many originally met as his army and research career took him and his dearly loved wife, Margaret, around the world. It was his work with the Australian military that resulted in his being honoured as a Member of the Order of Australia.

During my six years chairing our UK/ Europe OAA group, Brian was a much valued supporter of events, regularly making the trip from his home in France to join us. It was a further support when Brian accepted my invitation to join our committee. He was hugely helpful, often enabling events at his London club, the Army and Navy, taking the time and trouble in many practical ways. He had the courage and common sense of the true military man. How grateful I will always be for that.

I salute him. He will be greatly missed.

### ANNUAL YOUTH SERVICE AWARD

Twenty-six Year 11 and 12 students from high schools across NSW were recognised for their community service at a special ceremony held at Government House in Sydney on 25 October. These very special awards were presented by our Patron and NSW Governor, Her Excellency, The Honourable Margaret Beazley AC KC.

Family members, friends and school principals attended to congratulate and celebrate these amazing students. Several members of the OAA NSW Branch Committee were also on hand to congratulate the students.

The students are recognised for the work they do in their communities – such as organising blood donation drives, finding ways to improve mental health issues in sport, organising gift packs for mums and dads staying at Ronald McDonald House, a blind equestrian raising awareness of people with disabilities, environmental work and improving the environment for a platypus. There were so many wonderful stories from these young people.

In his opening address, NSW Chairman, Dr John Gullotta AM, thanked Her Excellency Margaret Beazley AC KC for hosting the awards once again at Government House. "It is such a fitting location to present these prestigious awards to our NSW Year 11 and 12 student recipients," he said. "The OAA Youth Community Service Award is conducted annually by the NSW Branch of the Order of Australia Association. The Award recognises community service by individual students that would not normally be recognised by their school systems, that usually reward academic, sporting and leadership achievements. This Award recognises the significant service performed by students beyond their school boundaries in the wider community, in the areas of Campaigning and Fundraising, Mentoring and Volunteering".

Communities served by past awardees range from local to state, national and international. The Award was initiated in 1992 by

Dr John Lincoln AM and first offered in 1993. It has been offered each year since then (except in 2020 because of Covid).

It was renamed the John Lincoln Youth Community Service Award on John's passing in 2012 but reverted to its original title of Youth Community Service Award in 2019. 2024 marks the 30th year of the Award.

This year nominations were sought from 972 NSW high school principals whose schools offer the NSW HSC (Higher School Certificate) or IB (International Baccalaureate) programmes. Nominations are considered by a judging panel of three Order of Australia recipients: Mrs Lynnette Smith OAM, Ms Judy Gray OAM and Prof Jim Pratley AM.

This year there were 42 nominations of which 26 students were selected and recommended for the Award. For students not selected, Certificates of Commendation in recognition of their service were presented at their respective school award ceremonies.

Since inception we have awarded 690 Youth Awards, 411 to young women and 279 to young men. Most of the recipients are from Sydney (421), Greater Western Sydney and the Blue Mountains, with the rest of state at 269. A total of 280 schools have nominated students for an award over the past 30 years.

Dr Gullotta AM concluded by thanking Dr Frank Kelleher OAM for his work as Convenor for the past seven years, the judges of the Award and our Patron, Her Excellency Margaret Beazley AC KC and her highly efficient team at Government House, Sydney for hosting the event.

John concluded by saying, "Once again, as NSW Chairman and on behalf of our NSW Branch Committee, congratulations to all the Awardees for your exceptional, excellent work and dedication to community service. Your citations are certainly a true inspiration to us all".

Following the ceremony, the recipients, family members and friends joined Her Excellency for canapes and drinks in the beautiful gardens of Government House Sydney.



## LUNCHEON IN DUBBO

On Saturday 19 October, 72 people attended a luncheon at Dubbo RSL Memorial Club to congratulate the 2024 Australia Day and King's Birthday Awardees. Many had travelled for four hours or more to attend. They came from as far away as Louth, Cobar, Nyngan and Gilgandra.

Guests arrived to hear the beautiful piano music being played by Paul Young, Director of the Macquarie Conservatorium.

Regional Convenor, Ruth Shanks AM, welcomed everyone. OAA NSW Branch Regional Coordinator David North OAM brought news from both the National and the NSW Committees. David then congratulated and recognised the 2024 Awardees present.

Sue-Ellen Lovett OAM, a blind dressage competitor and Paralympian, represented Australia at the Paralympics in Atlanta in 1996 and Sydney in 2000. Ellen Stanmore OAM received her award on Australia Day for decades of helping the community, particularly the Royal Flying Doctor Service. Sue-Ellen hails from Mudgee and told the story of her long-distance horse riding. In 1997 she rode from Melbourne to Sydney to raise money for the Sydney 2000 Paralympics. In 2018 she rode more than 800km all around the Central West area to raise funds for the oncology unit at Dubbo Hospital. She raised \$80,000 on that ride. Sue-Ellen is an author and has written several books, including

On 7 August, on a wintry Perth evening, 21 awardees and their guests were welcomed by the Right Honourable Lord Mayor, Mr Basil Zempilas, City of Perth and the Chairman of the OAA WA Branch, Mrs Bettine Heathcote AM, at the City of Perth Council

House. The Lord Mayor welcomed everyone on behalf of the councillors and the team from the City of Perth. He pointed out how important these receptions are in highlighting the variety of backgrounds and different fields of each recipient. He spoke about the honour to his mother and family when she received an OAM in 1996.

Bettine welcomed the new recipients and encouraged them to join the Association, discussing the Foundation Scholarships, the recent National Conference in Perth and the activities of the WA Branch, particularly the Police Patron Scheme. The award and the citation of each recipient was read out. The citations were once again overwhelming with the amount of volunteering and community support that each recipient has made.

Suzanne Ardagh AM responded on behalf of the recipients and thanked the City of Perth for holding the reception. She congratulated the award recipients and said, "Let's celebrate each other and the great things happening in Perth".

Maj Gen Barry Nunn AO, OAA National Chairman, spoke about the honour to be again at Perth Council House and thanked the team who made the evening successful. He pointed out that the awards are really team awards for behind each recipient are family, friends and colleagues who give support. The evening concluded with a delicious supper.

**WA BRANCH ANNUAL DINNER 2024**

On a beautiful Spring evening with a nip in the air, 99 members and their guests enjoyed a delicious three course meal at the Royal Perth Golf Club, a favourite venue for many years. It gives the attendees the opportunity to dress for the occasion and everyone looked very special.

The speaker for the evening was Nicholas Hasluck AM, retired QC, Australian novelist, poet, short story writer and former judge on the Supreme Court of WA. He spoke of the Order of Australia recognising people of exceptional achievement and those who have provided outstanding community service.

Nicholas then described his father's appointment by Her Late Majesty, Queen Elizabeth II, as a Knight of the Garter. His father was the son of impecunious Salvation Army Officers but who won a scholarship to Perth Modern School, became a journalist and then was recruited to the Department of External Affairs in Canberra. Towards the end of WW II, Paul Hasluck represented Australia at the United Nations. He was elected to federal parliament as the member for Curtin, serving as a cabinet minister continuously from 1951 to 1969. After five years as Governor-General, while in retirement, he was appointed a Knight of the Garter in 1979. Nicholas spoke of the Most Noble Order of the Garter and his father's appreciation of the link with the UK and western civilisation.

On his father's death, Nicholas found in the safe with his valuables, a Deed of Covenant, signed by his Father, that on his death the complete insignia of the Order of the Garter, including the Garter, the Lesser George, the Star, and the Collar with the George appendant be returned to the Queen. Nicholas then described the journey to the UK, the meeting with the Queen and the handing over to her of the Garter Box containing his father's insignia. In a beautiful service in St George's Chapel, Windsor, he was handed his father's banner

that had been hanging in the Chapel. The Hasluck Banner is now hanging in St George's Cathedral in the city. This, Nicholas said, is a visible reminder of the bond between the Anglican Church in Australia and the rich and varied history over many centuries of the Church of England in the British Isles.

Nicholas Hasluck ended by saying, "I have spoken of these matters this evening not so much as a reminder of the past but as a reminder that institutions honouring the importance of communal service are common in many countries of the world. Our Order has its own special features, including a diverse membership, with a view to acknowledging the work of men and women from many backgrounds. We are naturally inclined to respect our feelings for customs brought to us from far afield but, in the end, our inheritance is not nostalgic for Europe or other places but the fulness of a new experience in Australia. The Order of Australia was established with this in mind and to recognise through communal links the importance of devoting a portion of our time to something older and much greater than ourselves".

**Peel Region:** On 4 September, the Mayor of Mandurah, Rhys Williams and the Mandurah Council gave a civic reception for recipients of the Order of Australia, with 31 recipients in attendance. The mayor spoke of their past and ongoing contribution and asked them to consider using their skills to mentor and guide young people in Peel.

**South-West Region:** On 18 October, in a beautifully restored room, 65 OAA members and friends attended the South-West Region's Annual Lunch at the historic Rose Hotel in Bunbury. This beautiful building has been and is still being restored, keeping in mind its long history. Attendees were welcomed by Hon Barry House AM, convener of the South-West Branch. The Host of the Hotel, Matt Jeffrey, spoke of the hotel's history and the many owners. The first Rose Hotel was built in 1865 and rebuilt in 1904. ### VISIT TO THE ROYAL FLYING DOCTOR SERVICE

Members of the Tasmania Branch, Northern Region, visited the local Royal Flying Doctor Service (RFDS) base on 7 August and were informed about the extensive programmes they provide

including their dental outreach service which delivers more than 15,000 free dental treatments each year. Supporting residents in rural and remote areas across Tasmania, the RFDS Tasmania primary health team also delivers more than 7,800 consultations each year in areas of mental and physical health including cardio. Members also had the opportunity to inspect a dental mobile bus and an air ambulance where the duty pilot outlined the operations, often flying 1,100 patients a year.

### ELIZABETH (LIBBY) PERKINS OAM

Elizabeth (Libby) Perkins lives at Gunns Plains on the north-west coast and was recognised with an OAM in the Australia Day Honours List in 2022 *For service to the community through a range of roles, in particular veterans.*

In 1969, at just 18 years of age, Libby waved a consent form in front of her father for him to sign and began her life of service

when she joined the Women's Royal Australian Army Corps (WRAAC) at the height of the Vietnam War. It was a far cry from the teaching career that her mother wanted for her. She served with several signal regiments during her three years, but her final deployment was to the 9 ANZUK Signal Regiment in Singapore as a Corporal. Libby undertook special training and received top-secret clearance. Swearing an oath to uphold the Official Secrets Act, she was tasked with encrypting and decrypting messages, especially highly secret correspondence coming in from Vietnam. Libby was only granted permission to speak about her life 30 years after the completion of her service, when it was acknowledged that she had indeed served overseas for her country during the Vietnam War. Her commitment to duty and her comrades was evident from the beginning, and her dedication continued long after her service to the WRAAC concluded in 1972. Libby was awarded an Australian Service Medal 1945-1975 with a SE Asia Clasp.

The experiences and connections Libby made during this time influenced and encouraged her to join the Ulverstone sub-branch of the RSL in 2004 where she

became an indispensable member of that community, ensuring the ongoing needs of veterans and their families are met. Over the years, she has held numerous positions, including vice president on three occasions, and in 2010 became the first woman in more than 95 years to be president of an RSL sub-branch on the NW Coast. Libby is also the first woman in 108 years to receive life membership of the Ulverstone RSL sub-branch.

Libby often says, "Soldiers today are not the stereotype. Nowadays, some of the soldiers are five-foot one. They are mothers. I can cook scones with the best of them. But I am not the wife of a returned soldier; I am a returned soldier."

Libby, also a JP, ensures her time is well spent visiting veterans, volunteering at the Visitors Information Centre, and attending committee meetings within the municipality. Living in a rural setting, she also keeps a vigilant eye on the welfare of veterans living in the outlying areas. She is currently undergoing state branch training to transition to welfare support officer within the sub-branch, a further example of her commitment to the wellbeing of her fellow veterans.

**North East Victoria and Goulburn Valley:** On 20 October, a glorious spring day, with the sun shining on the lake in front of the Woolshed reception centre in Shepparton, the North East Victoria and Goulburn Valley Regional Group held a very successful Spring luncheon.

Regional Group Chair Mary Lou Davis OAM welcomed 50 members and guests to the event. Following a delicious lunch, the participants settled back to hear one of the members of the group, Don Kilgour OAM, speak about the golden days of radio and television.

Don had an extensive career in both radio and television as well as being a former member of the Victorian Parliament. Those present were reminded about what they had listened to on the radio as they grew up and what they watched in the early days of television.

Don spoke about the emergence of radio in the 1930s and what it meant particularly to country people living a distance from regional centres. It was good to remember programmes such as the *Quiz Kids*, *Life with Dexter*, *When a Girl Marries* (for all those in love and those who can remember), *Dad and Dave*, *Smokey Dawson*, *Martins Corner* and *Blue Hills*. The news bulletins were most important to keep people up to date with national and international affairs, especially during the Second World War.

Children loved stories in the breakfast programmes like *Davey Crocket* and *Rick O'Shae* and in the afternoons with *The Air Adventures of Biggles* and the schoolboy pranks in *Yes What*. There were also birthday calls and kindergarten of the air. The ladies were catered for with programmes like *Portia Faces Life*, *Dr. Paul* and *Sara Dane*. In the evening a highlight was the quiz programmes hosted by Bob Dyer and Jack Davey.

Radio provided farmers with vital information through a stock market report. Local church ministers gave a thought for the day and an epilogue and a most important segment was the funeral announcements each morning to advise when local funerals would be held.

Radio jingles helped sell products for the advertisers with ads for products such as BEX Powders and Tablets, Dr. McKenzies Menthoids and Ford Pills.

In the early 1960s the introduction of television brought major changes to radio listening when radio had to supply what television could not such as popular music and instant news. Television was hugely popular with classic programmes such as *Bonanza*, *Rawhide*, *Father knows Best*, *Leave it to Beaver* and *Disneyland*.

The electronic media, both radio and television, played an important role in everyday life and those present enjoyed the opportunity to think about their favourite entertainment programmes in the past.

It was an enjoyable and memorable afternoon with lots of laughter and discussions afterwards.

The group's next luncheon will be the AGM at the Benalla Lakeside Community Centre on Sunday 23 March 2025 with guest speaker Dr. Will Twycross OAM.

### COLIN KRYCER OAM

Colin Krycer OAM was delighted to be at the Victorian Reception for new recipients of the Order of Australia for his services to the LGBTQIA+ community.

To say that he is a tireless advocate is an understatement. Colin took the time out for this interview upon his return home from an event he was heavily involved in: the 20th anniversary event for the Australian LGBTQIA Multicultural Council, of which he is a founding member. The interview was squeezed into then moving on to other commitments. It is this quiet, sustained and focused energy that seems to characterise his work.

Colin explains, "Volunteering has given me the absolute delight of meeting the most extraordinary, wonderful people and giving me the opportunity to give something back to my Victorian LGBTQIA+ community."

By profession, Colin was a Court Services public servant to which he dedicated 29 years of service. Alongside this role, Colin saw a need in the community and stepped up to provide a voice and advocate for the LGBTQIA+ community. He became a volunteer for the Victorian AIDS Council, now known as Thorne Harbour Health, of which he has received life membership.

"Back then it was all about volunteer care teams and hands-on assisting people with HIV/AIDS. Very grim days back then," he says.

Colin was not deterred by the 'grim' and difficult days during a period when misinformation fuelled discrimination against the LGBTQIA+ community. The community felt marginalised and voiceless as many suffered and lost their lives to HIV/AIDS.

However, the community has moved on and Colin continues to his volunteer his time, experience and expertise. "Today with Thorne Harbour Health I volunteer to make fundraising events happen, not only for them but for several other LGBTQIA organisations such as Living Positive Victoria, Melbourne Gay & Lesbian Chorus, Melbourne Rainbow Band, Positive Attitude."

Colin has been a long-standing board member of the Pride Foundation Australia, a philanthropic organisation run by a team of amazing volunteers. He is also a past convener of the AIDS Memorial Quilt. To add to his CV, he is a founding member and one of the original on-air presenters of LGBTQIA FM station, JOY 94.9.

This has all been as a volunteer. When asked about his motivation for all the voluntary work he contributes across the community, Colin explains that he simply loves "helping out and making a difference to peoples lives".

Colin is proud of his Order of Australia recognition and has become a member of the Association. For Colin it is an opportunity to meet other interesting people who have also contributed in various ways to the community.

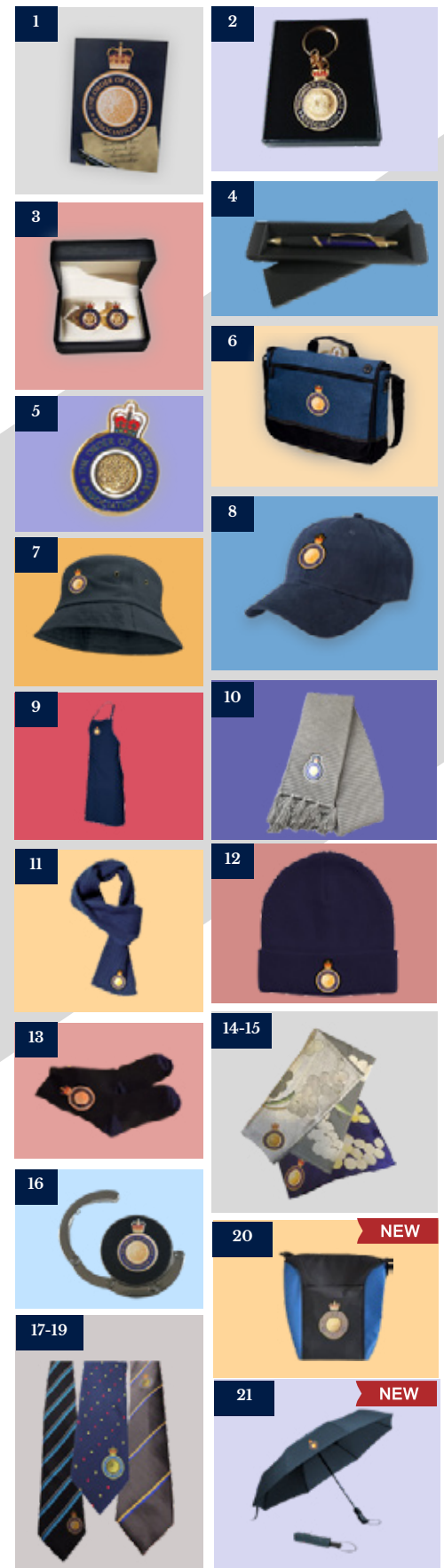
"Had I not been awarded an Order of Australia Medal, nothing would have changed and I would still be volunteering but, having said that, having the respected medal does put a little spring in my step. It's nice to know people appreciate what I love doing," he said. "I really like that the Order of Australia Medal is awarded to many volunteers from varying fields of work. 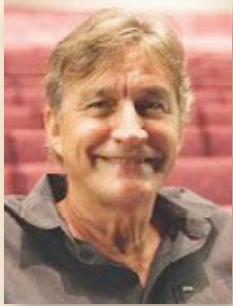

## FEATURED AWARDEES

Committee member **Wayne Kraft AM** is one of the founders, along with another of our members, Ted Egan AO, of Mates of the Murrumbidgee. In late 2020, a group of Mates decided that it was time to work with government to drive the resurrection of the Newcastle Waters Historic Township. This station and small township grew up at the junction of the biggest stock routes in North Australia, with huge historic significance. The Mates are working at preserving the remnants of the township and creating a sustainable vision for the future, involving opportunities for tourism and cultural interaction with the Marlinja Aboriginal community. The inaugural meeting of the Mates, at the Junction Hotel in Newcastle Waters, numbered 40 and, after successful promotion and newsletters, there are now more than 400 Mates from around Australia – you too can join! The group is working towards centenary celebrations in 2026. On 4 June 2026, it will be a century since the Northern Australia Act gazetted that Newcastle Waters would be the capital of North Australia.

**Doctor Grahame Webb AO** is continuing his distinguished service to environmental conservation and to wildlife preservation. Dr. Webb is recognised as one of the world's leading authorities on crocodilian research and management. During his research, he has worked closely with Indigenous communities, learning from methods of traditional management. Dr. Webb believes that conservation of wildlife will be enhanced if landowners can derive economic benefit from using wildlife sustainably, thus ensuring that crocodiles, numbering now more than 80,000, become a valuable asset to the Northern Territory.

**Lesley Woolf OAM** is Manager of Mala'la Health Service Aboriginal Corporation. Lesley has been a nurse, midwife and health administrator more than five decades, and was honoured this year in June. Ms Woolf has transitioned two health services to the Aboriginal community-controlled health organisation (ACCHO) model, making a tangible difference to the lives of Aboriginal Australians. "In most big health departments," Ms Woolf says, "decisions are made for the good of the territory/state, whereas we can concentrate on the community. It's really important that they have a voice".

## SECONDARY SCHOOLS CITIZENSHIP AWARDS – STILL GOING STRONG AFTER 25 YEARS

The Honourable Paul de Jersey AC CVO KC, the former (26th) Governor of Queensland, again presented the Secondary Schools Citizenship Awards at the annual Awards Presentation Ceremony in the Premiers' Hall of Queensland's Parliament House on Friday 13 September 2024. Paul performed his role splendidly and his address to the gathering, reflecting on life for students 25 years ago compared to now, was most incisive.

This was the 25th (Silver) Anniversary of these awards being conducted by the Queensland Branch, and it was another inspirational and memorable occasion. We were very pleased with the response from 60 secondary schools this year comprising both state high schools and private colleges from across Queensland, and we received a creditable 109 student nominations, 15 more than last year.

The 2023 awardees have told us of the diverse ways they have benefited from the Scholarship's financial assistance.



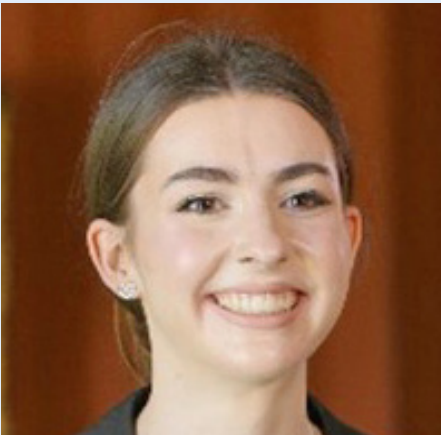
**Hukam Kohli** (Law/Commerce, University of Western Australia) says the financial support has allowed him to focus more deeply on his studies without the burden of financial stress. "This has allowed me to excel in my degree," he says, "with my passion for commercial and corporate law growing significantly due to the intersection between incorporating this work within my outreach in the community".



**Chelsea Allen** (Bachelor of Business and Health Science, Swinburne University of Technology), explains how the funding has facilitated her studying in Sweden, allowing her to "challenge myself and step outside my comfort zone".



**Luke Barron** (Bachelor of Marine Science, Deakin University) has fully immersed himself in his studies, while working and volunteering in ways aligned to his career ambitions. This includes working “with the Warrnambool City Council on the Middle Island Project where Maremma Guardian dogs were used to protect the local population of Fairy Penguins, and run tours to engage the public with active conservation initiatives.” He also travelled to Borneo, the Philippines and Indonesia, where he explored a possible Honours Project on the uses for plastic pollution. Luke has taken on a “placement with Parks Victoria monitoring invasive kelp within Port Phillip Bay and with the Wetland Revival Trust working with Indigenous Rangers in Northwestern Victoria revegetating and rehydrating native wetlands”.



**Lotte George** (Bachelor of Biomedical Science, University of Western Australia) travelled to Port Headland in regional Western Australia with the Teach Learn Grow Rural Programme to tutor mathematics and science at a primary school. She says she has chosen elective units without economic restrictions and has applied for postgraduate medicine through the Graduate Entry Medical School Admissions System (GEMSAS) after sitting the Graduate Medical School Admission Test (GAMSAT).



**Bree Harris** (Bachelor of Exercise and Sports Science at Charles Darwin University) gave more time to her studies, completing 140 hours alongside accredited exercise physiologists, gaining hands-on experience with clients. This has sparked an interest in neuromuscular rehabilitation, working with clients with neurological conditions such as cerebral palsy, traumatic brain injuries and multiple sclerosis.



**Roisin Wallace-Nash** (Bachelor of Performing Arts, WAAPA) initiated the development of her first professional play as a writer and performer. The Scholarship has allowed her to dedicate time and practice to her first professional work. She is embarking on international travel for training to enhance her skills and contribute to her current play “Stacks”, providing an opportunity to work with global peers and mentors.
