THE GENESIS

- THE ORDER OF CANADA
 - 1967 CENTENARY OF CANADIAN CONFEDERATION.
 - LESTER PEARSON (PM), JOHN MATHESON (Politician / Judge), JOHN HALSTEAD (Diplomat / Academic).
 - 1966 SUGGESTED A SINGULAR CANADIAN HONOUR TO COINCIDE WITH CENTENARY.
 - TO BE CALLED THE ORDER OF CANADA.
 - 2nd ONLY TO IMPERIAL ORDER OF MERIT.
 - OM PERSONAL GIFT OF SOVEREIGN.
 - OM ONLY 24 LIVING RECIPIENTS.
 - FOR OUTSTANDING MERIT / DISTINGUISHED SERVICE.
 - ANY CANADIAN COULD NOMINATE.
 - ADVISORY COUNCIL TO CONSIDER NOMINASTIONS.
 - DETACHED FROM POLITICS.
 - APPROVED BY GOVERNOR-GENERAL
 - CORNERSTONE FOR THE CANADIAN HONOURS SYSTEM.
 - INSTITUTED IN 1967 AS SOCIETY OF HONOUR COMPANIONS, OFFICERS & MEMBERS.

 SERVING POLITICIAN & PUBLIC SERVANT INELIGIBLE FOR NOMINATION.

• GOUGH WHITLAM.

- o 1967 ELECTED LEADER OF ALP.
- THUS, LEADER OF THE OPPOSITION.
- o ASKED QUESTIONS IN THE HOUSE.
- ADDED THE AUSTRALIAN HONOURS SYSTEM TO HIS 'ITS TIME TO DO LIST.
- ALP VIEWED THE IMPERIAL HONOURS SYSTEM AS A CONSERVATIVE CLOSED CLUB.
 - POLITICAL PATRONAGE INFLUENCE OF ELITES
 - GG, STATE GOVERNORS.
 - PM, STATE PREMIERS.
 - SENIOR BUREAUCRATS AT ALL LEVELS.
 - MINIMAL INVOLVEMENT BY ORDINARY AUSTRALIANS.
 - A VIEW FROM A POLITICAL PARTY OUT OF GOVERNMENT FOR OVER 20 YEARS!!
 - BUT SO MUCH OF THIS WAS TRUE!!

- THE ELECTION OF THE ALP TO GOVERNMENT.
- A TIME OF GOVERNMENT AND POLITICAL REVOLUTION.
- A TIME OF BUREAUCRATIC & ADMINISTRATIVE UPHEAVAL.

- THE DAWN OF A NEW AUSTRALIA OR THE END OF CIVILISATION AS WE KNOW IT!!
- WHITLAM & BARNARD SWORN INTO MULTIPLE MINISTRIES, UNTIL 19 DECEMBER.

- o FREE TERTIARY EDUCATION.
- **OUNIVERSAL HEALTH CARE (MEDIBANK)**
- LAW REFORM FAMILY COURT, NO FAULT DIVORCE / HUMAN RIGHTS / ANTI-DISCRIMINATION LEGISLATION.

 - ALP SMALLER MAJORITY IN REPS BUT 3 EXTRA SENATORS.
- O NEW GG SIR JOHN KERR. 11 JULY 1974.
- o JOINT SITTING. 6 AUGUST 1974.
 - LEGISLATION PASSED.
- CONTINUED PARLIAMENTARY WARFARE.
- KHEMLANI AFFAIR.
- MINISTERIAL RESIGNATIONS.
- BLOCKING OF SUPPLY.
- o DISMISSAL. 11NOV75.
- IMAGE ON STEPS OPH.
- THE CREATION OF THE ORDER OF AUSTRALIA WAS CONDUCTED INSIDE THIS POLITICAL, LEGISLATIVE AND ADMINISTRATIVE WHIRLPOOL.

• 1972 / 1975 – CREATION OF THE ORDER.

- o DECEMBER 1972 PM INSTRUCTIONS.
- INTENDED TO DISCUSS WITH THE QUEEN, 1973. (ACTUALLY DECEMBER 1974.)
- THE ORDER OF CANADA WAS THE DECLARED REFERENCE MODEL.
- BUT THE ORDER OF AUSTRALIA WAS TO BE CLEARLY 'AUSTRALIAN'.
- THE PM'S NON-NEGOTIABLE FACTORS.
 - DIVORCED FROM POLITICAL PATRONAGE.
 - DIVORCED FROM INFLUENCE OF ELITES.
 - EGALITARIAN NOMINATION PROCESS.
 - MANAGEMENT OUTSIDE NORMAL BUREAUCRATIC STRUCTURES.
 - ADVISORY COUNCIL.
 - GOVERNOR-GENERAL APPROVES HONOURS.

• THE 'CLUB' IS NOT AMUSED.

- WHILE OF COURSE THE 'NEW' MINISTERS AND PERMANENT HEADS FULLY SUPPORTED THE PM'S INITIATIVE.
- MANY POWERFUL PEOPLE & OFFICES DID NOT LOOK KINDLY ON THEIR POSSIBLE DIMINISHED POWER & INFLUENCE.

- THE ORDER OF AUSTRALIA CONCEPT BECAME FOR SOME A TOTEM OF POLITICAL & SOCIAL DISSENT TO THE WHOLE ALP AGENDA.
- THE IMPERIAL HONOURS CONTINUED AT STATE LEVEL.
- o MORE ON THIS LATER.
- ADMINISTRATIVE REALITY 1974 / 75.
 - THE GG HAD NO STAFF, NO OFFICE SPACE & NO PROCEDURES OR PROCESSES TO ADMINISTER THIS NEW HONOURS SYSTEM.
 - SIR DAVID LIAISED WITH CANADIAN AUTHORITIES, OVER 1974, AS INTERIM MEASURE, FOR 1975 LAUNCH.
 - EVENTUALLY IN EARLY 1975 HE WAS DESPATCHED TO CANADA AND THE UK TO ACQUIRE MORE BACKGROUND AND IDEAS.
 - BILL HESELTINE (SIR WILLIAM) WORTH RESEARCHING
 - WEST AUSTRALIAN. PM DEPARTMENT. SECRETARY TO MENZIES, ACTING OFFICIAL SECRETARY TO GG.
 - PRESS OFFICER ROYAL HOUSEHOLD 1960's
 - ASSISTANT PRIVATE SECRETARY (EVENTUALLY PRIVATE SECRETARY) TO OUEEN.
 - 'BACK HOME KIND OFFER FROM 'SIR HUMPHREY.'
 - 'HUMPHREY' IN INTERESTS OF PRIVACY!!

- PERHAPS THE FEDERAL BUREAUCRACY COULD ASSIST BY LOCATING THE NEW HONOURS SECRETARIAT IN VARIOUS GOVERNMENT OFFICES?
- PERHAPS EVEN FINDING SOME TEMPORARY STAFF AND A SOUND SENIOR APS OFFICER TO LEAD THE HONOURS SECRETARIAT?
- GG THANKS, BUT NO THANKS.
 - REFERS TO PM'S FOUNDING DIRECTIONS & DOCUMENTATION.
 - HIS OFFICIAL SECRETARY WILL BE SECRETARY OF THE ORDER.
- OLD COTTAGES AND STORE ROOMS WERE CLEANED OUT.
- DESKS, CHAIRS ETC AND STAFF WERE BEGGED, BORROWED AND ACQUIRED!
- THESE OFFERS OF 'ASSISTANCE' WERE REPEATED THROUGHOUT THE EARLY YEARS WELL INTO 1982 / 1984.
- VARIOUS GG's DECLINED GRACEFULLY!!
 - REFERS TO PM'S FOUNDING DIRECTIONS & DOCUMENTATION.

o FORMAL APPROVAL FEBRUARY 1975.

- PM WHITLAM MET QUEEN DECEMBER 1974
 THE LETTERS PATENT FORMALLY APPROVED ON 14 FEBRUARY 1975.
- LEADING TO A FIRST LIST QUEEN'S BIRTHDAY 1975.

- NOTE: AUSTRALIAN BRAVERY DECORATIONS WERE ALSO APPROVED.
- INVESTITURES 1975 / 1977.
 - FIRST LIST OF 106 QB 1975.
 - **COMPANIONS SIX**
 - OFFICERS EIGHT
 - MEMBERS NINETY TWO
 - BUT NO MEDALS (ADDED IN 1976 WITH KNIGHTS / DAMES).
 - THE QUEEN WISHED TO CONDUCT THE FIRST INVESTITURE, DURING HER FORTHCOMING VISIT (PERHAPS LATE 1975 / EARLY 1976).
 - BUT CERTAIN POLITICAL EVENTS INTERVENED!!
 - IN THE EVENT IT WAS 1977 BEFORE THIS INVESTITURE WAS CONDUCTED.
 - 106 RECIPIENTS PLUS GUESTS WERE ASSEMBLED IN CANBERRA AND HER MAJESTY CONDUCTED A VERY SOLID ONE HOUR CEREMONY.
 - NEVER AGAIN. COST / LOGISTICS.
 - BUT OF COURSE BY THAT TIME THERE WERE 4 MORE LISTS, INCLUDING QB 77, AWAITING INVESTITURES.
 - THE GG GOES ON THE ROAD!!
 - GOVERNMENT HOUSES IN EACH STATE, THEN DARWIN, KATHERINE & ALICE SPRINGS.
 - NEVER AGAIN!!

- FROM AUSTRALIA DAY 1978 THE STATE GOVERNORS TOOK OVER SHARING THE WORKLOAD.
- 1982 NEW GOVERNMENT HOUSE & LODGE?
 - SIR HUMPHREY RETURNS.
 - MOVE HONOURS SECRETARIAT.
 - LOWER REFURB COSTS.
 - GG SAYS NO REFERS TO FOUNDATION PRINCIPLES OF 1972.
- 1983 / 1984 NEW ALP GOVERNMENT.
 - PM HAWKE ANNOUNCED INTENDED COMPLETION OF THE AUSTRALIAN HONOURS SYSTEM
 - CONSPICUOUS, GALLENTRY, MERITORIOUS & APS AWARDS.
 - AS ORIGINALLY INTENDED BY PM WHITLAM IN 1972.
 - A THWARTED BUREAUCRATIC 'COUP".
 - CABINET DECISION RE REVERTING TO NOMINATIONS VIA PM, PREMIERS (75%) AND ONLY 25% THROUGH THE COUNCIL.
 - NO CONSULTATION WITH GG. SIR NINIAN STEPHEN, AFTER CONSULTING THE CHIEF JUSTICE, RAISED THE MATTER WITH THE THEN PM, MINISTER(S) IN HIS CAPACITY AS CHANCELLOR.
 - REFERS TO PM'S FOUNDING DIRECTIONS & DOCUMENTATION.

- POSSIBLE CONFLICT WITH LETTERS PATENT?
- OBTAINING SOVERIEGN VIEWS?
- PRESENTATION OF A FAIT-ACCOMPLI!!
- THE CABINET SWIFTLY MET AND CANCELLED ITS DECISION!!
- THE ADDITIONAL COMPONENTS OF THE HONOURS & AWARDS WERE INSTITUTED IN 1989.
- 1990 NEW YEARS LIST THE END OF IMPERIAL HONOURS FOR AUSTRALIA.
 - NO AUSTRALIAN NOMINATIONS.
 - LETTER FROM SIR WILLAM HESELTINE CONVEYING HER MAJESTY'S BELIEF THAT NOW WAS THE TIME TO HONOUR AUSTRALIANS EXCLUSIVELY IN OUR AUSTRALIAN SYSTEM.
 - PM WHITLAM'S GOAL ACHIEVED.
- 1996 ONWARDS.
 - SIR HUMPHREY IS BACK AGAIN!!
 - INDEED, ABOUT EVERY 7 YEARS OR SO, ON ANY EXCUSE!!
 - GENERALLY REPULSED BY REFERENCE TO PM'S FOUNDING DIRECTIONS.

REWINDING TO 1972.

- 1972 DECISIONS RE MEMBERSHIP OF ADF.
 - SIR ARTHUR TANGE SECRETARY OF DEFENCE. WORTH RESEARCHING.
 - GOVT DECISION HENCEFORTH ONLY AUSTRALIAN CITIZENS COULD BE IN ARMED FORCES.
 - ORDER OF AUSTRALIA POLICIES, PROCESSES & CHECKLISTS, BEING DEVELOPED 1973 / 1974.
 - CIVIL (GENERAL) DIVISION CHECK 1 AUST CITIZENSHIP?
 - MILITARY DIVISION NOT THERE!!
 - BECAUSE ONLY AUSTRALIAN CITIZENS COULD BE IN ARMED FORCES.
 - O MY LITTLE SAGA!!
 - 1987 QB APPOINTED MEMBER MILITARY DIVISION.
 - BUT NOT AN AUSTRALIAN!!
 - A LESSON LEARNED AND RE-LEARNED OVER 40 YEARS AS AN ADMINISTRATOR.
 - THE IMPORTANCE OF AN HISTORICAL UNDERSTANDING OF THE SYSTEMS ONE ADMINISTERED.

CONCLUSION THE FUTURE

FIFTY YEARS FOR THE ORDER OF AUSTRALIA. AN EMBARRASMENT OF RICHES (NOMINATIONS). DELAY IN RESULTS.
