Inspiring Australians Oration

The Inspiring Australians Oration held at The Angliss Conference Centre on Friday 28 March 2025 was delivered by John Wylie AC titled 'A love letter to Australia'.

The event was well attended by OAA VIC Branch members, friends and a representation of secondary students from Strathcona Grammar School. Further, a string quartet provided background music to welcome everyone and the Viva Voci choir from St Catherine's School sung a beautiful rendition of the National Anthem and an inspirational song to end formalities. Beverley Pinder OAM an OAA VIC Branch committee member MCed the Oration.

In delivering the Oration John Wylie AC (photo on the right) described his experiences of Australia's unique assets – its remarkable geographical features, resources, wildlife and history. A history brought into sharp focus by a visit to Arnhem Land where the millennia old rock area and stories provided a "greater appreciation of why we should celebrate our indigenous history".

John explored the notions of resilience and egalitarianism, which motivate athletes, leaders, and community members to excel and contribute towards overcoming adversity and challenges for a more robust future. This is marked by many achievements and initiatives including, accomplishments in sports, the avoidance of recession over 31 years ('save for the initial impact of COVID'), systems which represents an ethos of affordable health care for all in the community such as the NDIS (despite its flaws), and an internationally enviable strong university education system.

The Love Letter, was not only appreciative of Australia, but provided some "tough love". The Oration presented a call to action on three fronts.



Firstly, a message for the students to consider when becoming involved in public and community life. John referred to his own experiences, particularly through philanthropy, as a way of making a difference. He also drew attention to public service through politics, however, warning of the trap of advancing personal interests rather than the "long-term interests of the entire country".

The second call to action was to "restore empathy and kindness in our civil society" something he contends was becoming increasingly difficult given the way social media is used, and, as a result of how people are responding to the increasing tension from geo-political issues globally.

The final call to action was to "dream big", that is, to respond to the national need not to fall into complacency or inactivity in shaping a better future for the next generations. Rather, take up the challenge personally and contribute actively.

The Oration certainly inspired, provoked and, in parts, entertained the appreciative audience.



Inspiring Australians Oration continued

2004 was the inaugural year of the Order of Australia Association Foundation Scholarships; it was a pleasure to have one of the recipients Dr. Felicia Eng provided a fascinating and personal perspective on the value of the scholarship in opening up opportunities which would otherwise remain unrealised.

Felicia graduated with a Bachelor of Commerce (Hons) and a Bachelor of Science from the University of Melbourne. However, this was achieved only through the support of the OAA Foundation scholarship. Felicia provided a frank and personal account of how family care issues resulted in a major upheaval which meant she was unable to focus on her study ambitions.

By chance the young Felicia Eng came across information on the scholarship and after much hesitation, and a lot of "what ifs", she submitted her application. She recounted her surprise and delight when on Christmas Eve of 2003 she received the good news – news that would have an



extraordinary impact on her life, and the contribution she has made to Haemonetics, a global medical devices company based in Boston and currently at IBM, as part of leading in Al and Quantum technologies.

The scholarship provided an opportunity for Felicia to move into Janet Clarke Hall, the University of Melbourne and the financial independence to pursue studies away from complex challenges at home. It also assisted Felicia to seek clinical assistance for depression and tackle study and life challenges.

Felicia also attributes her success to the mentoring that the scholarship provided. Felicia was paired with Professor Adrienne Clarke – still a valued mentor and friend till this day. She also acknowledged the generosity of her scholarship donor Hugh Morgan AC.

Felicia's own experiences led her to a Board Directorship at St. Hilda's College, and, as they say, passing on the baton through

her own scholarship fund: "I shape the experience of the students who live there. They place their trust in us to provide them a safe space to learn, grow and build their identity. I also fund a scholarship at the College. The scholarship provides students the opportunity to get hands-on experience working with disadvantaged communities. They get to see a different perspective, and learn how they can make an impact in this world."

In closing Felicia acknowledged an inspirational reminder of the power of the OAA Foundation Scholarships, and her own remarkable contribution to academia, science and the lives of others as a result, "I can say definitively, without the Foundation's scholarship, I would not be the person you see in front of you today". She encouraged students to pursue their passions with determination and ambition.

Inspiring Australians Oration continued

OAA VIC Branch Chair Helene Bender AM mentioned one of the key objectives of former Victoria Branch Chair, Paul Wheelton AM was to have a 'signature event' created for the Victoria Branch. From this the annual Inspiring Australians Oration was established.

The initial Oration in 2017 was delivered by Her Excellency Linda Dessau AC Governor of Victoria.

The OAA VIC Branch committee agreed to rename the Inspiring Australians Oration from next year to the Paul Wheelton AM Inspiring Australia Oration. This pays tribute to the longstanding contribution of Paul Wheelton AM to this event.

When asked about the tribute, Paul explained:

The Oration goes back to when I was Chair of Victoria of the Association and Deputy Chair of the National Board. I struggled with the Association's true purpose.

Most activities revolved around social events and a gathering of new awardees. The National Board became engaged in the need to fund scholarships via the OAA Foundation, which they

had not done for years. Taking the lead, we raised the money to fund a Victorian Scholarship, and this began an ongoing achievement of the Victorian Branch in funding more scholarships than any other State or Territory.

The idea of the Oration was born out of my desire to engage recipients of an Order of Australia with a yearly oration given by a recipient that would inspire others in our community to go above and beyond in their desire to make a difference.

Because of my involvement with several schools as a mentor in the Youth in Philanthropy program run by the Lord Mayor's Charitable Foundation, having young Australians attend would be worthwhile and also guide the



speaker in inspiring these young Australians in their content.

Vic Branch certainly looks forward to successful Inspiring Australians Oration in the years to come.

OAA member Mike Zervos OAM provided his reflection on attending the 2025 Inspiring Australians Oration noting "it was a wonderful opportunity to interact with other members and hear such inspiring presentations. I will certainly be attending other events in the future."

Having students from both St Catherine's School and Strathcona Grammar School leader program added a youthful energy to the Oration.

In HIS role as CEO of the education charity Courage to Care Victoria, Mike has interacted with Strathcona Grammar School as part of the Lord Mayor's Charitable Foundation (LMCF) Youth in Philanthropy grant program. Schools interview various charities and recommend if they be awarded funding; it was a wonderful surprise for him to reconnect with these students and their teacher at the Oration.

Courage to Care was this year's recipient of funds from Strathcona's 2024 Youth in Philanthropy initiative. This is an excellent educational opportunity for students to assess the impact of charitable giving and activities plus a source of much needed funds to charities.

Strathcona did recommend funding support and as a result a grant was made by LMCF. Courage to Care used these funds to continue offering free Upstander education into Victorian schools; the programs educate participants on how to counter the dangers of racism, prejudice, discrimination and bullying and not be bystanders.

I congratulate the OAA VIC Branch committee for arranging this event and the involvement of

The Eastern Suburbs Regional Group has been encouraged by several offers from members to join our committee, and we were delighted to appoint four new members at the Annual General Meeting recently. We returned to the Blackburn Lake Sanctuary for our meeting and were particularly grateful to Professor June Kane AM for stepping in at short notice when our

advertised guest speaker was unable to be with us. June shared some of her story and members were in awe of her lifetime record of work in combating human trafficking, exploitation of children and violence against women and children.

We continue to plan for webinars, although the attendance at these is generally disappointing. For some members, though, this type of event, along with our recordings posted on our YouTube channel, are a very important way of engagement, especially if limited mobility means face-to-face events are difficult. The speaker at our most recent webinar, just last week, was Dan Collins, who participated in four Olympic Games and is now an inspirational speaker engaging with large and small organisations to encourage the use of teams to create safe, challenging, and purposeful environments. Eastern Suburbs Regional Group continued

Our current membership is 405, down from 421 this time last year. Since 1st January we have removed seven names, (including 2 deceased, 2 change of address, and 3 non-renewals) and 2 added (new awards). We find that about 50% of those who decide not to renew membership advise us, and the rest simply let their membership lapse. In looking at membership trends, we also need to look at the number of awards made in the Australia Day and King's Birthday Honours & Awards. The number of awards in the last two has been, at least for the Eastern Suburbs Region, significantly lower than in previous years. In the six years prior to 2024, the average number of new awards in each list for the Eastern suburbs was 43 (ie a yearly average of 86), while the total number of awards in the last two lists has been 39, a drop of over 50%. It is not clear whether this represents a change in policy or a lack of nominations.

Gippsland Regional Group

Although the Annual General Meeting of the Gippsland Regional Group held on Sunday 23 March was not well attended with only 11 attendees in person, there were 17 apologies and 6 proxies submitted which suggests that there is still a reasonable amount of interest by members in the activities of the Regional Group in Gippsland.

Of note was a notice of motion submitted in advance of the meeting to develop a 'staggered tenure' approach to the election of committee members and, following a short discussion, the motion was passed that will enable half the committee positions to serve a two year term going forward therefore creating an alternating two year period of tenure into the future. The motion passed to stagger Committee appointments was to ensure that there was continuity of 'corporate knowledge' and therefore not create a void of capability and knowledge should a number of committee members not stand for re-election in the future.

Following the AGM formalities the group was addressed by the Chair of the Fundraising Subcommittee of the Rotary Centenary House Committee of Management (Kaye Radford) who delivered an interesting insight into the current and future operation of the facility that is located adjacent to the Latrobe Regional Health facility in Traralgon.

Which medal to wear when?



Day Functions

The full-size insignia (Main Piece) is generally worn at day functions where decorations have been prescribed by the event, for example OAA Events or Anzac Day

Evening Functions

At events such as evening receptions and dinners where decorations have been prescribed, the miniature insignia is generally worn. The main exception to this is Neck Decorations (AC and AO), which are worn in full-size.

Every day Wear

A lapel pin may be worn on civilian clothes at any time. Only one badge should be worn at a given time and not when other insignia pieces are worn.



April 2025 celebrations in our multicultural communities

For the first time since 2017, Western and Orthodox Easter fall on the same day – Sunday 20 April – Easter is a multi-day religious event where Christians reflect on the story of the crucifixion and resurrection of Jesus.

The period leading up to Easter is called Lent, which started at the beginning of March with Shrove Tuesday and Ash Wednesday.

While traditions may vary, the most significant days of the Easter festival are Good Friday and Easter Sunday.

Western Easter revolves around faith, family and food. Good Friday is a solemn day of prayer, reflection and hot cross buns while Easter Sunday is celebrated with church services and a feast with loved ones. Tables are laden with fish, lamb and sweet treats. Easter egg hunts are popular for chocolate lovers of all ages.

During Easter or Pascha, there are some typical greetings that Greek Orthodox Christians say to one another. These greetings are said after the Saturday evening and early Sunday morning church service.



Undoubtedly, the most popular Easter Sunday meal is slow cooked lamb and tsoureki, sweet bread made with orange zest and spices and the fun of cracking red eggs with family and friends. These traditions unite the Orthodox community.

Our Jewish friends celebrated Passover, also called Pesach from sunset Saturday 12 April to nightfall Sunday 20 April, the Exodus of the Israelites from slavery in Egypt.

Based around the Seder (a symbolic meal) they eat unleavened bread which symbolizes the hurried departure from Egypt of the Israelites.



Other symbolic foods placed on the Seder plate include a roasted lamb bone to represent the Passover sacrifice, bitter herbs to remind them of the bitterness of slavery and charoset, a sweet apple mix, which represents the mortar used in the building of the pyramids.

A time usually spent with family; Passover is one of the most important festivals in the Jewish year.

2025 Australia Day Order of Australia Investitures





This year marks the 50th anniversary of the Order of Australia.

Successive Governors of Victoria have presented these honours, awards and medals to more than 10,000 Victorian recipients at official ceremonies.

Gaye Hamilton is a Member of the Order of Australia (AM) in the General Division recipient for significant service to tertiary education and to the community.

Gaye grew up on a dairy farm in Mardan, went to school in Mirboo North and went on to make an impact across the community. In fact, her contribution spans various sectors including education, government, Australian Rules Football and Jazz music.

Trained as a teacher, Gaye's involvement in education took her from the classroom to a range of leadership roles. She was Council member of Victoria University. Never one to shy away from a challenge, Gaye became Co-Chancellor of Victoria University during the COVID pandemic. A time which saw the University close its doors and, like many, move to digital-based activities.



The western suburbs of Melbourne benefitted from Gaye's inclusive and visionary leadership over the years.

Gaye was the Director of Scienceworks which provides both informal and formal educational experiences to its many visitors. She was the inaugural Director and CEO of Werribee Zoo. She was also the Assistant Director of Melbourne Zoo and was part of commissioning the now famous butterfly house.

Gaye's love of sports saw her take on a role as the Director of Western Bulldogs (formerly Footscray Football Club) and then Chair of the Western Bulldogs Community Foundation for several years ensuring that it grew and opened its doors to the new and emerging communities which made the west of Melbourne their home.

Whilst many would have retired, Gaye's move to Inverloch in 2022 with her husband Roy

Hamilton provided an opportunity to support jazz music and she became secretary of the Inverloch Jazz Festival for three years.

Gaye has a list of roles which have contributed to community: she was the former Director of the Sports Centres Trust, Western Chances, People and Parks Foundation amongst others.

Adding to the accolades, Gaye was awarded Victorian Senior Australian of the year in 2022.

Bassilios (Basil) Morcos OAM

Fifty years of service to the community is quite an achievement. Basil came to Australia in 1971 as a young man from Egypt with his young wife and two children under three. A huge undertaking – and leap of faith. Basil's primary task was to navigate a new culture, education system and focus on settlement and survival with his family.

However, Basil saw a need – and responded. In 1973 he established the Australian Egyptian Association to support others who also found they required assistance. He quickly became an advocate for migrants and helped establish the Ethnic Communities Council of Victoria, an important peak body.

Basil is also a founding member of the 3ZZZ radio station which, till this day, provides programs in many languages to the community.

Basil faced several challenges, including finding a school for his children. Unable to enrol in a Catholic school, he worked tirelessly to gather support to finally establish St Mary's Coptic Orthodox College after ten years of effort. From 50 students he has seen it grow now to almost 1,100 students.

Education was always a passion. He took up two degrees at La Trobe University to add to the degree received from Alexandra University. He taught humanities and social science at Altona North Technical School for 21 years. His focus then, and now, is to inspire young people to rise to their potential and live full lives.

A Rotary member for over 45 years, Basil served as President and Vice President of Brimbank Central Rotary Club. He has a determined approach to supporting youth initiatives locally and internationally through sponsorships and fundraising.

Basil has received several acknowledgements for this community work, including from the Deserted Children Association of Victoria and a Centenary Medal as President of the Australian Egyptian Association – a role he held for 13 years. Through this role he helped countless migrants settle in Australia.

A dedicated family man, Basil was presented with his Medal of the Order of Australia (OAM) at Government House at the age of 88. Present at the ceremony were his two sons, Albert and Jimmy, his daughter Rosetta, and his wife Amira – all of whom have been steadfast supporters of his community work and who expressed great pride in his accomplishments.



Basil is humbled, happy and honoured to be an Order of Australia recipient – and hopes that it will inspire others to also give to the community.

A trained primary school teacher with experience in classroom, drama and music teaching and as a Music Advisor, visiting 25 schools to assist with music programs.

Jill ran music and drama school holiday programs for Cities of Moorabbin, Casey, Greater Dandenong, and Kingston. She conducted theatre workshops for young adults and mature adults in Kingston and Greater Dandenong.

Facilitator for Arts Centre Melbourne Members Conversation Group Jill organised monthly meetings and planning the speaker's schedule.

She trained the Kingston U3A choir "Vivace Voices" for 14 years and currently trains Bayside U3A choir "Baytone Singers".

Jill is the President, Administrative Secretary and Senior Classical Vocal Convener of Eisteddfod by the Bay, formerly The Mordialloc Eisteddfod EST in 1955. The eisteddfod encourages and supports young singers, actors and pianists, offering performance in a theatre before an audience, and the opportunity to receive a critique from professional adjudicators. She is also a Creativity Australia and One Voice Board Director.

Jill is a passionate supporter of the performing arts and is a patron of Arts Centre Melbourne, Victorian Opera and was a Patron of The Production Company.

Luz Restrepo OAM

Luz Restrepo OAM is a social entrepreneur dedicated to building inclusive, connected communities through small business. She founded *SisterWorks* and *Migrant Women in Business*, supporting thousands of migrant women to grow their skills and businesses.

Starting a business is always a challenge, but it can seem next to impossible for those new to



Australia; particularly for those who are still trying to find their footing.

Founder of SisterWorks, Luz Restrepo, understands this problem all too well. When she came to Australia seven years ago from Colombia, as a political asylum seeker, she had no friends here and spoke no English.

'As a political refugee, with my life in tatters, I felt like a nobody: frightened, isolated and disempowered. I soon discovered that I was not alone.'

In 2011, along with a group of 25 women experiencing similar challenges, Luz began to make and sell crafts around Melbourne. The women in this circle understood that to support each other was also to strengthen each other.

'Our thinking was the same: Don't give us fish. Teach us how to fish and we will fish for our own food in Australia,' says Luz.

In 2013, with the support from a committee of legal, fundraising and marketing volunteers, Luz formalised the business and SisterWorks was born.

Today, the not-for-profit social enterprise supports women with migrant, asylum seeker or refugee backgrounds to become financially independent, while also helping them to become happily settled in Australia.

'When you grow up in Australia, you know how Australia works and you have friends and family that give you capacity,' Luz says.

Now based in Maldon, Luz leads *Village Business*, connecting small-town entrepreneurs, councils, and business associations to strengthen regional economies. Since 2022 she is a member of the Regional Advisory Committee Loddon Mallee - Victorian Multicultural Commission.

She believes that when people can access meaningful work and earn a decent living, they feel included—and inclusion is the foundation of a thriving community. In towns without big employers, small and micro businesses keep main streets alive and create local jobs. Luz works to ensure they are heard, supported, and connected.

Luz Restrepo was awarded a Medal of the Order of Australia (OAM) King's Birthday 2024 for service to the multicultural community of Victoria.

The Deakin family is a special one which comprises over 360,000 Alumni worldwide, and I am very thankful that so many years ago I chose Deakin University for my tertiary education."



As Chair of Anam Cara Geelong, Diana also recognised the world-leading role and leadership of Deakin University in support of the amazing community palliative care hospital and the community at Waurn Ponds Deakin University.

Deakin University Chancellor John Stanhope AM is also an OAA VIC Branch member.

The Late Adam Glen McKay OAM

Adam McKay left an indelible mark on many in his sphere. In recognition of his service to basketball and to the community, he was awarded the Medal of the Order of Australia. It was received by his wife Yuki McKay. Sadly Adam passed last year after a short battle with stage 4 brain cancer aged 43.

Adam was the Founder of Helping Hoops in 2009 after noticing that there was no charitable organisation which focussed solely on running free programs for children who didn't have access to basketball. In fact, his initial motivation was to volunteer for such a program – instead 13 years ago he founded what has become a pivotal organisation in the community.

Adam knew that whilst gaining basketball skills, having an opportunity to engage in a sport without financial and other barriers was important for young people. Being able to play basketball in the community is also about personal participation, community connection,

developing social skills and belonging. His vision to break down barriers for young people has touched many over the years.

Adam ran the first program on October 5, 2012. From that initial day, programs continued to



grow in number. Adam led his team of volunteers across Melbourne to places where he knew young people needed such programs. This included, for example, Melbourne's west, Dandenong, Prahran and at Fitzroy's housing estate. The programs have now evolved but continue to focus on engaging young people whose circumstances would otherwise not allow them to engage in sport, for instance, migrants who have limited connections as part of their settlement process, young people with limited financial means and those with special needs.

As a result of a desperate need for funds, the first 24-hour Charity Shootout was launched in 2012. The aim was to shoot as many free throws as possible in 15 minutes. The funds raised not only supported the continuing viability of Helping Hoops, the Shootout became so popular it continues as a highly anticipated annual event.

Adam's determination was instrumental in leading the charity work. He brought together coaches, volunteers, partners and of course, participants. There are now 11 programs running, many in housing estates which run after school hours, weekends and during holiday periods for over 1,000 young people.

Yuki collected the Order of Australia Medals earlier this month with much pride – and fond recollections were Andrew coming home with ideas to share with her and their two young daughters. And, of course, Yuki was always there to assist and support each endeavour. The McKay family, friends and the basketball community are delighted that Andrew received the recognition.

Andrew's citation for service to basketball, and to the community also acknowledged he was a documentary filmmaker - *Sidelined: The Fight for Equality in Women's Basketball*, 2021-2022. And Head of Brand and Digital, Melbourne Boomers, Women's National Basketball League, 2022-2024.

It is pleasing to know Helping Hoops is still servicing the community.
