It was on 14 February 50 years ago that the Order of Australia was instituted by Her Majesty Queen Elizabeth II, Queen of Australia, on the advice of the Prime Minister of Australia – by Letters Patent given under the Great Seal of Australia at St James's on 14 February 1975.

Notification was published in the *Commonwealth of Australia Gazette*, No S28 dated 17 February 1975.

It is interesting to reflect that the Order was initially created with a 'Civil Division' and a 'Military Division', and comprised just three grades – AC, AO and AM.

We will bring you more interesting insights into the Order of Australia in this and subsequent newsletters.

One of the key aims of our Association is to spread information about the purposes of the Order. As recipients, we receive a lot of information about the Order, and a very useful information booklet from the Office of the Governor-General. I strongly encourage you to look through this booklet and learn more about your award.

In particular, as an Association we often take the opportunity to remind people that, as identified leaders and role models in our community, we should all be on the lookout for the 'next generation' of recipients.

We all have a role to identify who might be worthy of receiving the Order, and we can either personally make a nomination or assist someone else to make the nomination.

If you feel daunted by this task, contact me and we will do our best to put an appropriate member of the Branch in contact with you to offer help and guidance navigating the nomination process.

THE ORDER OF AUSTRALIA Letters Patent dated 14 February 1975

On Friday 14 February this year we will mark the 50-year anniversary of the institution of the Order of Australia.

The Order of Australia was established by Her Majesty Queen Elizabeth II, Queen of Australia, on the advice of the Prime Minister of Australia, by Letters Patent dated 14 February 1975. Her Majesty became Sovereign of the Order.

The Order was designed to be "an Australian society of honour for the purpose of according recognition to Australian citizens and other persons for achievement or for meritorious service".

When the Order was created in 1975, it comprised a Civil Division and a Military Division – following the precedent of the Order of the British Empire. The former was retitled 'General Division' under Letters Patent dated 24 May 1976. The General Division is senior to the Military Division.

At the time of its creation, the Order of Australia comprised just three levels, or grades – Companion (AC), Officer (AO) and Member (AM).

The grade of Knight (AK) and Dame (AD), and also the Medal of the Order of Australia (OAM), were created by Letters Patent dated 24 May 1976 (the level of Knight/Dame was subsequently abolished on 3 March 1986, re-introduced on 19 March 2014 and again discontinued on 29 October 2015).

His Majesty King Charles III, King of Australia is the current Sovereign of the Order.

Since 1 February 1989, the Governor-General has been Chancellor of the Order, while the Official Secretary to the Governor-General is Secretary of the Order.


We were very privileged to have Associate Professor Dr Carolyn Palmer AM as guest speaker, on the topic, "Working with vision impaired children and some interesting highlights".

Prior to joining the academic staff at Flinders University, Carolyn held the positions of acting Primary Principal and Policy Development Project Manager in the DECS Special Education Team.

She was then Deputy Principal of Townsend School, Deputy Master of Method at Lockleys Primary, and Deputy Principal of Stradbroke Primary School.

During her 26 years working at Flinders University, Carolyn taught in the Master of Education (Leadership and Management) and the Master of Special Education (Vision Impairment). She taught topics in the Master of Education (Leadership and Management) in China – in Tianjin, Sian and Chongqing.

She also taught topics in the Master of Education (Special Education) in Singapore.

Carolyn has also given conference papers in the USA, England, Sweden, Scotland, Hong Kong and throughout Australia.

Carolyn has extensive experience in supervising Doctoral students and in conducting research in, and publishing on aspects of school leadership, inclusive education and the education of students with sensory impairment.

Carolyn has extensive experience in working with children with vision impairment as a class teacher and in an advisory role.

She can read and write braille, and has a broad understanding of the impact of severe vision impairment on children's learning.

She is a committee member of the Leaders in Vision Education Services (LIVES), and the SA Chapter of the Australian Association of Special Education (AASE).

She chaired the Board of Management of CanDo4Kids Townsend House, SA for 10 years.

She continued as a Director on the Board of the CanDo Group for approximately 30 years, and as Vice Chair chaired the CanDo Group Professional Services Committee.

FELLOWSHIP PROGRAM 2024

HONOURS RECIPIENTS FELLOWSHIP LUNCHEON Thursday 31 October 2024

Peter and Shirley Dunn joined our October luncheon last year, and Peter addressed the group on, "A Life That Just Happened". Peter was awarded the Medal of the Order of Australia, "For service to the road transport industry" (AD22). Here are some excerpts from Peter's story:

I operated, with my wife Shirley, our school, charter & tour business in Kadina from 1976. We operated bus tours all over Australia, primarily concentrating on the outback areas of SA, NSW, Queensland and the NT.

I was also involved in operating the family hotel in Lyndhurst in the Flinders Ranges, operating a general freight service from Adelaide to Birdsville for 12 years, and operating our own Travel Agency. Shirley, a Registered Nurse, has worked in several hospitals in Adelaide and the Copper Triangle, was the District Nurse in the Copper Triangle for 8 years and then spent 26 years in Community Nursing and administration at the Northern Yorke Peninsula Health Service at Wallaroo. In all that time she has been a bus driver, and Cook and First Aid Officer on some of our Outback Camping Tours besides looking after a non-domesticated husband and three children.

I grew up in Kilburn and went to school at Christian Brothers College. Prior to leaving Adelaide for Kadina, I was awarded Life Membership of the Kilburn Football Club and Player Life Membership of the SA Amateur Football League. I played 50 Junior Games, 150 senior games, was a selector and was captain of a senior team for 2 years. When I returned to Adelaide to live, I was elected as President and served for 3 years.

I have been a member of the Bus & Coach Association of SA (BCA) for 37 years. I was President for 5 years (1989-94) and again for a short time after the President in 1996. I was elected President in 2002 and held that office for two years. I have served as Vice President at various times totalling 17 years in all.

In 2007 at the Bus Industry Confederation National Conference in Perth, I was a nominee for the BIC Outstanding Industry Contribution Award. In 2008 I was awarded the Industry Excellence award at our own State Conference – two awards of which I am extremely proud. Some years earlier I was awarded Life Membership of the BCA, something of which I am also extremely proud and humbled.

In 2000 I worked for Bus 2000, a company set up by the Bus & Coach Association (NSW), at both the Olympics and the Para-Olympics for a period of about 5 months. My role was managerial, in that I along with a team of at times up to 50 people commissioned and decommissioned buses and coaches for the 2000 Games passenger transport system. I was responsible for upwards of several thousand buses over several depots to make sure buses were available for the different facets of the transport system. It was an extremely onerous task. I was charged with liaising with the bus contracting manager and various other depot managers including the State Transit Authority (NSW) about their various vehicle requirements, on a daily basis.

In early 2015 my wife Shirley and I took the decision to sell our business. It was extremely hard, on 22 April 2015, to make that decision after operating for just on 39 years and 3 months. I thought at 68 it was time to take it a little easier.

Shirley and I have been heavily involved in the Student Exchange program, AFS, and we have hosted 10 foreign students for a year each, plus other students and teachers. Shirley and I have both been awarded Life Membership of AFS.

In August 2018 I was accepted for inclusion on the Wall of Fame at the National Transport Hall of Fame in Alice Springs. In March 2022 I was included on the Wall of Fame at the 'Stories from The Road Museum' in Port Pirie.

I have decided to remain involved in consultancy in the industry, and was asked to continue as Chairman of the Bus Industry Group Independent Bus & Coach Operators of SA (IBCO), which I am very proud to have accepted and which I have held for almost 8 years.

I am currently the Vice-President of the Military Vehicle Preservation Society of SA, and concurrently the National Military Vehicle Museum which is situated at Edinburgh, SA.

THE OPERATIONAL SERVICE MEDAL (BERMUDA)

The Operational Service Medal (Bermuda) is the most recent medal authorised by the United Kingdom to bear the crowned effigy of King Charles III.

The OSM (Bermuda) will be awarded to personnel of the Royal Bermuda Regiment (RBR) who have served from 15 September 1965 and meet the qualifying criteria.

The Tudor Crown has been included in the design to symbolise the monarch's central role and inspiration for the armed forces.

The RBR is the home defence unit of the British Overseas Territory of Bermuda. The RBR is a territorial infantry battalion, formed in 1965 through the amalgamation of two volunteer units – the Bermuda Militia Artillery and the Bermuda Rifles. On 1 September 2015, Queen Elizabeth II awarded the title 'Royal' to the regiment to mark the 50th anniversary of its formation.

As Bermuda is a British Overseas Territory, and defence is the responsibility of the United Kingdom, the RBR is under the control of the Governor and Commander-in-Chief of the island.



The reverse of the Operational Service Medal (Bermuda) features at the centre the crest and cap badge of the Royal Bermuda Regiment – the new pattern bearing the Tudor crown of King Charles III. The badge combines elements from the Royal Regiment of Artillery and the original Bermuda Volunteer Rifle Corps (later Bermuda Rifles).
