THE AUSTRALIAN HONOURS SYSTEM

Founded 14 February 1975

This year we are marking the 50-year anniversary of the institution of the Order of Australia and the Australian Honours System.

When the Order was created, by Letters Patent dated 14 February 1975, it comprised a Civil Division and a Military Division – following the precedent of the Order of the British Empire.

The former was retitled ‘General Division’ under Letters Patent dated 24 May 1976. The General Division is senior to the Military Division.

At the time of its creation, the Order of Australia comprised just three levels, or grades – Companion (AC), Officer (AO) and Member (AM).

By Letters Patent dated 24 May 1976, the Medal of the Order of Australia (OAM) was created as an additional grade. The grade of Knight (AK) and Dame (AD) existed only between 1976 and 1986, and again in 2014-15.

The Royal Australian Mint has acknowledged the more than 500,000 inspirational Australians who have been recognised within the Australian Honours System since 1975. The 2025 Year Set both celebrates the 50th anniversary of the Australian Honours System and allows us as a nation to honour the recipients, extraordinary Australians that have been celebrated in the first five decades of the Australian honours system.

The 2025 Six-Coin Coloured Uncirculated Year Set, ‘50th Anniversary of Australian Honours and Awards System’, features a set of coins in copper nickel / aluminium bronze bearing on the obverse the effigy of King Charles III by Dan Thorne.

The reverse of each coin is the familiar standard design by Stuart Devin and Horst Hahne, featuring a 50 cent coin with a coloured centre, superimposed on the badge of the Order of Australia – a disc representing a single flower of mimosa or Golden Wattle.

There is also a Six-Coin Coloured Proof Year Set available.

King Charles has some special connections to Australia, which include the following:

- > The naming of the 'Prince Charles Mountains' in the Australian Antarctic Territory (1956).
- > Prince Charles attended the Timbertop campus of Geelong Grammar School (1966).
- > He founded The Prince's Charities Australia.
- > He was appointed Colonel-in-Chief of the Royal Australian Armoured Corps (1977).
- > The Royal Visit to Australia by King Charles III was the first time a reigning King of Australia had set foot on Australian soil.
- > His Majesty was appointed to the honorary rank of Marshal of the Royal Australian Air Force.

Through an amendment to the Constitution of the Order of Australia, on 14 March 1981 the then Prince of Wales was appointed a Knight of the Order of Australia.

As heir apparent, the Prince of Wales (Charles Philip Arthur George) acceded to the throne of the United Kingdom and fourteen other Commonwealth realms on 8 September 2022.

At this time King Charles III, King of Australia, became Sovereign of the Order of Australia.

The insignia of The Sovereign of the Order of Australia is defined as a Badge of the same material, fashion and size as the Breast Badge of a Knight or Dame of the Order but with such alterations as distinguish the Royal dignity.

A new Royal Portrait was released ahead of the Royal Visit by King Charles III and Queen Camilla to Australia in October 2024, in which the King is wearing the insignia of Sovereign of the Order of Australia.

ANZAC DAY – COMMEMORATION Friday 25 April 2025

Quite a number of Branch members and Order of Australia recipients could be found around Adelaide on Anzac Day, as we marked the 110th anniversary of the Gallipoli landings.

John Jarrett AM (pictured below left) joined the march with the Korea & South East Asia Forces Association contingent in Group 3. John's award was announced in the 2023 Australia Day Honours List (*"For significant service to community health, and to veterans and their families"*), and he was then a guest at our New Recipients' Reception held on Monday 1 May 2023.

Major Paul Rosenzweig OAM (ret'd) carried the Sarawak Flag at the head of the Malaya & Borneo Veterans contingent in Group 3, in honour of the Australians and Iban Trackers who died on operational service in defence of Sarawak during Confrontation (below centre).

Former Warrant Officer Class One Johannes Leonardus 'Dutchy' Viergever OAM could be seen leading the Royal Australian Armoured Corps Vietnam contingent in Group 4 (pictured below right) – he was awarded the OAM, *"For Service to the Australian Army as the Regimental Sergeant Major, 4th/19th Prince of Wales's Light Horse"* (QB91, Military Division). Also marching was former Warrant Officer Class One Jeffrey Wayne Yates – awarded the OAM, *"For Service to the RAA as the Regimental Sergeant Major of 2nd Signal Regiment"* (QB90, Military Division). Lieutenant-Colonel John Spencer OAM RFD (ret'd) carried the UN flag for the Peacekeepers Association.

Two former Presidents of the Air Force Association (SA Division) Dave Helman OAM and Group Captain Robert Black AM RFD (ret'd) marched with the AFA contingent in Group 6.

Lieutenant-Colonel Bill Denny AM BM (ret'd), RSL South Australia Ambassador, once again delivered the commentary for the march. Meanwhile Noel Hender OAM BEM was on duty with St John Ambulance.

A notable absence on this year's March was Colonel Peter Scott DSO OAM (1929-2025), a veteran of the Korea and Vietnam Wars who was awarded the OAM this year but passed away in Adelaide just ten days earlier.

Colonel Peter Scott had advised of his intended attendance at our New Recipients' Reception in May, but passed away in Adelaide on 15 April 2025.

After his early Army Cadet service, Peter was a post-war graduate of the Royal Military College—Duntroon, as an officer of the Royal Australian Infantry Corps.

Peter served with the 3rd Battalion, Royal Australian Regiment (3RAR) as part of the British Commonwealth Occupation Force (BCOF) in Japan. He then deployed to the Korean War in 1951-52 as a rifle platoon commander and later Intelligence Officer.

He was Mentioned-in-Dispatches for his 'courage of high order' at Hill 317 in the Battle of Maryang San (Operation 'Commando') in October 1951. For his command of 3RAR in South Vietnam during 1971 he was awarded the Distinguished Service Order.

FELLOWSHIP LUNCHEON Thursday 17 April 2025

The guest speaker at our April luncheon was Major Paul Rosenzweig OAM (ret'd), on the topic "Anzackery – misinterpreting the Anzac Legend".

Paul was introduced by Reverend Brenton Daulby OAM JP.

Paul was born in Semaphore, and is a graduate of Marion High School, the University of Adelaide and the Northern Territory University. He is a retired Army Major who served in the Army Reserve for 20 years, and then in the Australian Regular Army for 12 years.

He held such appointments as reconnaissance troop commander and squadron commander in the North West Mobile Force in Darwin. From 1991 to 1997 he worked at Government House Darwin as Aide to the Administrator of the Northern Territory.

He raised and commanded two specialist teams for deployment to East Timor in 2001 and 2002, and he returned to Timor Leste in 2010 for a year as an Advisor to the East Timorese Defence Force.

He also had a 3-year appointment as Assistant Defence Attaché to the Philippines.

Paul is an author of military history and biography, with three books and numerous research papers published, including four entries in the *Australian Dictionary of Biography*.

He received the 2001 Centenary Medal for 'long and outstanding research into Australia's military history', and in 2009 was made a Fellow of the Military Historical Society of Australia. In 2017 he was awarded the Medal of the Order of Australia, "For service to military history preservation" (QB17).



SUE CHASE AM Thursday 26 June 2025

Members of the Order of Australia and other honours recipients, partners and friends are invited to join the next honours recipients fellowship luncheon at the Naval, Military and Air Force Club on **Thursday 26 June**. The speaker will be **Sue Chase AM** on the topic, "Taking power beyond the Horizon".

Sue was appointed a Member of the Order of Australia "For significant service to business, development, and the community of South Australia" (AD19).

Sue was born and bred in the country, in the town of Cowell on Eyre Peninsula, the youngest of five children and the only girl. She worked for Cowell Electric Supply for over 20 years before buying the business with three other minor shareholders in 2001.

Cowell Electric's business was principally constructing power lines in regional and remote areas of Australia, and operating power stations in remote communities. Having her pilot licence enabled her to fly to many remote sites over her years at Cowell Electric.

In her talk, Sue will outline her journey through life, family and work.

ORDER OF AUSTRALIA ASSOCIATION 2025 NATIONAL CONFERENCE 1 – 4 May 2025

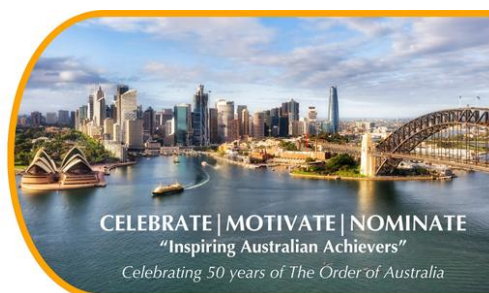

Our guest speaker Dr Barry Elsey received the OAM in the 2024 Australia Day Honours List "For service to tertiary education" – he is pictured here at the New Recipients' Reception held on Monday 6 May 2024.

Our guest speaker was Dr Barry Elsey OAM, on the topic, "My OAM story in South Australian universities – from manual labourer to knowledge worker: supervising the PhDs of industry leaders (present & emerging)".

In working with various PhD students, notably with those from industry leadership backgrounds and diverse country contexts, Barry said that an important feature of the long-haul learning journey was to encourage everyone to tell their story and what made them 'tick'.

The invitation was always accepted, which helped me become the 'guide, philosopher and friend' as the doctoral research supervisor.

Such a learning facilitation role was based on the students knowing more about the subject-matter and my job to guide them through the challenges of academic research scholarship.

The synergy worked as we shared a mutual learning journey.

Numerous shared learning experiences represented my zenith years in adult education and the source of my OAM nomination and remarkable accolade of a long university career in South Australia and previously in England.

After providing a general background about the PhD as a special kind of adult learning and education attention was paid to select examples of students with a research interest in teaching hospital leadership and management (Iran), electronic defence technology (Israel) and food manufacture (Hong Kong).

They illustrate what it means in practice to be 'guide, philosopher and friend' with very capable and knowledgeable industry leaders, present and emerging.

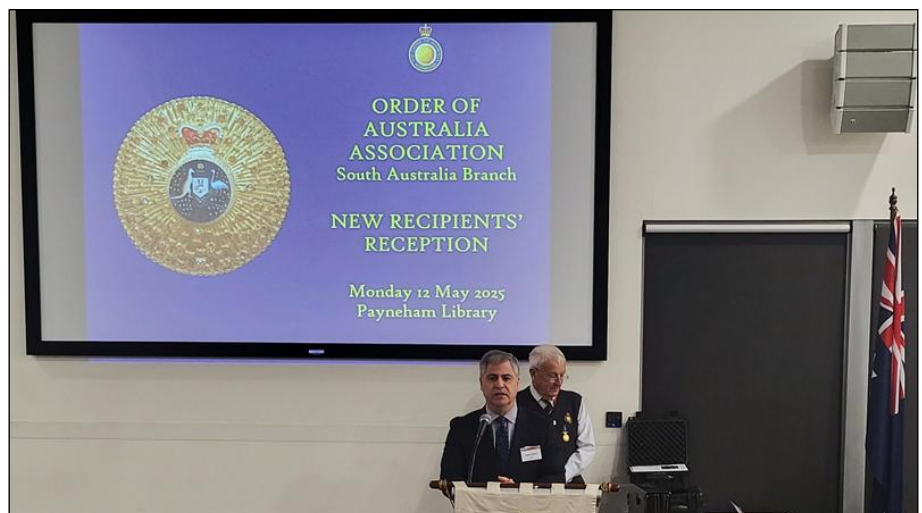

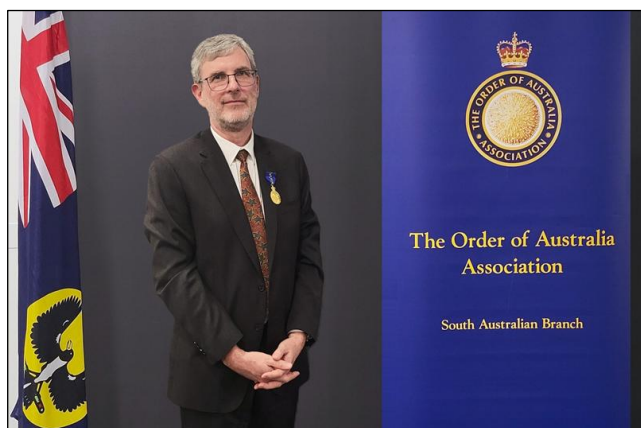

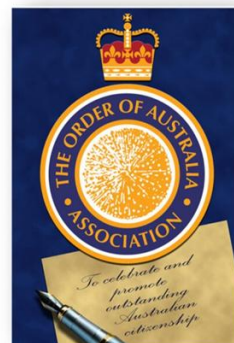

THE KING'S BIRTHDAY

Charles III is King of the United Kingdom and the 14 other Commonwealth realms, the fifth monarch of the House of Windsor.

He was born in Buckingham Palace on 14 November 1948 during the reign of his maternal grandfather, King George VI, as 'Charles Philip Arthur George'.

The King's Birthday is the designated day in most Commonwealth realms on which the birthday of the monarch is officially celebrated. It does not always correspond to the date of the monarch's actual birth.

The first time the sovereign's birthday was officially marked was in Great Britain in 1748, for King George II.

Most Australian states and territories now observe the King's Birthday on the second Monday in June.

Until 1936, the King's Birthday celebration was held on the actual birthday of the monarch, but after the death of King George V it was decided to keep the date on the second Monday in June.

This allows the public holidays to be more evenly spaced through the year. This now remains the case, with the actual birthday of King Charles III falling shortly after Remembrance Day.
