# 2025 National Conference, Sydney

CELEBRATE | MOTIVATE | NOMINATE "Inspiring Australian Achievers"

In May five Tasmanians were among more than 200 members and partners attending the 2025 National Association Conference in Sydney held over a four-day period based at the Sofitel Sydney Wentworth Hotel. The conference commenced on Thursday 1<sup>st</sup> May with a Welcome Reception at Government House hosted by Her Excellency the Honourable Margaret Beazley AC KC.

The next day we were treated with hearing 14 amazing speakers, two of whom, **Dr Jordan Nguyen** and **Deborah Wallace APM**, have details shown below with text taken from the Conference booklet.

Saturday commenced with the Association Annual General Meeting followed by the Members' Forum. Following a free afternoon or optionally attend a special service of Choral Evensong at St James' Church to commemorate 50 years of The Order of Australia. In the evening the Gala Dinner with about 300 guests not only enjoyed good food and wine but witnessed the presentations to five brilliant young Australian scholars of the Order of Australia Association Foundation awards by Her Excellency, the NSW Governor.



The Conference concluded on Sunday with a Remembrance Service and wreath laying at HMAS *Katabul* followed by the Farewell Lunch aboard HMAS *Adelaide*, that is described as a Landing Helicopter Docks (LHD) along with sister ship, HMAS *Canberra*, the largest ships ever constructed for the Royal Australian Navy. The ships provide



the Australian Defence Force with one of the most capable and sophisticated air-land-sea amphibious deployment systems in the world.

#### Dr Jordan Nguyen



Dr Nguyen is a leading Australian engineer, inventor and innovator, committed to improving as many lives as possible and becoming a driving force behind both human and technological evolution as we move into the future.

An internationally renowned engineer for humanity, Jordan designs life-changing technologies to transform the lives of people with disabilities and the elderly and is Founder and CEO of Psykinetic, a social business creating futuristic, inclusive and empowering technologies to improve independence and quality of life for disability, aged care and beyond.

Dr Jordan and his team have successfully created a mind-controlled wheelchair, numerous Virtual and Augmented reality applications, inclusive gaming, an instrument that enabled a friend with cerebral palsy to perform live music with

her eye movements and blinks, and devices that make it possible to control household appliances or even drive cars using only the tiny electrical signals created from eye movements.

Author of the book 'A Human's Guide to the Future', Jordan is also an award-winning documentary maker and presenter. His work is regularly featured in the media. Jordan recently founded his own media company and aims to continue creating world-changing content on the intersection between technology and humanity.

Involved in teaching university engineering masters' students and overseeing PhDs in Artificial Intelligence design and Biomedical instrumentation, Jordan believes our young generations are the change-makers of tomorrow and has the potential to create solutions to the world's greatest challenges.

### Deborah Wallace APM

Deborah Wallace APM is a retired Commander of Task Force Raptor, NSW Police Force.

Deborah joined the NSW Police Force in 1983, starting at the Blacktown station. She gained notoriety early in her



career, when she was involved in the investigation into the murder of 26-year-old nurse Anita Cobby.

Despite the police force being a tough place for a woman, Deborah Wallace rose to the top job of Detective Superintendent with grace, humour and an iconic sense of style. In her incredible 36-year career with NSW Police, Wallace took on murderers and drug suppliers and dismantled the State's most nefarious gangs.

Tenacious, perceptive and sharp, Wallace commanded a range of police crime

squads, bringing order to the wild west of 1990s Cabramatta and busting criminal bikie gangs with Strike Force Raptor, until her retirement in late 2019. Her inner strength and empathy meant that she was a constant go-to for some of the state's toughest cases, and her poise and compassion earned her a special place in the lives and hearts of her colleagues - and the grudging respect of her criminal foes.

Often referred to as "the gang buster", Detective Superintendent Deborah Wallace, has delved into the dark underbelly of crime investigating and dismantling some of the State's most feared gangs. Throughout a stellar career spanning more than 30 years with NSW Police, Deb has faced murderers, drug manufacturers and extortionists - to name just a few - armed with her trademark heels and colourful suits.

Deborah is the Past Commander of the State Crime Command Gangs Squad and her pragmatic approach, tenacity, sense of humour and ability to separate her work and personal lives, has enabled Deb to thrive in high pressure police operations.

Deborah is a recipient of numerous awards including the Australia Day Achievement Award, the Australian Crime and Prevention Award, and the Australian Police Medal, Deborah is strongly committed to community endeavours and is a long-time supporter of Youth off the Streets.

She is currently the star of the TV series Million Dollar Murders, dissecting Australia's most baffling cold cases.

### **Recent Tasmania Branch Events**

Each of the three Regional Groups and the Branch have conducted a number of social functions.

The year started with the **Tasmania Branch** Annual General Meeting in Perth. Following the Members' Forum attendees were treated with a most interesting and revealing talk by Gretta Pecl AM, professor of marine ecology at the Institute of Marine and Antarctic Studies. Gretta is ranked in the top 200 most influential climate scientists in the world (and the top 20 women) and has a specific expertise in how climate change is resulting in the climate-driven redistribution of life on earth, and she leads several national and international efforts to better understand climate-driven changes to species distributions, including the National multi award-winning citizen science initiative Redmap Australia and the Species on the Move international conference series.

On the day of the investitures at Government House, the Branch hosts a lunch providing a complimentary meal to the attending new awardees. The usual attendance is generally over 70 persons making a significant addition to an already enjoyable and memorable day for everyone.

The **Southern Regional Group** morning teas with guest speakers have been scheduled, the first held in March had guest speaker Judy Tierney OAM, a state and national award-winning journalist with ABC radio and television for over 35 years. Currently, Judy is on the board of Island, Tasmania's most respected literary magazine and is a Leadership Champion with Tasmanian Leaders. She is an extensive traveller having been to over75 countries.

The next event on Wednesday 25<sup>th</sup> June will be Andy Spate AM whose professional career spans more than 50 years as a research scientist in CSIRO, as a manager of caves and karst in the NSW National Parks and Wildlife service and as a consultant with his own business. Andy has extensive experience in Australia and internationally in the fields of cave and karst research and management, natural resource inventory, landscape rehabilitation, forest firefighting and tourism planning, management, and interpretation.
