- Nominations are encouraged from all members of the Australian public.
- Anyone can nominate a member of the community for recognition.
- The Order of Australia was established in 1975 by Her Majesty Queen Elizabeth II

Companion (AC)

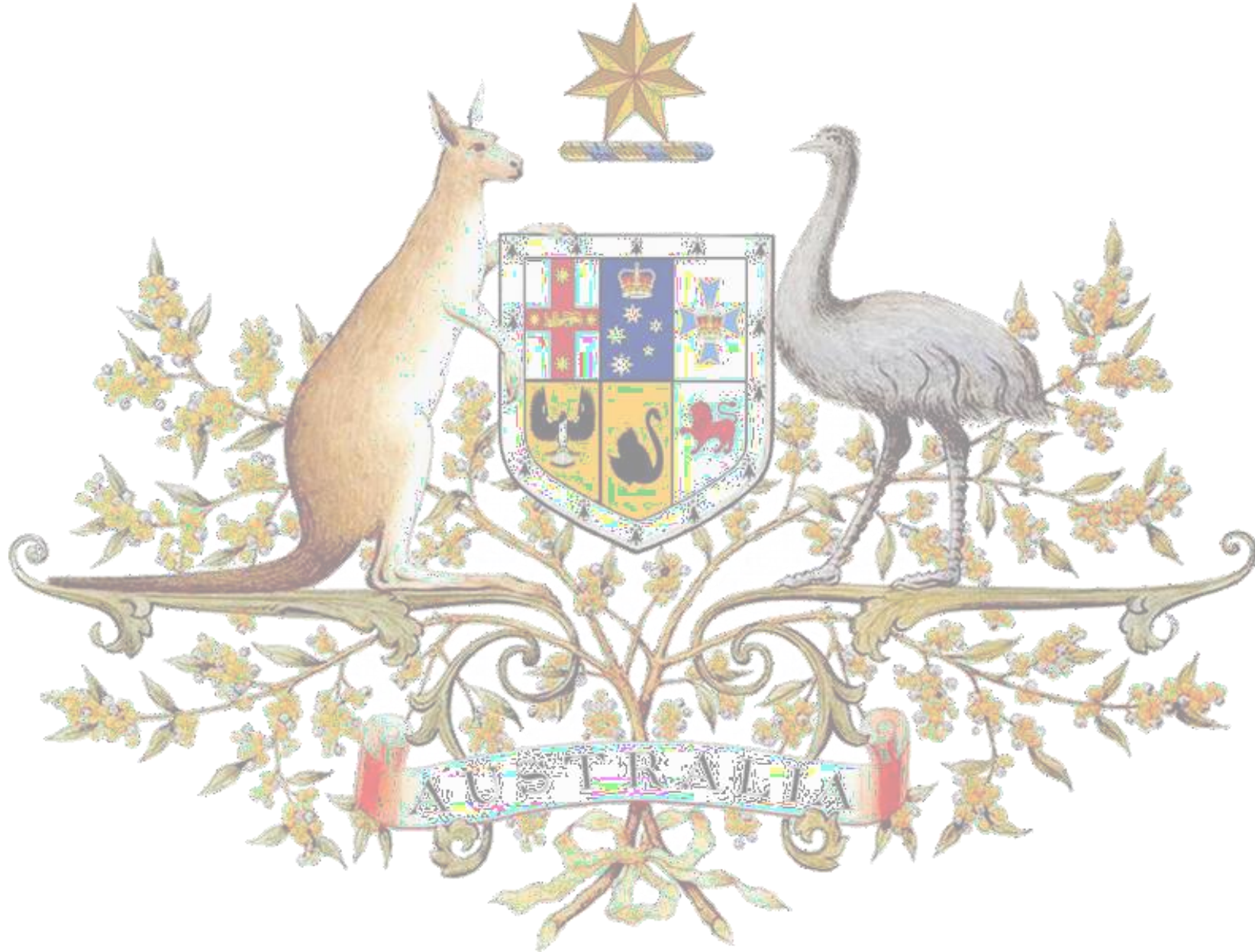
Officer (AO)

Order of Australia: Structure

- King Charles III is Sovereign
- Governor-General is Chancellor
- Official Secretary serves as Secretary of The Order of Australia
- Independent and is free from political patronage.

Order of Australia: Council

- Independent
- 19 including representatives of each state and territory
- Community representatives appointed by Governor-General on recommendation of Prime Minister
- Meets twice per year usually February and August
- Considers each nomination
- The independent Council of The Order of Australia makes recommendations to the Governor-General
- The Council operates under and by the Constitution of the Order of Australia

How to nominate

- Anyone can nominate a member of the community for an award using the Order of Australia *online portal*
- Thousands of nominations are processed each year. Given the volume of nominations and the depth of research that goes into each one, nominations generally take 18 months to more than 3 years to complete. Some nominations will take longer should the Council for the Order of Australia elect to defer making a decision to seek additional information

How to nominate

- Nominations are confidential
- Nominator and referees (3 or 4) details required
- Details of how the nominee has made a significant contribution
- Process managed by the Honours Secretariat at Government House Canberra
- Unsuccessful nominations may be reconsidered again after 3 years

Tips

- ✓ Gather as much information as you can about the person you are nominating
- ✓ You will need up to four referees (including contact details) so consider this before you start writing
- ✓ Make a short case of why/who you are nominating; including
 - examples of the impact they have made
 - what they have done to make things better for others
 - the role(s) or area(s) in which they have excelled
 - the period of time, or dates of service (if known)
 - evidence of other awards or recognition received by the nominee
