## FROM HER EXCELLENCY THE HONOURABLE SAM MOSTYN AC

GOVERNOR-GENERAL OF THE COMMONWEALTH OF AUSTRALIA



On 1 July, I was delighted to celebrate my first anniversary as Governor-General. Of course, this also means I have been Chancellor of the Order of Australia for over a year now. It has been a remarkable period, particularly as we have taken the opportunity throughout the year to mark the 50th anniversary of the Australian Honours system.

The richness and diversity of our Honours system was probably no better exemplified than the investitures I was proud to be involved with in July. Over the course of one remarkable week, I had the honour of presiding over two historic investiture ceremonies. The week began in Rockhampton, where I presented the posthumous Victoria Cross for Australia to the Late Private Richard Norden. We held the ceremony in Rockhampton at the request of Private Norden's widow, Robyn, and sons Shane and Scott. The deeply moving ceremony, in the city the family now calls home, was attended by senior members of the Australian Defence Force. A few days later, in East Arnhem Land, I had the immense privilege of presenting the insignia of the Companion of the Order of Australia to the late Dr G. Yunupingu. His daughter, Binmila Yunupingu, received the award on his behalf at a special Yolngu ceremony at Gunyangara, on Gumatj land, in the Northern Territory.

In that week alone, I saw firsthand the power of our Australian Honours system in this country, 50 years after its inception.

As I reflect on my first 12 months as Governor-General, the investiture ceremonies at Government House in Canberra stand out as some of the most rewarding moments of my role. The weeks we open our doors to recipients and their families, to congratulate and thank them for the impact they have on our country, are always a joy for everyone at Government House. Taking time to speak

with recipients and their families and seeing their joy and delight at their inclusion in The Order is always affirming. It is one of the great privileges of my role.

As Governor-General, I also welcome remarkable Australians into Government House and Admiralty House to host events or celebrate achievements. As we continue to celebrate the 50th anniversary of our Australian Honours system, I have been meeting recipients from previous honours lists who continue to shape modern Australia in ways reflective of their past recognition. In recent months, we hosted an *Accelerating Women's Leadership* forum with Catherine Fox AM, and a celebration of Professor John Pollaers OAM, Convenor of the University Chancellors Council.

In June, I had the great pleasure of announcing The King's Birthday 2025 Honours list. It was pleasing to see that this list is growing in numbers, with 581 people receiving recognition within the Order of Australia. Of those recipients, 32 per cent were recognised for service to the community, making it the largest category of recognition within the list.

When I was sworn-in as Governor-General, I promised to put the values of care, kindness and respect at the core of my work. As the months have passed, I have met countless members of the Order of Australia who steadfastly live out these values. From community service, sport, industry, social welfare and research, community health, Indigenous and multicultural communities, and individuals and groups caring for our environment, our Honours system celebrates the very best of our country. As we begin preparations at Government House Canberra for our September investitures, I look forward to meeting more inspiring Australians.

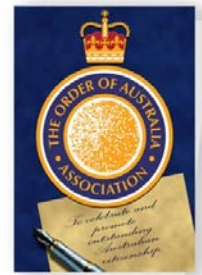

The King's Birthday Luncheon was an opportunity to mark the 50th anniversary of the institution of the Australian Honours system and, in particular, the Order of Australia. Making the event especially noteworthy, we had the distinct privilege of Her Excellency the Governor, our Branch Patron, joining us in uniform before another official engagement.

The next major celebration due is to mark the creation of the Order of Australia Association, which was soon followed by the establishment of the SA Branch in 1980. We are starting to look ahead to marking our '50th birthday' in five years' time, and are looking for a volunteer Branch Curator/ Historian to help us prepare for this event. Nominations for the 2025 Student Citizenship Awards have closed, and our Student Citizenship Awards Assessment and Selection Panel has finished their deliberations. On behalf of all our members I would like to express my gratitude for those who have volunteered their time to join this panel and review the many nominations. Your unseen efforts are greatly appreciated.

On the topic of the Student Citizenship Awards programme, I would also like to express our gratitude to the Honourable Blair Boyer MP, State Minister for Education, Training and Skills, for the first tranche of support to ensure the continuation of the practice of presenting a medallion to all awardees. We have received a grant of \$1,500, the first of three such donations covering the three-year period 2025 to 2027 inclusive.

I am also pleased to announce two further support initiatives – from Catholic Education SA and from the Association of Independent Schools of SA, who have each agreed to support the Association with collaborative funding of \$500 per year starting in 2028. We greatly appreciate this support!

## EVENTS

### COMMEMORATIONS

Four of our members attended a sunset wreath-laying service at the Air Force Memorial at Torrens Parade Ground to mark the 104th Anniversary of the formation of the Australian Air Force on 31 March 1921. The host for the ceremony was Group Captain Robert Black AM RFD (Retd), Acting President of the Air Force Association (SA Division), and he recited the Ode of Remembrance. Air Force Cadets formed the Catafalque Party and Honour Guard, and individual cadets fulfilled roles in laying a wreath, raising the Ensign and reciting the poem *High Flight* by Pilot Officer John Gillespie Magee Jr.

Several Branch members and Order of Australia recipients could be found around Adelaide on Anzac Day, as we marked the 110th anniversary of the Gallipoli landings. John Jarrett AM joined the march with the Korea & South East Asia Forces Association contingent. Major Paul Rosenzweig OAM (Retd) carried the Sarawak Flag at the head of the Malaya & Borneo Veterans contingent in honour of the Australians and Iban trackers who died on operational service in defence of Sarawak during confrontation. Lieutenant-Colonel John Spencer OAM RFD (Retd) carried the UN flag for the Peacekeepers Association.

Lieutenant-Colonel Bill Denny AM BM (Retd), RSL South Australia Ambassador, once again delivered the commentary for the march. Meanwhile Noel Hender OAM BEM was on duty with St John Ambulance.

On Saturday 31 May 2025, three Branch members attended a service of commemoration in the West Torrens War Memorial Gardens to mark the 75th Anniversary of the start of Australian involvement in the Malayan Emergency (on 31 May 1950). The SA/NT Branch of the National Malaya & Borneo Veterans Association Australia honoured six of its members who are surviving veterans of the Malayan Emergency (1948-1960), four of whom were in attendance on the day. Air Force Cadets from No 604 Squadron provided a ceremonial detachment in support of the ceremony.

## FELLOWSHIP LUNCHEONS

For the Fellowship Luncheon held at the Naval, Military and Air Force Club on Thursday 26 June, the guest speaker was Sue Chase AM on the topic, *Taking power beyond the Horizon*. Sue outlined her journey through life, family and work in the town of Cowell, 'the gateway to the Eyre Peninsula', in particular as an employee of Cowell Electric Supply for more than 20 years and then as co-owner from 2001 to 2018.

Cowell Electric's business was principally constructing power lines in regional and remote areas of Australia, and operating power stations in remote communities. The company serviced the regional areas not only in South Australia but the surrounding states of Western Australia, the Northern Territory and

Queensland. Using the money she earned helping her father in the school holidays in the 1970s surveying lines to farms on the Eyre Peninsula, Sue obtained her pilot's licence when she was 17; this later enabled her to readily visit many remote sites.

Sue described how, during her career, she and her business suffered many ups and downs but how with perseverance, stubbornness, leadership and a great team of employees, they all survived – stronger and more resilient.

Sue observed, "I believe the essence of being successful is having a vision, a dream for the future, sharing it with others and then having the confidence in and trusting your own ability and that of those around you to make it happen. In my experience, success comes to those who take pride in their work, who go the extra mile to exceed their customer's expectations".

## FEATURED MEMBER

### JAYA SRINIVAS OAM: Finding a calmer environment

Jaya Srinivas OAM has called the Territory home for more than 34 years. She received the Order of Australia Medal in 2018 for her extensive contribution to and leadership among the culturally and linguistically diverse communities right across the NT. She is also the proud recipient of the Pride of Workmanship award from Rotary.

Jaya was born in South India but spent most of her young life in New Delhi. She graduated from Delhi University with Honours in Political Science and started work as a journalist. She and her husband and baby daughter then moved to Mumbai, but concerns about the pressures of life in that huge city led the young family to think about moving to a calmer environment. They thought, "What about Australia?". "Why not?" was the reply and so in 1990, armed with a Skilled Migration visa, Jaya and her husband moved to Sydney with \$500 to their name. The following year his work brought them to Darwin, where Jaya got a temporary clerical position in Royal Darwin Hospital.

Jaya's immediate early childhood education experience led her to embark on an Advanced Diploma in Early Childhood in 1992. She then gained a Master of Education at the Northern Territory (now Charles Darwin) University and followed this up with a year in the US specializing

in the Montessori Education methodology. Back in Darwin, Jaya was invited for work experience at The Essington School and soon won a position teaching at the pre-school there. It was not surprising that, after a further qualification of Master of Business Administration, Jaya ultimately became Assistant Principal at Essington, where she became known for innovative approaches, and encouraging students to pursue individualised learning pathways.

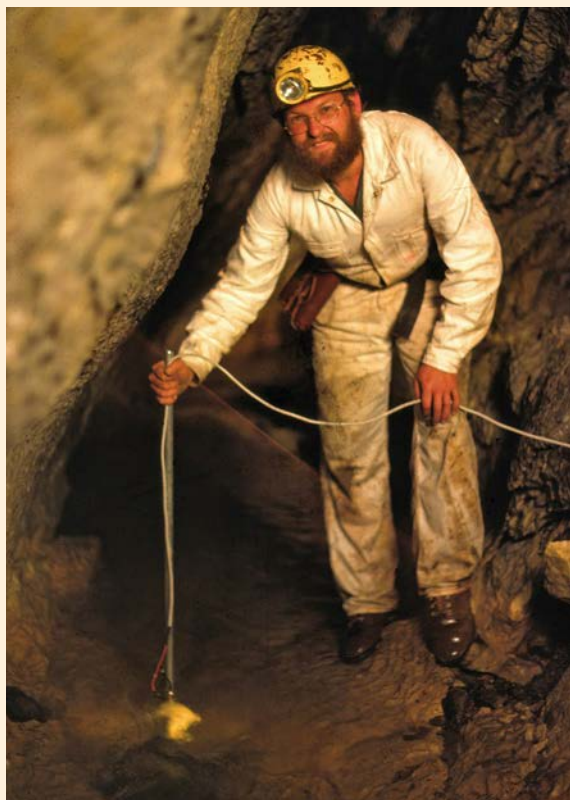

## FEATURED MEMBER

### VALE: THE HON. SIR GUY GREEN AC KBE CVO

“Every now and again a real Titan in society comes along”- David Rees.

What follows was edited from the eulogy presented at Sir Guy’s funeral by David Rees who was Sir Guy Green’s Associate at the Supreme Court:

Sir Guy Stephen Montague Green was born in Launceston in 1937 and was educated at the Launceston Church Grammar School before moving to Hobart to study law at the University of Tasmania. In 1958 he was awarded the Alfred Houston Philosophy Scholarship before graduating with a Bachelor of Laws (Hons) degree in 1960. He was admitted as a legal practitioner in the Supreme Court of Tasmania on 29 February 1960 and moved back to Launceston where he practised as a solicitor at the firm Richie & Parker, Alfred Green & Company, becoming a partner in 1963.

Following a period of private legal practice, Sir Guy was appointed as a Magistrate in June 1971 and went on to be appointed Tasmania’s youngest ever Chief Justice on 30 October 1973 at just 36 years of age. Sir Guy retired as Chief Justice in 1995, just 29 days short of serving in that role for 22 years, the longest serving Chief Justice in the court’s history.

Sir Guy was appointed as the first Tasmanian-born Governor of Tasmania in October 1995, a position he held until October 2003. As Governor, he was described as a man of ‘grace and style’, who had the common touch and who could speak in great depth to people of all backgrounds. He further consolidated the respect of Tasmanians following his compassionate handling of the 1996 Port Arthur Tragedy.

He was called upon to serve as Administrator of the Commonwealth of Australia on several occasions including between May and August 2003 before Major General Phillip Jeffrey took office as Governor-General.

From 2005 to 2022 Sir Guy was Tasmania’s Honorary Antarctic Ambassador. He was a passionate champion of Antarctica and had a deep understanding of the role Australia and indeed Tasmania played in its scientific research and a commitment to protecting the Antarctic environment. He was also a passionate scholar of philosophy, mathematics and science.

Sir Guy was actively involved in numerous community organisations which included being Chancellor of the University of Tasmania, Chairman of Trustees of the Tasmanian Museum and Art Gallery, Chairman of the Board of the Ten Days on the Island festival, Chancellor of the Australian Priory of the Order of St John of Jerusalem, Chairman of the Duke of Edinburgh Award and Chairman of the Churchill Memorial Trust

He was recognised for his service when he was made a Knight Commander of the British Empire in 1982, appointed Companion of the Order of Australia in 1994, appointed a Commander of the Royal Victorian Order during Her Late Majesty Queen Elizabeth II’s visit to Tasmania in 2000, and was awarded the Centenary Medal in 2001.

A past President of the Order of Australia Association, Sir Guy was an active and ardent supporter of the Association, regularly attending OAA events.

David Rees summed up Sir Guy’s qualities which were important to him and indeed all Tasmanians: “His respect for institutions, his genuine love of Tasmania, his overall philosophy to keep grounded and how his philosophy influenced others. What more can I say – every now and again a real Titan in society comes along, and all of us here were privileged to spend some time with this ‘Titan’, Sir Guy Stephen Montague Green”.

### MID-YEAR LUNCH BEATS THE WINTERY CHILL

On a chilly winter's day in Melbourne, more than 100 OAA VIC Branch members and guests turned out at the Stamford Plaza Melbourne Hotel to enjoy a mid-year lunch and listen to Dr Jenny Gowan AM speak on the topic of medicine management. They were also there to celebrate new members of the Association and reconnect with OAA friends.

With Dr Teresa De Fazio OAM as MC of the busy afternoon, proceedings ran smoothly for what turned out to be a pleasant and informative event.

Dr. McGowan provided insights into the importance of ensuring that medications are managed for both compatibility and effectiveness, and certainly, to avoid any unwanted side effects.

Jenny has an admirable track record as a practising pharmacist and is an accredited consultant pharmacist. Her company focuses on medication reviews in the home and in aged care facilities. She spoke about the danger of being prescribed medicines without the opportunity to carefully consider previously prescribed medications, sometimes further complicated by the intake of supplements. One anecdote that did make the audience stop and think related to one of her clients who had been prescribed 52 daily medicines.

Questions to ask your doctor, interactions of medications, safety issues in crushing medicines were key themes of her very illuminating

presentation. Jenny also spoke about generic medication, stressing the importance of checking that levels of active ingredients are the same as the originally prescribed medication.

She advised on the importance of also checking the compatibility of using supplements or herbal medicines in case of unintended consequences. Safe use of medicines also encompasses the frequency, longevity of use, timing of taking medications (morning, afternoon, evening etc.) and the actual method of taking medications. Further, the way medicines interact with, for instance, alcohol which may increase drowsiness. Some medicines such

as pain relievers and those used for blood pressure reduction and Parkinson's may also increase drowsiness and increase the risk of falls. Jenny's salient advice was to ensure that a review of medications by a trusted doctor was part of a periodic consultation process.

The afternoon was deemed a success by many who attended with respect, friendship and connection being the overarching theme for the attendees. Despite the wintery weather, it was pleasing to see members and guests came from all our Regional Groups across rural, regional and metropolitan Melbourne to enjoy a two-course lunch.

Fifteen new recipients were acknowledged at the lunch, 12 of whom had already joined the Association. Their respective work over many years was outlined briefly by the MC. Their remarkable contributions certainly provided inspiration to all attendees, demonstrating excellence in international, nation and state community contributions.

The lunch coordination was, as always, a team effort: Helene Bender AM, Barb Brook OAM, Jim Liaskos OAM and Fred Harrington OAM are acknowledged for their valuable contribution, along with tremendous support from Milly Parker OAM and Vic Branch Committee member, Beverly Pinder OAM.

The warmth of the event was perfect to ward off the winter chills. The afternoon came to a close with MC Dr Teresa De Fazio OAM reminding the guests about the upcoming end-of-year dinner scheduled for Thursday 20 November at the Stamford Plaza Melbourne Hotel. Barbara has been the Group leader of the CCV since 2006. The group is involved in event fundraising and raising awareness of the support service offered by CCV. She says it has been a wonderful experience being involved with such a committed group of people and volunteering for an organisation that is so worthy.

As well as her Cancer Council volunteer role, Barbara is currently actively involved in women's golf and in particular in attracting more women into golf.

She says, "Contributing is incredibly important. Living in a regional area it is vital that people help each other in as many ways as possible. Volunteering through groups is extremely rewarding and is a win-win for everyone".

Barbara has spent many years contributing to the OAA and says, "It has been a great joy to be part of the OAA and meet so many wonderful people who have all helped to make this country a better place. I have marvelled at how much these special people have contributed".

Barbara is not the only one in the family to receive an honour. Her father received an OAM in 1982 and joined the Association. Barbara explains that watching her parents attending many functions both in Melbourne and in the Northeast Goulburn Valley inspired her to also become an active member when she received her award.

She recalls her inspiring parents, "My father was such a wonderful man and, along with my mother, was a great role model. Although my father passed away in 2006, he is still remembered fondly in our local community and has left a great legacy".

BARRY CAPUANO OAM – A SMART WINGMAN

Barry Capuano OAM was honoured in the 2025 King’s Birthday list for service to Australian Rules football, almost immediately joined the Order of Australia Association, and is an active member of the Western Suburbs Regional Group. He says he looks forward to meeting up with other Order recipients and finding out how they received their awards.

Barry has been described as “a smart wingman who never stopped trying. Speed was his main asset and he could deliver magnificent kicks on the run”. He was recruited into the Essendon Football Club Thirds from North Essendon Methodists and won Best First Year Player award in 1958. He was selected in the League Combined Second 18 team the following year. He performed brilliantly and was elevated to the Seniors.

Barry was one of the best players on the wing in Essendon’s 1962 AFL Premiership win but a knee injury cost him a place in the 1965 premiership team.

He was selected for the State side in 1963 and also won Essendon’s award for Best Player under 21 in 1961 and the Most Consistent Player award in 1963.

When he left Essendon, Barry became captain-coach of Mitcham in 1967 and 1968 and then captained Eltham in 1969 and 1970 to two Diamond Valley League premierships.

Barry’s service to Australian Rules continued in managerial and directorial roles: he was on the Essendon committee from 1974 to 1976 and was the Club’s general manager from 1981 to 1988. In between he coached Stawell in 1978 and 1979. He has been a key member of the Essendon Football Club Past Players and Officials Association, serving as President from 2015 to 2021. He was elevated to a Legend of the Hall of Fame in June 2023.

Barry was awarded the Australian Sports Medal in 2000, so he is clearly not short of awards and accolades! He says, though, that the OAM “is without doubt the most prestigious award I have ever received, although each award is very special, as you do not seek awards when doing things you enjoy doing”.

Barry also singles out the AFL Life Membership award as an extremely special award to receive, but says it is difficult to

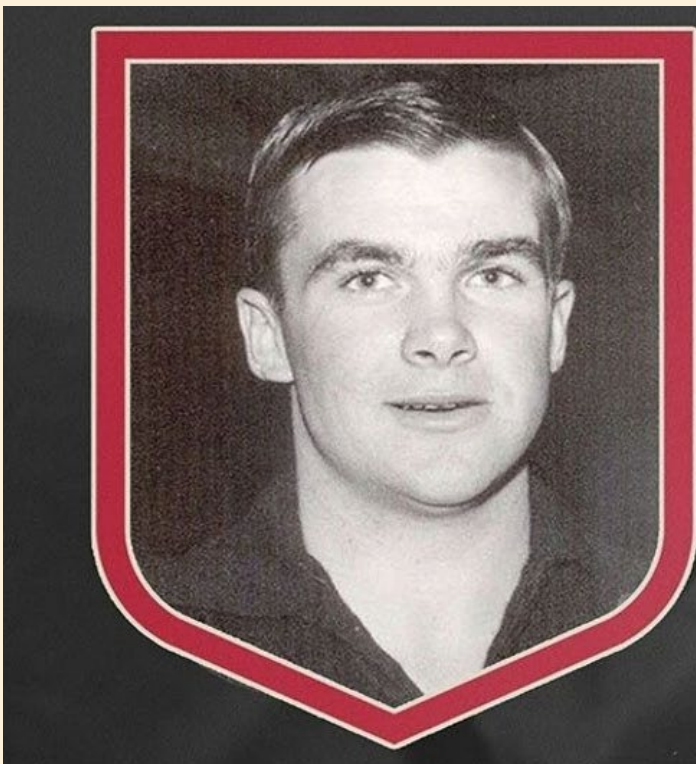

consider which award is the most important to him, as all awards mean something different. He remembers that, at the time, being a member of the 1962 Premiership team was his proudest award. Apart from the OAM, Barry is extremely proud to have been inducted as a Legend of the Essendon Football Club Hall of Fame and having a room named after him at Windy Hill, the EFC’s traditional home.

Coincidentally, when the Western Suburbs Regional Group organised a reception for new 2025 awardees in August, the event was held in the ‘Barry Capuano Room’ at Windy Hill, the first time the group has met in a room named after one of its members!

Barry retired completely in 2019 and until 2024 was involved as Secretary of the Owners Corporation Committee where he lives. He joined the Aberfeldie Men’s Shed in 2023 and says he has greatly enjoyed making many pieces of furniture and toys, mainly for his family.

Barry and wife Anna have two daughters, Leah and Julia, Leah producing two beautiful daughters Shae and Meg, and Julia producing two great sons, Joshua and Dylan. They recently became great grandparents when granddaughter Shae produced a fantastic little girl called Sunny.

Barry says, “I am greatly proud of my OAM and hopefully can continue to have some influence on those who nominated me for this prestigious award”.

# “ A HEARTFELT TRIBUTE THAT ECHOES FAR BEYOND THE MUSIC ”

The City of Traralgon Band has returned from an extraordinary Tour of Remembrance across Europe, a journey that honoured the Gippsland region's deep connections to those who served in World War I.

Established in 1881, the Band has long been a pillar of community and commemoration, its legacy stretching back to performances at the Traralgon Railway Station as troops departed for and returned from war.

This year the tour took members across the UK, Belgium, France and Denmark, performing at key historic and memorial sites that hold profound meaning for Australians.

The Band began in Yorkshire, a region that has itself transitioned from a coal-dependent past. There, they participated in the renowned Whit Friday Brass Band competitions, securing accolades including Best Tuba Section, Best Overseas Band and runner-up in the Second Section Band category.

In London, concerts at the Royal Hospital in Chelsea and Greenwich further underscored the Band's musical excellence before they travelled to the battlefields of Northern France. Performing across Flanders Fields and the Western Front—including Messines, Hill 60, Polygon Wood, Fromelles, VC Corner, Pozieres and Villers-Bretonneux—the Band paid tribute at the very sites where Australian lives were lost and remembered. They also performed at the new Sir John Monash Centre, in Fouilloy, Somme, in France, deepening their connection to Australia's war legacy.

A most moving moment came at the Menin Gate Memorial in Ypres, Belgium, where the names of 55,000 Commonwealth soldiers without known graves are engraved and the band performed for the Last Post ceremony. So impressed were the event organisers by the Band's performance that they have extended an invitation for the group to return in three years for the memorial's centenary commemorations.

The Band also joined the Amiens Brass Band for a packed joint

concert in Villers-Bretonneux, attended by local civic leaders.

Throughout the tour, the Band was accompanied by Lieutenant Colonel Doug Caulfield OAM RFD (Retd), who conducted all the Last Post services. Latrobe City Mayor, Councillor Dale Harriman, also accompanied the group on the tour. Their presence lent further official significance to the trip, and the Band was frequently praised for the respect and honour displayed during each ceremony.

The final stages of the journey took the Band to Rouen, Normandy, and then to Copenhagen, Denmark. There, they performed a memorial service at the military barracks at Kastellet Fortress, beside the Royal Palace, with Australian Ambassador Ms Kerin Ayyalaraju in attendance. They marched in to "Waltzing Matilda," a powerful symbol of national pride and remembrance. At the Ambassador's invitation, the Band closed the tour with a spirited concert for Embassy staff at her official residence — an uplifting end to a journey marked by reverence, emotion and cultural exchange.

Band President Alan Wilson OAM described the Tour as "incredible," noting how members laid poppies on graves at the request of families from the Traralgon region. He added, "After more than 12 months in planning, logistics and fundraising, the generous support provided by the community to assist the City of Traralgon Band in achieving this remarkable Tour has been greatly appreciated".

More than a tour, this was a heartfelt tribute—one that echoes far beyond the music, into the shared memory and gratitude of a nation.

By far the most moving aspect of this tour of remembrance is the story of the 'lost bugle'.

In 1983 a tourist from Queensland was visiting Norfolk, England, when an unusual object caught his eye in a local antique store. It was a brass bugle bearing the rising sun badge of the Australian army. A crown and the word Australia were emblazoned across the top of the instrument with the name 'Eyre' on top of the bell section.

Intrigued, Mr Wilkes purchased the bugle for 75 pounds and

brought it home to Australia where he began researching its origins. He was able to connect it to a First World War soldier, Private George Eyre, attached to the 10th Battalion, who was killed in action in France in 1917. The only information he could find on Private Eyre was that he was born in Buln Buln, a small village just north of Warragul in Gippsland, Victoria. Recognising the historical significance of the instrument, Mr Wilkes presented the bugle to a grateful Warragul RSL, who reimbursed him the equivalent of the 75 pounds he had paid.

Little is known about Private George Eyre. His military records show that he was born and went to school in Buln Buln in 1881 and enlisted in the Australian Infantry Forces on 18 January 1916 aged 34 years seven months, one of seven children born to James and Sarah Eyre.

The only known photo of Private Eyre was taken just before his unit departed for Europe on 25 March 1916. In that photograph, he is seated in the front row, clutching the bugle on which he was to play the Last Post as the company bugler in the far-off trenches of northern France.

Sadly, the only other information on Private Eyre's military records are the words "Killed in Action 8 April 1917" and his place of burial as Moeuvres Communal Cemetery Extension, France.

The 10th battalion were engaged in an attack at nearby Louverval on 8 April 1917 and it is likely that Private Eyre lost his life during this engagement. What became of his beloved bugle over the next 66 years, and how it came to be in an antique store in Norfolk in 1983, is unknown. What is clear is Private Eyre's skill as a blacksmith, engraving his own name and Australian emblems on the instrument. It was ultimately these inscriptions which made tracing the bugle's origins possible and saw it traced back to Warragul RSL.

The bugle is not only part of the Warragul RSL collection but also used every Anzac Day and Remembrance Day in memory of soldiers like Private Eyre who made the ultimate sacrifice for their country.

"It is treasured by the Warragul RSL," said Lynn Mizen, the President of the Warragul RSL. "I can think of no better way to commemorate the veterans of this area than by sounding the Last Post on the very bugle used in the trenches of France."

Warragul resident Sarah Lucas had seen the bugle played on Anzac Day and was aware of the bugle's connections to the First World War. Sarah and her husband Anthony Lucas, both members of the Warragul Municipal band, were offered the opportunity to join the City of Traralgon Band in a tour of European battlefields, honouring fallen soldiers through music. Remembering the bugle, Sarah did some research and traced Private George Eyre to the Moeuvres Community Cemetery Extension in France.

Sarah approached Lynn Mizen, of the Warragul RSL sub-branch and asked if the bugle could be taken on the tour in honour of Private George Eyre. Both Warragul RSL sub-branch and the City of Traralgon Band enthusiastically embraced the idea, and the tour schedule was changed to incorporate a visit to Private George Eyre's gravesite.

"To hear the Last Post played by the grave of a veteran who has been separated from his home and family for over a hundred years will be a very special moment," said Sarah Lucas. "I am so grateful to Warragul RSL sub-branch for the loan of the important part of their collection, and for how warmly the idea was accepted by the City of Traralgon Band."

The honour of performing the Last Post by the gravesite was given to the City of Traralgon Band's 19-year-old bugler, Lachlan Wilson. "I am honoured to be given the opportunity to sound the Last Post on the very bugle played and engraved by a First World War veteran from my region," Lachlan said. "I feel as if I have a personal connection with the man and that by playing at his grave, we are letting him know his sacrifice has not been forgotten."

The Last Post service for Private Eyre was held on 18 June 2025 with the Ode read by LTCOL Doug Caulfield OAM RFD (Retd), who has been the master of ceremonies at both Anzac and Remembrance Day services for Traralgon RSL for the last 20 years.

"To me, performing this service is the embodiment of mateship, one of the core values of the RSL and the Australian soldier. We are being true to the words in the ode I read at the service, that we will remember them. Lest we forget".

They now stand as a testament to the resilience, creativity and enduring connection to Country of the Stolen Generations, and the visit was a wonderful way to celebrate NAIDOC week.

Also in June, The Peel Region held a wonderful luncheon and get-together at the Peel Country Club, with Guest speaker Professor Kingsley Dixon AO FTSE. A key theme of Professor Dixon's talk was the need for us to take better care of our surroundings and become more aware and respectful of the land we live in.

The coming months in Perth will see our annual dinner at the Royal Perth Golf Club in September, and a Sundowner in October with speaker Professor Kingsley Dixon AO FTSE.

# CONNECTION TO COMMUNITY AND SERVICE - JUDY HOGBEN AM

Judy, who is Chair of the Western Australia Branch, was born in Subiaco, WA, where she was educated locally including the University of Western Australia where she received her professional qualification in psychology.

Her family's ethos of volunteering and community work, along with her early work experience in social housing, helped shape Judy's strong connection to community and the human services sectors. "Working with individuals, families and communities to assist

them and to strengthen local communities has always been important to me and has influenced where and how I work and volunteer," Judy says.

When her children were young and she was taking time out from the paid workforce, Judy was actively engaged in her local community, founding a local Toy Library and being strongly involved in the local learning centre.

A significant part of Judy's work life has been in the policy and service areas of seniors, child protection and disability services. While working in the Department of Child Protection/Community Development, she took on a variety of roles, including Executive Director, Office of Seniors Interests and Volunteering; Executive Director Statewide Services, Department of Child Protection; A/Director General of Department of Child Protection. One of the highlights for Judy was being a member of the Australian delegation (as an advisor) to the UN's Second World Assembly on Ageing. "It was such an honour to be part of this team who could advocate for and promote the issues, concerns and

future policy areas and ways to improve the lives of Australia's current and future seniors," Judy says. Being responsible for a statewide team in child protection gave Judy some of the most challenging but also most rewarding times of her career. She says, "I have the greatest respect for people who work in the area of child protection as everyday they are faced with decisions that can have a life-time impact on people's lives".

After leaving state government, Judy worked in the disability services area, firstly as CEO of the Centre for Cerebral Palsy (now Ability WA) and then as the inaugural Chair of the WA National Insurance Scheme Appeals Panel. For her innovative work at Ability Centre, Judy was awarded the Telstra Business Innovation Award, Western Australia, 2014.

Apart from her work in the Order of Australia Association, Judy continues to be actively involved in community, being a consumer representative and member of the Architects Board of WA, a member, Red Cross's Lady Lawley Management Committee, and as President of Maylands Tennis Club.

# A DIPLOMATIC MUSICIAN – FRED SMITH OAM

In the 2025 Kings Birthday Honours, Fred Smith was awarded the Medal of the Order of Australia for *service to music and foreign affairs*, a combination a former Australian Ambassador described as “improbable”.

It has been an unusual trajectory for this softly spoken troubadour. In 1996 he completed an Economics Law degree and joined the Department of Foreign Affairs and Trade. It was around that time he also began writing songs that ranged from folk ballad to rock ‘n’ roll to polka.

In 2001 Fred returned from work on peacekeeping operations in Bougainville and the Solomon Islands to record *Bagarap Empires*. The album won the 2002 NFSA National Folk Recording Award and blended personal, political and historical narratives in a way that characterised much of his subsequent travelogue recordings.

In 2009 he was the first Australian diplomat to be sent to work as a political officer alongside Australian soldiers in Uruzgan province, southern Afghanistan, and was the last to leave in 2013. While there he wrote songs and conducted regular concerts performing with Australian, US and Dutch soldiers and Afghan interpreters.

Returning to Australia, Smith released these songs on the album

*Dust of Uruzgan*. The album received very good reviews and the title track was covered by Lee Kernaghan on his top-selling *Spirit of the Anzacs* album.

The lyrics to his song *A Sappers’ Lullaby* were engraved in marble at the Australian plot in the centuries old central cemetery in Kabul. In 2013 Fred was the subject of an ABC Australian Story feature of the same name for his work as musician and storyteller of Australia’s offshore stabilisation interventions.

Smith’s memoir *The Dust of Uruzgan* was published in 2016 and described by Channel 10 Political Editor Hugh Riminton as, “as convincing a picture as we will ever have of the tragedy, hope, oddness and courage of Australia’s Uruzgan enterprise...an astonishingly vibrant piece of reportage from the heart of our longest war”.

In 2020, Fred went back to Afghanistan to work as front of house for Australia’s humanitarian programme at the Embassy. When Kabul fell under Taliban control, he worked from Kabul International Airport on Australia’s mission to evacuate passport and visa holders. On returning to Australia he wrote another memoir, *The Sparrows of Kabul*.

In 2022, he blended his accounts of the evacuation with songs from *Dust of Uruzgan* into a stage show called *Sparrows of Kabul*. It toured extensively and was described as a “a beautiful retelling of Australia’s Afghanistan experience”.

Fred says, “offering a balanced and relatable account of our involvement in Afghanistan has been a fixation and a folly which I’ve pursued. It felt like an important story and one I was uniquely placed to tell. Whatever you think of the war in Afghanistan, it matters that we understand the experiences of our soldiers over there, so they don’t walk the land as strangers in a way that a generation of Vietnam veterans did”.

Fred’s body of work on Afghanistan was recognised in 2022 when he was named Folk Alliance Australia Solo Artist of the Year and was named ACT Artist of the Year in 2023.

Commenting on being awarded an OAM, he said, “It’s a nice thing to be recognised in this way. It confers some dignity on what has felt most of the time like a scrappy and unconventional existence”.

In August 2025 Fred performed the final incarnation of his Afghanistan stage show called *Unforgotten: Songs of Australians at War* in Sydney and Wollongong. This show combined the iconic war ballads of John Schumann, Eric Bogle and Henry Lawson with Fred’s Afghanistan material in a chronological song cycle that goes some way to humanising and explaining the arc of Australia’s involvement in alliance wars.

### OAA NSW HUNTER REGION MORNING TEA

On 2 August, more than 120 members, families, and friends of the Association gathered to celebrate the King's Birthday Honours recipients in the Hunter Region. The event began with a warm welcome and Acknowledgement of Country by MC Gerry Collins, followed by a delightful morning tea.

The Hunter Region Convenor, Emeritus Professor Maree Gleeson OAM warmly welcomed distinguished members of the NSW Branch, including Dr John Gullotta AM, NSW Branch Chair, and his wife Mara, Dianne North OAM, NSW Branch Secretary, Louise Paisley OAM, Treasurer, and husband Peter, and David North OAM, Regional Coordinator.

Dr John Gullotta AM gave a warm welcome to the new recipients on behalf of the Branch, thanked the attendees of the National Conference in Sydney, with special recognition for volunteer Maree Gleeson OAM. He outlined the NSW Branch activities and spoke on the importance of our Regional Groups with Hunter being our largest.

David North OAM shared updates in his role as NSW Branch Nominated Director and Regional Coordinator.

Guest speaker Wing Commander Cameron Douglas AM delivered an insightful presentation on the evolution of air and missile defence including the development of radar and defence technologies; threats from ballistic missiles, Unmanned Aerial Vehicles (UAVs), and hypersonic weapons; historical milestones such as the beginning of air power in 1914, German V1 and V2 rockets (1944), nuclear arms (1945), and Mutually Assured Destruction (MAD) Triad (1960). He noted that, despite numerous treaties since 1967, the largest recorded attack was in 2024.

Cameron was made a Member of the Order on Australia Day 2025 *for exceptional service delivering advanced integrated air and missile defence capabilities for Australia and the US*. He was presented with a wattle shrub by Convenor Maree Gleeson OAM as a gesture of appreciation.

## THE FOUNDATION'S WORK CONTINUES

The 2024 Scholarship awardees have sent positive reports on their activities since they were presented with their awards at SYD25 earlier this year. They say the impact of the Scholarship has been life-changing. They have: maintained their high academic performance, enhanced their community activities; engaged constructively with their mentors, and are benefiting from reduced financial stress.

Meantime, the Foundation Board continues its activities in three key areas:

### Awarding Scholarships for 2025

The Foundation Board has decided to award six scholarships in 2025. Given that the 2026 Order of Australia Association Conference and dinner will be held in Brisbane, and having considered the wishes of donors, four scholarships will go to universities based in Brisbane and on the Gold Coast, with the other two being made available to the University of Western Australia. Only two of the previously awarded 60 scholarships had gone to students from Queensland universities (both to the University of Queensland).

The assessment process for the award of these six scholarships is well underway with applications being received from students from the following universities and disciplines:

- **Queensland University of Technology in Robotics:** Donated by Ms Beverley Pinder OAM and Mrs Angela Wheelton OAM.
- **University of Queensland in Arts/Law:** Donated by the Order of Australia Association Foundation, following a significant anonymous donation received by the Foundation during the 2025 financial year.
- **University of Queensland in Allied Health and Psychology:** Donated by the Order of Australia Association. We thank the Association for their ongoing support of the Scholarship programme.
- **Bond University in Medical Science:** Donated by Dr Helen Nugent AC, reflecting not just her role on the Board of the Foundation, but also her being a previous Chancellor of Bond University.
- **University of Western Australia in Science:** Information Technology and Engineering: Donated by The McCusker Charitable Foundation. We acknowledge and thank the Hon. Malcolm McCusker AC CVO KC and Mrs Tonya McCusker AM on behalf of The McCusker Charitable Foundation for their ongoing support of our activities.
- **University of Western Australia in Earth and Marine Sciences, Geology and Geophysics:** Donated by The Goodeve Foundation. We recognize Mr Stephen Munday for The Goodeve Foundation's continued support.

### Increasing Donor Support

The Foundation Board is delighted to announce that at the end of the 2024-25 financial year, it achieved its target of having a corpus of \$5 million. We are extremely thankful to the donors who helped us realize this objective. This represents a doubling of our net assets over the past three years. The Board has now re-set its target to be \$10 million, with a view to a future stretch target.

We have a simple objective: growing our corpus to help more young Australians fulfil their ambitions for the benefit of Australia. Over the past three years, as we interviewed so many talented students, we have been struck not just by the raw talent and degree of social commitment of our applicants, but also by the extent of financial stress being experienced by university students, almost regardless of their background.

The commitment of the Foundation Board is to be worthy guardians of our donors' trust, implicit in our ability to continue to deliver a Scholarship Scheme that has a reputation as the most

highly regarded undergraduate scholarship programme offered in Australia. The Governor-General's support has reinforced the Scholarship's prestige.

### Engaging with Alumni

With 60 scholarships having previously been awarded, we are now of a size where we can meaningfully engage with past scholarship recipients.

To that end, we have sought to reconnect with past winners, a task in which members of the Foundation Board have engaged for some time. More recently, a fresh impetus has been given to this activity through the generous efforts of Mr Glenn Smith, who was the recipient of a scholarship kindly donated in 2007 by former Foundation Board member, Mr Ross Adler AC. Glenn also benefited from Ross's wisdom as a mentor.

Glenn is joined in this endeavour by Ms Emily Blyth, the former Australian Head of the global strategy and communications giant, Teneo. Emily's unparalleled experience in engagement services will greatly assist the Foundation. We are indebted to her and Glenn for their *pro bono* services.

They are working with the Foundation Board to develop an alumni strategy, through which we hope to take to a whole new level what it means to be an alumnus of the Order of Australia Association Foundation Scholarship programme.

### In Summary

We aim to make all awardees in the Order of Australia proud of the work of the Foundation. In this way, the Foundation strives to bring even greater credit to Australia and what it means to have received an award within the Order of Australia.
